Technical Enhancements

The following are technical enhancements for Oracle Retail Service Layer.

Oracle Exadata Database Machine X2

Oracle Exadata Database Machine X2 is a combination of smart software and industry-standard hardware. It provides database-aware storage services, such as the ability to offload database processing from the database server to storage, transparently, without affecting SQL processing and your database applications.

Oracle Retail Service Layer Release 12.0.11 is supported on Oracle Exadata Database Machine X2 through the binary compatibility with Oracle Linux Release 5 Update 5 and Oracle Database 11g Release 2 Enterprise Edition on Oracle Real Application Clusters (RAC) 11g.
