Documentation Release Only

Note: The Oracle Retail Active Retail Intelligence (ARI) 13.0.1.1 patch release is a documentation-only release. There is no code associated with this release identifier. The current version of the application code remains ARI 13.0.1.

The purpose of this patch release is only to make corrections to the following ARI 13.0.1 documents, and new versions of these documents are included in this release:

- *Oracle Retail Active Retail Intelligence User Guide*

Overview of Documentation Corrections

Some Oracle Retail Active Retail Intelligence 13.0.1 documentation incorrectly states that ARI 13.0.1 is integrated with Oracle Retail Data Warehouse (RDW). Integration of ARI 13.0.1 with RDW is *not* supported or tested.

For the ARI 13.0.1.1 release, the following documents have been corrected as noted:

- **Operations Guide**
Information related to RDW has been removed from the "Product Integration" chapter, "Architectural Reference" appendix, and "ARI Options" appendix.
- **User Guide**
Information related to RDW has been removed from the "ARI Setup and Maintenance" section, "ARI User and Group Administration" section, "Exception and Event Definition" section, and Glossary.
