Technical Enhancement

The following technical enhancement is for Oracle Retail Extract, Transform, and Load.

Oracle Exadata Database Machine X2 Support

Oracle Exadata Database Machine X2 is a combination of smart software and industry-standard hardware. It provides database-aware storage services, such as the ability to offload database processing from the database server to storage transparently, without affecting SQL processing and your database applications.

Oracle Retail Extract, Transform, and Load Release 13.1.3.1 is supported on Oracle Exadata Database Machine X2 through the binary compatibility with Oracle Linux Release 5 Update 3 and Oracle Database 11g Release 2 Enterprise Edition on Oracle Real Application Clusters (RAC) 11g.
