This document provides a recommendation on the Activities table space before you upgrade from Release 13.2.1 or a previous release to Release 13.2.2.

Documentation Release Only

Note: Oracle Retail Markdown Optimization Release 13.2.2.2 is a documentation-only release. There are no code changes associated with this release identifier.

Activities Table Space Recommendation

Markdown Optimization Release 13.2.2 includes the patch cdw_978 that reorganizes the Activities database table. This patch will be applied when you upgrade from Release 13.2.1 or previous releases.

Ensure that the database tablespace is large enough for this purpose. For this process to run successfully, it is recommended that you have at least one and a half times of the tablespace occupied by the Activities table.
