The Analytic Parameter Calculator (APC) provides an end-to-end product solution to successfully configure and use the analytical products that rely on the causal forecasting methodology. It uses the latest in retail science to calculate elasticities and seasonality curves. The APC will be used on-site by third parties or by Oracle Retail Consulting.
