It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. The OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

Data Governance Studio (DGS).

The Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED) solution enables financial services organizations to manage and execute regulatory reporting in a single integrated environment. It automates end-to-end processes from data capture through submission with industry-leading solutions. It leverages Oracle Financial Services Analytical Application (OFSAA) and Oracle Financial Services Data Foundation (OFSDF) for managing analytical application data. The AgileREPORTER in Regulatory Reporting (REG REP) Solution enables firms to automate the final mile of the reporting process. 2.2 Pre-installation Requirements

The following prerequisite software must be installed:

- Install and configure Oracle Financial Services Analytical Application Infrastructure Pack 8.0.9.3.0 (patch ID **31656153**, see the OFS AAI Installation Guide) on your machine.
- Install and configure Oracle Financial Services Data Foundation Pack 8.0.9.3.1 (patch ID 31931579, see the OFS FSDF Release Notes) on your machine.
- Install and configure Oracle Financial Services AgileREPORTER Application 8.0.9.5.0 (patch ID 32323199).
- Install and configure Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS AGILE RP US FED)
 8.0.9.6.6 (patch ID 32566273).
- Ensure that you have executed the .profile file before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For detailed information on restarting the services, see the OFS Analytical Applications Infrastructure Installation and Configuration Guide Release 8.0.7.0.0.

2.3 Installing this One-off Patch Release

To install this one-off patch release, follow these steps:

- 1. Download the 32736238_GENERIC.zip archive file from My Oracle Support. Search for patch ID **32736238** under the **Patches & Updates** tab.
- 2. Copy the archived file to your OFSAA server in Binary mode.

3. Shut down all the OFSAAI Services. For more information, see the *Stopping Infrastructure Services* section in the OFS Analytical Applications Infrastructure Installation and Configuration Guide Release 8.0.7.0.0.

NOTE

Ensure that the FICSERVER is up and running.

- **4.** Execute chmod -R 751 32736238 GENERIC.zip
- 5. Execute unzip -a <name of the file to be unzipped> For example: unzip -a 32736238 GENERIC.zip

NOTE

The above "-a" option is mandatory to unzip the patch. If you notice an error message "unzip: not found [No such file or directory]", contact your UNIX administrator to resolve the issue.

- **6.** Navigate to the <>/OFS AGILE RP USFED/conf directory.
- 7. Configure the UPLOAD_MODEL parameter in the params.conf file to determine if the Model Upload is required or not by using the following parameter values:
 - 0 = If you have already performed Model Upload and want to skip the Model Upload process
 - 1 = If you want to perform Model Upload
- **8.** Navigate to the <>/OFS_AGILE_RP_USFED/bin directory and execute ./install.sh
- **9.** You can view the installation progress by periodically refreshing the log file under the <>/OFS AGILE RP USFED/logs directory.
- **10.** Verify the log file for any errors or warnings after the installation is completed. Contact My Oracle Support in case of any issues.

NOTE

This patch installation required approximately 10 minutes to complete in Oracle Test Labs.

2.4 Post-installation Steps

Follow these steps after a successful installation of the 8.0.9.6.7 one-off patch:

- See the log file in the <code>/OFS_AGILE_RP_USFED/logs</code> directory to ensure that no errors are reported.
- Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying the EAR or WAR file, see

the *Post Installation Configuration* section in the <u>OFS Analytical Applications Infrastructure</u> <u>Installation and Configuration Guide Release 8.0.7.0.0</u>.

- Restart all the OFSAA services. For more information, see the Starting Infrastructure Services section in the OFS Analytical Applications Infrastructure Installation and Configuration Guide Release 8.0.7.0.0.
- Resave the DE for FFIEC-031, FFIEC-041, and FR Y-9C using the following batches:
 - <INFODOM>_RESAVE_DE_USFED_FFIEC031
 - <INFODOM>_RESAVE_DE_USFED_FFIEC041
 - <INFODOM>_RESAVE_DE_USFED_FRY9C

Or, resave the Derived Entities in a sequence according to the level numbers as mentioned in the following table to reflect the changes.

NOTE

All the DEs at the same level can be resaved in parallel. Complete resave of all the set of DEs at each level before starting the next level. The order of resaving execution is from the highest level to the lowest level.

- To perform additional steps for secure configuration of drill-down from the AgileREPORTER portal, see the Configuration for Referrer Header Validation section in the OFS Analytical Applications Infrastructure Security Guide.
- Perform the additional configurations, if required, as mentioned under the Additional Configurations section in the OFS Analytical Applications Infrastructure Installation and Configuration Guide Release 8.0.7.0.0.

The Oracle Financial Services Regulatory Reporting for US Federal Reserve is now ready for use. If you encounter any problems during the setup, contact OFSAA Support at My Oracle Support.

2.5 Post US FED Run Execution

After the US FED Run execution, follow these steps:

- 1. See the Prior Date Reporting document for prior date reporting.
- **2.** Execute the <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate the RUNEXESUMM table if you are not using the FFIEC-002 or FFIEC-002S report.

If you are using the FFIEC-002 or FFIEC-002S report, execute the

```
<Installer Path>/OFS_REG_REP_USFED/Post_Scripts/RUNEXESUMM_VW.sql in
atomic schema.
```

Lombard AgileREPORTER displays additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM table.

- a. Run Execution ID is the Run Execution Identifier concatenated with Run Description.
- **b.** Run Status shows the status of US FED Run Execution.
- **c.** Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
- 3. Execute the REFRESH batches to refresh the Derived Entities.

2.6 Deploying Template Package

After saving the derived entities, follow these steps to deploy the template package:

- 1. To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA_RP_TEMPLATE_USFED_80960.zip bundled inside the Template_Package directory of the installer:
 - **a.** Navigate to the /Template Package directory inside the installer.
 - **b.** Extract the files using the following command:

```
unzip OFS_RP_TEMPLATE_USFED_80960.zip

The FED v1.25.0-b40 sign.lrm file is extracted.
```

- **c.** Navigate to the path where AgileREPORTER is installed and then go to the /bin directory.
- **d.** Add a new configuration with the following command:

```
./config.sh -p -a <Template_Package Full Path>/<.lrm file>
For example:
    ./config.sh -p -a <Template_Package Full Path>/
FED v1.25.0-b40 sign.lrm
```

2.7 Deploying Configuration Package

After saving the derived entities, follow these steps to deploy the config package:

- 1. To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA_REG_REP_USFED_80960.zip bundled inside the Config_Package directory of the installer:
 - **a.** Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
 - **b.** Add a new configuration with the following command:

```
./config.sh -a <Config Package Full Path>
```

For example:

./config.sh -a /scratch/kit/80960/OFS_REG_REP_USFED/Config_Package/
OFSAA REG REP USFED 80960.zip

2. Update the Alias with the following command:

./config.sh -ea OFSAA_REG_REP_USFED_80960 -iv 8.0.9.6.0 -alias "OFSAA FED DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
