OFS AgileREPORTER is a form and workflow tool that enables the creation and submission of regulatory returns. The OFS AgileREPORTER Application is configured with product configurations delivered using configuration packages. Different configuration packages are loaded into the OFS AgileREPORTER Application to support different sets of regulatory returns based on the jurisdiction.

2.1 New Features

The RBI Trial Template Package (Regulatory Reports for the Reserve Bank of India) package contains the following RBI return templates:

- RCA3
- IRS
- RAQ
