## 1 What's New

This chapter provides the details of the new features and enhancements in Oracle Banking Enterprise Default Management (OBEDM) Release 2.11.0.0.0.

## **1.1 Oracle Banking Enterprise Collections**

This section describes the key enhancements that are released as a part of Oracle Banking Enterprise Collections Release 2.11.0.0.0.

### 1.1.1 Upgrade of Technical Components

Oracle Banking Enterprise Collections has now modified technical components. This is to ensure flexibility in configurations and to make integration with external components easier.

Following are the upgrades made to technical components:

- Security stack has been made optional. This ensures that Oracle Banking Enterprise Collections can be deployed with either native database security or Oracle security stack.
- Document generation is now possible using Apache FOP. This removes the dependency on Documaker and Oracle Analytics Server.
- SOA component has been deprecated. All the approvals required for PTP, Hardship, Legal, and ROSO
  are now ported to the Work Item Inquiry (Fast Path: WL001) page. This removes the dependency on
  SOA component and helps to achieve faster approval process with higher efficiency.
