For a base release ("0" release, such as 12.0), Oracle Retail strongly recommends that you read all patch documentation before you begin installation procedures. Patch documentation can contain critical information related to the base release, based on new information and code changes that have been made since the base release.

Release Notes

Overview

Oracle Retail Customer Support investigates submitted issues assuming that all release patches have been applied. While it is at the client's discretion when to apply patches, delays in their application can complicate the support process.

Before installing the RMS 11.0.11 French release, confirm that RMS 11.0 and all following patches up to RMS 11.0.10 French have been successfully applied.

As with all patches, the following points should be considered before applying RMS 11.0.11 French:

- Copy the original files to an archive directory before you overwrite them, in case they are later needed for reference.
- Note whether customizations have been made to the module. If so, the customizations need to be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.

Defect Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, performance enhancement, or functional enhancement). Each defect fix included in this patch has a corresponding defect document titled <defect#> <module>.PDF (for example, "123456 nxprcno.PDF"). Fully review defect reports before implementing this patch.

Performance Issues

The following performance issues are addressed in this release.

Defect 5738447

Performance of the queries involving REPL_RESULTS table is poor when joined based on ORDER_NO.

Defect 5695020

Slow performance is encountered with the costcalc batch.

Defect 5666599

There is a performance issue with a pre run of the precostcalc batch process in prepost.

Defect 5926379

There are performance issues when running the Price Event Execution batch.

French Release Language-Specific Defects

Language-specific defects are code changes that are made specifically for the language, or defects that were not fixed in the corresponding English release. Defect reports for each defect and module affected are also included. See the defect reports for details.

The following are summaries of the French language-specific defects addressed in this release.

Defect 5953060

When an item parent with its VPN is selected for a cost change, an error message is displayed.

Defect 5880538

In satrdetl, the user encounters an error when navigating out of the discount quantity field in the Discount Detail screen.
