# Release Notes

## Overview

Oracle Retail Customer Support investigates submitted issues assuming that all release patches have been applied. While it is at the client's discretion when to apply patches, delays in their application can complicate the support process.

Before installing the RMS 11.0.12 French release, confirm that RMS 11.0 and all following patches up to RMS 11.0.11 French have been successfully applied.

Please see the Release Notes for the English-language RMS 11.0.12 release for information about technical, performance, and functional fixes that are also included in the RMS 11.0.12 French release.

As with all patches, the following points should be considered before applying RMS 11.0.12 French:

- Copy the original files to an archive directory before you overwrite them, in case they are later needed for reference.
- Note whether customizations have been made to the module. If so, the customizations need to be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.

## Defect Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, performance enhancement, or functional enhancement). Each defect fix included in this patch has a corresponding defect document titled <defect#> <module>.PDF (for example, "123456 nxprcno.PDF"). Fully review defect reports before implementing this patch.

## French Release Language-Specific Defects

Language-specific defects are code changes that are made specifically for the language or defects that were not fixed in the corresponding English release. Defect reports for each defect and module affected are also included. See the defect reports for details.

The following are summaries of the French language-specific defects addressed in this release.

Defect Number	Summary
6030651	When a cost change is created on a parent item with no locations associated, the reclass_cost_chg_queue table is not populated with transaction-level child items.
6167055	When a void transaction with a SKU_NOT_FOUND error in sa_error table is edited, the SKU_NOT_FOUND error is not deleted from the sa_error table after the error is fixed.
