Without code modifications, the RETL 11.3 release is now supported for operation in upgraded environments as described in "Technical Enhancements."

## Technical Enhancements

The following are the additional operating environments now supported for the RETL 11.3 code:

- Oracle Database 10g compatibility  
RETL 11.3 is compatible with Oracle Database 10g (10.2.0.3). Database server support has been upgraded from Oracle9i Database (9.2.0.8).
- IBM AIX 5.3 operating system compatibility  
RETL 11.3 is compatible with the IBM AIX 5.3 operating system.
- RDW 10.2.8 compatibility  
RETL 11.3 is compatible with Oracle Retail Data Warehouse (RDW) 10.2.8.
