If an element is not documented with the process or task in which it is used, then either it requires no additional explanation or it is documented with common fields for the section, chapter, implementation guide, or product line. Fields that are common to all JD Edwards EnterpriseOne applications are defined in this preface.

JD Edwards EnterpriseOne Application Prerequisites

To benefit fully from the information that is covered in these books, you should have a basic understanding of how to use JD Edwards EnterpriseOne applications.

You might also want to complete at least one introductory training course, if applicable.

You should be familiar with navigating the system and adding, updating, and deleting information by using JD Edwards EnterpriseOne menus, forms, or windows. You should also be comfortable using the World Wide Web and the Microsoft Windows or Windows NT graphical user interface.

These books do not review navigation and other basics. They present the information that you need to use the system and implement your JD Edwards EnterpriseOne applications most effectively.

Application Fundamentals

Each application implementation guide provides implementation and processing information for your JD Edwards EnterpriseOne applications.

For some applications, additional, essential information describing the setup and design of your system appears in a companion volume of documentation called the application fundamentals implementation guide. Most product lines have a version of the application fundamentals implementation guide. The preface of each implementation guide identifies the application fundamentals implementation guides that are associated with that implementation guide.

The application fundamentals implementation guide consists of important topics that apply to many or all JD Edwards EnterpriseOne applications. Whether you are implementing a single application, some combination of applications within the product line, or the entire product line, you should be familiar with the contents of the appropriate application fundamentals implementation guides. They provide the starting points for fundamental implementation tasks.

Typographical Conventions

This table contains the typographical conventions that are used in implementation guides:

Typographical Convention or Visual Cue	Description
Bold	Indicates PeopleCode function names, business function names, event names, system function names, method names, language constructs, and PeopleCode reserved words that must be included literally in the function call.
<i>Italics</i>	Indicates field values, emphasis, and JD Edwards EnterpriseOne or other book-length publication titles. In PeopleCode syntax, italic items are placeholders for arguments that your program must supply. We also use italics when we refer to words as words or letters as letters, as in the following: Enter the letter <i>O</i> .
KEY+KEY	Indicates a key combination action. For example, a plus sign (+) between keys means that you must hold down the first key while you press the second key. For ALT+W, hold down the ALT key while you press the W key.
Monospace font	Indicates a PeopleCode program or other code example.
“ ” (quotation marks)	Indicate chapter titles in cross-references and words that are used differently from their intended meanings.

Typographical Convention or Visual Cue	Description
... (ellipses)	Indicate that the preceding item or series can be repeated any number of times in PeopleCode syntax.
{ } (curly braces)	Indicate a choice between two options in PeopleCode syntax. Options are separated by a pipe ().
[] (square brackets)	Indicate optional items in PeopleCode syntax.
& (ampersand)	<p>When placed before a parameter in PeopleCode syntax, an ampersand indicates that the parameter is an already instantiated object.</p> <p>Ampersands also precede all PeopleCode variables.</p>

Visual Cues

Implementation guides contain the following visual cues.

Notes

Notes indicate information that you should pay particular attention to as you work with the JD Edwards EnterpriseOne system.

Note. Example of a note.

If the note is preceded by *Important!*, the note is crucial and includes information that concerns what you must do for the system to function properly.

Important! Example of an important note.

Warnings

Warnings indicate crucial configuration considerations. Pay close attention to warning messages.

Warning! Example of a warning.

Cross-References

Implementation guides provide cross-references either under the heading “See Also” or on a separate line preceded by the word *See*. Cross-references lead to other documentation that is pertinent to the immediately preceding documentation.

Country, Region, and Industry Identifiers

Information that applies only to a specific country, region, or industry is preceded by a standard identifier in parentheses. This identifier typically appears at the beginning of a section heading, but it may also appear at the beginning of a note or other text.

Example of a country-specific heading: “(FRA) Hiring an Employee”

Example of a region-specific heading: “(Latin America) Setting Up Depreciation”

Country Identifiers

Countries are identified with the International Organization for Standardization (ISO) country code.

Region Identifiers

Regions are identified by the region name. The following region identifiers may appear in implementation guides:

- Asia Pacific
- Europe
- Latin America
- North America

Industry Identifiers

Industries are identified by the industry name or by an abbreviation for that industry. The following industry identifiers may appear in implementation guides:

- USF (U.S. Federal)
- E&G (Education and Government)

Currency Codes

Monetary amounts are identified by the ISO currency code.

Common Fields Used in Implementation Guides

Address Book Number

Enter a unique number that identifies the master record for the entity. An address book number can be the identifier for a customer, supplier, company, employee, applicant, participant, tenant, location, and so on. Depending on the application, the field on the form might refer to the address book number as the customer number, supplier number, or company number, employee or applicant ID, participant number, and so on.

As If Currency Code	Enter the three-character code to specify the currency that you want to use to view transaction amounts. This code enables you to view the transaction amounts as if they were entered in the specified currency rather than the foreign or domestic currency that was used when the transaction was originally entered.
Batch Number	Displays a number that identifies a group of transactions to be processed by the system. On entry forms, you can assign the batch number or the system can assign it through the Next Numbers program (P0002).
Batch Date	Enter the date in which a batch is created. If you leave this field blank, the system supplies the system date as the batch date.
Batch Status	Displays a code from user-defined code (UDC) table 98/IC that indicates the posting status of a batch. Values are: <i>Blank</i> : Batch is unposted and pending approval. <i>A</i> : The batch is approved for posting, has no errors and is in balance, but has not yet been posted. <i>D</i> : The batch posted successfully. <i>E</i> : The batch is in error. You must correct the batch before it can post. <i>P</i> : The system is in the process of posting the batch. The batch is unavailable until the posting process is complete. If errors occur during the post, the batch status changes to <i>E</i> . <i>U</i> : The batch is temporarily unavailable because someone is working with it, or the batch appears to be in use because a power failure occurred while the batch was open.
Branch/Plant	Enter a code that identifies a separate entity as a warehouse location, job, project, work center, branch, or plant in which distribution and manufacturing activities occur. In some systems, this is called a business unit.
Business Unit	Enter the alphanumeric code that identifies a separate entity within a business for which you want to track costs. In some systems, this is called a branch/plant.
Category Code	Enter the code that represents a specific category code. Category codes are user-defined codes that you customize to handle the tracking and reporting requirements of your organization.
Company	Enter a code that identifies a specific organization, fund, or other reporting entity. The company code must already exist in the F0010 table and must identify a reporting entity that has a complete balance sheet.
Currency Code	Enter the three-character code that represents the currency of the transaction. JD Edwards EnterpriseOne provides currency codes that are recognized by the International Organization for Standardization (ISO). The system stores currency codes in the F0013 table.
Document Company	Enter the company number associated with the document. This number, used in conjunction with the document number, document type, and general ledger date, uniquely identifies an original document. If you assign next numbers by company and fiscal year, the system uses the document company to retrieve the correct next number for that company.

If two or more original documents have the same document number and document type, you can use the document company to display the document that you want.

Document Number

Displays a number that identifies the original document, which can be a voucher, invoice, journal entry, or time sheet, and so on. On entry forms, you can assign the original document number or the system can assign it through the Next Numbers program.

Document Type

Enter the two-character UDC, from UDC table 00/DT, that identifies the origin and purpose of the transaction, such as a voucher, invoice, journal entry, or time sheet. JD Edwards EnterpriseOne reserves these prefixes for the document types indicated:

P: Accounts payable documents.

R: Accounts receivable documents.

T: Time and pay documents.

I: Inventory documents.

O: Purchase order documents.

S: Sales order documents.

Effective Date

Enter the date on which an address, item, transaction, or record becomes active. The meaning of this field differs, depending on the program. For example, the effective date can represent any of these dates:

- The date on which a change of address becomes effective.
- The date on which a lease becomes effective.
- The date on which a price becomes effective.
- The date on which the currency exchange rate becomes effective.
- The date on which a tax rate becomes effective.

Fiscal Period and Fiscal Year

Enter a number that identifies the general ledger period and year. For many programs, you can leave these fields blank to use the current fiscal period and year defined in the Company Names & Number program (P0010).

G/L Date (general ledger date)

Enter the date that identifies the financial period to which a transaction will be posted. The system compares the date that you enter on the transaction to the fiscal date pattern assigned to the company to retrieve the appropriate fiscal period number and year, as well as to perform date validations.

Common Fields Used in This Implementation Guide

A/B Firm and A/B Plan	Select this option to determine whether you can adjust the demand by modifying either the quantity that you have already shipped (also known as <i>ahead amount</i>) or the quantity that you need to ship (also known as <i>behind amount</i>) in relation to the customer's requirements. If you activate this option, then you can adjust the demand before you create the sales order.
Authorization to Meet Competition Number	The Authorization to Meet Competition Number is transmitted and extracted for the ASN.
Branch/Plant	Enter an alphanumeric code that identifies a separate entity within a business for which you want to track costs. For example, a business unit might be a warehouse location, job, project, work center, branch, or plant.
Card Number	The card number is an OEM assigned value that further describes the part number
Contract	Enter a unique number assigned by the company to identify a particular contract. A contract is defined as a legally enforceable promise and must include these factors: an offer, an acceptance, consideration, legality of subject matter, capacity of parties to execute, and more. You may wish to assign some significance to the contract number (such as a contract type code, state, year, and so forth). A contract may have multiple supplements (field GSUP) to record addendums or changes.
Delivery Batch/Batch Lot Number	The Delivery Batch Number is used to identify items that are required to be packaged together. It is not returned on the ASN or the MPL; although, it will be on the delivery batch label.
Demand Type	Enter a code that specifies whether the demand is firm or planned. The demand type is used to determine how the system processes demand.
Engineering Tag	A number that identifies the initial production part (IPP) tag being returned on an advance ship notice (ASN). Companies typically use the IPP tag to indicate that a new part is being shipped because of an engineering change, a new supplier, and so on. The tag number is generated outside the supplier's system and input for the ASN preferably through scanning. The supplier associates the IPP tag with the serial number for a specific carton and attaches the tag to the first shipment of changed parts.
Engineering Tag Reason Code	A code that identifies the reason associated with an initial production part (IPP) tag being returned on an advance ship notice (ASN). Companies typically use the IPP tag to indicate that a new part is being shipped because of an engineering change, a new supplier, and so on.
Item Revision Level Qualifier	The qualifier for Item Revision Levels as follows: <ul style="list-style-type: none"> • EC - Delta - Supplier must ship to this level • BE - Latest revision on books, ship this or newer (GPCS)
Job Number	The lot number or job number that represents a group of sequence numbers and which uniquely identifies a job. The system uses the job number for production sequencing.

Job Sequence Number	The sequence number sent in from the OEM and that the system uses for production sequencing. Production sequencing is the process of indicating the order in which goods are unloaded from the truck.
Line Number	The line number that you assign when originating an EDI transaction. This number can represent an order line number (applicable for any order type), an invoice pay item, a journal entry line number, and so forth.
Off Line Date	The date most of the OEM vehicles are expected to be produced. The off line date determines the first part of the rotation number or sequence number.
Processed (Y/N) (processed (yes/no))	<p>Select this option to indicate whether a record has been successfully processed. Depending on the program, the system updates the EDSP field in a table with one of these values:</p> <p>Blank: The record has not been processed.</p> <p><i>I</i>: The record has been successfully processed. In order to run the EDI Inbound Demand Edit/Update batch program (R47171), you must specify <i>I</i>.</p>
Product Type	OEM reference number for third-party vendors for kanban orders.
Program ID (program identification)	<p>The number that identifies the batch or interactive program (batch or interactive object). For example, the number of the Sales Order Entry interactive program is P4210, and the number of the Print Invoices batch process report is R42565.</p> <p>The program ID is a variable length value. It is assigned according to a structured syntax in the form TSSXXX, where:</p> <p><i>T</i>: The first character of the number is alphabetic and identifies the type, such as P for Program, R for Report, and so forth. For example, the value <i>P</i> in the number P4210 indicates that the object is a program.</p> <p><i>SS</i>: The second and third characters of the number are numeric and identify the system code. For example, the value <i>42</i> in the number P4210 indicates that this program belongs to system 42, which is Sales Order Processing.</p> <p><i>XXX</i>: The remaining characters of the number are numeric and identify a unique program or report. Requirement Type	Enter a code from the EDI transaction set/message that indicates the type of demand being received. The requirement type is typically defined via OEM requirement type of firm or plan.
Route	Enter a code that represents a sequence of points at which goods are collected on the assembly line.

Route Suffix	The suffix from the EDI transaction set/message that identifies the sequence of points where goods are collected.
Routing Date	The routing date is transmitted for eKanban orders and populated to the third-party data collection vendor and printed on the UCC/B10 label.
Routing Order Sequence Number	The routing order sequence number is transmitted for eKanban orders and populated to the third-party data collection vendor and printed on the UCC/B10 label.
Routing Time	The routing time is transmitted for eKanban orders and populated to the third-party data collection vendor and printed on the UCC/B10 label.
SCAC	A unique four-character code assigned to the carrier.
Send/Receive Indicator	Enter an indicator that identifies a specific transaction set can be sent, received, or both. Values are: <i>S</i> : Send <i>R</i> : Receive <i>B</i> : Both
Sold To	Enter a user-defined name or number that identifies an address book record. You can use this field to enter and locate information. If you enter a value other than the address book number (AN8), such as the long address or tax ID, you must precede it with the special character that is defined in the Address Book constants. When the system locates the record, it returns the address book number into the field.
Transaction Set	Enter a qualifier that the system uses to identify a specific type of EDI transaction.
Transaction Set Purpose	Enter a code that identifies the purpose of the transaction set. Refer to UDC 47/PU. The 1st character of the 2nd description in that table controls how the transaction is processed. Refer to ANSI X.12 Data Item 353.

Demand Scheduling Overview

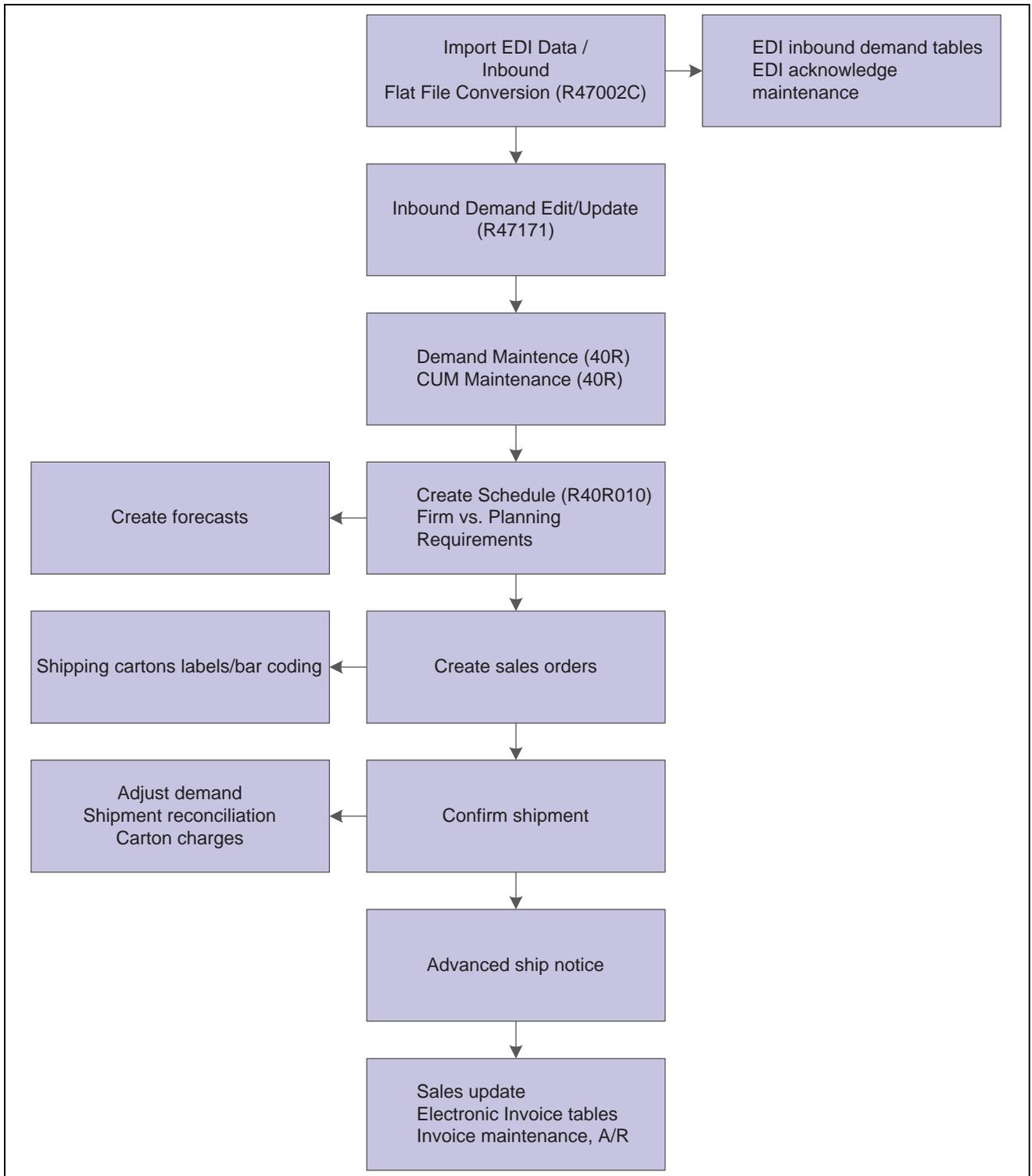
You use the JD Edwards EnterpriseOne Demand Scheduling system (40R) to manage requirements for shipment and production schedules between customers and suppliers. Firm or planned demand requirements enable you to receive, interpret, or validate, net order information for shipments, and to automatically communicate shipment details to the supplier or customer.

The system interprets and receives information using Electronic Data Interchange (EDI) documents that are transmitted from customers to suppliers, and then populates the appropriate demand scheduling tables to create records within sales orders, and forecasts. You set up the demand scheduling system to manage all of this information.

Typically, forecasted schedules are transmitted from the manufacturer or distributor to the supplier to cover a future period of time and are formatted as a series of year-to-date cumulative totals. You can use this information for forecasting and planning when ordering parts and materials in high volume supply chains.

JD Edwards EnterpriseOne Data Interface for Electronic Data Interchange

Demand scheduling focuses on capturing the raw EDI demand requirements sent by customers to suppliers. Typically, you send and receive information using the JD Edwards EnterpriseOne Electronic Data Interchange system (47). This demand scheduling information includes cumulative quantities and supplier release scheduling. You can determine which transactions and messages are sent to the supplier, and how to use them.

JD Edwards EnterpriseOne Sales Order Management

You can enhance customer service by using the JD Edwards EnterpriseOne Sales Order Management system to create order templates, standing or blanket orders. Also, this system provides additional customer service support through online displays that provide:

- Pertinent order, inventory, transportation, and financial information.
- Net profitability of a product line when promotions, discounts, and allowances are applied.

JD Edwards EnterpriseOne Warehouse Management

The JD Edwards EnterpriseOne Warehouse Management system works in conjunction with other JD Edwards EnterpriseOne systems to manage the inventory and enable you to satisfy the customers' requirements through efficient storing, packing, and shipping.

JD Edwards EnterpriseOne Transportation Management

The transportation industry deals with a wide variety of shipping needs. To meet those needs, the company might need to set up a range of transportation scenarios. The JD Edwards EnterpriseOne Transportation Management system enables you to set up parcel shipments, less than truckload shipments, truckload shipments, and rail shipments.

JD Edwards EnterpriseOne Inventory Management

The JD Edwards EnterpriseOne Inventory Management system defines discreet inventory items, which enables you to manipulate inventory throughout the supply chain. CHAPTER 2

Understanding Demand Scheduling Execution

EDI Transactions and Messages

Demand Scheduling Execution enables you to capture the raw EDI demand requirements that are sent by customers to suppliers. Typically, you send and receive information using the JD Edwards EnterpriseOne Electronic Data Interchange system (47). This demand scheduling information includes cumulative quantities and supplier release scheduling. You can determine which transactions and messages are sent to the supplier, and how to use them.

A supplier might receive the same type of information on several different transactions or messages, depending on the mix of customers with which they conduct business. The translator can interpret and process this data consistently and map the information to the database, based on the user-defined translation rules.

For example, demand information can be received by an 830, 850, 862, 866, DELJIT, DELFOR, or ORDERS document. The third-party translator then maps the data from the EDI transmission to EDI system (47) demand tables, based on the trading partner, the EDI transaction, and the data that was received.

Occasionally, customers use the 850 (purchase order) document for planning and forecasting, or for spot buys. Other customers use it as a blanket purchase order. For the customers that use the 850 for planning and forecasting, this document flows through the demand tables as a planning requirement. For spot buys, the system processes the 850 as a firm type of requirement. If the 850 document is used as a blanket purchase order, the system maps it to the PO System/47 tables and processes it as a typical 850 document.

You can also enter and revise this information manually and direct this information to customers or suppliers.

Demand Rules and Maintenance

The JD Edwards EnterpriseOne Demand Scheduling system enables you to maintain demand requirements that you receive from the customer. Demand rules include demand data and cumulative quantities that you set up at the customer and ship to level. These rules define how requirements are updated during the shipping process.

For example, demand rules enable you to:

- Specify the day on which a customer's week begins, which enables you to determine whether a demand record is associated with the current week or the prior week.
- Adjust shipment dates for nonworking days.
- Increase or decrease cumulative quantities when updating the cumulative quantity that was shipped.
- Replace the existing demand with the new demand that is associated with a particular ship to record.
- Calculate ahead or behind values to adjust the demand before you create the sales order.
- Establish shipment and delivery times based on the values for Branch/Plant, ship to, or sold to time zones.

Demand Records

You use demand records to maintain all of the demand information. Demand records include these types of information:

- Supplemental data that is stored at the demand header and detail level.
- Current schedules for creating forecast records and sales orders.
- Preferences for setting up fence dates, tolerances, pack rounding, and so forth.
- Address and contact information.
- Packaging information.
- Historical data of each schedule change or release.
- Net variance changes through inquiry and alerts.
- Activity data for analyzing inactive or obsolete items.

Planning Demand

In the context of Demand Scheduling, customers might have two types of requirements, firm and planned. Planned requirements represent demand for items that are not needed right away and do not need to be shipped immediately, but are items for which the supplier needs to plan because the customer anticipates needing the material within a specific future time horizon.

After customers have communicated their requirements to their suppliers, typically using EDI, the requirements are transferred from the EDI demand tables to the F40R11 table by running the EDI Inbound Demand Edit/Update program (R47171). The resulting records in the F40R11 table are characterized as planning or firm demand by the value in the Demand Type field. Each record also contains a demand period indicator that specifies the period of time for the demand record (daily, weekly or monthly).

Note. You can also enter firm or planned demand into the system by using the Demand Maintenance program (P40R10). Set a processing option to start the Create Demand Schedule program (R40R010) automatically.

You transfer planned demand values into the JD Edwards EnterpriseOne Forecast Management system by running the Create Demand Schedule program. Based on the schedule fence that you defined in the preferences for a customer and item combination, the system determines whether to create a forecast record from the demand record. If the demand record is within the time frame that is specified by the horizon start date (the release date or the date that is provided by the customer), the system creates a forecast record; otherwise, the data is used for information only. After the system sends a demand detail record to the JD Edwards EnterpriseOne Forecast Management system, the Create SO Status is set to 0 in demand detail.

Forecasts

Demand scheduling enables a supplier to use demand information from the customer as a way to create forecasts for the company's own production schedule. If the release that is sent by the customer is in the time period between the horizon start date and the plan forecast fence date, the system considers it planned demand and processes it into a forecast.

Forecast Consumption by Customer

When working with large customers, you might want to consider the demand for each customer separately and plan production quantities accordingly. You can set up the system to net forecasts and sales orders for a particular customer separately so that you can plan more accurately for the specific demand from individual customers. When you are netting forecasts against sales orders, the results can differ depending on whether you compare aggregate forecast and sales order values or whether you compare the values for each individual customer.

When you run the MRP/MPS Requirements Planning program (R3482), you can set up the program to use forecast consumption by customer. You can use this functionality for items that are defined with planning fence rule C, G, or H. You cannot use forecast consumption logic for process items.

Demand Spreading

Demand spreading refers to the process of spreading the demand forecast quantity for a given date or date range across a specified time period. In this process, the planning dates and quantities in the Detail Demand records are consolidated and then distributed into forecasting buckets in aggregate weekly or monthly values. The JD Edwards EnterpriseOne Forecast Management system supports two methods of demand spreading:

- Template spreading

You create a demand spreading template to indicate how to spread planned demand quantities across a week. You can specify a different percentage for each day. The percentages that you specify in the template must add up to 100.

- Even spreading

When no demand spreading template exists, the system automatically distributes demand quantities evenly across the days of the week. This is the default method.

Cumulative Processing

You use cumulative processing to communicate firm and forecasted requirements for accumulated quantities of goods from the start of a blanket purchase order to a particular future date. For example, you can send and receive notifications regarding year-to-date quantities received, quantities required, and quantities shipped.

Each demand detail record is associated with a unique cumulative record. The system receives cumulative data when you enter it manually using the CUM Maintenance program (P40R12), or through the EDI Demand Header program (P47171) using the EDI Inbound Demand Edit/Update program (R47171). You can also adjust cumulative information using the adjust demand process and CUM Rollback program (P40R421), which automatically resets cumulative quantities to zero.

Shipping and Planning Schedules

You can create shipping and planning schedules based on demand and cumulative information. This table describes how you work with schedules.

Decrementing CUMs	You use decrementing CUMs to decrease the cumulative amount that was shipped and to place orders on hold when the CUM shipped reaches zero.
Fences	<p>You can use schedule fences and preferences to control how the system maintains records for new releases and changed quantities. Two kinds of fences exist, firm and plan.</p> <p>A firm shipment fence specifies the number of days of demand for which you create sales orders. The planned forecast fence specifies the number of days of demand for which you create forecasts.</p>
Standard Pack	You use standard pack and rounding rules and cumulative calculations to determine order quantities. You set up standard pack information at the customer and item level to ensure that shipments are made in the correct quantity. Customers can request shipments that are not using standard pack.
Ahead/Behind	You can determine whether a supplier is over-shipped, under-shipped, or even. You calculate this amount by subtracting the cumulative shipped amount from the cumulative required amount. If the amount is positive, the supplier is behind (under-shipped). If the amount is negative, the supplier is ahead (over-shipped). If the difference amount is zero, the supplier is on schedule.

Forecast Dates	You create forecasted schedules and transmit them from the trading partner to the supplier to cover a forward period of time, usually in a days/weeks/months format. The schedules are often given in a series of year-to-date cumulative totals.
Schedule Revision Preferences	You set up a preference to specify how the customer sends their planning demand.

Firm Demand

Firm demand represents the demand requirements for items and material that are needed for a specified, future time. You can create and process records to manage firm demand. These records store the information that you use to maintain the requirements, including schedules, sales orders or forecasts, maintenance rules, and other default information that is relevant to suppliers and customers. You can also specify how the system processes cartons, labels, shipments, and notifications, and you can run reports to analyze all of the demand information.

Demand Sales Orders

A demand sales order is a sales order that is generated from the JD Edwards EnterpriseOne Demand Scheduling Execution system when you run the Create Demand Schedule program (R40R010). The sales orders that are created or updated reflect what items must be shipped to meet the customer's schedule.

The system automatically creates shipment records to organize the daily shipments. The demand sales orders are linked to the originating demand scheduling record by means of demand-related fields that you can review in the Sales Order Entry program (P4210) in the JD Edwards EnterpriseOne Sales Order Management system.

Carton Information

You can store detailed information about each carton on a shipment for tracking, carton charges, and the Advanced Ship Notice (ASN).

Carton information includes:

- Serial numbers.
- Weight information.
- Scanning information.
- Third-party or custom modifications for data collection and scanning.
- Manual processing.
- Carton recommendations.
- Recommendations for packing.
- Next numbers for label serial number.
- Carton reorganization for changes.

The ASN enables the sender to describe the contents and configuration of a shipment. The ASN lists the contents of a shipment of goods, as well as information that is related to the shipment, such as:

- Order information.
- Product description.
- Physical characteristics.
- Type of packaging.
- Carrier information.
- Configuration of goods within the transportation equipment.

The system prints the bill of lading from shipment and carton detail with detail and summary carton information. Customers control the format for the bill of lading number, which uses next numbers and is not customer-specific.

Label Processing

The system gathers label data from various tables into an outbound document and sends this information to a third-party to format and print the labels. You can send label information from these programs:

- Demand Maintenance (P40R10).
- Sales Order Entry (P4210), if you are not using Demand Scheduling.
- Carton Detail Inquiry (P4621), if the carton detail was created from carton recommendations.

The system uses inbound scanned label data to create or update carton detail and to create the ASN. The system requires detailed carton information on the ASN and the Bill of Lading to describe the shipment. Labels must have standard data from the inbound EDI message.

You can generate label serial numbers based on the branch/plant value using label next numbers. You can also generate labels externally. Label serial numbers are stored and validated by the third-party vendor. The system stores these numbers after you scan the number to verify quantities of shipment items with the quantities of carton detail items. You can correct discrepancies as necessary.

Shipment Reconciliation and Confirmation

When reconciling shipments, you validate that a shipment quantity for an item matches the carton detail quantity. You can reconcile shipment information when entering and scanning labels. The system links the labels to the carton detail and matches the values for shipment number, item, ship to, and quantity. If you are using smart labels, the system compares the information for each container label that is linked to the scanned label. When a match is found, the system updates the information with the correct master/mixed and container label numbers. The system also creates a record for the master/mixed label in carton detail.

After you reconcile and load a shipment, you can confirm the shipment. You can enter last-minute ASN information, such as seal numbers or freight authorization codes. You can also specify whether to automatically extract the ASN.

Shipping Reports

Shipping reports display information that is useful for pick slips, packing slips, carton recommendations and packaging requirements for shipping, bill of lading information, cumulative amounts, and shipment analysis. These reports are available:

- Document Batch Print UBE (R49590).
- Transportation Bill of Lading Build (R49110).

- Transportation Bill of Lading Print (R49118).
- Shipment Analysis (R40R030).
- ASN On Time Analysis (R470361).
- Acknowledgement Accuracy Analysis (R47191).

Notifications

This table describes how the system processes notifications for demand scheduling:

<p>ASN</p>	<p>ASN are electronic messages that provide product and shipment information to a customer prior to delivery.</p> <p>EDI tables maintain ASN data, and this enables you to quickly change ASN data to send timely messages to customers. If the changes must also be reflected in the demand and shipping tables, you can make those changes through the appropriate application at a later time. You can also roll up totals and updates to related records.</p> <p>You can set up customer rules and preferences to specify whether to perform ASN tracking. The rules and preferences determine how long the system waits for an ASN acknowledgment to be received before sending a message, as well as the workflow process name to be initiated. For example, if you want to be informed that an ASN was not acknowledged within twenty minutes, the customer rules will specify twenty minutes. If the wait time expires, the system sends an email to the designated personnel.</p>
<p>Acknowledgments</p>	<p>When you receive an EDI acknowledgement or application advice, the System/47 ASN database is updated with the acknowledgement date and time, as well as the status. The system processes these transactions for the ASN and the invoice.</p> <p>You use customer rules to determine what type of activity will take place at each status. Statuses are:</p> <ul style="list-style-type: none"> • Rejected • Accepted with Errors • Accepted <p>Each of these statuses can optionally initiate a workflow process that can send a message or an email. You can correct any required data or mapping issues and resubmit the ASN for transmission.</p>

<p>Demand Adjustments</p>	<p>When a shipment is confirmed, the system issues an XAPI message with shipment information and adjusts the demand to handle remaining, partial requirements if the actual amount that is shipped is less than the amount that is required.</p> <p>Demand is adjusted after the system receives the inbound demand and processes the associated order. The system uses the shipment confirmation message to communicate the actual quantity that is shipped to the rest of the system. The system uses the quantity shipped (including cartons) to adjust the original demand request and the associated cumulative quantities.</p> <p>For product messages (sales order detail lines), the system sends this information:</p> <ul style="list-style-type: none"> • Demand ID • Branch/plant • Sold To address book number • Ship To address book number • Quantity shipped • Unit of measure • Shipment number • Actual shipment date • Actual shipment time <p>For carton messages, the system sends this information:</p> <ul style="list-style-type: none"> • Branch/plant • Sold To address book number • Ship To address book number • Customer carton number • Number of cartons <p>The system uses the statuses of the ahead and behind calculation to determine whether to perform the update.</p> <p>The system also updates cumulative shipped amounts for products and cartons if you have activated cumulative tracking.</p>

Demand Workflow Notification	The contents of EDI and the way it is transmitted, varies from customer to customer. To accommodate those differences, a default workflow has been created that contains known business processes used by many trading partners. Each activity in this workflow represents a business process. The user has the option to use this default workflow, or copy the workflow and modify the activities. Once modified, the user can define which Branch/Plant, Sold To, and Ship To combinations should use the new workflow. The user will also have the option to not launch a workflow for a particular customer, in which case the user will not define a workflow for the Branch/Plant, Sold To, and Ship To combination.
Demand Net Variance Workflow Notification	The Net Change Variance Workflow initiates a single messaging function activity to alert production or other personnel about a net variance change that exceeds the user-defined tolerance. Parameters passed in the data structure of the workflow permit the customer to customize the workflow or messaging as business practices may require.
Invoicing	<p>The system creates the invoice after shipment confirmation. The system uses the Print Invoices program (R42565) to collect the required data from the related system files, and then converts the data into Electronic Commerce (47) system files.</p> <p>The system then uses the EDI Invoice Extraction Conversion program (R47042C) to create a flat file. The translator maps the flat file into an 810 or INVOIC format, which you send to the customer.</p>

Sales Update and Receipts

When you process sales orders using the Sales Update program (R42800), the system generates a shipment number for invoices that are stored in the F03B11 table. The system can select invoices and apply cash against invoices based on the shipment number, similar to using values like the invoice number, sales order number, customer reference, or statement number for processing and matching invoices and receipts.

Some suppliers are not required to generate an invoice, so the system enables you to issue payments based on the ASN.

Reports

You can run a variety of reports to analyze demand scheduling information. For example, you can print bills of lading or print information to analyze discrepancies for shipments, review demand activity, or analyze the efficiency of the advance ship notice process. These reports are available:

- Shipment Analysis (R40R030).
- CUM Reconciliation (R40R1010).
- Demand Inactivity Analysis (R40R1020).

CHAPTER 3

Working with EDI Demand Information

This chapter discusses and provides an overview of the setup requirements for demand scheduling EDI information:

- Create an EDI demand header record.
- Revise EDI demand detail information.
- Revise EDI demand scheduling detail information.
- Run the EDI Inbound Demand Edit/Update report (R47171).
- Set processing options for EDI Inbound Demand Edit/Update (R47171).
- Purge EDI demand records.

Understanding EDI Information for Demand Scheduling Execution

Demand Scheduling Execution focuses on capturing the demand requirements that are sent by customers to suppliers, including cumulative quantities. You can determine which transactions and messages are sent to the supplier, and how to use them.

The EDI (47) tables store the relevant data items as interpreted by the third-party translator. You can manually revise this information using EDI Demand Header Maintenance (P47171) and then process the demand requirements using the EDI Inbound Demand Edit/Update (R47171), which stores the demand requirements in the Demand Scheduling (40R) database. After the EDI data has been imported into the Demand Scheduling tables, the system will not reflect any changes to the EDI tables in the Demand Scheduling tables unless you change the Successfully Process flag in the EDI Demand Header and EDI Demand Detail to a blank or *N*. Periodically, you can purge the processed EDI records using the EDI Demand Purge (R47190) program to reduce the size of the EDI tables.

When you run the EDI Inbound Demand Edit/Update program, the system cross-references the Requirement Type value and Requirement Frequency values with the Demand Type and Demand Period values via Demand Cross Reference (P40R21).

Note. When you delete EDI demand information from the programs, the system deletes all of the dependent data. For example, when you delete an EDI demand address, the system also deletes the dependent EDI demand contact name and demand contact number.

A supplier might receive the same type of information on several different transactions or messages, depending on the mix of customers with which they conduct business. Demand information can be received either by an 830, 850, 862, 866, DELJIT, DELFOR, or ORDERS document. The third-party translator then maps the data from the EDI transmission to EDI system 47 demand tables, based on the trading partner, EDI transaction, and the data received. The translator can interpret and processes this data consistently and map the information to the database, based on the defined translation rules.

Note. Occasionally, customers use the 850 (purchase order) document for planning and forecasting, or for spot buys. Other customers use it as a blanket purchase order. For the customers that use the 850 for planning and forecasting, the information flows through the demand tables as a planning requirement. For spot buys, the system processes the 850 as a firm type of requirement. If the 850 document is used as a blanket purchase order, the system maps it to the PO System/47 tables and processes it as a typical 850 document.

The system uses information from inbound transactions to populate these EDI demand tables with information translated by the third-party translator:

Table	Description

Understanding EDI Demand Detail Information

After you enter demand header records manually or automatically into the system, you can review and change the EDI detail information as necessary before updating the 40R tables. EDI demand detail information focuses on the line items from an EDI message. Demand detail information includes the values for firm demand (sales orders) and planned demand (forecasts), including customer quantities, customer dates, and the customer purchase order number. Using this information, you can compare releases and perform net change and variance reporting and processing.

Item Revision	Enter a reference number that identifies the revision level of the customer's item. In item cross-reference, when translating a customer or supplier external item number to the internal short item number, using only the customer's number is not always sufficient. In some instances, you must use the customer part number in conjunction with the item revision level. This combination enables the system to uniquely identify the customer's item.

Blank: Has not been processed.

I: Has been successfully processed.

Revising Packaging Information

Access the EDI Demand Packaging Revisions form.

Standard Pack Enter a number that indicates the standard quantity within a container.

Type of Packages ID Enter a code that identifies the type of packaging to use when you ship an item.

Revising Addresses for EDI Demand Records

Access the EDI Demand Addresses Revisions form.

Party Type Enter a code that identifies the type of party in an EDI message. This code is typically the first element of the N1 segment of an X12 transaction set.

ID Type (identification type) Enter a user-defined code (40R/ID) that indicates the type of identification number.

Party ID (party identification) Enter a code that identifies the party in an EDI message. This code is typically the fourth element of the N1 segment of an X12 transaction set.

Revising Contact Names for EDI Demand Records

Access the EDI Demand Contact Names Revisions form.

Contact Type	Enter a UDC (40R/CT) that identifies the type or purpose of a contact. For example, you can set up codes to identify a contact as an expeditor or as an information contact.
Translation Format	Enter the qualifier that identifies a specific mapping structure to process both inbound and outbound EDI transactions. This does not apply to non EDI transactions.

Revising Contact Number Information

Access the EDI Demand Contact Numbers Revisions form.

Contact Number	Enter an alphanumeric code that is associated with a contact. Examples are a telephone number or an email address.
Phone Type	Enter a UDC (40R/PT) that identifies the type of contact number. For example, you can set up a code to represent a telephone contact.

Running the EDI Inbound Demand Edit/Update Report (R47171)

From the EDI Inbound menu (G40R11), select Inbound Demand UBE.

You run the EDI Inbound Demand Edit/Update batch program to update the demand and cumulative tables with EDI information. This process is useful for comparing a supplier and customer's cumulative quantities. Updating the cumulative and demand tables consists of these steps:

- Validating this information in the F47171 table:
 - Branch/Plant
 - Sold To
 - Ship To
- Validating this information in the F47172 and F47173 tables:
 - Item
 - Demand Header
 - Demand Processing Cross Reference
- Launching a workflow process that executes multiple customer specific business processes.
- Updating the CUM and demand tables with the values from the EDI (47) tables.

You can also run this program from the Inbound Flat File Conversion program (R47002C) after loading EDI demand data into the EDI database tables.

Setting Processing Options for EDI Inbound Edit /Update Report (R47171)

Processing options enable you to specify the default processing for programs and reports.

Defaults

- CUM Adjustment Code** Specify the CUM Adjustment Code (40R/CA) that will appear on CUM records (F40R21) that are either created or updated during the Inbound Edit/Update (R47171) process. Values are:

Purging EDI Demand Records

From the Demand Advanced and Technical Ops menu (G40R31), select EDI Demand Purge.

You can purge the processed EDI records to reduce the size of the EDI tables. The EDI Demand Purge program (R47190) determines which EDI header records have been successfully processed and deletes all the header record and its child records.

CHAPTER 4

Working with Demand Setup

This chapter provides overviews of demand records, demand rules, preferences, and net variance, and discusses how to:

- Set up demand rules for demand scheduling.
- Cross reference demand.
- Set up demand scheduling workflow.
- Run the Launch Demand Net Variance Workflow (R40R1110).
- Set up a product cumulative model.
- Set up a carton cumulative model.
- Set up item cross-references

Understanding Demand Records

A demand record stores the information that you use to maintain the requirements, scheduling information, rules, and other default information that is relevant to suppliers and customers. This information describes the components of a demand record.

Demand Rules

Includes settings to determine processing for demand cumulative quantities, and defines how requirements are updated during the shipping process.

Preferences

Includes scheduling fence dates, forecast dates, tolerances, pack rounding, and so forth. You can manage business requirements and link all of the preferences to one schedule.

Demand Header

Contains the default information that is relevant to a specific branch/plant, Sold To, Ship To, and item number for a demand requirement. Typically, information for demand records is created automatically using electronic data interchange (EDI).

Demand Detail

Includes the schedule information for firm demand (sales orders) and planned demand (forecasts), including quantities, dates, and the customer purchase order number.

Demand Packaging

Contains packaging information that is associated with a demand record.

Demand Addresses and Contacts

Contains addresses, contact names, and phones.

Demand History

Contains a snapshot of demand detail and demand address information, and distinguishes this information based on the date and time the snapshot was created.

Supplemental Demand

Stores information that is not included in the standard master tables. Examples of supplemental data include remarks, amounts, dates, codes, and times.

Demand Inactivity Analysis

Identifies items that have been inactive for a specified period of time, or are obsolete, or which may have errors that prevent processing.

The system uses these tables when processing demand records:

- F40R10
- F40R11
- F40R13
- F40R14
- F40R143
- F40R141
- F40R142
- F40R41

Understanding Demand Rules

Demand rules affect how the system processes demand data and cumulative quantities, as well as how requirements are updated during the shipping process. For example, demand rules enable you to:

- Specify the day on which a customer's week begins, allowing you to determine whether a demand record is associated with the current week or the prior week.
- Adjust shipment dates for nonworking days.
- Increase or decrease cumulative quantities when updating the cumulative quantity shipped.
- Replace the existing demand with the new demand that is associated with a particular Ship To record.
- Calculate ahead or behind values to adjust the demand before you create the sales order.
- Establish shipment and delivery times based on the branch/plant, Ship To, or Sold To time zones.

You set up demand rules at the customer or ship to level, and needs to occur only once for each customer.

The system uses these tables when processing demand rules:

- F40R11

- F40R12
- F40R41
- F40R42
- F40R12WF
- F40R20
- F40R23
- F40R24

Understanding Preferences for Demand Scheduling

You can set up preferences to handle different business requirements and link all of the preferences to one schedule. This information describes the preferences you can set up for demand scheduling.

Scheduling Fences (Preference Type 27)

You can set up two fences when creating sales orders and forecasts. You set up the firm shipment fence to specify the number of demand days for which you create sales orders. You set up the planned forecast fence to specify the number of days for which you create forecasts. The criteria that you use is Sold To, Ship To, and item.

Forecast Dates (Preference Type 28)

Usually, customers send only a single date when dealing with planned demand. To generate the forecast record, you can set up a preference that specifies how a customer sends their planning demand. The system uses these values for this purpose:

- Month Calculation
- Month Begin/End
- Week Begin/End
- Anchor Day of Week

Net Variance Tolerance (Preference Type 31)

When you set up net variance, you specify how the system processes these types of information:

- Tolerance level
- Notification level
- Critical indicator

This information helps you determine when the variance is considered significant and whether to issue a notification. For example, if the net variance setting is greater than the notification level, the system can send a notification message. You use the critical indicator to attach a ranking significance to the percentage amount.

Round to Standard Pack (Preference Type 32)

Most customers want their suppliers to ship items in a standard pack quantity. For example, if a standard pack is 100 pieces in a carton, and the customer orders 75, the supplier must ship 100 pieces. You can specify whether the Round to Standard Pack option is active when you create a demand header record. You set up this preference based on the Sold To, Ship To, and item values.

Acknowledgment Notification (Preference Type 33)

The EDI acknowledgment message indicates acceptance or rejection of a previously sent EDI message, such as the Advanced Ship Notice or the invoice. This preference returns an address book number of a person to be notified. You set up this preference using the Sold To, Ship To, Acknowledgment Code, and Message Being Acknowledged values.

ASN Tracking Workflow (Preference Type 34)

Typically, when the customer receives the ASN, they send back an EDI Acknowledgment to the supplier indicating acceptance or rejection of the ASN. You set up this preference to specify how long to wait for the returning ASN before sending a message indicating that an EDI Acknowledgment message has not been received. The system sends the message to the appropriate address book number. You set this preference up based on the Sold To and Ship To values.

Message Notification (Preference Type 35)

You use this preference to specify which address book number to use for sending notifications. You can set up this preference based on these criteria:

- Branch/Plant
- Sold To/Ship To
- Notification Field:
 - 00 = Net Variance
 - 01 = Sales Orders
 - 02 = Forecast/Planning
 - 03 = INVRPT (Inventory Advisement)
 - 04 = ASN
 - 05 = CUM
 - 06 = Adjust Demand
 - 07 = Inbound Demand
 - 08 = Acknowledgments
 - 09 = EDI Maintenance

EDI Advance Ship Notice (Preference Type 36)

You use this preference to specify whether workflow runs and to whom the system sends the message. This preference is based on these values:

- Ship To and Sold To
- Acknowledgment Code
- Message Being Acknowledged

For example, you set up preferences to run workflow for all Sold To and Ship To values, but only for Advance Ship Notices that are rejected. If the system receives an acknowledgment with an *R* (rejected) acknowledgment code for an 856 Message Being Acknowledged, the system sends you a workflow message that contains a link to the appropriate record on the Work with EDI Acknowledgments form (W47191A).

Label Processing (Preference Type 37)

You use this preference to activate label processing at the branch/plant level. You specify the party ID (values for Party Type 1 and 2) in the F40R14 table to retrieve for outbound label data. An example of a party ID is the supplier code or plant code.

For inbound label data, you specify the version for Carton Reorganization (P4620), and specify whether to automatically allocate sales order quantity to cartons. You must also specify the name of the third-party that processes the XAPI response.

Label Serial Numbers (Preference Type 38)

You use this preference to specify the label next number for outbound and inbound labels, as well as UCC128 information for inbound labels, including:

- Company UCC code
- SSCC document company
- SSCC document type
- Label generation function
- Label validation function
- Electronic product codes (EPC)

Carton Label (Preference Type 39)

You use this preference to specify whether a carton code should be assigned a label serial number. Label numbers creation must be on in either the Label Serial Number (38) preference or the version for Carton Reorganization (P4620). This preference is useful when items are packaged in multiple cartons but only outer cartons are labeled.

For example, if packaging for an item consists of a box, carton and pallet, you can specify whether to generate a label number for the pallet, for the pallet and carton, or for the pallet, carton and box.

Understanding Demand Net Variance

Net variance is the percent variation between current and previous order quantities for an item. You can specify net variance information at the item or customer level and use it to prepare for unexpected demand changes. For example, you can specify whether to alert a supplier if requirements change significantly as the supplier's ship date approaches, regardless of whether the change is an increase or decrease in order quantities.

You set up how the system processes net variances on the Net Variance tab in the Demand Maintenance (P40R10) processing options. You specify how the system processes these types of information:

- Tolerance level
- Notification level
- Critical indicator

When you set up net variance, you determine net variance days from the requested ship date, demand period, and demand processing type. This information helps you determine when the variance is considered significant and whether to issue a notification. For example, if the net variance setting is greater than the tolerance level, the system considers this difference as a significant change and displays net variance and critical ID information on the Work with Demand Detail form and on the Shipment tab on the Demand Detail Revisions form.

If the net variance setting is greater than the notification level, the system can send a notification message to an address book to alert you of the change. You can use the critical indicator to attach a ranking significance to the percentage amount.

Demand Rules Revisions form

Branch Plant

Enter an alphanumeric code that identifies a separate entity within a business for which you want to track costs. For example, a business unit might be a warehouse location, job, project, work center, branch, or plant.

You can assign a business unit to a document, entity, or person for purposes of responsibility reporting. For example, the system provides reports of open accounts payable and accounts receivable by business unit to track equipment by responsible department.

Business unit security might prevent you from viewing information about business units for which you have no authority.

Sold To

(Optional) Enter a user-defined name or number that identifies an address book record. You can use this number to locate and enter information about the address book record. If you enter a value other than the address book number, such as the long address or tax ID, you must precede it with the special character that is defined in the Address Book constants. When the system locates the record, it returns the address book number to the field.

For example, if address book number 4100 has a long address TOTAL and an * distinguishes it from other entries, you could type *TOTAL into the field, and the system would return 4100.

Ship To

(Optional). If you complete the Ship To field, you must also complete the Sold To field.

Weekly Start Day	Enter a user-defined code (UDC) (42/DW) that represents the day on which the customer's week begins. When the system removes outdated demand records, the system uses this code to determine whether a demand record is associated with the current week or the prior week.
CUM Adjustment Code for Shipments (cumulative adjustment code for shipments)	Enter a UDC (40R/CA) that identifies the type of adjustment that results from the shipment process.
Replace by Ship To	Select this option to determine whether the system replaces the existing demand with the new demand that is associated with a particular ship to record. If you do not select this option, then the system does not replace the existing demand.
Calculate Ahead and Behind Firm	Select this option to determine whether you can adjust the demand by modifying either the quantity that you have already shipped (also known as ahead amount) or the quantity that you need to ship (also known as behind amount) in relation to the customer's requirements. If you select this option, then you can adjust the demand before you create the sales order.
Calculate Ahead and Behind Plan	Select this option to determine whether you can adjust the demand by modifying either the quantity that you have already shipped (also known as ahead amount) or the quantity that you need to ship (also known as behind amount) in relation to the customer's requirements. If you select this option, then you can adjust the demand before you create forecast records.
Put Sales Order on Hold	Select this option to determine whether the system places a sales order on hold when the cumulative quantity shipped has reached zero. If you do not select this option, then the system does not place the sales order on hold.
	<hr/> Note. Placing a sales order on hold when the cumulative quantity shipped has reached zero creates a difference in the actual quantity shipped versus the contract amount to be shipped. <hr/>
Remove Partial Shipped Demand	Select this option to determine whether the system removes a demand detail record when only a partial quantity of the required shipping quantity has been shipped. Some customers allow their suppliers to ship only part of the requirement and then consider the shipment complete. However, if the customer wants the remainder of the quantity, the customer adjusts for the quantity in the next EDI transmission. Customers who want the requirement to remain open until it is fully shipped also use adjustment processing, they access from the ship confirm EDI message.
Partial Shipment Indicator	Indicate whether demand will be identified as a partial shipment upon the release of backordered demand. This is based on an appended value of "S" to the pull signal on the sales order (F4211). Values are: Blank: Do not populate the pull signal on the sales order (F4211) with the value S. / : Populate the pull signal on the sales order (F4211) with the value S.
Quantity of One Container Definition	This flag determines whether or not the quantity of one will be converted into the standard pack quantity for the current item. Values are:

	Blank: No conversion into Standard Pack. The inbound quantity and UOM will be processed.
	<i>I</i> : Convert quantity and UOM into the standard pack for the current item. If no definition is found, a workflow message will be generated. You define standard pack recommendations for an item through the Item Standard Pack (P460131).
Add Old Demand to CUM Required (add old demand to cumulative required)	Select this option to determine whether the system adds the quantity of the demand detail that was removed to the value in the CUM Required Priorfield when you run the Purge Demand History Record program (R40R094). If you do not select this option, then the system does not add the quantity of the demand detail that was removed to the value in the CUM Required Prior field.
Replace CUM Required (replace cumulative required)	Select this option to allow the supplier to override the cumulative quantity of an item that the customer requires. If you select this option, the supplier can override the cumulative quantity.

The system uses this option for the bill of lading and Advanced Ship Notice (ASN).
Don't Adjust	Select this option to specify whether the system adjusts the ship date for non work days when you run the schedule creation process. Values are: Blank: The system does not adjust the ship date. <i>I</i> : Changes the ship date to an earlier date. <i>2</i> : Changes the ship date to a later date.
Increment	Select this option to specify whether the system increases or decreases CUM quantities when updating the CUM quantity shipped. If you do not select this option, the system increases CUM quantities.
Decrement	Select this option to specify whether the system increases or decreases CUM quantities when updating the CUM quantity shipped. If you do not select this option, the system increases CUM quantities.

Cross Referencing Demand

This section provides an overview of and discusses cross references and how to cross reference EDI codes to the demand type.

Understanding EDI Cross References

When EDI data enters the system, the codes are used to identify the type and the frequency of the requirement. Requirement codes are standard within the EDI system, but their uses can vary, depending on each customer's business practices, as described in the table:

Customer	EDI	Requirement Type	Requirement Frequency	Actual Use

In order to handle these differences, you must set up a cross reference record for each requirement type and requirement frequency combination. This record specifies the demand type (firm or plan) and the frequency of demand (such as daily). The system processes the Demand Type and the Demand Period fields to determine the requirement.

You can set up cross references for all Branch/Plant and Sold To records, all Sold To records for a Branch/Plant, or for a specific Sold To record.

Prerequisites

Before you complete the tasks in this section:

- Set up UDC 40R/DT for the demand type and period.
- Set up UDC 40R/PD for the demand period.

Setting Up Demand Scheduling Workflow

This section provides an overview of and discusses demand scheduling workflow and setup.

Understanding Demand Scheduling Workflow

You can set up workflow to run during the inbound demand process of editing and updating records. You can use a default workflow process that contains all the possible business functions that can be run during inbound demand processing. The default workflow process contains a list of all the possible business functions that can be run during the inbound demand process. If you do not need any of these business functions, you must duplicate the workflow process and then use the new workflow process to add or remove unnecessary business functions.

The system does not allow you to create or duplicate workflow processes in the Demand Workflow Maintenance program (P40R22). The workflow process you specify must be an existing workflow process in the F98800 table. However, information regarding the workflow process, such as workflow activities, is handled by the Process Master program (P98800) and is stored in other database tables.

The system stores demand workflow information in the F40R22 table.

Demand Workflow Revisions form

Process Name (Optional). Enter the unique identifier for a process. If no value is entered, a next number is assigned. Once assigned, the value cannot be changed.

If you do not want to run a workflow for a specific Branch/Plant, Sold To, and Ship To combination, leave the Process Name field blank. Otherwise, the Process Name must be a valid workflow process name in the F98800 table.

Note. Although the Branch/Plant, Sold To, and Ship To fields are optional, if you enter a Ship To value, the Branch/Plant and Sold To must be completed. The same is true that if you enter a Sold To value, the Branch/Plant must also have a value.

Running the Launch Demand Net Variance Workflow (R40R1110)

You run this report automatically by specifying the version in the Launch Net Variance Workflow (R40R1110) processing option on the Versions tab in the processing options for Demand Maintenance (P40R10). You can run this report over specific batches of demand records to review net variance amounts that exceed the notification level for each record. If the system does not find matching Demand Detail records, the system will not launch the batch program.

Note. If you want to run the Create Demand Schedule batch program (R40R010) in addition to manually running the Launch Demand Net Variance Workflow batch application, you should run R40R1110 first. Depending on settings, the Create Demand Schedule program may delete demand detail records.

The system uses the F40R11 table for processing net variance workflow information.

Setting Up Product Cumulative Models

This section provides an overview of and discusses product cumulative models.

Understanding a Product Cumulative Model

Because each customer may wish to track this information differently for each branch/plant record, you can specify whether to track by Branch/Plant, Branch/Plant and Sold To, or Branch/Plant, Sold To, and Ship To. You can then specify whether the customer tracks information specific to a Ship To, Customer PO, or any combination of three defined fields.

For example, a customer may track cumulative quantities at a Ship To and Model Year level. To set up this type of model, you would use the Ship To option and enter the user-defined code (UDC) associated with Model Year in User Field 1.

You can associate each cumulative model combination with multiple cumulative records, each distinguished by a different customer item number, which you set up using the CUM Maintenance program (P40R12).

This table indicates the differences between four example models, followed by examples of how you can set up each model to track cumulative information:

An infinite number of model combinations exist that you can set up using any combination of the Sold To, Ship To, Customer PO, and user-defined fields.

Model 1

In this model, the cumulative information is tracked for GM using only the Sold To and Model year values. Each record with the Sold To, User Defined Field Type, and Model Year value combination is referred to as the cumulative model combination. Each row indicates a separate cumulative model combination for which information is tracked.

This model is set up for GM using Sold To, Ship To, and Customer PO specifically where the Ship To is Livonia.

Model 4

This model indicates that Ford Wixom can track cumulative information using a model that is distinct from the model used by most of Ford's Ship To addresses, as detailed in Model 3. Ford Wixom can track by Sold To, Ship To, Model Year, and Dock. The model combinations are as follows:

Setting Up Carton Cumulative Models

This section provides an overview of and discusses carton cumulative models.

Understanding Carton Cumulative Models

You can set up carton cumulative models to help you track and identify the carton elements that are specific to a product being shipped. Carton cumulative models are limited to using Sold To and Ship To values to differentiate the models.

You can associate each cumulative model combination with multiple cumulative records, each distinguished by a different customer item number, which you set up using the CUM Maintenance program (P40R12).

You can track cumulative information at the carton level using either the Sold To or Ship To values as these models describe:

Setting Up Item Cross-References

This section provides an overview of item cross-references and discusses how to maintain cross-references.

Understanding Item Cross-References

As part of inventory management, you can define relationships between the company's item information and the item information of a supplier or customer. Additionally, you can set up substitute items, replacement items, and bar codes that are associated with an item. Cross-references associate the internal item numbers with those from other trading partners. The Item Cross Reference program (P4104) enables you to manage these relationships in the JD Edwards EnterpriseOne Inventory Management system. For example, suppose that a customer orders items using the customer's item numbers. If you have the Item Cross Reference program set up for the customer, you can easily convert those item numbers into the company's equivalent numbers.

Examples of cross-referenced items are:

- Vendor item numbers.
Use when you are required to use vendor part numbers on orders or communications.
- Customer item numbers.
Use so that customers can order with their part numbers.
- Substitute items.
Use when the ordered item is out of stock.
- Replacement items.
Use when you or vendors discontinue an item and replace it with a new item.
- Bar codes.
Use to associate bar code input with a specific item.
- Associated items.
Use to recommend other, associated items as part of the sale.

When setting up cross-references for EDI, you need to cross-reference every possible number that the trading partners might transmit.

Prerequisite

Before setting up item cross-references, set up UDC table 41/DT for the cross-reference types that you define.

Enter the address number of the customer or supplier.

A cross-reference number enables you to use a supplier's item number if it is different from the item number you are processing in an order or printing. CHAPTER 5

Working with Manually Created Demand Header Records

This chapter provides an overview of demand records and discusses how to:

- Manually create demand header records manually.
- Revise demand detail records.
- Enter address and contact information for demand records.
- Enter supplemental database information for demand scheduling.
- Review demand history records.
- Purge demand history records.

Understanding Manually Created Demand Header Records

Typically, information for demand records is created automatically using electronic data interchange (EDI). You can also create demand header records manually and use the Work with Demand Header for to locate existing demand records to revise or delete entries. You can view information that relates to a specific customer, such as cumulative information, dates, times, and attachments.

You can also navigate among the various demand maintenance forms and applications, including:

- Work With Demand Detail (W40R10D).
- CUM Maintenance (P40R12).
- Demand History (P40R41).
- Demand Addresses (P40R14).
- Supplemental Data (P00092).

Note. If a header record does not already exist, the system automatically creates a demand header record when you create a demand detail record.

When creating a demand header record, you can add demand header attachments. To do so, select Header Attachment from the Form menu. You can also specify in the Demand Header Attachments processing option whether to automatically display the Media Objects form when creating records.

Manually Creating Demand Header Records

This section lists the prerequisites, forms, and discusses how to manually create demand header records.

Prerequisites

Before you complete the tasks in this section:

- Ensure that you have set up the UDCs for Category Codes 1 through 10 (40R/01 through 40R/10) and Critical Indicator (40R/CI).
- Set up the Demand Maintenance processing options (P40R10) to specify how the system processes demand records. For example, you can specify information such as which forms to display when creating a record, which versions the system should use for demand processing, and the values for net variance processing.

Versions

- 4. Supplemental Demand Header (P00092)** Specify the version of the Supplemental Demand Header (P00092) that the system uses.

- 5. CUM Maintenance (P40R12)** Specify the version of the CUM Maintenance (P40R12) that the system uses.
- 6. Item Standard Packs (P460131)** Specify the version of the Item Standard Packs (P460131) that the system uses.
- 7. Std Pack Carton Recommendations (P4615)** Specify the version of the Standard Pack Carton Recommendations (P4615) that the system uses.

Net Variance

- 1. Critical Indicator Range Minimum** Specify the UDC default value (40R/CI) for Demand Maintenance (P40R10). The critical indicator is a user-defined value that indicates how critical a quantity change to a demand detail record is.
- 2. Critical Indicator Range Maximum** Specify the UDC default value (40R/CI) for Demand Maintenance (P40R10). The critical indicator is a user-defined value that indicates how critical a quantity change to a demand detail record is.
- 3. Calculate Net Variance** Indicate whether the system calculates a net variance when it compares demand detail records among prior releases. Values are:
Blank: No
/: Yes
- 4. Net Variance Notification** Determine whether you receive notification when a net variance exceeds the maximum variance as defined in Advanced Preferences. A net variance is the difference in demand detail records between two releases. Values are:
Blank: No
/: Yes

Demand Header Revisions form

Customer Item Number

(Optional). Enter the cross reference item number that the system assigns to an item number. A cross reference number allows you to use a supplier's item number if it is different from the item number when you are processing an order or printing. You set up this number in the Item Cross Reference program (P4104).

Default Customer PO
(default customer purchase order)

(Optional). Enter a number that represents the default customer purchase order that the system uses in demand detail records when a customer purchase order has not been entered. The system also uses this number as a reference to the sales order or blanket sales order.

Default Item Revision

(Optional). Enter a number that the system retrieves from the EDI transaction set or message. This revision level is based on the revision level for the item that is set up in the F4101 table. You can enter this number manually.

Vendor Part Number

(Optional). Enter a number that identifies the vendor's part and is typically sent by the customer in an EDI message.

Last Shipment ID (last shipment identification)

(Optional). Enter the number that identifies the last shipment that the customer has received.

Round to Standard Pack Firm

Select this option to specify whether the system rounds up firm quantities to the pack quantity for a standard carton. For example, assume that you have selected this option. If a customer whose standard pack quantity is a carton of 500 items requests a reduced shipment of 475 items, then the supplier must still ship 500 items.

You can set up an advanced preference to specify whether this option is activated by default when the system automatically creates a demand header record. You set this up using the Advanced Preferences Name Revisions program (P4071).

Round to Standard Pack Plan

Select this option to specify whether the system rounds up plan quantities to a standard carton pack quantity. For example, if a customer's standard pack requirement is 500, and they request a shipment of 475, the supplier must ship 500. If you leave this option blank, the system does not round up firm quantities to a standard carton pack quantity.

You can set up an advanced preference to specify whether this option is activated by default when the system is automatically creating a demand header record. You set this up using the Advanced Preferences Name Revisions program (P4071).

Revising Demand Detail Records

This section provides an overview of and discusses demand detail records and label information.

- Add demand detail information.
- Revise shipment details.
- Revise EDI information for demand details.
- Revise miscellaneous demand detail information.
- Revise destination information.
- Revise pull signal information.
- Revise category codes for demand details.

Understanding Demand Detail Records

After demand header records are entered manually into the system, or automatically through electronic data interchange (EDI), you can review and change the detail information as necessary. Demand detail information includes the values for firm demand (sales orders) and planned demand (forecasts), including quantities, dates, and the customer purchase order number. Using this information, you can compare releases and perform net change and variance reporting and processing.

You differentiate demand detail records from each other based on the combinations of the Requested Ship Date, Requested Ship Time, Customer PO, Demand Processing, Demand Period, Pull Signal, Job Number, and Job Sequence Number fields:

You use these addresses to represent different types of parties. For example, a demand address can represent a buyer, a seller, a carrier, an expeditor, or transit principal.

For each demand address you enter, you can add contact information, such as a contact person or general office expeditor, as well as telephone contact information.

Note. In the Demand Maintenance (P40R10) processing options, you can use the Demand Header Addresses and the Demand Detail Addresses processing options on the Process tab to specify whether to automatically display the Demand Header Address or the Demand Detail Addresses forms when adding a demand header or detail record.

The system stores demand address and contact information in the F40R14 table. You can also cross reference common addresses, such as plants or customer numbers, with the Address Book system, as applicable.

You use supplemental data to store information that is not included in the standard master tables. Examples of supplemental data include remarks, amounts, dates, codes, and times. For demand scheduling, you can store defined text and defined time.

The information you set up in the supplemental database for the Demand Maintenance program (P40R10) is accessible only from the Work With Demand Header (W40R10A) and Work With Demand Detail (W40R10D) forms.

The system can store supplemental data at the demand header or detail level. The supplemental data codes are:

- DD (demand detail)

This section provides an overview of cumulative information for demand scheduling and discusses how to:

- Revise cumulative records.
- Review cumulative history.
- Calculate ahead and behind amounts.
- Reset cumulative values using cumulative (CUM) rollback.

Understanding Cumulative Information for Demand Scheduling

You can use cumulative processing to communicate current and forecasted requirements for accumulated quantities of goods from the start of a blanket purchase order to a particular future date. For example, you can send and receive notifications regarding year-to-date quantities received, quantities required, and quantities shipped.

When working with cumulative records, you can perform these types of tasks:

- Track cumulative information using product or carton models.
- Increment or decrement the values for the cumulative amounts shipped.
- Calculate ahead and behind values.
- Manually add, update, or delete cumulative records.
- View cumulative history.
- Reset (roll back) cumulative records to a specified date.

You can create cumulative data automatically by using the EDI Inbound Demand Edit/Update program (R47171) or manually by using the CUM Maintenance program (P40R12). The system uses these tables to process cumulative information for demand scheduling:

- F40R12
- F40R42
- F40R12WF
- F40R20
- F40R23
- F40R24

Revising Cumulative Records

This section provides an overview of cumulative records and discusses how to:

- Enter header information.
- Revising cumulative information.

Understanding Cumulative Records

Typically, cumulative information is entered automatically into the system from EDI messages by means of the Inbound Demand Edit/Update batch program (R47171). However, you can use the CUM Maintenance program (P40R12) to review and manually adjust cumulative records. You can enter missing information, update information, add attachments, and so forth. The system automatically writes cumulative record changes to the F40R42 table.

You can revise these types of information:

- Cumulative shipped for the customer and supplier.
- Firm cumulative required, or the quantity required by a customer that results in a sales order.
- Planned cumulative required, or the quantity that results in a forecast record.
- Quantity that the customer received.
- Fabrication cumulative quantity, or the quantity of parts that a supplier is authorized to produce.
- Material cumulative quantity, or the quantity of raw materials that the supplier is authorized to purchase for manufacturing the finished goods.
- Cumulative rollback information.
- Cumulative shipped net adjustment information.
- Attachments.

You can add two types of attachments to cumulative records. One attachment can be linked to the cumulative record and one to the history record.

You can set the processing options to specify whether to allow values to be entered in the various fields on the tabs on the CUM Revisions form.

Fabrication Cumulative Information

Quantity	Enter the largest total quantity of an item that the customer has authorized the supplier to produce to date. Regardless of whether the customer stops the production process before the authorized quantity has been completed, the customer must pay the supplier for the full authorized quantity.
Release Date	Enter the highest total quantity of an item received to date that the customer has authorized the supplier to produce. Regardless of whether the customer stops the production process before the authorized quantity has been completed, the customer must pay the supplier for the full authorized quantity.
Release Number	Enter a number that is generated by the customer and identifies an EDI transaction set/message.

Miscellaneous Information

Calculating Ahead and Behind Amounts

When creating schedules, you can determine whether a supplier is overshipped, undershipped, or even. You calculate this amount by subtracting the cumulative shipped amount from the cumulative required amount. If the amount is positive, the supplier is behind, or undershipped. If the amount is negative, the supplier is ahead, or overshipped. If the difference amount is zero, then the supplier is on schedule.

Note. The system does not display ahead or behind values. You use the CUM Maintenance program (P40R12) to view the CUM Shipped and CUM Required values, and you perform the calculation manually.

- 1. Mandatory Attachment Adjust Code 1 through 5.** Specify whether to automatically display the attachment form when you enter or change a CUM record with an adjustment code that is equal to the one that is entered here. Default UDC (40R/CA) values are:
- AP*: Automated Process
 - CI*: Customer Initiated
 - CR*: CUM Rollback
 - SA*: Shipping Adjustment

Resetting Cumulative Values Using CUM Rollback

This section provides an overview of CUM rollback, lists a prerequisite, and lists the form that is used to reset cumulative values.

Understanding CUM Rollback

You can use cumulative rollback to automatically reset cumulative quantities to zero for values that are incremented. When you reset cumulative values, the system updates current cumulative values for each item to reflect all activity occurring since the beginning of the period. The system displays the updated values on the applicable fields on the CUM Shipped, Firm CUM Required, Plan CUM Required, and Prod. Seq. CUM Required tabs on the CUM Revisions form.

When using cumulative rollback, you manually select a set of records based on a cumulative model combination to roll back the values. You specify the date to which you want the information reset and which adjustment codes you want to include in the rollback.

You can review the details of the rollback. The system displays all of the cumulative records within the selected model. You cannot update information when reviewing the details on the CUM Rollback Detail form. You can also run this report in Proof mode.

When you reset values, the system runs the Rollback CUMs program (R40R020), which resets cumulative values to zero and calculates the adjusted values for the CUM shipped and required fields.

If you set the CUM Rollback (P40R421) processing options to run the report, the system displays the On Report Output Destination form. Specify the report destination and click OK.

Example: CUM Rollback Calculations

When calculating cumulative information, the system:

1. Resets all incremented cumulative amounts to zero.
2. Calculates the CUM Quantity Shipped value by adding all the CUM Shipped Adjustment quantities for all of the records with the selected Shipment Adjustment code (SA) and Manual Adjustment code (CI) occurring on or after the rollback date.
3. Calculates the CUM Required value using two calculations:
 - Adjustment Quantity = Current CUM Shipped: Calculated CUM Shipped
 - Adjusted CUM Required = Previous CUM Required: Adjustment Quantity

Prerequisite

Set up the Rollback Code UDCs (40R/RC), which enable you to use as many adjustment codes as needed when resetting cumulative values.

CHAPTER 7

Working with Firm Demand

This chapter provides overviews about and discusses firm demand, shipping and planning schedules, fence dates, and forecast planning.

- Create demand scheduling sales orders.
- Set up demand spreading.
- Create a demand spreading template.

Understanding Firm Demand

Firm demand requirements represent demand for material that is required for a specific future time horizon. When you create and process records for firm demand, the system uses this information to maintain the requirements, scheduling and fence information, rules, and other default information that is relevant to suppliers and customers.

For example, you can create planning schedules that enables you to retrieve plan or firm demand, and, based on fences, the system determines whether to process the data as sales orders or forecast records. You also specify how to process cartons, labels, shipments, notifications, as well as run reports to analyze demand information.

Understanding Shipping and Planning Schedules

When you run the Create Demand Schedule (R40R010), the system creates shipping and planning schedules based on the information stored in the demand and cumulative databases. These schedules enable you to retrieve plan or firm demand, and, based on fences, the system determines whether to process the data as sales orders or forecast records. The system also performs calculations for ahead/behind amounts, rounding to standard pack, and updates the Create SO Status field (CRTSOST) on the demand detail record.

The system uses the cumulative ID to identify demand detail records. This table describes how the system selects records for processing schedules:

Cumulative Tracking Method	Process
Sold To Level	For each cumulative record associated with the Sold To field (where the Ship To field is blank), the Create Demand Schedule program processes all the demand details associated with the cumulative ID for that record.

Cumulative Tracking Method	Process
Sold To and Ship To Level	For each cumulative record associated to the Sold To and Ship To, the Create Demand Schedule program processes all the demand details associated with the cumulative ID for the record.
None	If the customer (Branch Plant, Sold To, Ship To combination) does not calculate cumulative information, the Create Demand Schedule program processes all the demand details for that demand header record that do not have a cumulative ID.

The system can decrement cumulative quantities to decrease the cumulative shipped amount. The cumulative shipped amount starts at the contract amount and is reduced by shipments until the amount reaches zero. When this value reaches zero, the customer can have all orders that are received from this point forward placed on hold until the cumulative shipped amount is adjusted.

The system uses these tables to process shipping and planning schedules:

- F40R20
- F40R10
- F40R11
- F40R23
- F40R12

Understanding Standard Pack Calculation

Typically when a supplier ships product to customers, the product must be in an agreed upon standard pack. The standard pack is the number of pieces that the customer wants in each pack. In most cases, if the customer orders less than the standard pack, the supplier must still round up to the standard pack amount. You can ensure that the shipments are made in the prearranged quantity and adjust sales orders and forecast quantities accordingly.

The system uses the Ship Quantity Requested value, and the Branch/Plant, Sold To, and Ship To values, and determines if the amount being shipped actually fulfills the standard pack. If the Shipped Quantity Requested value is not a multiple of the standard pack amount, the system rounds the Ship Quantity Requested up to the next highest multiple of the standard pack. This quantity is then returned as the new value for the Ship Quantity.

Understanding Fence Dates

You can use schedule fences and preferences to control how the system maintains records for new releases and changed quantities. A firm shipment fence specifies the number of days of demand for which you create sales orders. The planned forecast fence specifies the number of days of demand for which you create forecasts.

When the system receives forecast releases and shipping schedules, the system interprets the transactions and messages and creates the demand detail records. Each record is identified as either plan or firm, with a period indicator as daily, weekly, or monthly.

Based on the preferences and fence settings, the system identifies the demand records to create or update sales orders or to create forecasts. The dates the system uses are a horizon start date, firm shipping fence date, and a plan forecast fence date.

For example, you can specify the number of days, beginning at the horizon start date, of firm demand to be used to generate sales orders. If the horizon start date is January 1, with six fence days, the system creates sales orders through January 7. If the customer does not transmit a horizon start date (HZSD), you can use the Release Date field (RLSDJ) for this purpose.

Firm demand that lies past the firm shipping fence is informational only. The system does not use this demand to generate sales orders or forecasts.

For planning fences, the system identifies the number of days from the horizon start date of the plan demand to be used to generate forecasts. The system does not create sales orders from plan demand. Any plan demand that lies past the plan forecast fence will be informational only.

Example: Calculating Fence Dates

This example describes how the system creates sales orders and forecast records based on fence dates. Assume that the system received the data automatically from the EDI scheduling, planning and shipping documents (830 and 862).

The system then creates forecast records for all of the plan requirements.

The system then creates forecast records for the first eight days of plan.

Understanding Forecast Planning Dates

The system uses forecast dates to anticipate demand for customers. The information flows into forecasts automatically, based on dates that customers provide. You can establish forecast dates based on days, weeks, or months. To calculate this information, the system uses the beginning date and end date for a specific period, along with the number of workdays in the period.

Customers use their own method for generating and communicating dates. For example, these dates can occur at the beginning or end of the month, or on certain days of the week. You specify in advanced preferences a demand forecast date (type 28) to allow the system to receive planning records from customers and then convert the records into start and end dates to create forecasts.

The preference includes a week begin and end date rule, as well as a month calculation value. This table describes these values:

Month Calculation Rule	Description
0: Calendar Month (Default)	The customer uses the calendar month. The start of the month is always the first, and the end of the month is always the last day of the month. The system supports partial months.
1: Day of Week Occurrence	The date received represents the begin date or end date for a given month. For example, if you receive a begin date for the second Tuesday of the month, then all months start on the second Tuesday. Likewise, if the end date is the third Saturday, then all months end on the third Saturday.
2: Day of Week Anchor	Anchor rules are set up as a value between 0 and 6, representing Sunday through Saturday. This rule defines a planning period where the first occurrence of the anchor day is in the first week of a calendar month. The planning period is either four or five weeks, which ensures that the planning period complies with the anchor rule. Values are: 0: Sunday 1: Monday 2: Tuesday 3: Wednesday 4: Thursday 5: Friday 6: Saturday
3: Date Pattern Month	A fiscal date pattern defines the details of the planning calendar dates. Based on the received date, the fiscal date pattern is used to find the start and end dates for the month.

Example: Calculating Forecast Planning Dates

Monthly calculations assume that any given month starts the day after the prior month ends. Likewise, any given month ends the day before the next month starts. A month's end date can be calculated by determining the start of the next month and backing up one day.

Weekly calculations assume that any given week ends six days after it began. Likewise, any given week starts six days before it ends.

When you use the calendar or week calculations with beginning and end date rules, this table describes the possible scenarios:

Calendar Month, Calculate Month End Date	You use the calendar month and receive the month begin date from the customer. The system calculates the month end date as the last day of the calendar month.
Calendar Month, Calculate Month Begin Date	You use the calendar month and receive the month end date from the customer. The system calculates the month begin date as the first day of the calendar month.
Calculate Occurrence Month, Calculate Month End Date	You base the beginning date on a day of the week and the occurrence of that day in the month. You receive the month beginning date from the customer. The system calculates the month end date by finding the next month's beginning date and backing up one day.
Day Occurrence, Calculate Month Begin Date	You base the ending date on a day of the week and the occurrence of that day in the month. You receive the month ending date from the customer. The system calculates the month begin date by finding the prior month's end date adding one day.
Anchor Month, Calculate Month End Date	You base the month on a day-of-week anchor and receive the month beginning date from the customer. The system calculates the month end date by finding the start of the next planning month and backing up one day. The system calculates the next planning month's beginning date by finding the start of that calendar month and locating the first occurrence of the anchor day of the week.
Anchor Month, Calculate Month Begin Date	You base the month on a day-of-week anchor and receive the month ending date from the customer. The system calculates the planning month's beginning date by finding the start of the calendar month and locating the first occurrence of the anchor day of the week.
Week Date Range	You use weekly beginning and ending dates. The system adds six days to determine the end date or subtracts six days to determine the beginning date.
Fiscal Date Pattern Month, Calculate End Date	You use the received date in conjunction with the fiscal date pattern to determine the end dates, based on the values established in the fiscal date pattern for that period. In this case, the system uses the last day of the fiscal period as the ending date.
Calculate Fiscal Date Pattern Month, Calculate Begin Date	You use the received date in conjunction with the fiscal date pattern to determine the beginning dates, based on the values established in the fiscal date pattern for that period. In this case, the system uses the first day of the fiscal period as the beginning date.

Creating Demand Scheduling Sales Orders

This section provides an overview of and discusses demand scheduling sales orders and how to run the Create Schedule UBE (R40R010).

Understanding Demand Scheduling Sales Orders

A demand sales order is a sales order that is generated when you run the Create Demand Schedule program (R40R010). Created or updated sales orders reflect what items need to be shipped in order to meet the customer's schedule. Changes that you make to a demand sales order must be done using the Demand Maintenance program (P40R10).

You can use this report to perform these types of processes:

- Create and update demand sales orders or forecasts.
- Calculate plan or firm fences.
- Calculate ahead/behind amounts.
- Calculate standard pack rounding.

You use Data Selection to specify how and when the system calculates and processes this information. For example, you can specify a time-of-day schedule (typically after the daily EDI messages have been processed into the demand tables), or whether to run this application automatically after the demand business function is finished processing, or manually from the menu.

Note. The system processes deleted demand records by deleting sales order entry items. On the Process tab, if you leave the F4211 Ship Date and Ship Time Update processing option blank, the system does not update the Promised Ship Date field or the Promised Ship Time field on the remaining, non-canceled sales order lines.

If you enter a *1*, the system updates non-canceled sales order lines with a ship time of zero, when sales order lines are canceled due to deleted demand information.

The system recognizes a demand sales order based on the Demand ID, which links the order to its original demand scheduling record. The system also associates demand sales orders to the originating demand scheduling record using other demand related fields that you can review in the Sales Order Entry application (P4210).

Note. The system disables the demand fields on the SOE Additional Information form (W4210B) when the Demand ID field is populated on the record in demand scheduling, or if the Demand Scheduling (40R) system is not enabled.

You can create demand sales orders using combinations of these values:

- Branch/Plant
- Sold To
- Ship To
- Promised Ship Date
- Promised Ship Time
- Customer PO

When the system creates or modifies sales orders, it also creates or modifies shipments and carton recommendations automatically for tracking orders and creating shipments.

For making deductions to backordered sales order lines, the system first deducts all the backordered lines if they exist. The system then processes the line having the least quantity backordered. If backordered lines do not exist, or backordered lines are all adjusted and canceled, the system processes the non-backordered lines with the least quantity first.

Running the Create Demand Schedule(R40R010)

Demand/CUMs menu (G40R12), Create Schedule UBE.

Setting Processing Options for Create Schedule UBE (R40R010)

Processing options enable you to specify the default processing for programs and reports.

Setting Up Demand Spreading

This section provides an overview of demand spreading and discusses how to create a demand spreading template.

Understanding Demand Spreading

Demand spreading refers to the process of spreading the demand forecast quantity for a given date or date range across a specified time period. In this process, the planned dates and quantities in the Demand Detail records are consolidated, spread across a week in daily buckets, and then distributed into aggregate weekly or monthly buckets that are required for forecasting and planning.

This step is necessary because the demand information transmitted by customers to the supplier can vary. Customers can define demand in daily, weekly or monthly quantities. Customers may also consider different days as starting days for a week, or they might define a month in different ways. This table indicates how the demand information can vary from customer to customer:

Customer	Month	Actual Time Period	Quantity
Customer A	June 2001	June 4 - July 1	18,000
	July 2001	July 2 - August 5	19,000
	August 2001	August 6 - September 2	20,000
Customer B	June 2001	June 1 - June 30	10,000

In order to accommodate the production schedule at a given branch/plant, the supplier has to accept these varying planning schedules and transform them into a common forecast.

When you process a batch of demand records through the Create Demand Schedule program (R40R010) to transfer planned demand into the Forecasting system, the system deletes any existing detail and summary forecast records (F3400 and F3460) for any combination of item, branch, customer and forecast type that occur in the batch. After the deletion, the system processes the batch one record at a time to load a new forecast. If a time period includes more than one demand record, the final forecast for this period contains the sum of the forecasts from all the overlapping records. The resulting forecast is considered the latest forecast for the combination of item, branch, customer and forecast type.

Once the previous forecast records are removed, the system automatically spreads and consolidates the demand quantities across the specified time period. In the process, the system invokes a demand spreading template, if one is available, and divides the demand into daily buckets, based on the percentages specified in the template. If no template is available, the demand is spread evenly across the workdays of the date range.

After the demand is broken down into daily values, the system rolls up these daily values into a forecast based on the date ranges defined for the forecast buckets and stores the records in the F3400 table and the F3460 table. The forecast buckets can be set up for weekly or monthly forecasts.

Creating a Demand Spreading Template

This section provides an overview of demand spreading templates and discusses how to create a template.

Understanding Demand Spreading Templates

For the purpose of spreading the demand received from customers across a specified time period, you can use the Work With Demand Spreading program (P3470) to define demand spreading templates to meet the business needs. You can define a demand spreading template for a branch/plant, but you can also set it up for a combination of branch/plant and ship to or a combination of branch/plant, ship to and item.

Setting up a demand spreading template allows you to specify percentage values for the days on the template that represent how the total forecasted demand is allocated to the days of a week and, if needed, a prior week. The sum of all the percentage values you enter has to be 100. On the template you also define the date pattern that determines the actual week for spreading demand into daily buckets.

Note. If you do not set up any demand spreading templates, the system allocates the demand evenly across the specified time period.

Item

Enter a number that identifies the item. The system provides three separate item numbers plus an extensive cross reference capability to alternative item numbers. The three types of item numbers are:

- Item Number (short), which is an 8 digit, computer assigned item number.
- 2nd Item Number, which is a 25 digit, user-defined, alphanumeric item number.

3rd Item Number, which is a 25 digit, user-defined, alphanumeric item number.

In addition to these three basic item numbers, the system provides an extensive cross reference search capability. You can define numerous cross references to alternative part numbers. For example, you can define substitute item numbers, replacements, bar codes, customer numbers, or supplier numbers.

Date Pattern

Enter a code that identifies date patterns. You can use one of 15 codes. You must set up special codes (letters A through N) for 4-4-5, 13 period accounting, or any other date pattern unique to the environment. An *R*, the default value, identifies a regular calendar pattern.

The information in this field determines how a week is defined for the demand spreading template.

CHAPTER 8

Understanding ASNs

An ASN lists the contents of a shipment of goods, as well as additional information about the shipment, such as:

- Order information
- Product description
- Physical characteristics
- Type of packaging
- Markings
- Carrier information
- Configuration of goods

The ASN allows a sender to describe the contents and configuration of a shipment in various levels of detail and provides an order that is flexible enough to convey the appropriate information. ASN reporting is important for measuring the accuracy and timeliness of shipments. In some cases, if an ASN does not reach the destination before the truck, the receiver can reject the shipment. You typically send the ASN as soon as the shipment leaves the dock.

These programs enable you to set up and maintain how the system processes ASNs:

- Hierarchical Configuration Definition (P47HL)
- EDI Time Zone (P4720)

These programs and reports are available to help you manage ASN information:

- Work With Ship Notice (P47036).
- Work With Ship Notice Details (P470371).
- ASN ReCalculate (R47035).
- Purge EDI ASN Records (R47039).

The data in the ASN tables can then be converted into a flat file using the R47032 Conversion program (R47032C). The translator then maps the various tables or the flat file into the 856 or DESADV format.

Note. Extended mode processing has been added to the ASN. This mode is activated in the Hierarchical Configuration Definition program (P47HL). With extended mode, the packaging information is retrieved from both the F4216 and the F4620 tables. If Demand Scheduling is active and the ASN is in Extended Mode, Demand information is also extracted with the ASN.

Updating Successfully Processed ASN Records

This section provides an overview of the ASN Update as Sent program and discusses how to run the EDI ASN Update as Sent program (R47037).

Understanding the ASN Update as Sent Program

This program marks all records as successfully processed. You can run this program from within the flat file R47032 Conversion Program (R47032C) or from the menu for a particular EDI document number (EDOC). The system updates the records with a *Y* in the EDI Successfully Processed field (EDSP).

You run this program before you download a new batch of transactions to the EDI interface tables to prevent duplicating data. The program flags all the documents that were transmitted as processed, which prevents the same documents from being sent again.

Ensure that you delete the flat file after processing the data through the translator software. Otherwise, the system appends new records to the records that were already translated.

Setting Up ASN Hierarchies

This section provides an overview of ASN hierarchies and discusses how to set up ASN hierarchies.

Understanding ASN Hierarchies

You can set up the hierarchical levels that the system uses for extracting ASN data to update the EDI ASN tables and the Advanced Ship Notice. You configure the hierarchical structure to match EDI guidelines, such as SOIT and SOTI. For example, you may need information that is displayed on the ASN to have a hierarchical structure that is based on the customer's requirements. In this case, you specify the hierarchical configuration and set up fields to level by on the Hierarchical Configuration Definition form. The system creates the hierarchical structure and uses it throughout the ASN maintenance process.

For example, to create a hierarchical structure with level breaks at Shipment, Order, and Item values, you set up the structure by defining the sequencing and level break fields for the shipment, order, and item. Next, run the EDI Advance Ship Notice Extraction program (R47032). The system extracts information for the ASN. As this program retrieves the information, the system considers the hierarchical configuration and makes a level break at each specified record. This break creates a parent/child relationship between each level break and provides totals at each break for quantity, price, weight, and so forth. The break also enables you to view how each level break is grouped.

For example, the orders on a shipment can contain a parent/child relationship with items. The shipment is the parent record and it contains shipment information and totals, such as quantity, price, and weight, for all of its child records. The order records are the shipment's child records and they contain order information and totals for the order. The parent/child relationship continues down the hierarchical structure.

You use the EDI Time Zone program (P4720) to specify the time zone and the daylight savings rule. The translator uses the time zone and daylight savings values to determine the time code. The universal time code (UTC) is set up at the branch/plant level.

Understanding ASN Recalculation

You can change all the calculated fields such quantities, amounts, currency, and so forth that the system displays on the ASN. Initially, the system calculates these fields when you run the EDI Advanced Ship Notice Extraction program (R47032). As the system processes the information for this program, it rolls up the calculated field values at each level break.

After you revise information and quit the Ship Notice Detail Revisions (Totals) form, the system:

- Determines the hierarchical level that you are updating.
- Examines the Parent and RecordID fields to identify all the level breaks that need to be updated.
- Determines whether you are adding or deleting information.
- Rolls up all the updates to the calculated fields that are associated with each level break.

In this example, you change the Quantity field on the item record from 300 to 100 at the lowest level.

Enter the number of units that are committed for shipment in Sales Order Entry, using either the entered or the primary unit of measure that is defined for this item.

	In the Manufacturing system and Work Order Time Entry, this field can indicate completed or scrapped quantities. The quantity type is determined by the type code that is entered.
Quantity	Enter the quantity of units that are affected by this transaction.

Understanding Ship Notice Information

After running the EDI Advance Ship Notice Extraction program (R47032) to update the EDI ASN tables, you can use the Work With Ship Notice program (P47036) to revise all of the shipment-related information for the ASN. Using this program, you can locate records based on shipments and dates and then revise these types of information:

- Child records
- Item information
- Order information
- Order totals
- Shipment information
- Address information
- Packaging information
- Demand addresses

You can also add or delete records as necessary.

The Work With Ship Notice form (W47036C) enables you to navigate to the Work With Ship Notice Details form (W470371A). The details form is another find/browse form that lets you search for even more detailed information to make revisions. The header on the Work With Ship Notice Details form contains the same search fields that are displayed on the Work With Ship Notice form. If you access the details form by using the Work With Ship Notice selection from the Row menu, the system passes the values from the Work With Ship Notice form to the details form and displays them in the header. If you access the details form through the main menu, then the search fields in the header will be blank.

If you are not running the extended version of the EDI Advance Ship Notice Extraction program (R47032), the system populates only the EDI Shipping Notice Detail Outbound (F470371) fields, and fields that are related to the F470373 table will be disabled.

In addition to revising ASN information that is generated through EDI, you can use the Work With Ship Notice program to create a new record at the header level. When you create an ASN record, the system writes information to these tables:

If you enter a value other than the address book number (AN8), such as the long address or tax ID, you must precede it with the special character that is defined in the Address Book constants. For example, if address book number 4100 (Total Solutions) has a long address *TOTAL* and an * distinguishes it from other entries (as defined in the Address Book constants), you could type **TOTAL* in the field, and the system would return 4100.

Carrier Name

Enter the text that names or describes an address. This 40-character alphabetic field appears on a number of forms and reports. You can enter dashes, commas, and other special characters, but the system cannot search on them when you use this field to search for a name.

Excess Reason Code Enter a UDC (49/ES) that identifies the reason for excess transportation charges.

Stop Code Enter a UDC (42/SP) that represents the stop on a delivery route. This field is one of several factors that are used by the freight summary facility to calculate potential freight charges for an order.

For picking, you can use the stop code with the route and zone codes to group all items that are to be loaded onto a delivery vehicle for a specific route.

You set up the default value for each of these fields on the Customer Billing Instructions form.

Shipping Commodity Class Enter a UDC (41/E) that represents an item property type or classification (for example, international shipment handling). The system uses this code to sort and process similar items. This field is one of three classification categories that are available primarily for inventory and shipping purposes.

Route Code The route field is a user defined code (system 42, type RT) that represents the delivery route on which the customer resides. This field is one of several factors used by the freight summary facility to calculate potential freight charges for an order. For picking, use the route code with the stop and zone codes to group all of the items that are to be loaded onto a delivery vehicle

for a specific route. You set up a default for each of these fields on the Customer Billing Instruction form.

Freight

Select the Freight tab.

Freight Handling Code

Enter a UDC (42/FR) designating the method by which supplier shipments are delivered. For example, the supplier could deliver to the dock, or you could pick up the shipment at the supplier's dock. You can also use these codes to indicate who has responsibility for freight charges. For example, you can have a code indicating that the customer legally takes possession of goods as soon as they leave the supplier warehouse and is responsible for transportation charges to the destination.

Select the Control Information tab.

Transaction Set Enter the qualifier that is used to identify a specific type of EDI Standard document or transaction.

EDI

Select the EDI tab.

Transaction Set Purpose Enter a code (47/PU) that identifies the purpose of the transaction set. Refer to ANSI X.12 Data Item 353.

Acknowledgement Code Enter a code that indicates the acceptance or rejection of an EDI transaction or message.

Acknowledgement Received Select to indicate whether an EDI transaction or message was received and acknowledged. Values are:

Blank: The EDI record has not been received or acknowledged.

I: The EDI record has been received and acknowledged.

Acknowledgement Time Enter a time that an EDI acknowledgement was received. This time is for information only.

Miscellaneous

Select the Miscellaneous tab.

Shipment I.D (shipment identification)	Enter the identification of a shipment that was made to a customer or from a supplier. This information is used in the Advanced Ship Notice EDI transaction. It can represent the order number (DOCO), container ID (CNID), or delivery number (DELN), depending upon the way that the processing options are set in the Advanced Ship Notice Extraction program.
Send/Receive Indicator	Enter an indicator that determines whether a specific transaction set can be sent, received, or both. Values are: <i>S</i> : Send <i>R</i> : Receive <i>B</i> : Both

User Reserved

Select the User Reserved tab.

User Reserved Amount	Enter this 15-position code that is reserved for the user.
User Reserved Number	Enter this 8-position code that is reserved for the user.
User Reserved Reference	Enter a 15-position code that is reserved for the user.

Understanding Ship Notice Details for ASN Items

The Work With Ship Notice Details program (P470371) is another entry point into ASN maintenance for revising detail records. You can use this program to revise, add, or delete elements of the detail record that relate to item information.

Note. The Work With Ship Notice form (W47036C) enables you to navigate to the Work With Ship Notice Details form (W470371A). The details form is another find/browse form that lets you search for even more detailed information to make revisions. The header on the Work With Ship Notice Details form will contain the same search fields that are displayed on the Work With Ship Notice form. If you access the details form by using the Work With Ship Notice selection on the Row form, the system passes the values from the Work With Ship Notice form to the details form and displays them in the header. If you access the details form through the main menu, then the search fields in the header will be blank.

These selections from the Row menu exist to provide different views of the same ship notice detail record:

- Item Revisions
- Additional Item Revisions
- Order Revisions
- Totals Revisions
- Miscellaneous Revisions

The detail area of the Work With Ship Notice Details form (W470371A) displays the detail for the selected shipment. The rows reflect the hierarchical structure of the shipment levels (such as Shipments, Orders, Items, Tares, and so forth). Each record contains a hierarchical level and code. The system populates the detail area starting with the highest level of the hierarchy at the top and the lowest level at the bottom.

For example, suppose that items roll up into orders, which roll up into shipments. The top of the grid will contain the overall shipment record followed by an order record and its related item records. If multiple orders exist, the system displays them followed by their child items.

If you select a shipment level record to delete, the system looks at the Allow Deletion of Sent Ship processing option on the Process tab in the Work With Ship Notice program (P47036) and determines whether you are authorized to delete the information. If the processing option is blank, the system issues an error message. After you delete a record, the system recalculates fields that are affected by the deletion.

After you select one of the options from the Row menu on the Work With Ship Notice Details form, you can view the specific fields that are tied to that level break. For example, if you wanted to view the item number that is located at the item level, you would select the item level and then select Item Revisions from the Row menu. Or, if you wanted to update the quantity of an item, you would select Totals Revisions from the Row menu.

Additionally, the Work With Ship Notice Details form interconnects with these forms, where you can further revise all of the shipment details of an ASN:

- Ship Notice Revisions (Shipment) (W47036F).
- Order Address Information (W4006B).
- Work With ASN Packaging (W470371G).

- Work With Ship Notice (W47036C).

Select the Item tab.

Customer/Supplier Item Number

Enter the cross-reference item number that the system assigns to an item number. A cross-reference number enables you to use a supplier's item number if it is different from the item number when you are processing an order or printing. You set up this number in the Item Cross Reference program (P4104).

Customer/Supplier Item Revision Level

Enter a reference number to use to identify the revision level of the customer's item.

In item cross reference, when you are translating a customer or supplier external item number to the internal short item number, the customer's number only is not always sufficient. In some instances, the customer part number

must be used in conjunction with the item revision level. This combination allows the system to uniquely identify the customer's item.

Lot Serial Number

A 30-character field to be used to additionally identify a specific lot of inventory; this may be the manufacturer's production run number or some user-assigned number. The serial number can be added to this lot during the receiving process or at any time.

Potency/Grade

Select the Potency/Grade tab.

From Potency

Enter a number that indicates the minimum potency or percentage of active ingredients that is acceptable for an item.

The system displays a warning message if you try to purchase or issue items that do not meet the minimum acceptable potency. The system does not allow you to sell items that do not meet the minimum acceptable potency.

Thru Potency

Enter a number that indicates the maximum potency or percentage of active ingredients that is acceptable for an item.

The system displays a warning message if you try to purchase or issue items that have a potency that exceeds the maximum potency that is acceptable. The system does not allow you to sell items that have a potency that exceeds the maximum potency that is acceptable.

From Grade

Enter a UDC (40/LG) that indicates the minimum grade that is acceptable for an item.

The system displays a warning message if you try to purchase or issue items with grades that do not meet the minimum grade that is acceptable. The system does not allow you to sell items with grades that do not meet the minimum acceptable level.

Thru Grade

Enter a UDC (40/LG) that indicates the maximum grade that is acceptable for an item.

The system displays a warning message if you try to purchase or issue items with grades that exceed the maximum grade that is acceptable. The system does not allow you to sell items with grades that exceed the maximum grade that is acceptable.

Reference

Select the Reference tab.

Item Number (Short)

Enter an inventory item number. The system provides three separate item numbers plus an extensive cross-reference capability to other item numbers (see data item XRT) to accommodate substitute item numbers, replacements, bar codes, customer numbers, supplier numbers, and so forth. Three types of item numbers are available:

Item Number (short): An eight-digit, computer assigned item number

2nd Item Number: The 25-digit, free form, user-defined alphanumeric item number

3rd Item Number: Another 25-digit, free form, user-defined alphanumeric item number

Vendor Part Number

Enter a number that identifies the vendor's part and is typically sent by the customer in an EDI message.

Pick Slip Number

Enter an automatic next number that the system assigns. The system can use the pick slip number to track picking information through the system. This number is assigned during the printing of pick slips. The shipment confirmation program allows inquiry and confirmation by this number.

Date Time 2

Select the Date/Time (2) tab.

Scheduled Pick

Enter the promised shipment date for either a sales order or purchase order. The Supply and Demand programs use this date to calculate Available to Promise information. This value can be automatically calculated during sales order entry. This date represents the day that the item can be shipped from the warehouse.

Scheduled Pick Time

Enter the time when the order is scheduled to be picked. Enter the time in the 24-hour format and include a leading zero if necessary.

General Ledger Date
(general ledger date)

Enter a date that identifies the financial period to which the transaction is to be posted.

The company constants specify the date range for each financial period. You can have as many as 14 periods. Generally, period 14 is used for audit adjustments. The system validates this field for PBCO (posted before cutoff), PYEB (prior year ending balance), PACO (post after cutoff), and WACO (post way after cutoff) messages.

Price Effective

Enter a date that the system uses to determine the base price and all advanced price adjustments. The system stores the date in the F4009 table.

UCC 128/Packaging

Select the UCC 128/Packaging tab.

SSCC Number Tare Level
(serialized shipping container code number tare level)

Enter the tare level Serialized Shipping Container Code. This code must conform to the UCC structure for SSCC numbers.

SCC Number (shipping container code number)

Enter the Shipping Container Code. This code must conform to the UCC structure for SCC numbers.

UPC Number (universal product code number)

Enter the Universal Product Code number. This code must conform to the UCC structure for UPC numbers.

Shipping Conditions Code

Enter a UDC (41/C) that represents an item property type or classification, such as special shipping conditions. The system uses this code to sort and process like items.

This field is one of three classification categories that are available primarily for inventory and shipping purposes.

Heat Number

Enter a number that is associated with primary metals.

Packaging Code Enter a code corresponding to one of the accepted values in the EDI X12 definition for data element 103. It is a combination of a packaging form (three characters) and a packaging material (two digits).

Category Code

Select the Category Code tab.

Demand Code 06 Enter a three-character category code (UDC 40R/06) that is reserved for customer use.

Sales Catalog Section Enter one of ten category codes for sales coding purposes. These codes can represent such classifications as color, material content, and use.

Miscellaneous

Select the Miscellaneous tab.

Commodity Class Enter a UDC (41/P1) that represents an item property type or classification, such as commodity type, planning family, and so forth. The system uses this code to sort and process like items.

This field is one of six classification categories that are available primarily for purchasing purposes.

Buying Segment Code Enter a value that groups customers with similar buying habits.

End Use Enter a UDC (40/EU) that identifies the end use of an order line and is used for duty reporting only. The system supplies a default value based on the end use preference. You may override this value at order entry.

Duty Status Enter a UDC (40/DS) that identifies the duty status of an order line. You should specify this value only for duty reporting. The system supplies a default value based on the end use preference. You can override this value at order entry.

Days Before Expiration Enter the number of days that are allowed before expiration for an item that can still be used or sold to a specific customer. When negative, this number indicates the number of days after expiration for an item that can still be used or sold to a specific customer.

For example, if the expiration date for item 1001 is June 1, 1998:

A value of 15 in Days Before Expiration means that this specific customer accepts this item only up to May 15, 1998.

A value of -15 in Days Before Expiration means that this specific customer accepts this item up to June 15, 1998.

User Reserved

Select the User Reserved tab.

User Reserved Code Enter a 2-position code that is reserved for the user.

User Reserved Date Enter this 6-position code that is reserved for the user.

User Reserved Amount Enter this 15-position code that is reserved for the user.

User Reserved Number Enter this 8-position code that is reserved for the user.

User Reserved Reference Enter this 15-position code that is reserved for the user.

EDI

Select the EDI tab and review these fields:

Type Code If you enter a subledger type code in this field for an account with a posting edit code of *S* or *L*, the system will require the subledger type during journal entry.

Address Number Type This field indicates the address number that is associated with the order address information. Values are:

1: For sales orders, Sold To Address Number. For purchase orders, Supplier Address Numbers.

2: Ship To Address Number.

Accounting

Select the Accounting tab.

Project Cost Center

Enter the business unit from an account number. The account number business unit is usually found in the data item MCU. However, distribution systems use the field MCU as the branch.

Object Account

Enter the portion of a general ledger account that refers to the division of the Cost Code (for example, labor, materials, and equipment) into subcategories. For example, you can divide the Cost Code for labor into regular time, premium time, and burden.

If you use a flexible chart of accounts and the object account is set to six digits, you should use all six digits. For example, entering 000456 is not the same as entering 456 because if you enter 456, the system enters three blank spaces to fill a six-digit object.

Subledger Type Enter a UDC (00/ST) that the system uses with the Subledger field to identify the subledger type and how the system performs subledger editing. On the User-Defined Codes form, the second line of the description controls how the system performs editing. This is either hard-coded or use-defined. Values are:

A: Alphanumeric field, do not edit.

N: Numeric field, right justify and zero fill.

C: Alphanumeric field, right justify and blank fill.

Account ID (account identification) Enter a number that the system assigns to each general ledger account in the F0901 table to uniquely identify it.

Ledger Type Enter a UDC (09/LT) that specifies the type of ledger, such as AA (Actual Amounts), BA (Budget Amount), or AU (Actual Units). You can set up multiple, concurrent accounting ledgers within the general ledger to establish an audit trail for all transactions.

Sales Order Status 16 Select to indicate that a record is created by the Variance Journal Entries program (R31804).

Accounting 2

Select the Accounting 2 tab.

Sales Taxable Enter a code that indicates whether the item is subject to sales tax when you sell it. The system calculates tax on the item only if the customer is also taxable.

Tax Rate/Area Enter a code that identifies a tax or geographic area that has common tax rates and tax authorities. The system validates the code that you enter against the F4008 table. The system uses the tax rate area in conjunction with the tax explanation code and tax rules to calculate tax and general ledger distribution amounts when you create an invoice or voucher.

Tax Expl Code (tax explanation code) Enter a hard-coded UDC (00/EX) that controls the algorithm that the system uses to calculate tax and general ledger distribution amounts. The system uses the tax explanation code in conjunction with the tax rate area and tax rules to determine how the tax is calculated. Each transaction pay item can be defined with a different tax explanation code.

Cross Dock

Select the Cross Dock tab.

Cross Docking Flag Enter a code that associates items or order lines with cross dock processing. This code might indicate whether an item or an order line is eligible for cross docking, whether it was cross docked, or whether it needs to be cross docked. When it is assigned to an item or item branch, this code indicates that the item or the item in the branch/plant is eligible for cross docking. When it is assigned to an order line, this code indicates that the order line needs to be cross docked. Values are:

Blank: Cross docking is inactivated.

I: Cross docking is activated.

Cross Dock Priority

The priority that the cross docking system follows when assigning supply quantity to the sales orders. This priority indicates the sequence in which cross-docked sales orders are fulfilled for a given date. Sales order lines with a lower value receive a higher priority than lines with a higher value. The system performs only numeric edits on this value. If you do not specify a priority, or if the same priority is given to more than one order line, the orders will be fulfilled in the sequence of order number and order type.

Inventory

Select the Inventory tab.

Commitment Method

Enter a code that indicates the method that the system uses to commit lot items from inventory. Values are:

1: The normal commitment method for inventory. The system commits inventory from the primary location and then from secondary locations.

The system commits inventory from the locations with the most inventory before committing inventory from locations with the least. The system commits backorders to the primary location.

2: The inventory commitment method by lot number. The system commits inventory by lot number, starting with the lowest lot number and committing orders to available lots.

3: The inventory commitment method by lot expiration date. The system commits inventory from the locations with the earliest expiration date first. The system considers only locations with expiration dates that are greater than or equal to the sales order or parts list requested date.

Printed Code

Enter a code that indicates the action to take if the available quantity of an ordered item is less than the quantity ordered. Values are:

B: The quantity that cannot be shipped is to be backordered.

C: The quantity that cannot be shipped is to be canceled.

Warehouse Status Code

Enter a code that indicates whether the sales order line has entered the warehousing process. Values are:

Blank: The sales order line that is not yet being processed by the JD Edwards EnterpriseOne Warehouse Management system.

I: The sales order line is being processed by the JD Edwards EnterpriseOne Warehouse Management system. You cannot modify the line.

O: The sales order line has already been processed by the JD Edwards EnterpriseOne Warehouse Management system.

Asset Number

Enter an eight-digit number that uniquely identifies an asset.

Item Revision Level

Enter a number that represents the revision level for an item. If you enter a revision level in this field, verify that the revision level of the routing for an item matches the revision level on the bill of material for the item.

Supplier Rebate Code

Enter a UDC (41/P3) that represents an item property type or classification, such as commodity type, planning family, and so forth. The system uses this code to sort and process like items.

This field is one of six classification categories that are available primarily for purchasing purposes.

Inventory Costing Method

Enter a code that represents the inventory costing method. Each inventory item can have up to seven different unit costs. When processing a transaction, the system searches the individual item record to find which of the seven costs to use. The code that you enter in this field is a backup in case the system cannot find a costing method specified in a particular item record.

In the JD Edwards EnterpriseOne Inventory Management system, when you add a new item to branch/plant item information, the system goes to the constants for the specified branch/plant to find this costing method. This is a required field. Values are:

- 1: Last in cost
- 2: Weighted average cost
- 3: Memo cost 1
- 4: Current cost
- 5: Future cost
- 6: Lot cost
- 7: Standard cost

Master Planning Family

Enter a UDC (41/P4) that represents an item property type or classification, such as commodity type or planning family. The system uses this code to sort and process like items.

This field is one of six classification categories that are available primarily for purchasing purposes.

Landed Cost Rule

Enter a UDC (41/P5) that indicates the landed cost rule for an item.

The landed cost rule determines purchasing costs that exceed the actual price of an item, such as broker fees or commissions. You set up landed cost rules on the Landed Cost Revisions form.

Pricing

Select the Pricing tab.

Adjustment Schedule

Enter a UDC (40/AS) that identifies a price and adjustment schedule. A price and adjustment schedule contains one or more adjustment types for which a customer or an item might be eligible. The system applies the adjustments in the sequence that you specify in the schedule. You link customers to a price and adjustment schedule through the customer billing instructions. When you enter a sales order, the system copies the schedule that is attached to the sold to address into the order header. You can override this schedule at the detail line level.

For Agreement Management, this is the Agreement Penalty Schedule. The information in the Agreement Penalty Schedule provides the system with the criteria for an agreement to have penalty conditions.

Item Price Group

Enter a UDC (40/PI) that identifies an inventory price group for an item.

Inventory price groups have unique pricing structures that direct the system to incorporate discounts or markups on items on sales and purchase orders. The discounts or markups are based on the quantity, dollar amount, or weight of the item ordered. When you assign a price group to an item, the item takes on the same pricing structure that is defined for the inventory price group.

You must assign an inventory price group to the supplier or customer, as well as to the item, for the system to interactively calculate discounts and markups on sales orders and purchase orders.

Price Adj. History Indicator (price adjustment history indicator)

Enter a code that indicates the existence of pricing history behind a given sales detail line. Values are:

1: Standard detail adjustments exist in the price history file. These adjustments might include accruals.

2: At least one of the adjustments in the price history file is a rebate accrual (ACNT = 5) and will be processed by Sales Update for purposes of sales volume history accumulation.

3: At least one of the adjustments in the price history file is a volume level adjustment.

4: A volume level adjustment and a rebate accrual exist in the price history file.

Price Code 1

Enter a UDC (40/P1) that enables you to control pricing adjustments. You can associate this code with a preference profile.

When you specify a price code 1 in the preference, it fills or overrides this field in the sales order detail.

Miscellaneous

Select the Miscellaneous tab.

Transfer/Direct Ship Flag

Enter a code that indicates whether the order line was created by a transfer order, a direct ship order, or all other order types. Values are:

Blank: All other order types

1: Transfer order

2: Direct ship order

Backorders Allowed (Y/N) (backorders allowed (yes/no))

Select this option to specify whether to allow backorders for this item. You can allow backorders by item using the Item Master (P4101) program or the Item Branch/Plant (P41026) program. You can allow backorders by customer using the Customer Billing Instructions program (P03013). You can allow backorders by branch/plant using the Branch/Plant Constants program (P41001).

Matrix Control Line Number

Enter a number that the system uses to group line numbers on a purchase order or sales order for use in a matrix. Although the number is generated automatically, you can override it.

Configurator Print Flag

Enter a UDC (32/PF) that indicates whether the system prints the configurator part on the sales order and work order. The system uses the value that you enter in this field to affect programs such as Print Pick Slips (R42520), Print Invoices (R42565), Bill of Lading (R42530), and parts list on Work Order Print (R31415). Values are:

- 0*: Do not print the configurator part on the sales order or the work order.
- 1*: Print the configurator part on both the sales order and the work order.
- 2*: Print the configurator part on the sales order only.
- 3*: Print the configurator part on the work order only.

Kit

Select the Kit tab.

Related Kit Component

In the JD Edwards EnterpriseOne Sales Order Management system, when a kit component is defined in the F3002 table as a second level or higher item, it will be grouped and stored in the F4211 table under a related kit component. This relationship is maintained so that the system can perform kit balancing on the kit throughout the order processing cycle.

Order Company

Enter a number that, along with order number and order type, uniquely identifies an order document (such as a purchase order, a contract, a sales order, and so forth).

If you use the Next Numbers by Company/Fiscal Year functionality, the Automatic Next Numbers program (X0010) uses the order company to retrieve the correct next number for that company. If two or more order documents have the same order number and order type, the order company lets you locate the desired document.

If you use the regular Next Numbers functionality, the order company is not used to assign a next number. In this case, you probably would not use the order company to locate the document.

Hold Orders Code

Enter a UDC (42/HC) that identifies why an order is on hold.

Revision Reason Enter a UDC (42/RR) that indicates why a sales order was revised.

Order Information 2

Select the Order Information 2 tab.

Related PO/SO/WO Number (related purchase order/sales order/work order number) Enter a number that identifies a secondary purchase order, sales order, or work order that is associated with the original order. This number is for informational purposes only.

Related PO/SO/WO Order Type (related purchase order/sales order/work order type) Enter a UDC (00/DT) that indicates the document type of the secondary or related order. For example, a purchase order might be document type OP and might have been created to fill a related work order with document type WO.

Related PO/SO Line Number (related purchase order/sales order line number) Enter the number of the detail line on the related order for which the current order was created. For example, on a purchase order that was created to fill open sales orders, this is the line number of the sales order on which the item you are ordering appears.

Invoice

Select the Invoice tab.

Priority Processing Code Enter a code that tells the system to handle this customer's orders on a priority basis. Use this value to set up print pick slips so that you can print them on a priority basis. The system assigns this code from the Customer Billing Instructions.

In addition, the backorder print report and automatic batch release program can be sequenced by this code to release those orders with the highest priority first.

Address

Select the Address tab.

Parent Number Enter the address book number of the parent company. The system uses this number to associate a particular address with a parent company or location. Any value that you enter in this field updates the F0150 table for the blank structure type. This address number must exist in the F0101 table for validation purposes.

Payment

Select the Payment tab.

Discount Days Enter the number of days after the invoice date that an invoice or voucher must be paid to receive the discount. The system adds the number of days that are specified to the invoice due date to calculate the discount due date.

Discount % Enter the percent of the total invoice or voucher that you will discount if it is paid within the discount period. You enter the discount percent as a decimal. For example, enter a 2 percent discount is 02.

Trade Discount	Enter the percentage by which the system reduces the price of each item. This is the only discount that will be applied. You can override it if you enter a price. Enter the percentage as a whole number (for example, 5 for 5 percent).
Discount Factor	Enter the factor that the system applies to the unit price of an inventory item to determine the net price. The system retrieves this value from the inventory pricing rules if you have assigned a rule to this item. The pricing rule setup determines whether the system multiplies the unit price by this value or adds to or deducts from the unit price.
Discount Factor Type - \$ or. %	On the Item Price Category Revisions form, a \$ indicates that the numeric type is an added amount, and a % indicates that the factor is a multiplier.
Cash Discount %	Enter a discount that is passed forward from the manufacturer or mill to the customer based upon the payment terms of the supplier. Enter 10 percent as <i>10.00</i> .
Payment Terms	Enter a code that specifies the terms of payment, including the percentage of discount that is available if the invoice is paid by the discount due date. You define each type of payment term on the Payment Terms Revisions form. Examples of payment terms include: Blank: Net 15 <i>001</i> : 1/10 net 30 <i>002</i> : 2/10 net 30
Payment Terms Override Flag	Select to indicate that the payment terms were manually entered or changed. Preferences do not override manually entered payment terms.
Net Days to Pay	Enter the number of days that the system adds to the invoice date to calculate the due date on the invoice or voucher. If you are using split payment terms, the system uses the value from this field to calculate the due date for the first split pay item.
Based on Date	Enter a code that indicates how the system updated the Price Effective Date field in various Sales Order Management tables. You can enter the code manually, or the system can apply a preference. Values are: Blank: No override or preference <i>0</i> : Transaction or order date <i>1</i> : Requested date <i>2</i> : Promised ship date <i>3</i> : Original ship date <i>4</i> : Actual ship date <i>5</i> : System date <i>6</i> : Invoice date <i>7</i> : Preferred date <i>O</i> : Override date

Prox Date Day (proximate date day) Enter the day that the voucher or invoice is due. The system uses this field in conjunction with the value in the Proximate Month field (PXDX) to calculate the due date.

For example, if the proximate month is 1 and proximate day is 15, the system calculates the due date as the 15th of the next month.

Miscellaneous

Select the Miscellaneous tab.

Line of Business Enter a UDC (40/LB) that identifies a customer's line of business.

Loc. Tax Code (location tax code) Enter a UDC (46/LT) that indicates whether the location contains tax paid inventory (in bond vs. duty paid). If an item has an assigned tax code, the system puts the item away only in locations with the same tax code.

You assign tax codes to items through the Item Profile program (P46010).

Payment Instrument Enter a UDC (00/PY) that specifies how payments are made by the customer. For example:

C: Check

D: Draft

T: Electronic funds transfer

Nature of Transaction Defines whether the movement of goods is for sale, lease, and so forth. For European Union VAT reporting, you can enter the nature of transaction codes using one of the UDCs on the Sales Order Detail Revisions form or the Order Detail form (for Procurement).

For Procurement, use UDCs 41/P1 through 41/P5.

For Sales, use UDCs 40/S1 through 40/S5.

The Intrastat Workfile Generation Sales (R0018I1) and Intrastat Workfile Generation Purchase (R0018I2) programs update the information in the F0018T table if you specify the UDC that you are using (41/P1 through 41/P5 or 40/S1 through 40/S5) in the appropriate processing option for the generation program. You can also enter the data directly in the Intrastat Workfile Revision program (P0018T).

Project Number Enter a number that identifies an ETO project in the system. The project must be set up in the Add/Revise Project program (P31P011).

General Ledger Offset Enter a code that determines the trade account that the system uses as the offset when you post invoices or vouchers. The system concatenates the value that you enter to the AAI item RC (for Accounts Receivable) or PC (for Accounts Payable) to locate the trade account. For example, if you enter *TRAD*, the system searches for the AAI item RCTRAD (for receivables) or PCTRAD (for payables).

You can assign up to four alphanumeric characters to represent the general ledger offset, or you can assign the three-character currency code (if you enter transactions in a multicurrency environment). You must, however, set up the corresponding AAI item for the system to use; otherwise, the system ignores the general ledger offset and uses the account that is set up for PC or RC for the company that is specified.

If you set up a default value in the general ledger Offset field of the customer or supplier record, the system uses the value during transaction entry unless you override it.

Note. Do not use code 9999. It is reserved for the post program and indicates that offsets should not be created.

Revising ASN Address Information

Access the EDI Order Address Control Revisions form.

EDI Order Address Control Revisions form

Record Type Enter the identifier that marks EDI transaction records as header and detail information. This is an EDI function only.

Batch Number Enter the number that the transmitter assigns to the batch. During batch processing, the system assigns a new batch number to the JD Edwards EnterpriseOne transactions for each control (user) batch number that it finds.

Revising ASN Miscellaneous Information

Access the Ship Notice Detail Revisions (Miscellaneous) form.

Order

Select the Order tab.

Change Order Enter the number of times this purchase order has been modified. You can locate a specific change order number to review the fields that were modified.

Discount Application Type Indicate the type of discount that is given to the sales order. Values are:
 Blank: Regular pricing (including repricing)
 /: Contract Pricing

Transport

Select the Transport tab.

Port of Entry or Exit Enter the port from which or to which the goods were shipped. For VAT reporting, certain countries require information about the port of exit or entry. You specify the port of entry or exit when creating a purchase order by using the PO Receipts program (P4312), when creating a sales order by using the Sales Order Entry program (P4210), when confirming shipments by using the Shipment Confirmation program (P4205), or by using the Intrastat Revision program (P0018T). Set up values in UDC 40/PE.

Ship Date Overridden Enter a code that indicates which date fields were entered in Order Entry. Values are:

- 1: Pick date (PDDJ) entered.
- 2: Delivery date (RSDJ) entered.
- 3: Pick date and delivery date entered.
- 4: Ship date (PPDJ) entered.
- 5: Pick date and ship date entered.
- 6: Ship date and delivery date entered.
- 7: Pick date, ship date, and delivery date entered.

Business Unit

Select the Business Unit tab.

Business Unit Enter an alphanumeric code that identifies a separate entity within a business for which you want to track costs. For example, a business unit might be a warehouse location, job, project, work center, branch, or plant.

You can assign a business unit to a document, entity, or person for purposes of responsibility reporting. For example, the system provides reports of open accounts payable and accounts receivable by business unit to track equipment by responsible department.

Business unit security might prevent you from viewing information about business units for which you have no authority.

Revenue Cost Center

Enter a business unit accounting entity that is required for management reporting. It can be a profit center, department, warehouse location, job, project, work center, branch/plant, and so forth.

This business unit is from the business unit that is entered on the header of a sales/purchase order for reporting purposes.

This data is always right justified on entry (for example, CO123 would appear as _____CO123). A security mechanism has been provided to inhibit users from entering or locating business units outside the scope of their authority.

Other

Select the Other tab.

Delivery Number

An automatic next number that is assigned by the system that can be used to track deliveries through the system. This number is assigned during the printing of delivery notes.

Line Type	<p>Enter a code that controls how the system processes lines on a transaction. It controls the systems with which the transaction interacts, such as General Ledger, Job Cost, Accounts Payable, Accounts Receivable, and Inventory Management. It also specifies the conditions under which a line prints on reports, and it is included in calculations. Values are:</p> <p><i>S</i>: Stock item</p> <p><i>J</i>: Job cost</p> <p><i>N</i>: Nonstock item</p> <p><i>F</i>: Freight</p> <p><i>T</i>: Text information</p> <p><i>M</i>: Miscellaneous charges and credits</p> <p><i>W</i>: Work order</p>
Committed (H/S) (committed (hard/soft))	<p>Enter a value that indicates whether you specified the source location and lot for a particular item. For sales orders with multiple partial receipts against an order, the first receiver that is used to record receipt has a suffix of *000*, the next has a suffix of *001*, the next *002*, and so forth.

Control Information

Select the Control Information tab.

Status Code: Next Enter a UDC (40/AT) that indicates the next step in the order flow of the line type.

Status Code: Last Enter a UDC (40/AT) that indicates the last step in the processing cycle that this order line has successfully completed.

Revising ASN Packaging Information

Access the ASN Packaging Revisions form.

Standard Pack	Enter a number that indicates the standard quantity within a container.
Number of Packages	The total quantity of an item to be reworked or scrapped as a result of an ECO disposition.
Container Code	Enter a UDC (46/EQ) that identifies a storage container or a shipping carton. A storage container can be an open container where items are stored on the container (for example, a pallet), or a closed container where items are stored in the container (for example, a box). You use the Container and Carton Codes program (P46091) to define storage containers.
Pack Level	Enter a UDC (47/PL) that defines the packaging hierarchy. For example, you can specify whether the packaging hierarchy is inner or outer.
Expendable Container	Select this option to indicate whether a container is expendable and can incur a sales order charge. Values are: Blank: Not expendable. I: Expendable.
Returnable Container Part Number	The cross-reference item number that the system assigns to an item number. A cross-reference number enables you to use a supplier's item number if it is different from the item number when you are processing an order or printing. You set up this number in the Item Cross Reference program (P4104).
Packaging Responsibility	Enter a UDC (47/PR) that identifies the agency that is responsible for packaging.
Package Terms	Enter a UDC (47/PT) that identifies packaging terms and conditions.
Serial Number	A 25-character alphanumeric number that you can use as an alternate asset identification number. You might use this number to track assets by the manufacturer's serial number. You are not required to use a serial number to identify an asset. Every serial number that you enter must be unique.
Label Data Identifier	Enter a value that specifies the type of label for the ASN.

Select the Weight tab.	
Item Weight	The weight of goods currently in a location. The system calculates this amount from the weight from the item/unit of measure profile and the weight of the container if the level 1 unit of measure for this location detail has a storage container.
Gross Weight	The gross weight of one unit of the item in this unit of measure, or the weight of an empty storage container or shipping carton. The default value comes from the F4602 table, and the system uses the values in maximum weight calculations for specified locations during put away.

EDI ASN Demand Address Revisions form

- Party Type** Enter a code that identifies the type of party in an EDI message. This code is typically the first element of the N1 segment of an X12 transaction set.
- ID Type (identification type)** Enter a UDC (40R/ID) that indicates the type of identification number.
- Ctry (country)** Enter a UDC (00/CN) that identifies a country. The country code has no effect on currency conversion.
- The JD Edwards EnterpriseOne Address Book system uses the country code for data selection and address formatting.

Adding a Child Record

This section provides an overview of child records and lists the form that is used to add a child record.

Understanding Child Records

When you run the EDI Advanced Ship Notice Extraction program (R47032), the system updates the RecordID and Parent fields for each hierarchical level. The RecordID data item contains a unique value for each record in the hierarchy. The Parent data item contains the RecordID value of its parent's record. This allows a direct parent/child link between each record in the ASN database.

The parent/child functionality enables you to add a child record between two hierarchical level breaks. Each level break represents a subset of the fields that are associated with the level break. When you add a child record, the system:

1. Stores the key fields of the selected record as variables.

2. Verifies the hierarchical level to ensure that a new record is not being added to the lowest-level hierarchical level.
3. Decrements the EDI Line Number value by 0.001.

If a detail record contains that EDI line number, then the system decreases its EDI line number by .001. If a detail record has that number, then it is decreased by .001, and so forth.

If the EDI line number on a record changes, then that change must be made to all related records within the ASN database.

4. Displays the new record on the Work With Ship Notice Details form.

The system determines the hierarchy level of the new child record. If you attempt to add a child to the lowest hierarchy level record, the system issues an error message.

Analyzing ASN Date and Time Intervals

This section provides an overview of ASN on time analysis and discusses how to run the ASN On Time Analysis Report program (R470361).

Understanding ASN On Time Analysis

You can analyze date and time intervals that occur during the ASN process, which enables you to judge the efficiency and determine time lags of the ASN process in order to correct problems. For example, you can compare the dates and times for these events:

- Ship confirm versus ASN creation.
- Ship confirm versus EDI transmission.
- ASN creation versus acknowledgment.
- EDI transmission versus acknowledgment.

You can use the Exception Time processing options on the Process tab to restrict the report to only those shipments in which at least one of the intervals exceeds a specified length of time. By default, the system does not display the dates and times that are used when calculating intervals. Use the Print Date Time processing option on the Print tab to specify whether to print dates and times of the calculated value.

Running the ASN On Time Analysis Report Program (R470361)

Select Reports menu (G40R111), ASN On Time Analysis.

Analyzing Acknowledgment Activity

This section provides an overview of acknowledgment activity analysis and discusses how to run the Acknowledgment Accuracy Analysis Report (R47191).

Understanding Acknowledgment Activity Analysis

You can analyze acknowledgment activity that is related to specific shipments and invoices. Each acknowledgement provides information pertaining to the acceptance or rejection of the EDI Transaction Message along with up to five reasons why the ASN was accepted or rejected. You can optionally select and view detailed error information that is related to the specific segments and elements.

The system provides two versions of this report. ZJDE0001 provides default data selection where the message being acknowledged is the ASN (856 or DESADV). ZJDE0002 provides data selection where the message being acknowledged is an Invoice (810 or INVOIC).

Running the Acknowledgment Accuracy Analysis Report (R47191)

Select Reports menu (G40R111), Acknowledgment Accuracy Report.

Recalculating ASN Information

This section provides an overview of ASN recalculation and discusses how to recalculate a single ASN record.

Understanding ASN Recalculation

After you revise ASN information in the Work With Ship Notice program (P47036), you can run the ASN ReCalculate report (R47035) to recalculate fields for the ASN. This report does not use processing options, but you must set up a version for data selection. The system processes records that are contained in the F470371 table and then recalculates, beginning at the lowest hierarchical level of an ASN.

Note. This report is designed to update records en masse. You can run this report over single ASN records from the Work With Ship Notice program.

You run the Purge EDI ASN Records program (R47039) to delete records from the F47036 table, as well as records from these subordinate tables, based on data selection:

The system uses the combined key values of EDI Document Number, EDI Document Type, and EDI Document Company to delete child records in the EDI ASN tables.

CHAPTER 9

EDI Acknowledgment Documents (997/CONTRL and 824/APERAK)

This chapter provides overviews of acknowledgment documents and acknowledgment preferences and discusses how to work with inbound EDI acknowledgment records.

Understanding Acknowledgment Documents

Acknowledgements are EDI messages that confirm that the original message that you sent was received. Acknowledgements can convey a simple acceptance of the EDI message or display detailed error information that was found on the message. The system can also automatically notify you if the message was accepted or rejected. For example, the system notifies you if no acknowledgments are received within a certain period of time that the Advanced Ship Notice (ASN) was sent.

The system populates the EDI (System 47) tables with the data from the Acknowledgement EDI message. The system processes the acknowledgement, updates the appropriate Advance Ship Notice record and the F47046 table, and then sends an acknowledgement notification using workflow.

The system receives acknowledgements through these messages:

- Functional Acknowledgements (997/CONTRL)
- Application Advice (824/APERAK)

Functional Acknowledgments enables the sender of the original message to know whether any enveloping or structural errors occurred. For Functional Acknowledgments, the system does not evaluate the content of the message.

For Application Advice, the system evaluates the content of the message and returns an application advice message to relay any errors on the content of the message.

Note. Some customers may use the Receiving Advice (861/RECADV) essentially as an 824/APERAK document. In such cases, you can map 861 messages into the acknowledgment tables.

Understanding Acknowledgment Preferences

During setup, you must specify whether workflow will run based on these preferences:

- Ship To and Sold To
- Acknowledgment Code
- Message Being Acknowledged

For example, you can set up preferences to run workflow for all Sold To and Ship To values, but only for advance ship notices that are rejected. If the system generates an acknowledgment with an *R* (rejected) code for an 856 Message Being Acknowledged, the system returns a *I* indicating that a workflow message needs to be sent. The message will contain a link to the appropriate record on the Work with EDI Acknowledgments form.

Working with Inbound EDI Acknowledgment Records

This section provides an overview of inbound EDI acknowledgment records, lists a prerequisite, and discusses how to:

- Set processing options for Inbound EDI Acknowledgement Inquiry (P47191).
- Add an acknowledgment header record.
- Review acknowledgment errors.
- Enter error notes for error details.
- Revise name and address information for acknowledgments.
- Revise reference information for acknowledgments.
- Run the Inbound EDI Acknowledgment Purge (R47188).

Understanding Inbound EDI Acknowledgment Records

You can search for particular acknowledgment records and revise information or investigate errors as necessary. You use the Inbound EDI Acknowledgement Inquiry program (P47191) to search for, revise, or delete a particular acknowledgement and investigate errors that occur during acknowledgment processing. You can revise error details or multiple error detail records at once. You can also add notes to a specific error detail record. You locate the records based on the EDI Document Number and the Transaction Set, and you can specify date ranges to refine the search for records. The system updates the advance ship notice and electronic invoice tables with acknowledgment information.

You can also use this application to view or edit the names, addresses and reference information associated with acknowledgment records.

The system uses these tables for processing acknowledgments:

F47191	Contains a record for each acknowledgment that is received. Contains data about the acknowledgment as a whole.
F47192	Contains details of errors that are reported on the ASN. Elements include the position of the segment in error and element error code.

Default

These processing options enable you to specify how the system processes information for items and cumulative quantities.

- 1. Item Detail** Specify whether the system prints items with cumulative discrepancies on the CUM Reconciliation report (R40R1010). Values are:

Glossary of JD Edwards EnterpriseOne Terms

activity	A scheduling entity in JD Edwards EnterpriseOne tools that represents a designated amount of time on a calendar.
activity rule	The criteria by which an object progresses from one given point to the next in a flow.
add mode	A condition of a form that enables users to input data.
Advanced Planning Agent (APAg)	A JD Edwards EnterpriseOne tool that can be used to extract, transform, and load enterprise data. APAg supports access to data sources in the form of relational databases, flat file format, and other data or message encoding, such as XML.
application server	A server in a local area network that contains applications shared by network clients.
as if processing	A process that enables you to view currency amounts as if they were entered in a currency different from the domestic and foreign currency of the transaction.
alternate currency	<p>A currency that is different from the domestic currency (when dealing with a domestic-only transaction) or the domestic and foreign currency of a transaction.</p> <p>In JD Edwards EnterpriseOne Financial Management, alternate currency processing enables you to enter receipts and payments in a currency other than the one in which they were issued.</p>
as of processing	A process that is run as of a specific point in time to summarize transactions up to that date. For example, you can run various JD Edwards EnterpriseOne reports as of a specific date to determine balances and amounts of accounts, units, and so on as of that date.
back-to-back process	A process in JD Edwards EnterpriseOne Supply Management that contains the same keys that are used in another process.
batch processing	<p>A process of transferring records from a third-party system to JD Edwards EnterpriseOne.</p> <p>In JD Edwards EnterpriseOne Financial Management, batch processing enables you to transfer invoices and vouchers that are entered in a system other than JD Edwards EnterpriseOne to JD Edwards EnterpriseOne Accounts Receivable and JD Edwards EnterpriseOne Accounts Payable, respectively. In addition, you can transfer address book information, including customer and supplier records, to JD Edwards EnterpriseOne.</p>
batch server	A server that is designated for running batch processing requests. A batch server typically does not contain a database nor does it run interactive applications.
batch-of-one immediate	<p>A transaction method that enables a client application to perform work on a client workstation, then submit the work all at once to a server application for further processing. As a batch process is running on the server, the client application can continue performing other tasks.</p> <p>See also direct connect and store-and-forward.</p>
business function	A named set of user-created, reusable business rules and logs that can be called through event rules. Business functions can run a transaction or a subset of a transaction (check inventory, issue work orders, and so on). Business functions also contain the application programming interfaces (APIs) that enable them to be called from a form, a database trigger, or a non-JD Edwards EnterpriseOne application. Business functions can be combined with other business functions, forms, event rules,

and other components to make up an application. Business functions can be created through event rules or third-generation languages, such as C. Examples of business functions include Credit Check and Item Availability.

business function event rule	See named event rule (NER).
business view	A means for selecting specific columns from one or more JD Edwards EnterpriseOne application tables whose data is used in an application or report. A business view does not select specific rows, nor does it contain any actual data. It is strictly a view through which you can manipulate data.
central objects merge	A process that blends a customer's modifications to the objects in a current release with objects in a new release.
central server	A server that has been designated to contain the originally installed version of the software (central objects) for deployment to client computers. In a typical JD Edwards EnterpriseOne installation, the software is loaded on to one machine—the central server. Then, copies of the software are pushed out or downloaded to various workstations attached to it. That way, if the software is altered or corrupted through its use on workstations, an original set of objects (central objects) is always available on the central server.
charts	Tables of information in JD Edwards EnterpriseOne that appear on forms in the software.
connector	Component-based interoperability model that enables third-party applications and JD Edwards EnterpriseOne to share logic and data. The JD Edwards EnterpriseOne connector architecture includes Java and COM connectors.
contra/clearing account	A general ledger account in JD Edwards EnterpriseOne Financial Management that is used by the system to offset (balance) journal entries. For example, you can use a contra/clearing account to balance the entries created by allocations in JD Edwards EnterpriseOne Financial Management.
Control Table Workbench	An application that, during the Installation Workbench processing, runs the batch applications for the planned merges that update the data dictionary, user-defined codes, menus, and user override tables.
control tables merge	A process that blends a customer's modifications to the control tables with the data that accompanies a new release.
cost assignment	The process in JD Edwards EnterpriseOne Advanced Cost Accounting of tracing or allocating resources to activities or cost objects.
cost component	In JD Edwards EnterpriseOne Manufacturing, an element of an item's cost (for example, material, labor, or overhead).
cross segment edit	A logic statement that establishes the relationship between configured item segments. Cross segment edits are used to prevent ordering of configurations that cannot be produced.
currency restatement	The process of converting amounts from one currency into another currency, generally for reporting purposes. You can use the currency restatement process, for example, when many currencies must be restated into a single currency for consolidated reporting.
database server	A server in a local area network that maintains a database and performs searches for client computers.
Data Source Workbench	An application that, during the Installation Workbench process, copies all data sources that are defined in the installation plan from the Data Source Master and Table and Data Source Sizing tables in the Planner data source to the system-release number data source. It also updates the Data Source Plan detail record to reflect completion.

date pattern	A calendar that represents the beginning date for the fiscal year and the ending date for each period in that year in standard and 52-period accounting.
denominated-in currency	The company currency in which financial reports are based.
deployment server	A server that is used to install, maintain, and distribute software to one or more enterprise servers and client workstations.
detail information	Information that relates to individual lines in JD Edwards EnterpriseOne transactions (for example, voucher pay items and sales order detail lines).
direct connect	A transaction method in which a client application communicates interactively and directly with a server application. See also batch-of-one immediate and store-and-forward.
Do Not Translate (DNT)	A type of data source that must exist on the iSeries because of BLOB restrictions.
dual pricing	The process of providing prices for goods and services in two currencies.
edit code	A code that indicates how a specific value for a report or a form should appear or be formatted. The default edit codes that pertain to reporting require particular attention because they account for a substantial amount of information.
edit mode	A condition of a form that enables users to change data.
edit rule	A method used for formatting and validating user entries against a predefined rule or set of rules.
Electronic Data Interchange (EDI)	An interoperability model that enables paperless computer-to-computer exchange of business transactions between JD Edwards EnterpriseOne and third-party systems. Companies that use EDI must have translator software to convert data from the EDI standard format to the formats of their computer systems.
embedded event rule	An event rule that is specific to a particular table or application. Examples include form-to-form calls, hiding a field based on a processing option value, and calling a business function. Contrast with the business function event rule.
Employee Work Center	A central location for sending and receiving all JD Edwards EnterpriseOne messages (system and user generated), regardless of the originating application or user. Each user has a mailbox that contains workflow and other messages, including Active Messages.
enterprise server	A server that contains the database and the logic for JD Edwards EnterpriseOne.
EnterpriseOne object	A reusable piece of code that is used to build applications. Object types include tables, forms, business functions, data dictionary items, batch processes, business views, event rules, versions, data structures, and media objects.
EnterpriseOne process	A software process that enables JD Edwards EnterpriseOne clients and servers to handle processing requests and run transactions. A client runs one process, and servers can have multiple instances of a process. JD Edwards EnterpriseOne processes can also be dedicated to specific tasks (for example, workflow messages and data replication) to ensure that critical processes don't have to wait if the server is particularly busy.
Environment Workbench	An application that, during the Installation Workbench process, copies the environment information and Object Configuration Manager tables for each environment from the Planner data source to the system-release number data source. It also updates the Environment Plan detail record to reflect completion.
escalation monitor	A batch process that monitors pending requests or activities and restarts or forwards them to the next step or user after they have been inactive for a specified amount of time.

event rule	A logic statement that instructs the system to perform one or more operations based on an activity that can occur in a specific application, such as entering a form or exiting a field.
facility	An entity within a business for which you want to track costs. For example, a facility might be a warehouse location, job, project, work center, or branch/plant. A facility is sometimes referred to as a “business unit.”
fast path	A command prompt that enables the user to move quickly among menus and applications by using specific commands.
file server	A server that stores files to be accessed by other computers on the network. Unlike a disk server, which appears to the user as a remote disk drive, a file server is a sophisticated device that not only stores files, but also manages them and maintains order as network users request files and make changes to these files.
final mode	The report processing mode of a processing mode of a program that updates or creates data records.
FTP server	A server that responds to requests for files via file transfer protocol.
header information	Information at the beginning of a table or form. Header information is used to identify or provide control information for the group of records that follows.
interface table	See Z table.
integration server	A server that facilitates interaction between diverse operating systems and applications across internal and external networked computer systems.
integrity test	A process used to supplement a company’s internal balancing procedures by locating and reporting balancing problems and data inconsistencies.
interoperability model	A method for third-party systems to connect to or access JD Edwards EnterpriseOne.
in-your-face-error	In JD Edwards EnterpriseOne, a form-level property which, when enabled, causes the text of application errors to appear on the form.
IServer service	This internet server service resides on the web server and is used to speed up delivery of the Java class files from the database to the client.
jargon	An alternative data dictionary item description that JD Edwards EnterpriseOne appears based on the product code of the current object.
Java application server	A component-based server that resides in the middle-tier of a server-centric architecture. This server provides middleware services for security and state maintenance, along with data access and persistence.
JDBNET	A database driver that enables heterogeneous servers to access each other’s data.
JDEBASE Database Middleware	A JD Edwards EnterpriseOne proprietary database middleware package that provides platform-independent APIs, along with client-to-server access.
JDECallObject	An API used by business functions to invoke other business functions.
jde.ini	A JD Edwards EnterpriseOne file (or member for iSeries) that provides the runtime settings required for JD Edwards EnterpriseOne initialization. Specific versions of the file or member must reside on every machine running JD Edwards EnterpriseOne. This includes workstations and servers.
JDEIPC	Communications programming tools used by server code to regulate access to the same data in multiprocess environments, communicate and coordinate between processes, and create new processes.

jde.log	The main diagnostic log file of JD Edwards EnterpriseOne. This file is always located in the root directory on the primary drive and contains status and error messages from the startup and operation of JD Edwards EnterpriseOne.
JDENET	A JD Edwards EnterpriseOne proprietary communications middleware package. This package is a peer-to-peer, message-based, socket-based, multiprocess communications middleware solution. It handles client-to-server and server-to-server communications for all JD Edwards EnterpriseOne supported platforms.
Location Workbench	An application that, during the Installation Workbench process, copies all locations that are defined in the installation plan from the Location Master table in the Planner data source to the system data source.
logic server	A server in a distributed network that provides the business logic for an application program. In a typical configuration, pristine objects are replicated on to the logic server from the central server. The logic server, in conjunction with workstations, actually performs the processing required when JD Edwards EnterpriseOne software runs.
MailMerge Workbench	An application that merges Microsoft Word 6.0 (or higher) word-processing documents with JD Edwards EnterpriseOne records to automatically print business documents. You can use MailMerge Workbench to print documents, such as form letters about verification of employment.
master business function (MBF)	An interactive master file that serves as a central location for adding, changing, and updating information in a database. Master business functions pass information between data entry forms and the appropriate tables. These master functions provide a common set of functions that contain all of the necessary default and editing rules for related programs. MBFs contain logic that ensures the integrity of adding, updating, and deleting information from databases.
master table	See published table.
matching document	A document associated with an original document to complete or change a transaction. For example, in JD Edwards EnterpriseOne Financial Management, a receipt is the matching document of an invoice, and a payment is the matching document of a voucher.
media storage object	Files that use one of the following naming conventions that are not organized into table format: Gxxx, xxxGT, or GTxxx.
message center	A central location for sending and receiving all JD Edwards EnterpriseOne messages (system and user generated), regardless of the originating application or user.
messaging adapter	An interoperability model that enables third-party systems to connect to JD Edwards EnterpriseOne to exchange information through the use of messaging queues.
messaging server	A server that handles messages that are sent for use by other programs using a messaging API. Messaging servers typically employ a middleware program to perform their functions.
named event rule (NER)	Encapsulated, reusable business logic created using event rules, rather than C programming. NERs are also called business function event rules. NERs can be reused in multiple places by multiple programs. This modularity lends itself to streamlining, reusability of code, and less work.
<i>nota fiscal</i>	In Brazil, a legal document that must accompany all commercial transactions for tax purposes and that must contain information required by tax regulations.
<i>nota fiscal factura</i>	In Brazil, a nota fiscal with invoice information. See also <i>nota fiscal</i> .

Object Configuration Manager (OCM)	In JD Edwards EnterpriseOne, the object request broker and control center for the runtime environment. OCM keeps track of the runtime locations for business functions, data, and batch applications. When one of these objects is called, OCM directs access to it using defaults and overrides for a given environment and user.
Object Librarian	A repository of all versions, applications, and business functions reusable in building applications. Object Librarian provides check-out and check-in capabilities for developers, and it controls the creation, modification, and use of JD Edwards EnterpriseOne objects. Object Librarian supports multiple environments (such as production and development) and enables objects to be easily moved from one environment to another.
Object Librarian merge	A process that blends any modifications to the Object Librarian in a previous release into the Object Librarian in a new release.
Open Data Access (ODA)	An interoperability model that enables you to use SQL statements to extract JD Edwards EnterpriseOne data for summarization and report generation.
Output Stream Access (OSA)	An interoperability model that enables you to set up an interface for JD Edwards EnterpriseOne to pass data to another software package, such as Microsoft Excel, for processing.
package	JD Edwards EnterpriseOne objects are installed to workstations in packages from the deployment server. A package can be compared to a bill of material or kit that indicates the necessary objects for that workstation and where on the deployment server the installation program can find them. It is point-in-time snapshot of the central objects on the deployment server.
package build	A software application that facilitates the deployment of software changes and new applications to existing users. Additionally, in JD Edwards EnterpriseOne, a package build can be a compiled version of the software. When you upgrade your version of the ERP software, for example, you are said to take a package build. Consider the following context: “Also, do not transfer business functions into the production path code until you are ready to deploy, because a global build of business functions done during a package build will automatically include the new functions.” The process of creating a package build is often referred to, as it is in this example, simply as “a package build.”
package location	The directory structure location for the package and its set of replicated objects. This is usually \\deployment server\release\path_code\package\package name. The subdirectories under this path are where the replicated objects for the package are placed. This is also referred to as where the package is built or stored.
Package Workbench	An application that, during the Installation Workbench process, transfers the package information tables from the Planner data source to the system-release number data source. It also updates the Package Plan detail record to reflect completion.
planning family	A means of grouping end items whose similarity of design and manufacture facilitates being planned in aggregate.
preference profile	The ability to define default values for specified fields for a user-defined hierarchy of items, item groups, customers, and customer groups.
print server	The interface between a printer and a network that enables network clients to connect to the printer and send their print jobs to it. A print server can be a computer, separate hardware device, or even hardware that resides inside of the printer itself.
pristine environment	A JD Edwards EnterpriseOne environment used to test unaltered objects with JD Edwards EnterpriseOne demonstration data or for training classes. You must have this environment so that you can compare pristine objects that you modify.

processing option	A data structure that enables users to supply parameters that regulate the running of a batch program or report. For example, you can use processing options to specify default values for certain fields, to determine how information appears or is printed, to specify date ranges, to supply runtime values that regulate program execution, and so on.
production environment	A JD Edwards EnterpriseOne environment in which users operate EnterpriseOne software.
production-grade file server	A file server that has been quality assurance tested and commercialized and that is usually provided in conjunction with user support services.
program temporary fix (PTF)	A representation of changes to JD Edwards EnterpriseOne software that your organization receives on magnetic tapes or disks.
project	In JD Edwards EnterpriseOne, a virtual container for objects being developed in Object Management Workbench.
promotion path	<p>The designated path for advancing objects or projects in a workflow. The following is the normal promotion cycle (path):</p> <p>11>21>26>28>38>01</p> <p>In this path, <i>11</i> equals new project pending review, <i>21</i> equals programming, <i>26</i> equals QA test/review, <i>28</i> equals QA test/review complete, <i>38</i> equals in production, <i>01</i> equals complete. During the normal project promotion cycle, developers check objects out of and into the development path code and then promote them to the prototype path code. The objects are then moved to the productions path code before declaring them complete.</p>
proxy server	A server that acts as a barrier between a workstation and the internet so that the enterprise can ensure security, administrative control, and caching service.
published table	Also called a master table, this is the central copy to be replicated to other machines. Residing on the publisher machine, the F98DRPUB table identifies all of the published tables and their associated publishers in the enterprise.
publisher	The server that is responsible for the published table. The F98DRPUB table identifies all of the published tables and their associated publishers in the enterprise.
pull replication	One of the JD Edwards EnterpriseOne methods for replicating data to individual workstations. Such machines are set up as pull subscribers using JD Edwards EnterpriseOne data replication tools. The only time that pull subscribers are notified of changes, updates, and deletions is when they request such information. The request is in the form of a message that is sent, usually at startup, from the pull subscriber to the server machine that stores the F98DRPCN table.
QBE	An abbreviation for query by example. In JD Edwards EnterpriseOne, the QBE line is the top line on a detail area that is used for filtering data.
real-time event	A service that uses system calls to capture JD Edwards EnterpriseOne transactions as they occur and to provide notification to third-party software, end users, and other JD Edwards EnterpriseOne systems that have requested notification when certain transactions occur.
refresh	A function used to modify JD Edwards EnterpriseOne software, or subset of it, such as a table or business data, so that it functions at a new release or cumulative update level, such as B73.2 or B73.2.1.
replication server	A server that is responsible for replicating central objects to client machines.
quote order	In JD Edwards Procurement and Subcontract Management, a request from a supplier for item and price information from which you can create a purchase order.

	In JD Edwards Sales Order Management, item and price information for a customer who has not yet committed to a sales order.
selection	Found on JD Edwards EnterpriseOne menus, a selection represents functions that you can access from a menu. To make a selection, type the associated number in the Selection field and press Enter.
Server Workbench	An application that, during the Installation Workbench process, copies the server configuration files from the Planner data source to the system-release number data source. It also updates the Server Plan detail record to reflect completion.
spot rate	An exchange rate entered at the transaction level. This rate overrides the exchange rate that is set up between two currencies.
Specification merge	A merge that comprises three merges: Object Librarian merge, Versions List merge, and Central Objects merge. The merges blend customer modifications with data that accompanies a new release.
specification	A complete description of a JD Edwards EnterpriseOne object. Each object has its own specification, or name, which is used to build applications.
Specification Table Merge Workbench	An application that, during the Installation Workbench process, runs the batch applications that update the specification tables.
store-and-forward	The mode of processing that enables users who are disconnected from a server to enter transactions and then later connect to the server to upload those transactions.
subscriber table	Table F98DRSUB, which is stored on the publisher server with the F98DRPUB table and identifies all of the subscriber machines for each published table.
supplemental data	<p>Any type of information that is not maintained in a master file. Supplemental data is usually additional information about employees, applicants, requisitions, and jobs (such as an employee's job skills, degrees, or foreign languages spoken). You can track virtually any type of information that your organization needs.</p> <p>For example, in addition to the data in the standard master tables (the Address Book Master, Customer Master, and Supplier Master tables), you can maintain other kinds of data in separate, generic databases. These generic databases enable a standard approach to entering and maintaining supplemental data across JD Edwards EnterpriseOne systems.</p>
table access management (TAM)	The JD Edwards EnterpriseOne component that handles the storage and retrieval of use-defined data. TAM stores information, such as data dictionary definitions; application and report specifications; event rules; table definitions; business function input parameters and library information; and data structure definitions for running applications, reports, and business functions.
Table Conversion Workbench	An interoperability model that enables the exchange of information between JD Edwards EnterpriseOne and third-party systems using non-JD Edwards EnterpriseOne tables.
table conversion	An interoperability model that enables the exchange of information between JD Edwards EnterpriseOne and third-party systems using non-JD Edwards EnterpriseOne tables.
table event rules	Logic that is attached to database triggers that runs whenever the action specified by the trigger occurs against the table. Although JD Edwards EnterpriseOne enables event rules to be attached to application events, this functionality is application specific. Table event rules provide embedded logic at the table level.
terminal server	A server that enables terminals, microcomputers, and other devices to connect to a network or host computer or to devices attached to that particular computer.

three-tier processing	The task of entering, reviewing and approving, and posting batches of transactions in JD Edwards EnterpriseOne.
three-way voucher match	In JD Edwards Procurement and Subcontract Management, the process of comparing receipt information to supplier's invoices to create vouchers. In a three-way match, you use the receipt records to create vouchers.
transaction processing (TP) monitor	A monitor that controls data transfer between local and remote terminals and the applications that originated them. TP monitors also protect data integrity in the distributed environment and may include programs that validate data and format terminal screens.
transaction set	An electronic business transaction (electronic data interchange standard document) made up of segments.
trigger	One of several events specific to data dictionary items. You can attach logic to a data dictionary item that the system processes automatically when the event occurs.
triggering event	A specific workflow event that requires special action or has defined consequences or resulting actions.
two-way voucher match	In JD Edwards Procurement and Subcontract Management, the process of comparing purchase order detail lines to the suppliers' invoices to create vouchers. You do not record receipt information.
User Overrides merge	Adds new user override records into a customer's user override table.
variance	In JD Edwards Capital Asset Management, the difference between revenue generated by a piece of equipment and costs incurred by the equipment. In JD Edwards EnterpriseOne Project Costing and JD Edwards EnterpriseOne Manufacturing, the difference between two methods of costing the same item (for example, the difference between the frozen standard cost and the current cost is an engineering variance). Frozen standard costs come from the Cost Components table, and the current costs are calculated using the current bill of material, routing, and overhead rates.
Version List merge	The Versions List merge preserves any non-XJDE and non-ZJDE version specifications for objects that are valid in the new release, as well as their processing options data.
visual assist	Forms that can be invoked from a control via a trigger to assist the user in determining what data belongs in the control.
vocabulary override	An alternate description for a data dictionary item that appears on a specific JD Edwards EnterpriseOne form or report.
wchar_t	An internal type of a wide character. It is used for writing portable programs for international markets.
web application server	A web server that enables web applications to exchange data with the back-end systems and databases used in eBusiness transactions.
web server	A server that sends information as requested by a browser, using the TCP/IP set of protocols. A web server can do more than just coordination of requests from browsers; it can do anything a normal server can do, such as house applications or data. Any computer can be turned into a web server by installing server software and connecting the machine to the internet.
Windows terminal server	A multiuser server that enables terminals and minimally configured computers to display Windows applications even if they are not capable of running Windows software themselves. All client processing is performed centrally at the Windows

terminal server and only display, keystroke, and mouse commands are transmitted over the network to the client terminal device.

workbench	A program that enables users to access a group of related programs from a single entry point. Typically, the programs that you access from a workbench are used to complete a large business process. For example, you use the JD Edwards EnterpriseOne Payroll Cycle Workbench (P07210) to access all of the programs that the system uses to process payroll, print payments, create payroll reports, create journal entries, and update payroll history. Examples of JD Edwards EnterpriseOne workbenches include Service Management Workbench (P90CD020), Line Scheduling Workbench (P3153), Planning Workbench (P13700), Auditor's Workbench (P09E115), and Payroll Cycle Workbench.
work day calendar	In JD Edwards EnterpriseOne Manufacturing, a calendar that is used in planning functions that consecutively lists only working days so that component and work order scheduling can be done based on the actual number of work days available. A work day calendar is sometimes referred to as planning calendar, manufacturing calendar, or shop floor calendar.
workflow	The automation of a business process, in whole or in part, during which documents, information, or tasks are passed from one participant to another for action, according to a set of procedural rules.
workgroup server	A server that usually contains subsets of data replicated from a master network server. A workgroup server does not perform application or batch processing.
XAPI events	A service that uses system calls to capture JD Edwards EnterpriseOne transactions as they occur and then calls third-party software, end users, and other JD Edwards EnterpriseOne systems that have requested notification when the specified transactions occur to return a response.
XML CallObject	An interoperability capability that enables you to call business functions.
XML Dispatch	An interoperability capability that provides a single point of entry for all XML documents coming into JD Edwards EnterpriseOne for responses.
XML List	An interoperability capability that enables you to request and receive JD Edwards EnterpriseOne database information in chunks.
XML Service	An interoperability capability that enables you to request events from one JD Edwards EnterpriseOne system and receive a response from another JD Edwards EnterpriseOne system.
XML Transaction	An interoperability capability that enables you to use a predefined transaction type to send information to or request information from JD Edwards EnterpriseOne. XML transaction uses interface table functionality.
XML Transaction Service (XTS)	Transforms an XML document that is not in the JD Edwards EnterpriseOne format into an XML document that can be processed by JD Edwards EnterpriseOne. XTS then transforms the response back to the request originator XML format.
Z event	A service that uses interface table functionality to capture JD Edwards EnterpriseOne transactions and provide notification to third-party software, end users, and other JD Edwards EnterpriseOne systems that have requested to be notified when certain transactions occur.
Z table	A working table where non-JD Edwards EnterpriseOne information can be stored and then processed into JD Edwards EnterpriseOne. Z tables also can be used to retrieve JD Edwards EnterpriseOne data. Z tables are also known as interface tables.
Z transaction	Third-party data that is properly formatted in interface tables for updating to the JD Edwards EnterpriseOne database.
