Overview

The Oracle Retail Merchandising System is a powerful, fully functional merchandise management system, which supports daily operations, and provides the foundation for subsystems. RMS is used as the base application, and layered on other applications for analytical reporting, exception management, planning, forecasting, distribution management, inventory management, point-of-sale, and so on.

Functional Change

The RMS 12.0.10IN release has the following functional change:

- The RMS application no longer publishes the primary maximum retail price (MRP) to the Point-Of-Service (POS) application. Instead, the Oracle Retail Price Management (RPM) publishes the changed primary MRP to POS.

Noteworthy Defect Fixes

The RMS 12.0.10IN release had defects forward-ported from 12.0.5, 12.0.6, 12.0.7, 12.0.8, 12.0.9, and 12.0.10 releases.
