Release 12.1.0.8

This document contains information on issues that have been addressed and resolved in Oracle Retail Price Management (RPM) 12.1.0.8. Oracle is making this bundled hot fix patch available for customers who do not want to wait for the quarterly patch to apply and test individual defect fixes.

The RPM 12.1.0.8 hot fix includes defect fixes and documentation updates.

Applying Source Code

Before applying the RPM 12.1.0.8 hot fix, be sure that RPM 12.1 and all hot fixes through RPM 12.1.0.7 have been applied.

Before applying the hot fix source files over your code:

- Note whether any modules have been customized. If so, the customizations must be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.
- Copy the original files to a different directory before you copy over them, in case you need to refer to them at a later date.

Running Scripts

Back up data before running any script, because the scripts provided *do not* preserve data. See defect reports for details.

Check with your database administrator to determine whether your database should be analyzed after a script is run. In many cases, analysis of the database is necessary to take advantage of new or modified indexes intended to improve performance of the application.

Defect Fixes

The following defect fixes are included in the RPM 12.1.0.8 hot fix.

7187130	The Promotion Component Detail container apply block should be populated on highlighting the component detail row in a multi-record table.
8280018	Problems occur in simple promotions when items do not exist at all selected locations.

Defect Number	Summary
8282511	The Zone column in the Conflict Check Results List is populated for multi-buy promotions.
8282637	Data model corrections for RPM_PROMO_ITEM_LOC_EXPL.PROMO_START_DATE and RPM_PROMO_ITEM_LOC_EXPL.PROMO_END_DATE columns.
8287000	Item and Location filters in Price Inquiry are not sorted.
8288851	Error messages for Price Changes, Clearances, and Promotions Search workspaces do not display the label for the ID field.
8292040	The active promotion component does not display the current cost and current markup percent if the VDATE is between the promotion start date and end date.
8308745	A promotion component detail cannot be approved at the class (or dept or subclass) level and zone level when at least one of the items in the item hierarchy is not ranged to at least one of the locations in the zone.
8309707	There are errors and exceptions in the App Server log when conflict checking completes.
8323046	When a selling UOM conflict error occurs for a promotion component detail, the change is still applied. Also, when other validation fails, a Save Changes prompt appears after the message is closed.
8323802	Problems occur in simple and threshold promotions when an item does not exist in a location.
