Release Notes

Overview

This document describes changes to Oracle Retail Security Manager (RSM) since the RSM 12.0.3 release.

Upgrade Oracle Application Server 10g (10.1.3.3)

The RSM 12.0.4 application release requires a newer application server patch level than the RSM 12.0.3 release. You must ensure that the Oracle Application Server running RSM is at the 10.1.3.3 patch level, plus additional patches listed in the RSM 12.0.4 Installation Guide.

RSM JNLP Files Updated for Client JRE

The JNLP files in this RSM release have been updated to require any 1.5* JRE. This should improve the matching that Java WebStart does between the RSM JNLP files and the installed JREs on a client system. See also Metalink Note 467514.1.

You must ensure that the 1.5* client JRE that is used on your system is update 11 (1.5.0_11) or newer, as noted in the software requirements in the RSM 12.0.4 Installation Guide.
