Documentation Release Only

Note: The Oracle Retail Store Inventory Management (SIM) 12.0.10.1IN release is a documentation-only release. There is no code associated with this release identifier. SIM 12.0.10IN remains the current version of the code.

This Release Notes document is the only component of the SIM 12.0.10.1IN release.

Installation Guide Corrections

The following updates are required to the *Oracle Retail Store Inventory Management Installation Guide* for Release 12.0.10IN:

- Under "Oracle Retail Dependencies" on page 3, correct the optional release of Oracle Retail Service Layer as follows (correction in **bold** type):

Retail Service Layer for RMS (RSLforRMS) **12.0.9** – Optional

- Under "Database Installation Tasks" on page 5, change the prerequisite installed release of SIM as follows (correction in **bold** type):

Check that **SIM 12.0.0.1IN** is installed.

- Under "Create a New OC4J Instance for SIM" on page 7, replace Step 2 with the following:

2. Choose a name for the new OC4J instance and group.

Example: sim-oc4j-instance

Example: sim_group

Create this OC4J instance and group as documented in the *Oracle Application Server Administrator's Guide*.

Example:

```
$ORACLE_HOME/bin/createinstance  
-instanceName sim-oc4j-instance -groupName sim_group
```

When prompted for the oc4jadmin password, provide the same administrative password you gave for the Oracle Application Server installation. All OC4J instances running Oracle Retail applications must have the same oc4jadmin password.
