Release Number

The previous release of Oracle Retail Active Retail Intelligence was 13.0.1. In order to align the release numbers for the Oracle Retail products, this release of Oracle Retail Active Retail Intelligence is named 13.0.4.

The Sun Oracle Exadata Storage Server is a combination of smart software and industry-standard hardware and provides database-aware storage services, such as the ability to offload database processing from the database server to storage, transparently, without affecting SQL processing and your database applications.

ARI 13.0.1 is not currently certified on Exadata hardware because of limited availability; however, as soon as ARI can be tested with an Exadata system, the certification process will be initiated. The infrastructure of ARI 13.0.1 is consistent with the use of Exadata storage servers.
