Oracle Retail Store Inventory Management (SIM) Release 13.2.6 is a patch release for SIM 13.2. SIM 13.2.6 includes selected defect fixes and enhancements for SIM 13.2 code.

Oracle Customer Support investigates submitted issues assuming that all released updates have been applied. It is the customer's decision when to apply a new release; however, delays in applying updates can complicate the support process.

## About Patch Releases

Oracle Retail patch releases are periodic releases that can include the following:

- New defect fixes
- Product enhancements
- Technology upgrades
- Performance fixes

Documentation for patch releases includes new and updated guides (for example, Operations Guides, User Guides, and so on) that apply to the patch release level. These documents include applicable updates made since the last patch release. Documents revised for this patch release supersede and replace all previous document versions. See "[Related Documentation](#)" for a list of the documents published for SIM 13.2.6.

## Applying the Patch Release

Before applying the SIM 13.2.6 patch release, be sure that:

- SIM 13.2 has been installed
- Patch releases SIM 13.2.1, 13.2.3, 13.2.4, and 13.2.5 have been applied

**Note:** To align release numbers with other Oracle Retail products, release number 13.2.2 was skipped.

You can apply all the fixes by applying the SIM 13.2.6 patch release. See "[About Patch Releases](#)."

Before applying the release over your files:

- Note whether any modules have been customized. If so, the customizations must be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.
- Copy the original files to a different directory before you copy over them, in case you need to refer to them at a later date.

## Running Scripts

Back up data before running any script, because the scripts provided *do not* preserve data. See defect reports for details.

Check with your database administrator to determine whether your database should be analyzed after a script is run. In many cases, analysis of the database is necessary to take advantage of new or modified indexes intended to improve performance of the application.

## Functional Enhancements

This section addresses the functional enhancements included in Oracle Retail Oracle Retail Store Inventory Management, Release 13.2.6.

### Zebra Multiple Copy Print Functionality

Users should be able to print multiple copies of item tickets from the SIM PC or handheld device by specifying the quantity, but a Zebra printer expects a different input format for printing multiple copies compared to a regular printer. The SIM code and reports are enhanced to support the printing of multiple copies. SIM includes an additional report parameter, *COPIES*, which specifies the number of copies to be printed.

The retailer needs to work with the Zebra team to implement a suitable approach to achieve multiple copy print functionality. As the final implementation is vendor-specific, the implementation cannot be certified by Oracle Retail.

## Partial Delete of Item Locations for Active Promotions

Oracle Retail Price Management (RPM) and SIM are enhanced to handle item/locations cancellations for active promotions. RPM publishes the promotions with item/locations details which are then updated in SIM. The item/locations excluded in the modified promotions are excluded in SIM, as well, if the promotion is active.

## Technical Enhancements

### Oracle WebLogic

Oracle Retail Store Inventory Management Release 13.2.6 login processing uses Oracle WebLogic security providers.

### Oracle Java 7

Oracle Retail Store Inventory Management Release 13.2.6 is supported for use with Oracle Java 7 Runtime Environment (JRE) on both the server and client. This is only supported on Oracle WebLogic.

### Browser Support

Oracle Retail Store Inventory Management Release 13.2.6 is supported for use with the Mozilla Firefox ESR 17.0.3+ System web browser.

## Defect Fixes and Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, a performance enhancement, or a functional enhancement). Each defect fix that is included in this release has a corresponding defect report titled *<defect-number>.PDF* (for example, 12345678.PDF).

Review each defect report carefully before implementing the defect fixes. Note that scripts do not preserve data. Make sure that all data is backed up before you run any script.

<b>Defect Number</b>	<b>Summary</b>
14599103	The line sequence numbers are incorrect in the STKU files generated by the ThirdPartyStockCountParser job.
14673671	Duplicate inventory adjustments occur in SIM and RMS.
14735370	The ResaFileParser batch program cannot process all input POSU files due to numeric overflow errors.
14743656	If the same transaction is sent from Oracle Retail Point-of-Service more than once, it is processed multiple times in SIM.
15967116	Quantities are shown from the purchase order, rather than from the Advance Shipment Notice (ASN) for a supplier ASN.
15978410	If a stock count has the status of Authorize Completed, the ThirdPartyStockCountParser can be run again for that stock count ID.
16035844	An error occurs during auto-creation of a ticket request for an auto-generated serial number (AGSN) inventory adjustment.
