What Is the UCM VCR Adapter?

The UCM VCR Adapter provides access through the WebLogic Portal Content Management Virtual Content Repository (VCR) to content stored in the Oracle UCM system. Oracle UCM is a suite of enterprise content management products that include Oracle Content Server and Oracle Site Studio. The adapter allows WebLogic Portal to access UCM-based content for use in portal applications. For example, you could access content stored in UCM with WLP features like Content Presenter and content selectors.

Note: Although the VCR supports read/write operations, the Version 1.0 of the UCM VCR Adapter is read-only.

This document explains how to install and configure the adapter. In addition, the guide describes best practices for modeling content in the UCM content repository and in Site Studio. These best practices help ensure the best exposure of that content through the VCR. Finally, this guide offers several examples that demonstrate techniques for modeling content in UCM to allow the most reliable mapping of content through the adapter.

Note: Only Content Server is required to use the adapter. The adapter works whether or not Site Studio is installed on the server. Site Studio is not required; however, extra features are available when Site Studio is installed.

This document is intended for portal developers, portal administrators, UCM administrators, and UCM content architects.



Adapter Architecture

The UCM VCR Adapter serves as a bridge between the WebLogic Portal Content Management VCR and a UCM repository. The relationships between the various elements are illustrated in Figure 1-1.

Note: Version 1.0 of the UCM VCR Adapter supports Read Only access to the UCM repository. Additionally, only content in a UCM repository that is in specified as State = Released will be accessible through the adapter. Content that is in any other workflow state, or is scheduled for future release, will not be accessible through the VCR.

Ensure the UCM Components are Installed

You must have the following UCM components installed to use the UCM VCR Adapter. For details on installing these components, refer to the UCM installation documentation.

Server Required Components

- Oracle Content Server 10gR3 (10.1.3.3.3) with Oracle Text Search (OracleTextSearch), Full Text Search (DATABASE.FULLTEXT), or Metadata-only Search (DATABASE.METADATA) configured.
- 2. CS10gR35UpdateBundle
- 3. Folders_g (Included in CS10gR35UpdateBundle)

Server Optional Components

- 4. Site Studio 10gR4 (10.1.4.0.0) component
- 5. SiteStudioSPI Only-10gR4 component
 - **Note:** This component is available on Oracle E-Delivery as one of the components included in part number V16530-01 Oracle Universal Content Management Web Content Management 10gR3 (10.1.3.3.7) for Windows, Linux and Unix.
- 6. Custom Link Form (ss_docname_link_form.htm) must be checked in. You can obtain this Site Studio Link Form on the Oracle Technology Network, here: http://www.oracle.com/technology/products/content-management/ucm/samples/ index.html.

Optional Client Components

• Site Studio Designer (required for creating and changing region definitions)

Install the Patch

The UCM VCR Adapter is distributed as a public WebLogic Portal patch. You have two options for installing the patch. You can use the Smart Update application (part of your existing WLP installation) or you can perform a command-line installation of the patch file.

Installing with the Smart Update GUI Application

Smart Update provides a user interface that lets you install and manage WLP patches. Just start Smart Update, locate the public patch for the UCM VCR Adapter, and install it.

For detailed instructions on running and using Smart Update, see "Oracle Smart Update Installing Patches and Maintenance Packs" in Oracle Smart Update Installing Patches and Maintenance Packs.

Installing with the Command Line Utility

You can also install the patch using the Smart Update command line utility. For detailed information on using this utility, see "Using the Command-Line Interface" in *Oracle Smart Update Installing Patches and Maintenance Packs*.

Here is an example Smart Update command-line installation. In this example, the Patch ID is AAAA. When following these instructions, you must replace AAAA with the correct ID of the patch.

- 1. If it is running, stop WebLogic Server.
- 2. Download the patch file, AAAA. jar. In place of AAAA, use the correct ID of the patch you are installing.
- Ensure that the patch-catalog.xml and prod-info.xml files located in <BEA_HOME>/utils/bsu/cache_dir are updated based on one of the following two options.
 - If you have a brand new WLP 10gR3 install and you have not previously downloaded or installed any other patches, then you can copy the patch-catalog.xml and prod-info.xml files included in the patch file set you downloaded and replace the existing files of the same names that were created as part of the WLP 10gR3 GA installation process.
 - If you have installed patch updates to your original WLP 10gR3 installation (by having used Smart Update in the past), then run the Smart Update GUI to get the latest patch-catalog.xml and prod-info.xml files. Then, either use Smart Update to directly install the patch or exit the Smart Update GUI and use these Smart Update command line instructions to install the patch manually. (Note that the GUI automatically downloads the patch catalog to the bsu/cache_dir of the selected installation.)
- 4. Put the downloaded AAAA.jar patch file into the Smart Update cache directory: <*BEA_HOME*>\utils\bsu\cache_dir, where AAAA is the ID of the patch you are installing.
- 5. In a command window, go to the directory containing the Smart Update executables: <BEA_HOME>\utils\bsu.
- 6. Enter the following command, where AAAA is the ID of the patch you are installing:

bsu -prod_dir=<BEA_HOME>\wlportal_10.3 -patchlist=AAAA -verbose
-install

7. Restart WebLogic Server.

Select Profile Trigger Field on the UCM Server

The UCM VCR Adapter requires a Profile Trigger Field to have been configured on the UCM Server. This is done in the Configuration Manager applet, on the Profiles tab. For example, you could select the Type (dDocType) field as the trigger field.

Update Existing Domains

- **Note:** Follow the steps in this section only if you are installing the adapter into an existing WLP domain. If you create a new domain *after* performing the patch installation (as described in "Install the Patch" on page 2-2), you can skip the steps in this section. Any new domain created after the patch is installed will automatically receive the patch artifacts.
- Note: You must use separate tablespaces in your database for UCM and WLP, because both have a table called USER. For more information, see http://download.oracle.com/docs/cd/E13155_01/wlp/docs103/db/oracle. html#wp1063226.

The basic steps for updating an existing domain are using the WebLogic Server Console to remove several J2EE Shared Libraries and to install new ones. You must perform these steps for each WLP domain in which you want to use the UCM VCR Adapter.

Tip: For more detailed information on deployment, see "Deploying Applications and Modules with weblogic.deployer" in *Deploying Applications to WebLogic Server*.

Delete Existing Libraries

- Start WebLogic Server for the WLP domain you wish to update. It is recommended that you start the server from the command line using: <BEA_HOME>/user_projects/domains/<my_domain>/bin/startWebLogic.cmd/.sh
- 2. Open the WebLogic Server Administration Console in a browser with the URL: http://<hostname>:<port>/console. For example, http://localhost:7001/console.
- 3. In the Domain Structure part of the console, click Deployments.
 - **Tip:** To increase the number of rows that are displayed in the table, click **Customize the table** and set the **Number of rows displayed per page** value to a larger number, like 100.

4. In the Summary of Deployments panel, locate and select the following libraries.

Note: The Status of these libraries was automatically set to Failed by the patch installer. content-management-app-lib(10.3.0,10.3.0) content-management-app-lib(10.3.0,10.3.0.1) content-management-web-lib(10.3.0,10.3.0) content-management-web-lib(10.3.0,10.3.0.1)

- 5. Click Delete.
- **Note:** If you see an error message, it is possible to safely ignore it. To verify that the libraries were deleted, click **Deployments** again to refresh the screen. The libraries should be gone. If any of the libraries are still in the list, try deleting them again.

Install New Libraries

- If it is not running, start WebLogic Server for the WLP domain you wish to update. It is recommended that you start the server from the command line using: <BEA_HOME>/user_projects/domains/<my_domain>/bin/startWebLogic.cmd/.sh
- If it is not already open, open the WebLogic Server Administration Console in a browser with the URL: http://<hostname>:<port>/console. For example: http://localhost:7001/console
- 3. In the Domain Structure part of the console, click **Deployments**.
- 4. Click Install.
- 5. In the Install Application Assistant wizard, navigate to this directory: <BEA_HOME>\wlportal_10.3\content-mgmt\lib\j2ee-modules
- 6. Select content-management-app-lib.ear, as shown in Figure 2-1.

- 7. Click Next.
- 8. Be sure Install this deployment as a library is selected, and click Next.
- 9. In the Optional Settings panel, click Next.
- 10. In the Review Your Choices panel, click Finish.
- 11. (Optional) In the Settings for content-management-app-lib panel, change the **Deployment Order** to **1**, and click **Save**.
- 12. In the Domain Structure part of the console, click **Deployments**.

Note: Now that the library has been installed, you need to update it, as explained in the following steps.

13. In the Deployments table, select the library **content-management-app-lib**. Note that the Update button becomes active.

14. Click Update.

- 15. In the Update Application Assistant wizard, click Change Path.
- 16. Navigate to

- 21. In the Domain Structure part of the console, click **Deployments**.
- 22. In the table, you should see both the installed and updated library files, as shown in Figure 2-4. Note that the version numbers may be slightly different depending on the actual patch version.

Add a Reference to the UCM VCR Adapter Shared Library

Use Workshop for WebLogic to add a library reference from your enterprise application to the UCM VCR Adapter library.

- 1. Start Workshop for WebLogic.
- 2. In the Package Explorer, navigate to the <EAR_PROJECT>/EarContent/META-INF folder.
- 3. Right-click the file weblogic-application.xml and select **Open With > WebLogic Deployment Descriptor Editor**.
- 4. In the editor, select the Libraries tab.
- 5. Click the Add button, as shown in Figure 2-5.

- 6. In the Select WebLogic Shared Library dialog, click the **Manage Shared Libraries** link near the bottom of the dialog.
- 7. In the Preferences dialog, click Add.
- 8. In the Add WebLogic Shared Library dialog, click Browse, and open the following library:

```
<BEA_HOME>/wlportal_10.3/content-mgmt/lib/j2ee-modules/
oracle-ucm-spi-app-lib.ear
```

- 9. In the Add WebLogic Shared Library dialog, click OK.
- 10. Verify that the library was added to the list of Shared Libraries and click **OK**.

- 11. In the Select WebLogic Shared Library dialog, select the **oracle-ucm-spi-app-lib** library, and click **OK**. The library appears in the Shared Libraries list of weblogic-application.xml.
- 12. Save the file weblogic-application.xml.

You have successfully added the UCM VCR Adapter library to your portal project.

Modify Cache Settings

You can configure or adjust UCM repository caches in two ways: in the EAR project file META-INF/pl3n-cache-config.xml or in the Portal Administration Console (under **Configuration & Monitoring > Service Administration**). Cache settings made in the Portal Administration Console take precedence over the file-based settings. You can also flush the caches from the Portal Administration Console.

Note: If you already have a pl3n-cache-config.xml file configured for another repository, simply add the UCM repository cache settings into that file.

Table 2-1 and Table 2-2 describes the available cache settings in p13n-cache-config.xml. Table 2-1 describes the VCR caches, which are caches used by the VCR component. These caches are repository specific and can exist for any repository. Table 2-2 describes the SPI caches, which are specific to the UCM SPI Adapter component.

The pattern for the cache entry names is *<elementName>.<repositoryName>*, where *<repositoryName>* is the name of the UCM repository as specified in the META-INF/content-config.xml file. For example, nodeCache.StellentRepository.

Note that <time-to-live> values are specified in milliseconds.

Configuring the Adapter

After the adapter is added to your WLP project, you are ready to configure it. Configuring means specifying how the adapter will talk to the UCM content repository. For example, the adapter has to know where the UCM server is running, its port number, an admin account name, and so on.

There are two configuration scenarios to consider. If you primarily work with the IDE in a development environment, you can configure the adapter by editing a configuration file. If you are a portal administrator who uses the WLP Administration Console, you can use the Administration Console to configure the adapter.

Configuring the Adapter in a Development Environment

This section explains how to configure the adapter using a configuration file. Developers working primarily in the IDE commonly use this method.

- **Note:** Because of the way in which WLP uses deployment plans, adapter configurations made in the WLP Administration Console take precedence over configurations made in the content-config.xml file.
- 1. Open the content-config.xml file. This file is located in the META-INF directory of your Portal EAR Project.
- 2. Edit the required elements in the file using Table 2-3 and Listing 2-1 as a guide.
- 3. Save the configuration file.
- 4. Redeploy the portal application.

Table 2-3 describes the required elements in content-config.xml that you must configure to successfully use the adapter.

Element	Description
class-name	The class name of the adapter, which is com.oracle.content.spi.ucm.RepositoryImpl.

Configuring the Adapter in the Administration Console

Users who typically work on staged or production portals use the WebLogic Portal Administration Console to configure content repositories. This section summarizes the basic configuration steps for this scenario. For more detailed instructions, see "Configuring Additional Repositories" in the *Oracle Fusion Middleware Content Management Guide for Oracle WebLogic Portal*.

Once the UCM repository is deployed and running it must be connected to WebLogic Portal so that it appears as part of its Virtual Content Repository. To add the UCM repository:

- 1. Open the WebLogic Portal Administration Console.
- 2. Select the Content tab to enter the Content Management page.
- 3. Select the **Repositories** link to view the repositories. This link is above the tree view on the left.
- 4. Click Virtual Content Repository at the top of the repository tree.
- 5. In the editor pane to the right, click the Add Repository Connection button.
- 6. Complete the Add Repository Connection dialog with the following information:

Field	Description
Name	A name you choose for the adapter.
Connection Class	The class name of the adapter, which is com.oracle.content.spi.ucm.RepositoryImpl.
Datasource JNDI name	Not required.
Username	If using the global config user option (all users of the application use the same credentials to connect to UCM), this field specifies the user name of a valid user of the UCM repository. For more information on security, see "Configuring Security" on page 2-19
Password	Not necessary for the UCM VCR Adapter.
Enable Library Services	Set this field to false.

- 7. Click Create. The new repository appears in the repository tree on the left hand side.
 - **Note:** If you receive an error after clicking **Create**, click the **Refresh Tree** button. The words "can't connect" appear next to the new repository name in the Administration Console. To correct the problem, select the new repository and use the Add Property dialog to add the required properties indicated by the error message: ContentServerHostname, ContentServerPort, ContentServerAdminUser.
- 8. Using the Administration Console, configure the same repository properties listed and described previously in Table 2-3.

Configuring Security

Note: The VCR adapter user identity assertion to the UCM content server will not work properly if the UCM Content Server users that are being referenced by WLP exist in an

ActiveDirectory and the UCM Content Server has been configured to use a non-LDAP based ActiveDirectory. This configuration is not supported.

A local or global user identity store will work, as will an external LDAP-based store (either ActiveDirectory or other LDAP).

Note: For best performance, use native security (useNativeSecurity = true).

WLP-Secured Global Config User

All users in the application use the same credentials to connect to the UCM instance. The data is secured through WebLogic Portal. WLP Content Entitlements will apply. Configure this type of security with these settings in the META-INF/content-config.xml file in the EAR Project, as described in the following table.

Identity Propagation with Native Security

WebLogic Portal and UCM use the same security store, such as a shared LDAP store. Each WLP user sees in the application what they are permitted to see on the UCM side. Entitlements (WLP content security) are disabled.

Verifying the Installation

To verify the installation, open the WLP Administration Console, go to the Content Management section, and attempt to browse to the UCM repository and view its contents or types.

Content Design Considerations

The UCM VCR Adapter provides the conduit through which the WLP Virtual Content Repository (VCR) accesses content in UCM. To function properly, the adapter expects content structures that can be mapped to the structures used in the VCR. For example, UCM uses profiles to manage how metadata is structured and displayed. However, the VCR does not use profiles; therefore, the adapter is required to provide reliable mappings between the two systems.

This section discusses the considerations for modeling content in the UCM to facilitate exposure in the VCR.

Note: If the UCM server is restarted, or if a UCM parameter is changed that might affect search, then the WebLogic Portal server must be restarted.

Content Modeling and Mapping Overview

Content modeled in UCM is modeled using some combination of the following constructs:

• Document – A basic content item construct that includes a full set of metadata fields. Every document contains the same set of fields.

- Content profile Content profiles allow UCM administrators to express which metadata fields are associated with a given document. Content profiles created by a system administrator can refine the metadata options available to users during check in and searching, as well as what metadata is displayed on a content information page. See also "Creating Profile-Based Content Types with the UCM Administration Console" on page 3-17
- Site Studio region definitions An add-on container construct created in Site Studio that allows definition of types (region definitions) composed of properties (content elements), in addition to the standard document fields. For example, a region definition could include a combination of text and graphic elements. See also "Creating Region-Based Content Types with Oracle Site Studio" on page 3-24

How these constructs map to WLP VCR content types and nodes are described in the following sections.

How Documents are Mapped to VCR Content Types

Documents not associated with a content profile map to a content type named IDC:GlobalProfile in the VCR that includes all of the metadata fields. All of the metadata fields you see in UCM will appear in the VCR type called IDC:GlobalProfile.

To ensure that content profiles are correctly mapped to VCR content types, keep in mind the following mapping behavior:

- Each metadata field in a content profile will correspond to a VCR property definition.
- A single binary property definition named idcPrimaryFile will always relate to the checked-in document. This binary property definition will be the primary property definition for the content type.
- Other metadata fields of type Text, Long Text, Memo, Integer, Decimal, and Date will map to VCR property data types of String, Long, Double, and Calendar.
- Text metadata fields using an option list based on the YesNoView or TrueFalseView views will be exposed in WLP as a property of type Boolean.

How Content Profiles are Mapped to VCR Content Types

Each content profile in UCM is exposed in the VCR as a content type. The profile's associated fields (defined by rules) are exposed on the VCR type.

How the Combination of Site Studio Region Definitions and Profiles are Mapped to VCR Content Types

Oracle Site Studio is a web development program that offers structured content features. In Site Studio, groups of individual content elements are arranged in region definitions. Each region definition in UCM is exposed in the VCR as a content type. If the region definition is associated with a profile, then the VCR content type will contain property definitions from both the region definition as well as from the profile.

If the region definition is not associated with a profile, then the VCR content type will contain property definitions from both the region definition as well as the standard document metadata fields (the fields from IDC:GlobalProfile).

Figure 3-1, illustrates a region definition called "Press_Release," which consists of the elements Title, Subtitle, Intro_Text, Body_Text, and Image.




Figure 3-1 Elements Assembled into a Region

To ensure that content regions are correctly mapped to VCR content types, keep in mind the following mapping behavior:

- Element definitions map to VCR property definitions. Note that unlike metadata property definitions associated with profiles, property definitions that are defined as part of a region are only searchable by doing a full text search.
- Element definitions map to string, link, or nested data types.
 - Links will be represented when a content custom element form called SS_DOCNAME_LINK_FORM is used that restricts the population of the link field to something the content server understands as a link.
 - Nested data types will be represented when a Site Studio static list is used. A static list is inherently one level deep and may only contain element definitions of type string (plain text or wysiwyg) and link. Static lists are inherently multi-valued.
 - The static list will be represented as an abstract content type by the VCR. The static list itself acts as a definition for an additional content type comprised of the element definitions in the static list.
 - Both plain text and wysiwyg element types are exposed as String values in the VCR.
- Region definitions, by default, receive all of the property definitions exposed by the global profile type. The content type for the region will extend the IDC:GlobalProfile content type.
- Region definitions may also be associated with a content profile. In this case the set of element definitions from the region, along with the set of metadata fields from the profile, will be represented as a single type by the VCR. The content type for the region will extend the profile content type.

Best Practices for Modeling Content

The VCR uses *content types* to describe content metadata. Content types are used to define the metadata that you can associate with content. When content contributors add content to a WLP VCR, they can associate the content with a content type. In the same way, when UCM content is surfaced in the VCR, the UCM VCR Adapter must provide some degree of mapping to ensure that the content types are structured correctly. This section describes best practices for modeling data in a WLP Repository or other repository to facilitate migration to the UCM Adapter, and to understand the mapping behavior of the UCM Adapter.

Table 3-1 describes the UCM modeling considerations for VCR content types. For more information on VCR content types, see the *Oracle Fusion Middleware Content Management Guide for Oracle WebLogic Portal*.

Property Field Mappings

This section explains how the VCR system property fields map to UCM content fields when searches are performed. During a search operation that is performed using the WLP search API, the standard VCR system properties listed in Table 3-7 are automatically converted to

corresponding UCM content fields by the UCM/VCR Adapter. For example, searches performed through Content Presenter or content selectors perform these conversions automatically.

Note: If you are performing a search, the best practice is to use the system properties as they appear in the WebLogic Portal user interface, such as in the user interface for Content Presenter or content selectors. For example, if you need the binary size, use VaultFileSize (the internal name) rather than cm_binarySize. This practice ensures that even if the system field mapping changes over time, the search behavior remains the same.

Table 3-7 shows how these mappings are made internally by the UCM/VCR Adapter. Note that UCM has two names for every field. One is an internal name, which you can see in UCM when adding a field to a rule, and the other is the field name that appears in the user interface. In Table 3-7, the internal name (for example, dDocName) is listed first, and the UI name (for example, Content ID) is listed below it in parentheses, where applicable.

Caution: The mappings in Table 3-7 are UCM/VCR Adapter-specific and are subject to change.



Figure 3-9 Site Assets Menu






Figure 3-14 Selecting the Static List and Clicking the Edit Icon






Figure 3-21 The Edit Dialog for the Link Element

Create a Region Definition

The next step is to create a Region definition and add the element definitions to it.

- 1. In the Site Assets dropdown menu in the Site Studio window, select Region Definitions.
- 2. From the **Page** icon dropdown menu, select **New > Region Definition**.
- 3. In the Content Server dialog enter a Content ID and a Title, as shown in Figure 3-24.

Associate this Region Definition to the Content Type that it will be used with. In this example, the Article content type is used.

6. In the Edit dialog, click **Add**.

7. In the next dialog, enter the Name and Label fields. The values you enter in these fields will appear in the Property fields in the VCR. Select one of the previously defined element definitions in the Element Definition ID drop down box, as shown in Figure 3-26. Do not check the **Embed the element definition inside the region definition** checkbox. Click **OK** when finished.

- 10. In the Regions Content Options dialog, make sure that the **Create new contributor data file** option box is checked, as shown in Figure 3-28, and click **OK**.

- **Note:** You can optionally associate the region definition with a profile. This technique is useful to expose in the WLP content type a combination of the fields from the profile as well as elements from the region. If no profile association is configured, then the WLP content type will contain a combination of all metadata fields on the content server as well as elements from the region. To associate a profile with the region definition, select **Modify Metadata** at the bottom of the region edit dialog. The Enable Metadata Modification dialog appears. In this dialog, select a profile from the Profile Trigger Value popup menu in the lower-right hand corner, then click **OK**. This associates the region definition with that profile.
- 11. You are now returned to the top-level element definition dialog. *At this point, you must save the element definition*. Click the **Save** icon in the to-left part of the window.

The creation of the regions-based content type is now complete.

Creating a New Contributor Data File Based On a Region Definition

This section explains how to use Oracle Site Studio and the UCM Administration console to create content using region definitions. The goal of this procedure is to create region-based content in UCM and have that content and its properties appear in the WebLogic Portal VCR. The Site Studio region elements will be expressed as property fields in the VCR.

For background information on Site Studio, see "Best Practices for Modeling Content" on page 3-4.

Prerequisites

As a best practice, it is recommended that you first create a profile definition to associate with a newly created region-based content type definition. If you do not associate a region definition with a profile, then by default the region-based content type will be associated with a global profile and all UCM metadata fields will be exposed when viewing instances of content based on the region. UCM uses profiles to manage how metadata is structured and displayed.

Note: The example in this section uses the Article profile definition discussed in the previous example, "Creating Profile-Based Content Types with the UCM Administration Console" on page 3-17.

Overview of Steps

The basic steps described in this section are:

- 1. Select the region definition from which the new content node will be created.
- 2. Create an empty contributor data file based on that region definition.
- 3. Edit the contributor data file to populate the content fields.

Selecting the Region Definition

This section describes how to select the region definition in Site Studio. Region definitions can also be selected outside of Site Studio Designer, in the Content Server.

- 1. Start Oracle Site Studio.
- 2. In Site Studio, select **Region Definitions** from the Site Assets dropdown menu, as shown in Figure 3-31.

3. From the resulting list of region definitions, select a region type on which to base the new content node, and select the **Doc Info** button to launch the Oracle Content Server Administration console, as shown in Figure 3-32. It is also possible to create contributor data files outside of Site Studio Designer, on the Content Server. The important part is to first locate the region definition.

4. From the Content Server Administration console, select **Create New Web Asset** from the Content Actions dropdown menu, as shown in Figure 3-33.

- 8. From the Content Information screen, select **Content Actions > Edit Data File** from the Content Actions dropdown menu. The Site Studio Contributor Data File Editor appears.
- 9. Use the editor to enter information in each of the pre-defined region fields (plain text, WYSIWYG, static list, and link. Also, select the Metadata tab and enter metadata for the contributor data file. Note that the available metadata fields are associated with the profile with which this content is associated. See Figure 3-36 and Figure 3-37.



Figure 3-38 UCM Content Surfaced in VCR









Figure 3-40 UCM Content Properties in the VCR
