This guide helps those of you who are familiar with the e*Gate Enterprise Manager to create sample e*Gate schemas called scenarios.

In this guide, you will find three step-by-step examples of creating schemas. The first two examples, or scenarios, create schemas for Java Collaboration environments. The third scenario sets up a schema for a Monk Collaboration environment.

This guide does not provide information about e*Gate or e*Gate Enterprise Manager beyond the creating of a schema. For additional information about e*Gate, refer to the documents listed in [Supporting Documents](#) on page 8.

2.1 Roadmap for Creating Scenarios

The procedure below provides a roadmap for creating the end-to-end scenarios. You can switch the order of certain items; in cases where you cannot, the applications alerts you and lets you create the required component before you continue.

To create scenarios

- 1 Verify the e*Gate installation and system requirements.
- 2 Create a new schema.
- 3 Create the Event Types and ETDs.
- 4 Create the Collaboration Rules.
- 5 Add the e*Ways, the JMS e*Way Connection (for Java schemas), and the IQs (for Monk schemas).
- 6 Add the Collaborations.
- 7 Review the complete schema.
- 8 Create the input data file.
- 9 Start the schema.
- 10 Test the schema.
- 11 Troubleshoot any problems.

Compared to the schema process presented in the schema diagrams in the following chapters, the roadmap procedure reverses the schema process. The roadmap calls for creating the Event Types and Collaborations before you create the e*Ways that use them. This method is more efficient because you can create all components of the same

type at the same time. It also ensures that the required components are available when you need them.

2.2 e*Gate Installation Requirements

To be able to create the scenarios described in this guide, you must have all e*Gate components installed on a single Windows system. Your system must have the following e*Gate components installed:

- Registry Host
- Participating Host
- GUIs (e*Gate Enterprise Manager and e*Gate Monitor)

Refer to the *e*Gate Integrator Installation Guide* for system requirements and installation instructions.

For the Java scenarios, you must have the following items available:

- Java 2 SDK, Standard Edition, v 1.3.1_02 (JDK 1.3.1_02)
You can download the JDK 1.3.1_02 from www.java.sun.com.
- Internet Explorer 5.x or later

The Java Collaboration Editor requires Internet Explorer 5.x or later. You can download Internet Explorer from www.microsoft.com.

Creating a Java End-to-End Scenario

This chapter provides step-by-step procedures for creating and testing an e*Gate schema with Java Collaboration Rules. This schema addresses a business challenge in a scenario where a company uses two systems to handle time tracking and payroll distribution. The systems use dissimilar formats which presents a challenge when one system must use data from the other system to accomplish its tasks.

This chapter describes the business challenge and how you can create a Java schema in e*Gate to allow the two systems to work together effectively.

3.1 Presenting the Business Challenge

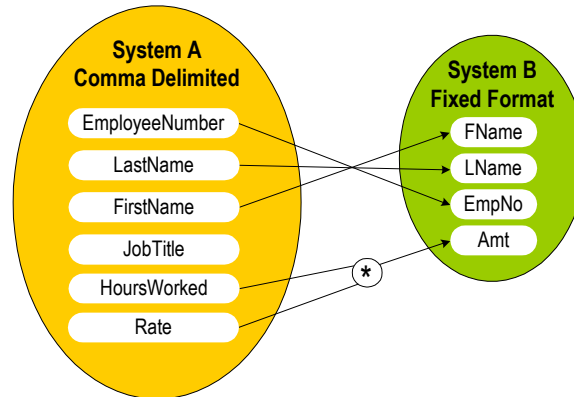
The Java end-to-end scenario described in this chapter provides a solution to the following business challenge:

System A is a timecard system and tracks the weekly hours worked by employees. The data in system A is in a delimited format. System B is a payroll system and is responsible for employee payment. The data in system B is in a fixed format of four fields: first name, last name, employee number, and amount. System A's data does not include amount information.

To integrate system A successfully with system B, the following issues must be addressed:

- System A's data in delimited format must be converted to system B's fixed format
- The value for system B's amount field must be calculated before it is sent to system B

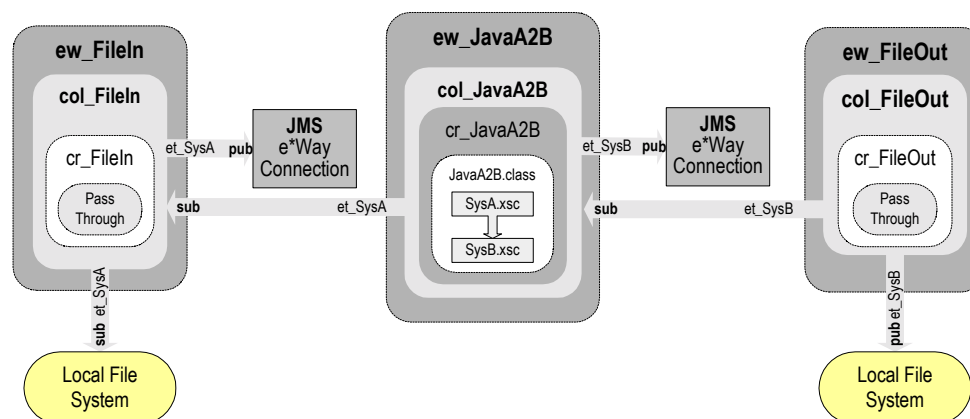
The figure below shows the relationship between the data in system A and system B.



3.2 Presenting the e*Gate Solution

The e*Gate solution uses the e*Gate Java Collaboration Service to transform the data from the system A format to the system B format. e*Gate provides flexibility regarding the location of transformation processing as the data transfers from system A to system B. The solution uses the Multi-Mode e*Way as the main transformation component and two Java Pass Through File e*Ways to bring data into and move data out of e*Gate.

The figure below shows the e*Gate schema.



In this figure, you see the following process:

- 1 The **ew_FileIn** e*Way brings system A data into e*Gate as follows:

The **col_FileIn** Collaboration in the **ew_FileIn** e*Way subscribes to a location on the local file system. It polls this location for a **.fin** file, which is a text file with data from system A. If it finds a **.fin** file, it reads the message, packages the data as an **et_SysA** Event, and publishes the Event to the JMS e*Way Connection.

- 2 The **ew_JavaA2B** e*Way transforms the data format and calculates the amount.

The **col_JavaA2B** Collaboration in the **ew_JavaA2B** e*Way subscribes to **et_SysA** Events published by **col_FileIn**. It uses the Java Collaboration Rules component **cr_JavaA2B** to change **et_SysA** Events into **et_SysB** Events. This rule uses the **JavaA2B.class** which implements the transformation. **cr_JavaA2B** also computes the amount field in **et_SysB** by multiplying the hours and the rate from **et_SysA**. Finally, **col_JavaA2B** publishes the **et_SysB** Event to the JMS e*Way Connection.

- 3 The **ew_FileOut** e*Way writes the transformed data out to local file system.

The **col_FileOut** Collaboration in the **ew_FileOut** e*Way subscribes to **et_SysB** Events published to the JMS e*Way Connection by the **col_JavaA2B** Collaboration. The **cr_FileOut** Collaboration Rules component uses the Java Pass Through service to move the data without modifying it. When an **et_SysB** Event is retrieved, the e*Way packages it as a text file and writes it to the specified location on the local file system, completing the end-to-end scenario.

3.3 Creating the Schema

Before you start creating the schema, make sure that you have the following system requirements:

- e*Gate Registry Host, Participating Host, and GUIs installed on a single system
- The system is running the Windows operating system
- The system has Internet Explorer 5.x or later installed
- The system has Java 2 SDK, Standard Edition, v 1.3.1_02 (JDK 1.3.1_02) installed

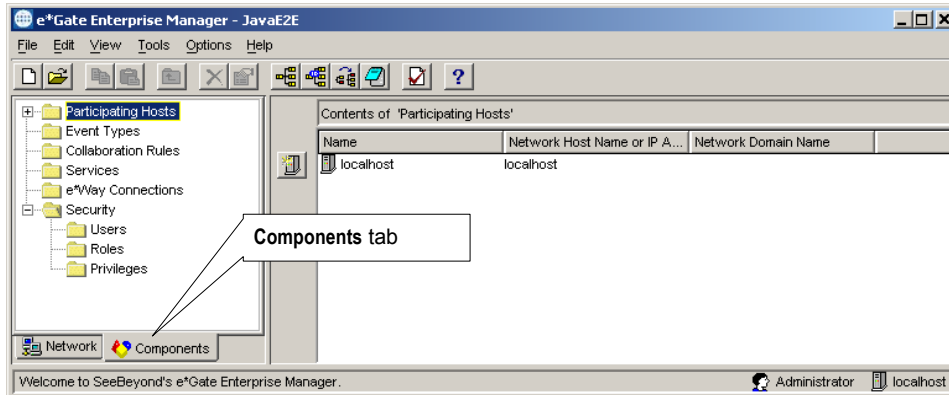

To create the schema

- 1 Start the e*Gate Enterprise Manager and log in as **Administrator** (or another user with administrator privileges) to the appropriate Registry Host.
- 2 In the **Open Schema on Registry Host** dialog box, click **New**.
- 3 In the **Enter New Schema Name** box, type **JavaE2E** and click **Open**.

The e*Gate Enterprise Manager displays the new **JavaE2E** schema.

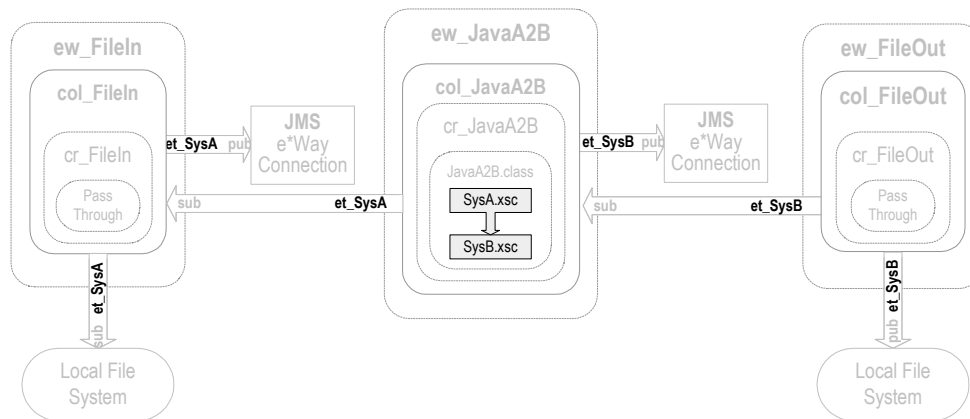
- 4 Click the **Components** tab. You perform all configuration steps in the **Components** tab.



3.4 Creating the Event Types and Java ETDs

This scenario uses two Event Types. These Event Types require their own Event Type Definitions (ETDs). The first Event Type, **et_SysA**, models the comma-delimited format of the data received from system A as defined in **SysA.xsc**. The second Event Type, **et_SysB**, models the fixed-length data format required by system B as defined in **SysB.xsc**.

The figure below shows where these parts fit into the schema.






3.4.1 Creating the SysA.xsc ETD

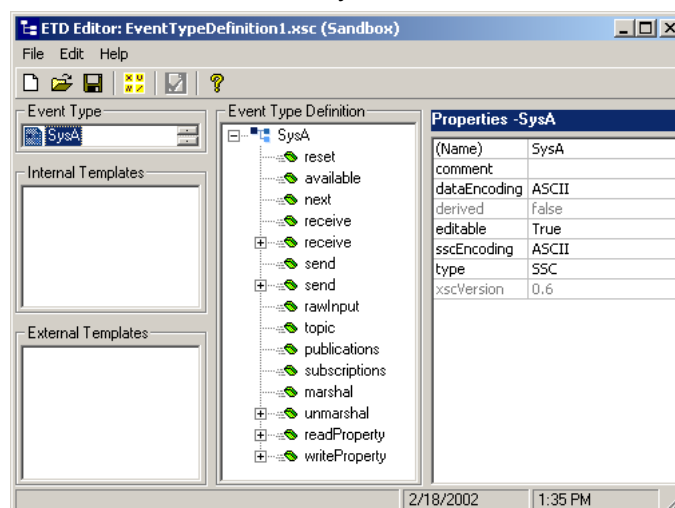
The procedure below describes how you create the SysA.xsc ETD. Before you start, you must have already created the JavaE2E schema as described in [“Creating the Schema” on page 14](#).

To create an ETD, you specify the ETD name, and the ETD’s root node name and a package name.

The package name is the name of the collection of Java classes that make up the ETD. This group of Java classes is the result of the ETD creation process. The root node name and package name **cannot** be the same.

To create the SysA.xsc ETD

- 1 In the e*Gate Enterprise Manager, click **Default Editor** on the **Options** menu.
- 2 Click **Java** if necessary and click **OK**.
- 3 In the **Components** tab, click the **Event Types** folder.
- 4 Click **Create a New Event Type** .
- 5 In the **Name** box, type **et_SysA** and click **OK**.
This adds **et_SysA** to the Event Types pane.
- 6 In the Event Types pane, double-click **et_SysA**.
The **Event Type - et_SysA Properties** dialog box appears.
- 7 Click **New**. The **ETD Editor** window appears.
- 8 Click **New** .
- 9 Double-click **Custom ETD Wizard** .
- 10 Click **Next**.
The **Custom ETD Wizard - Step 1** dialog box appears.
- 11 In the **Root Node Name** box, type **SysA**.
- 12 In the **Package Name** box, type **SysApackage**.
- 13 Click **Next**, review the summary information, and click **Finish**.
The screen below shows the new SysA.xsc ETD.



Adding SysA.xsc Nodes

The procedure below describes how you add nodes to the SysA.xsc ETD. Before you start, you must have already created ETD as described in [“Creating the SysA.xsc ETD” on page 15](#).

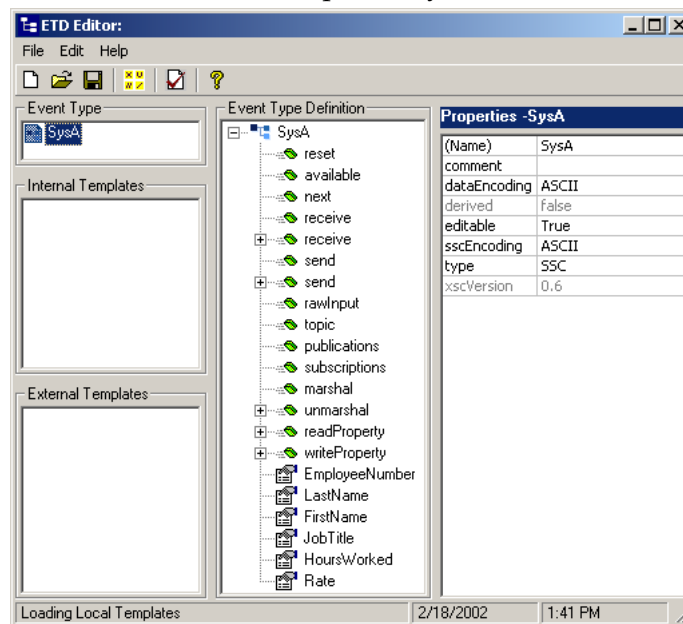
To add SysA.xsc nodes


- 1 In the Event Type Definition pane, right-click **SysA**, point to **Add Field**, and then click **As Child Node**.


This adds a **Field1** node under the **SysA** root node.

- 2 Right-click the **Field1** node and click **Rename**.
- 3 Type **EmployeeNumber** and press ENTER.
- 4 Repeat steps 1 through 3 to add the following nodes:
 - ◆ LastName
 - ◆ FirstName
 - ◆ JobTitle
 - ◆ HoursWorked
 - ◆ Rate

The screen below shows the completed SysA.xsc ETD



- 5 Click **Global Delimiters** .
- 6 Click **Add Level**.
- 7 Click **Add Single End Delimiter**.
- 8 Click **Value** in the Properties pane and enter **“,”** (a comma, no quotes).
- 9 Click **OK**.

- 10 On the **File** menu, click **Compile and Save**.
- 11 In the **File name** box, change **EventTypeDefinition1.xsc** to **SysA.xsc**.
- 12 Click **New Folder** .
- 13 In the **Enter directory to create** box, type **JavaE2E** and click **OK**.
- 14 Double-click the **JavaE2E** folder and click **Save**.
This compiles and saves the SysA ETD as **SysA.xsc** in the **\etd\JavaE2E** folder.
- 15 On the **File** menu, click **Close**.
The Java ETD Editor closes and the location of the file **SysA.xsc** now displays in the Event Type Definition pane.
- 16 Click **OK** to close the **Event Type - et_SysA Properties** dialog box.

3.4.2 Creating the SysB.xsc ETD

The SysB.xsc ETD corresponds to the fixed data structure used by system B.

Use the procedure in [“Creating the SysA.xsc ETD” on page 15](#) to create a new Event Type named **et_SysB** and a corresponding Java ETD with root node name **SysB** and package name **SysBpackage**. Then use the following procedure to add nodes to **SysB.xsc** in the ETD Editor.

Adding SysB.xsc Nodes

The procedure below describes how you add nodes to the SysB.xsc ETD. Before you start, you must have already created ETD as described in [“Creating the SysB.xsc ETD” on page 18](#).

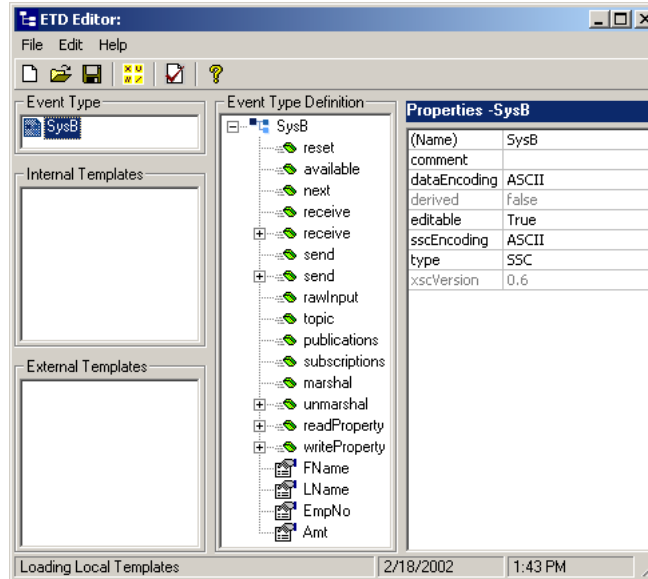
To add SysB.xsc nodes

- 1 In the Event Type Definition pane in the ETD Editor, click the **SysB** node.
The SysB node properties appear in the Properties pane.
- 2 In the Properties pane, click **structure** and select **fixed** from the list.
- 3 Right-click **SysB**, point to **Add Field**, and then click **As Child Node**.
- 4 Right-click the **Field1** node and click **Rename**.
- 5 Type **FName** and press Enter.
- 6 With the **FName** node selected, click **length** in the Properties pane.
- 7 Change its value from **undefined** to **25**.
- 8 Click **offset** in the Properties pane, and change its value from **undefined** to **0**.
- 9 Repeat steps 3 through 8 to set up three additional nodes as follows:

| Node Name | Structure | Length | Offset |
|-----------|-----------|--------|--------|
| LName | fixed | 25 | 25 |
| EmpNo | fixed | 10 | 50 |

| Node Name | Structure | Length | Offset |
|-----------|-----------|--------|--------|
| Amt | fixed | 10 | 60 |

The screen below shows the completed SysB.xsc ETD.



- 10 On the **File** menu, click **Compile and Save**.
- 11 In the **File name** box, change **EventTypeDefinition1.xsc** to **SysB.xsc**.
- 12 Double-click the **JavaE2E** folder and click **Save**.

This compiles and saves the SysB.xsc ETD as **SysB.xsc** in the `\etd\JavaE2E` folder.

- 13 On the **File** menu, click **Close**.

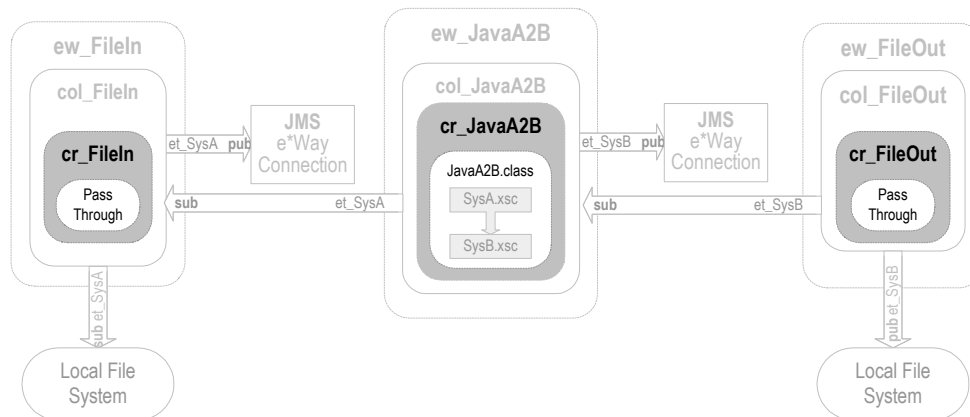
The Java ETD Editor closes and the location of the file **SysB.xsc** now displays in the Event Type Definition pane.

- 14 Click **OK** to close the **Event Type - et_SysB Properties** dialog box.

3.5 Creating the Collaboration Rules

The Java end-to-end scenario uses three Collaboration Rules: two Java Pass Through rules and one Java Collaboration Rules component. The Pass Through rules, **cr_FileIn** and **cr_FileOut**, route the Events through the e*Gate environment. The Collaboration Rules component **cr_JavaA2B** transforms the Event from Event Type **et_SysA** to Event Type **et_SysB**.


The figure below shows where the Collaboration Rules fit into the schema.



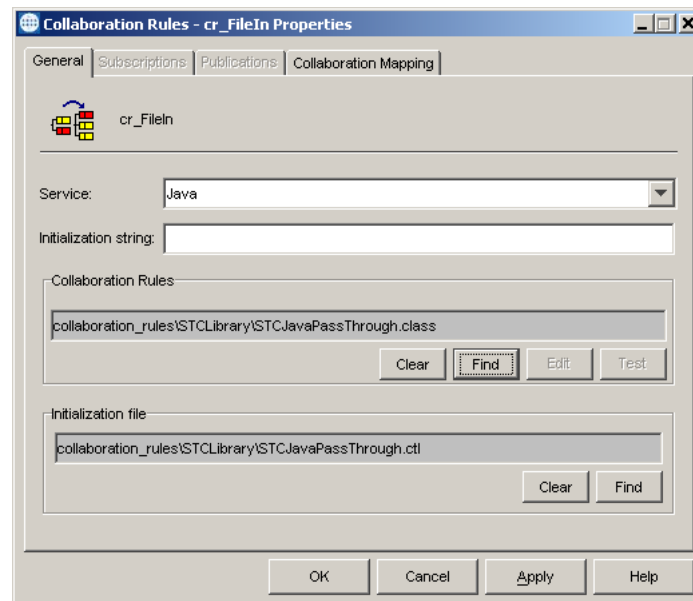
3.5.1 Creating the Java Pass Through Collaborations

The Java Pass Through Collaborations bring data into and move data out of e*Gate. The Pass Through Collaboration Rules do not change the data. The following procedure describes how you create the Java Pass Through Collaborations for this scenario.

To create the Java Pass Through Collaboration Rules

- 1 In the **Components** tab of the e*Gate Enterprise Manager, click the **Collaboration Rules** folder.
- 2 Click **Create New Collaboration Rules** .
- 3 In the **Name** box, type **cr_FileIn** and click **OK**.
cr_FileIn displays in the Contents pane.

Creating an ELS End-to-End Scenario

This chapter provides step-by-step procedures for creating and testing an end-to-end e*Gate scenario that uses Event Linking and Sequencing (ELS). This schema addresses the following scenario: a company needs its receiving system to send a message to its purchasing system when all items of an order with multiple items are received. At that point, the purchasing system issues payment for the purchase order.

This chapter describes the business challenge and how you can create an ELS schema in e*Gate to have the receiving system track the receipt of order items and to send a message to the purchasing system when the order is received in its entirety.

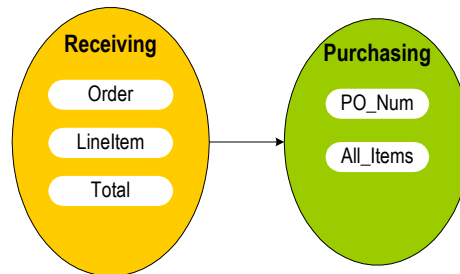
4.1 Presenting the Business Challenge

The ELS end-to-end scenario described in this chapter provides a solution to the following business challenge:

Purchasing buys office supplies for the company. The purchasing systems generates orders with multiple line items. Receiving processes the items as they are delivered. Typically, only individual line items are delivered, not entire purchase orders.

Purchasing only pays purchase orders that are completely fulfilled. The company needs a way to track whether an entire purchase order has been filled.

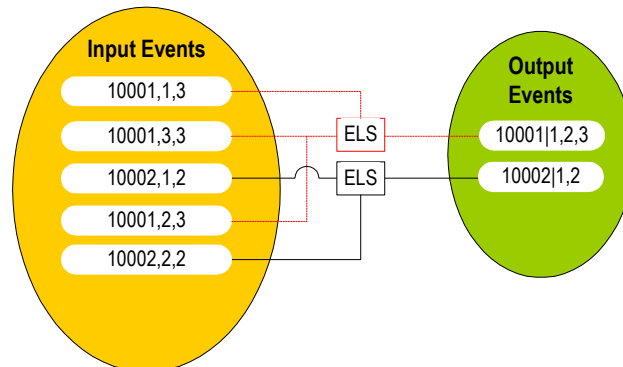
The figure below shows the relationship between the receiving and purchasing systems.



4.2 Presenting the e*Gate Solution

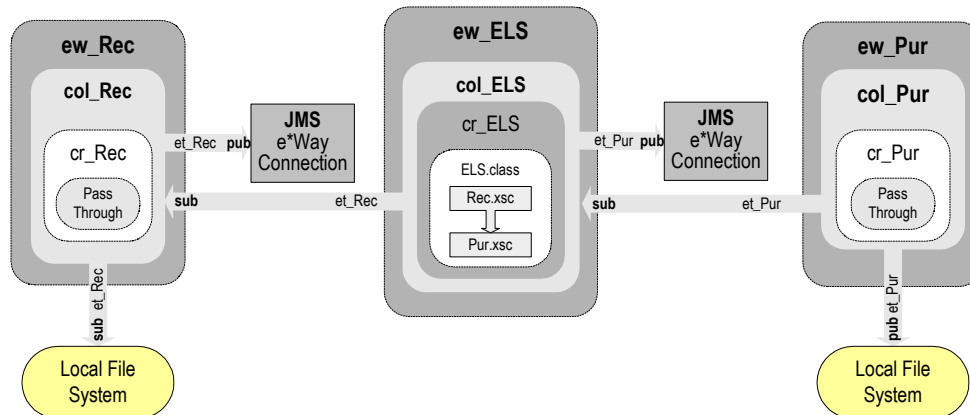
The ELS scenario shows you how e*Gate’s ELS feature can correlate the individual line items taken in by receiving so that when all line items for a specific purchase order have been received, a combined Event is sent to purchasing. Purchasing uses the receipt of this Event to trigger payment of the purchase order.

The figure below shows the e*Gate solution to this business challenge.



The proposed e*Gate solution makes use of e*Gate enhanced Java Collaboration Service and the ELS methods added to the Java Collaboration to combine the data from Events that have the same order number into a single Event. e*Gate is very flexible about where the actual ELS processing can occur as the data moves from the receiving system to the purchasing system. Our solution uses a Java Collaboration as the main transformation component and two File e*Ways to bring data into and move data out of e*Gate.

The figure below shows the complete e*Gate schema.



In this figure, you see the following process:

- 1 The **ew_Rec** e*Way brings data from the Receiving System into e*Gate.
The **col_Rec** Collaboration in the **ew_Rec** e*Way subscribes to a location on the local file system. It polls this location for a text file with extension **.fin** containing data from the Receiving System, packages the data as an **et_Rec** Event, and then publishes the Event to the JMS e*Way Connection.
- 2 The **ew_ELS** e*Way combines Events with matching order numbers into a single Event.
The **col_ELS** in the **ew_ELS** subscribes to **et_Rec** Events published by the **JMS** e*Way Connection. It uses an ELS-enabled Java Collaboration Rules component **cr_ELS** to temporarily store **et_Rec** Events. Once all the Events associated with a specific order are received, **cr_ELS** publishes a combined Event, **et_Pur**, to the JMS e*Way Connection. This Collaboration Rules component uses the **ELS.class** file that implements the business logic.
- 3 The **ew_Pur** e*Way writes the combined Event out to local file system.
The **col_Pur** Collaboration in the **ew_Pur** e*Way subscribes to **et_Pur** Events published by the JMS e*Way Connection. The **cr_Pur** Collaboration Rules component uses the Java Pass Through service to move the data without modifying it. When a **et_Pur** Event is retrieved, the e*Way packages it as a text file and writes it to the specified location on the local file system, completing the end-to-end scenario.

4.3 Creating the Schema

Before you start creating the schema, make sure that you have the following system requirements:

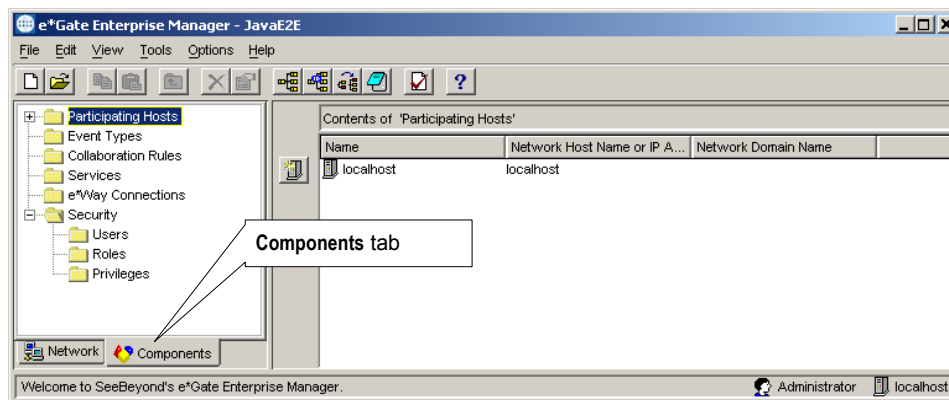
- e*Gate Registry Host, Participating Host, and GUIs installed on a single system
- The system is running the Windows operating system

- The system has Internet Explorer 5.x or later installed
- The system has Java 2 SDK, Standard Edition, v 1.3.1_02 (JDK 1.3.1_02) installed

To create the schema

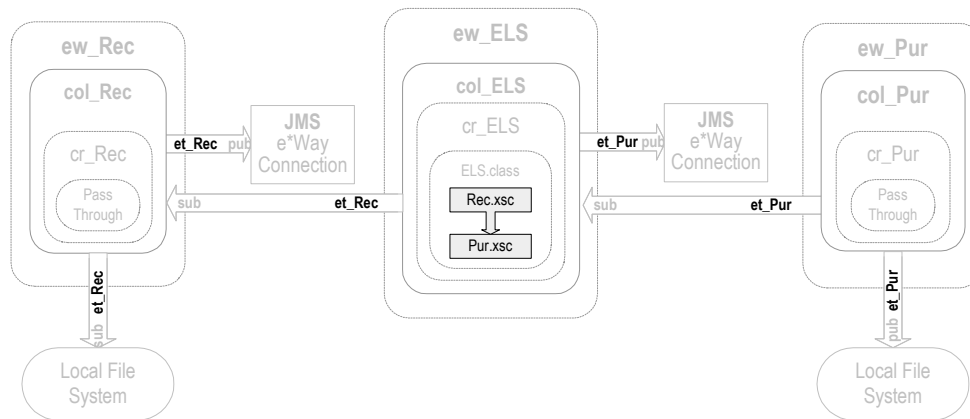
- 1 Start the e*Gate Enterprise Manager and log in as **Administrator** (or another user with administrator privileges) to the appropriate Registry Host.
- 2 In the **Open Schema on Registry Host** dialog box, click **New**.
- 3 In the **Enter New Schema Name** box, type **ELSE2E**, and click **Open**.

4.4 Creating the Event Types and Java ETDs

This scenario uses two Event Types. These Event Types require their own ETDs. The first Event Type, **et_Rec**, models the format of the data sent by the receiving system. The second Event Type, **et_Pur**, models the format used by the purchasing system.

The figure below shows where these parts fit into the schema.






4.4.1 Creating the Rec.xsc ETD

The procedure below describes how you create the Rec.xsc ETD. Before you start, you must have already created the ELSE2E schema as described in [“Creating the Schema” on page 43](#).

To create an ETD, you specify the ETD name, and the ETD’s root node name and a package name.

The package name is the name of the collection of Java classes that make up the ETD. This group of Java classes is the result of the ETD creation process. The root node name and package name **cannot** be the same.

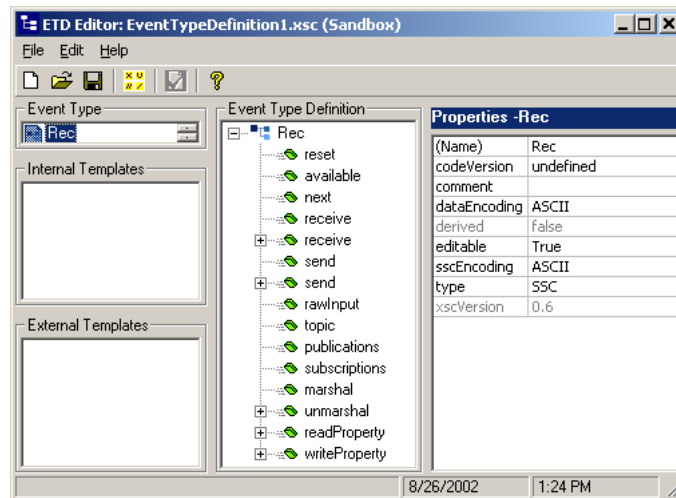

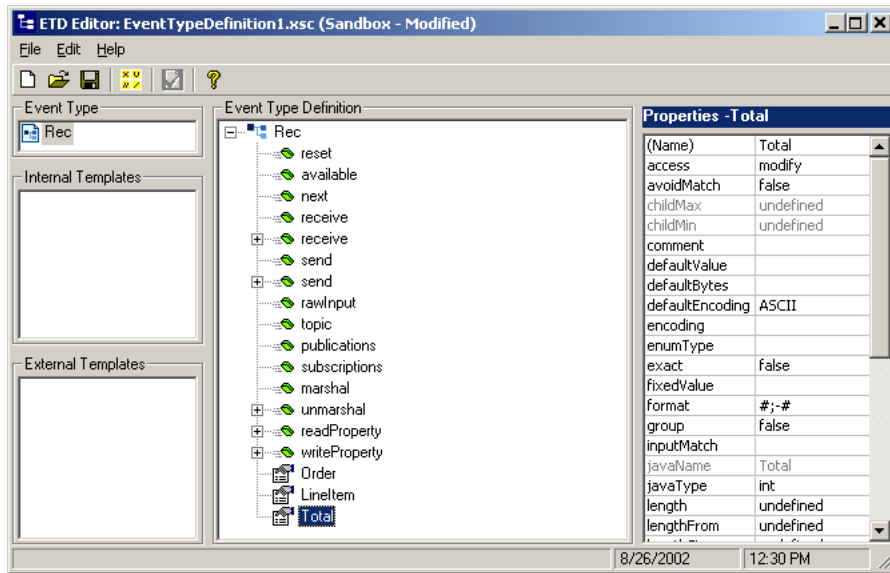

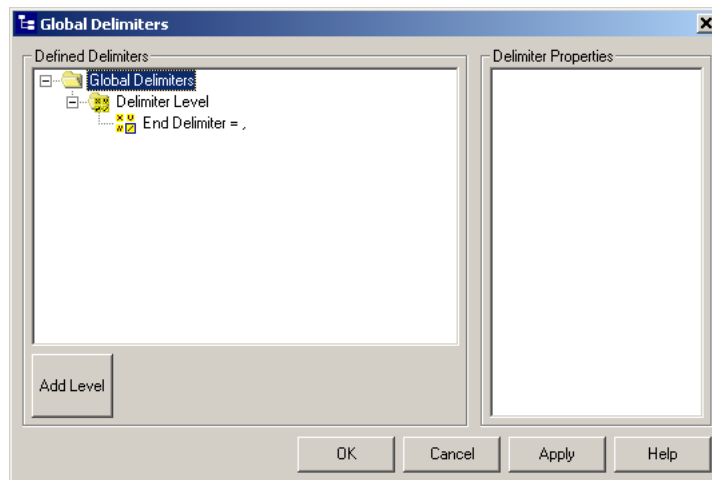

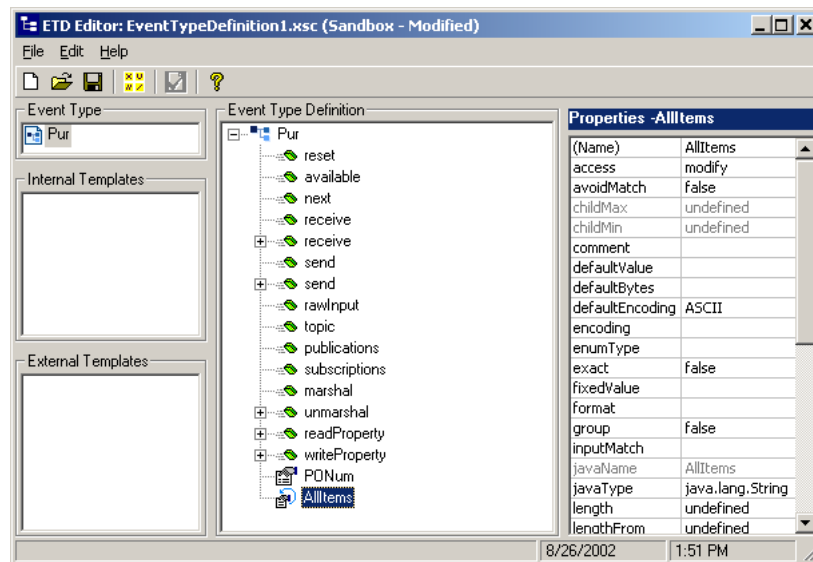

- 9 Right-click the **Field1** node and click **Rename**.
- 10 Type **AllItems** and press ENTER.
- 11 With the **AllItems** node selected, click **local delimiters** in the Properties pane and click the ellipsis  button.
The **Local Delimiters** dialog box appears.
- 12 Click **Add Single End Delimiter**.
- 13 Click **Value** in the Properties pane and enter “,” (comma, no quotes).
- 14 Click **OK** to close the **Local Delimiter** dialog.
- 15 Click **maxOccurs**, and then enter “-1” (minus one, no quotes) to change **AllItems** to a repeating node.

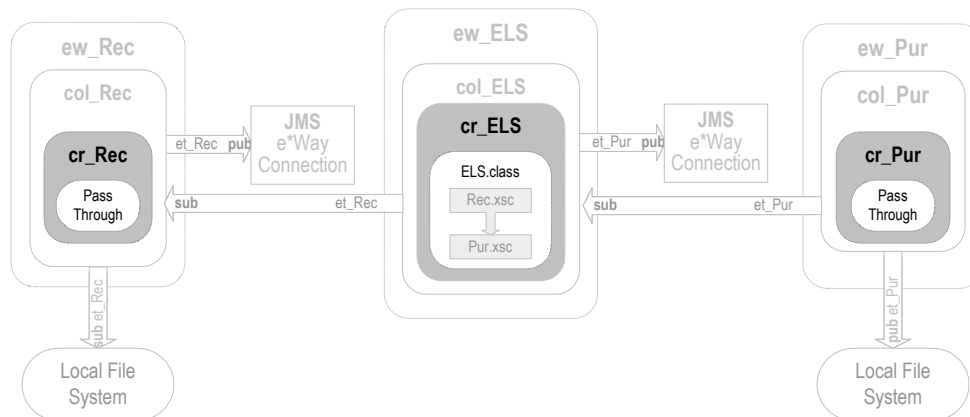

4.5 Creating the Collaboration Rules

The ELS end-to-end scenario uses three Collaboration Rules: two Java Pass Through Collaboration Rules and one Java Collaboration Rules component. The Pass Through rules, **cr_Rec** and **cr_Pur**, route the Events through the e*Gate environment. The Java Collaboration Rules component **cr_ELS** combines the individual line item Events into a single complete purchase order Event.


The figure below shows where the Collaboration Rules fit into the schema.



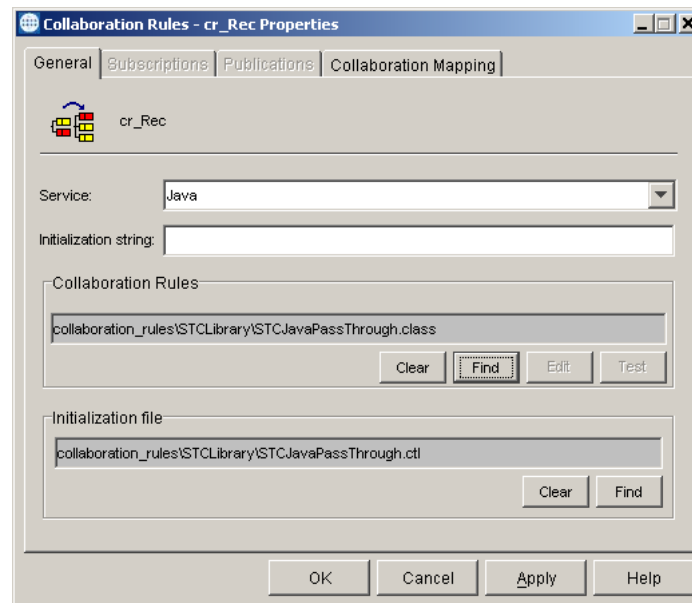
4.5.1 Creating the Java Pass Through Collaboration Rules

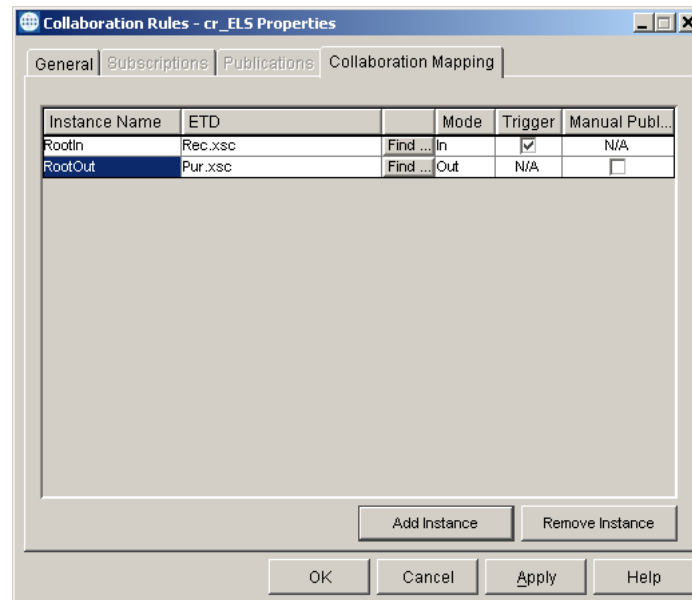

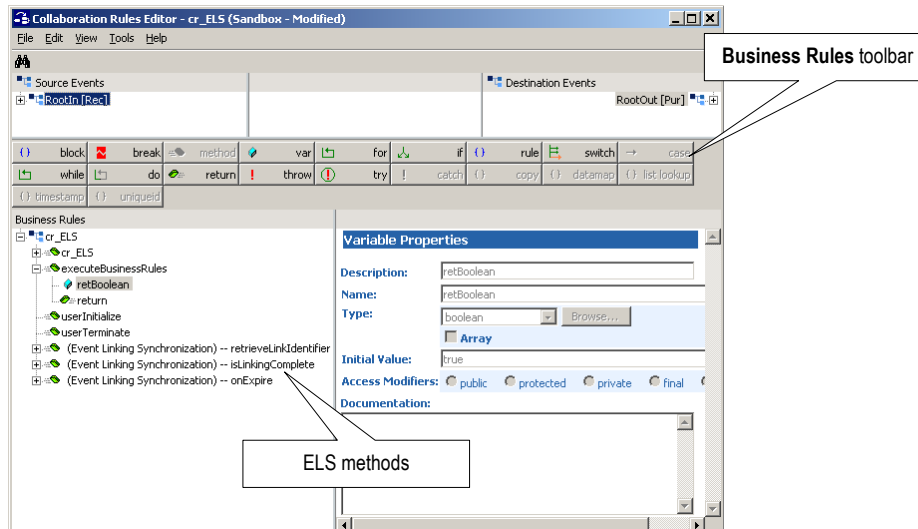

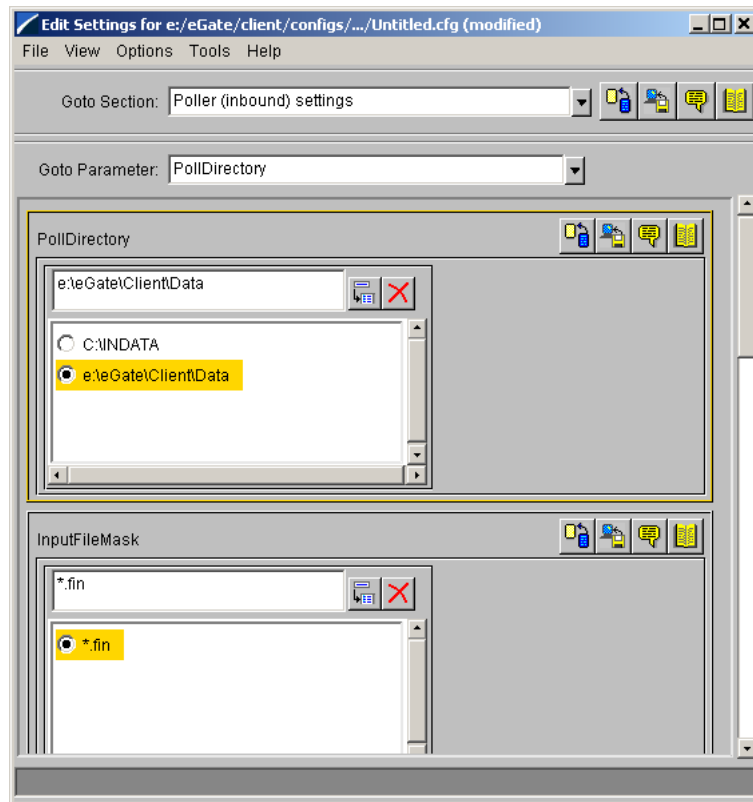

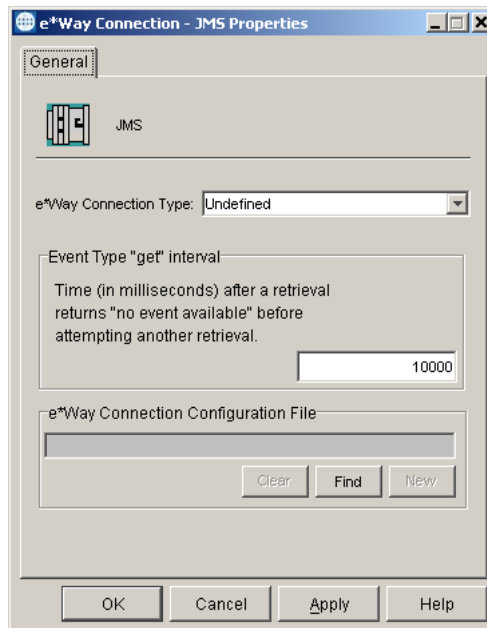

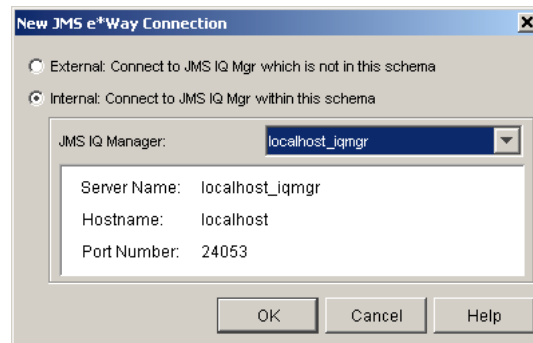

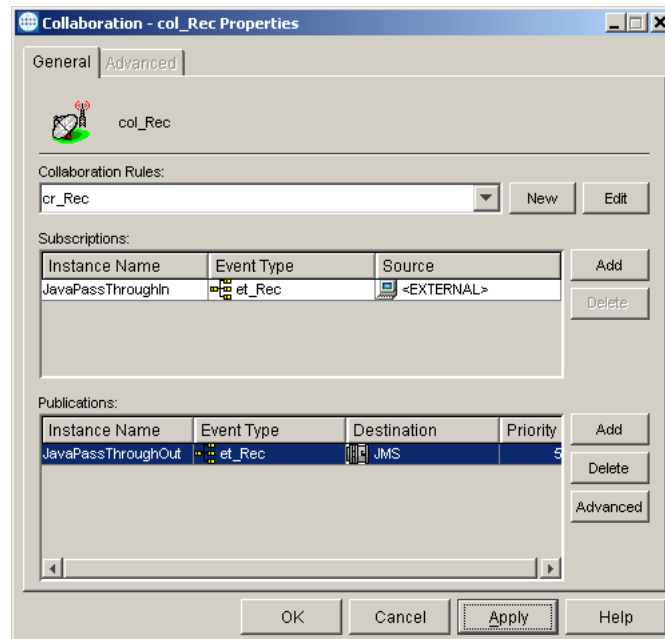

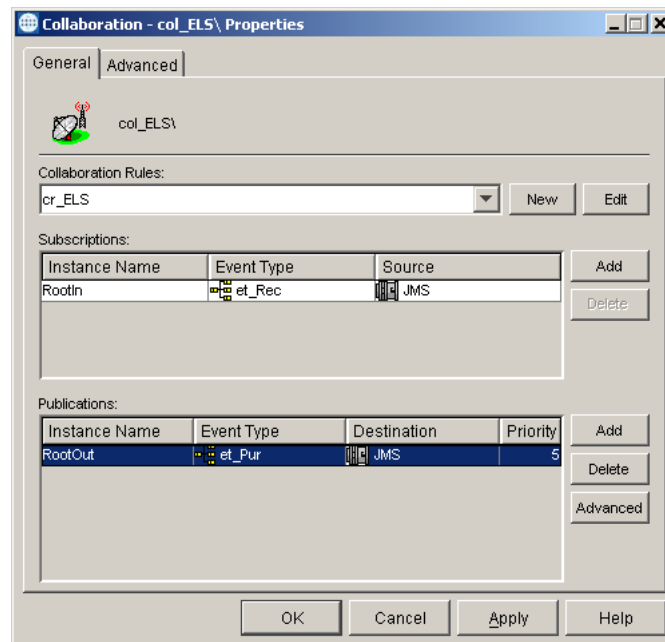

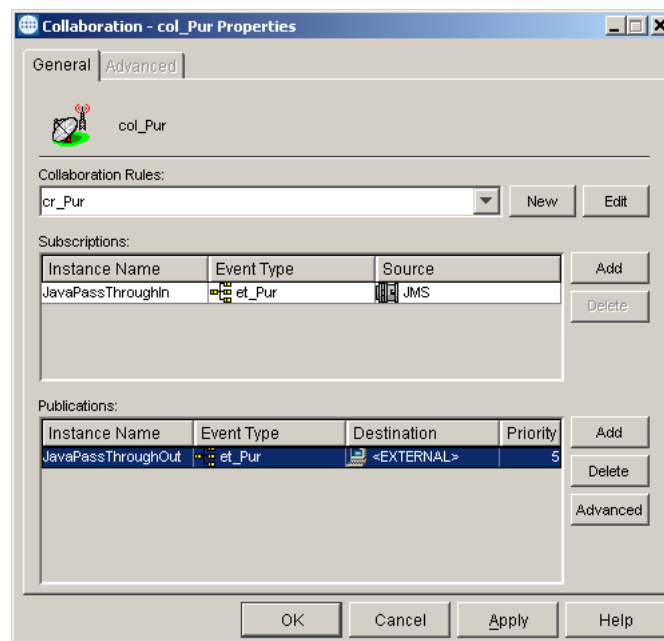

- 3 In the **Client** folder, create a folder named **Data**.
- 4 Save the file as **ELSE2Einput.txt**.

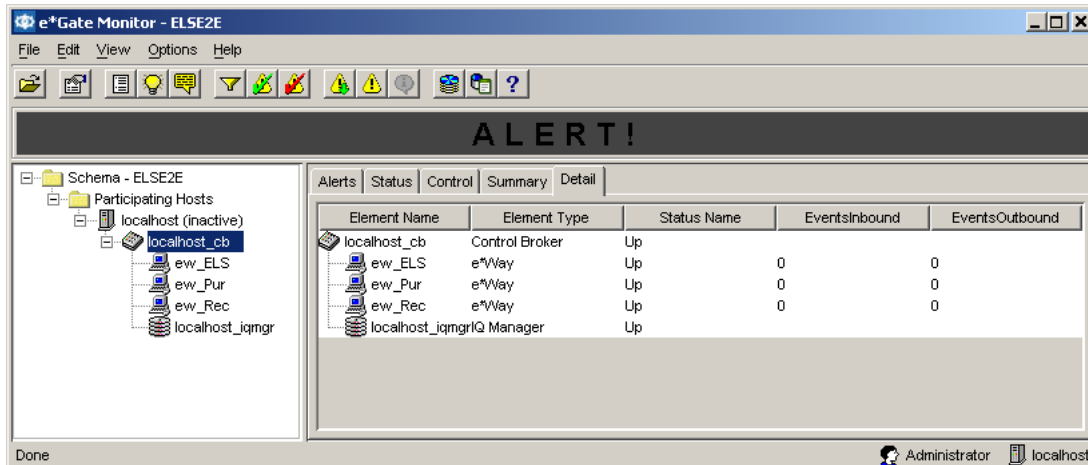

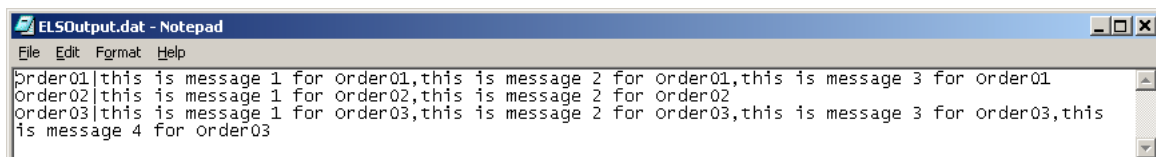

- 2 Change the file extension of **ELSE2Einput.txt** to **.fin**.
- 3 Click **Yes** when the confirmation message appears.
- 4 Verify that the extension changes to **.~in** indicating that the **ew_Rec** e*Way retrieved the file.

Almost immediately, the output file **ELSE2Eoutput#.dat** appears in the folder, indicating the schema ran successfully.

- 5 Verify that the output looks like that shown in the screen below.

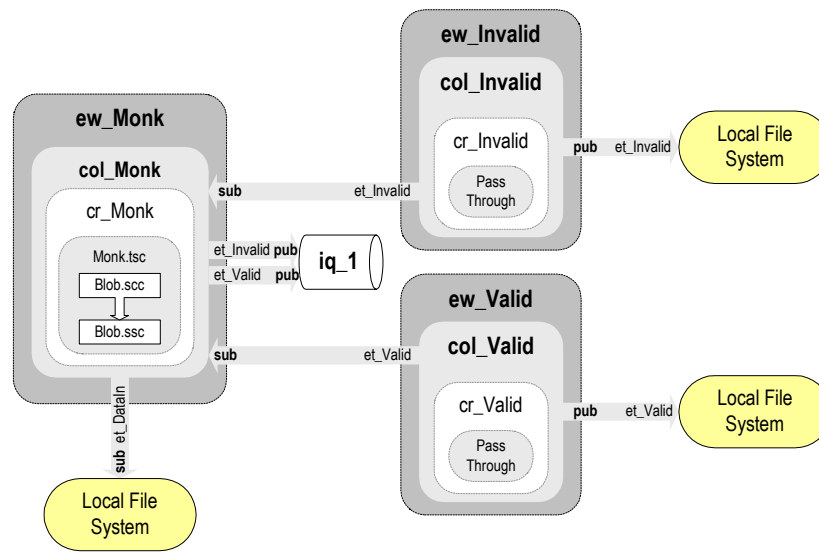
5.1 Presenting the Business Challenge

The business needs a way to determine if incoming data is valid or not and route the data accordingly. Valid data is sent to one system while invalid data is sent to another.

5.2 Presenting the e*Gate Solution

The e*Gate solution uses a Monk Collaboration in the inbound e*Way to separate and route the data. The figure below shows the component relationships of e*Gate that implements this business logic.

The figure below shows the complete e*Gate schema.



In this figure, you see the following process:

- 1 The **ew_Monk** e*Way brings the data into e*Gate and separates it into valid and invalid types.

The **col_Monk** Collaboration in the **ew_Monk** e*Way subscribes to a location on the local file system containing data to process. The data is packaged as Event Type (**et_DataIn**) and processed by the Collaboration Rules Script (**Monk.tsc**). The Monk script determines whether the data is valid or invalid. Invalid data is repackaged as Event Type **et_Invalid**. Valid data is repackaged as Event Type **et_Valid**. The **col_Monk** Collaboration published both Event Types to **iq_1**.

- 2 The **ew_Invalid** e*Way retrieves the invalid data and publishes it to a location on the local file system.

The **col_Invalid** in the **ew_Invalid** subscribes to **et_Invalid** Events published by **col_Monk**. The **cr_Invalid** Collaboration Rule uses the Pass Through service to move the data without modifying it. When an **et_Invalid** Event is retrieved, the **ew_Invalid** file e*Way packages it as a text file and writes it to the specified location on the local file system.

- 3 The **ew_Valid** e*Way retrieves the valid data and publishes it to a location on the local file system.

The **col_Valid** in the **ew_Valid** subscribes to **et_Valid** Events published by **col_Monk**. When an **et_Valid** Event is retrieved, the **ew_Valid** file e*Way packages it as a text file and writes it to the specified location on the local file system.

5.3 Creating the Schema

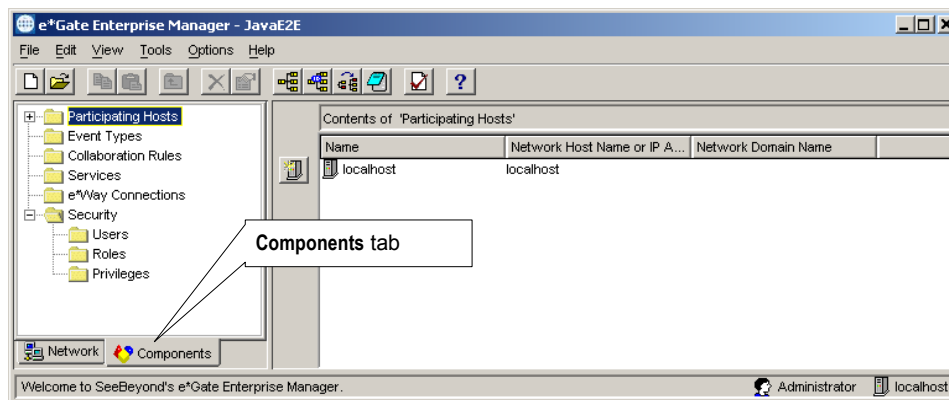
Before you start creating the schema, make sure that you have the following system requirements:

- e*Gate Registry Host, Participating Host, and GUIs installed on a single system
- The system is running the Windows operating system

To create the schema

- 1 Start the e*Gate Enterprise Manager and log in as **Administrator** (or another user with administrator privileges) to the appropriate Registry Host.
- 2 In the **Open Schema on Registry Host** dialog box, click **New**.
- 3 In the **Enter New Schema Name** box, type **MonkeE2E**, and click **Open**.
The Enterprise Manager displays the new **MonkeE2E** schema.
- 4 Click the **Components** tab. You perform all configuration steps in the **Components** tab.



5.4 Creating the Monk ETD and the Event Types

The ETD is created first using the Monk ETD Editor and then the three Event Types are created in the e*Gate Enterprise Manager.

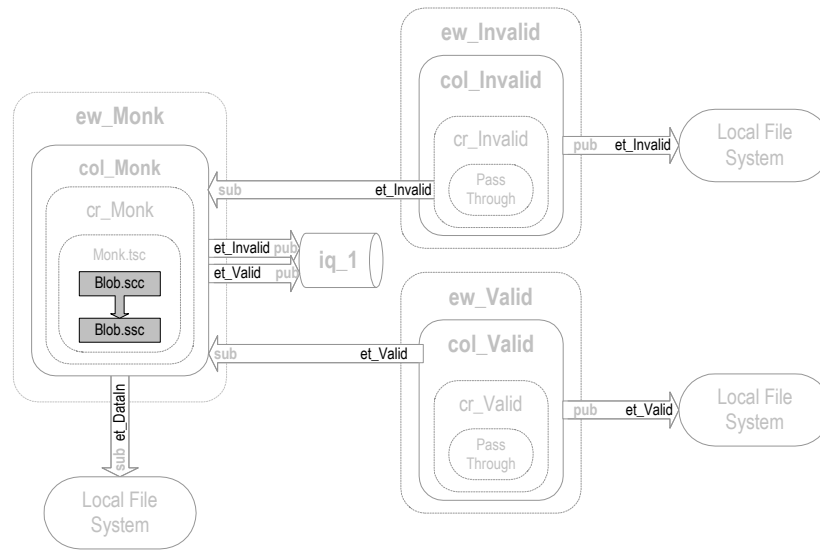
This scenario uses three Event Types that share one common Monk ETD called **Blob.ssc**. The Event Types are:

- **et_DataIn**
- **et_Invalid**
- **et_Valid**

Event Types group together similar Events. In this scenario, the similarity between the Events named by a particular Event Types is their routing. For example, all the Events routed to the **ew_Valid** e*Way use the Event Type **et_Valid**.

The sections below describe how you create the Monk ETD and the Event Types for the MonkeE2E schema.

The figure below shows where these parts fit into the schema.

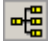




5.4.1 Creating the Blob.ssc ETD

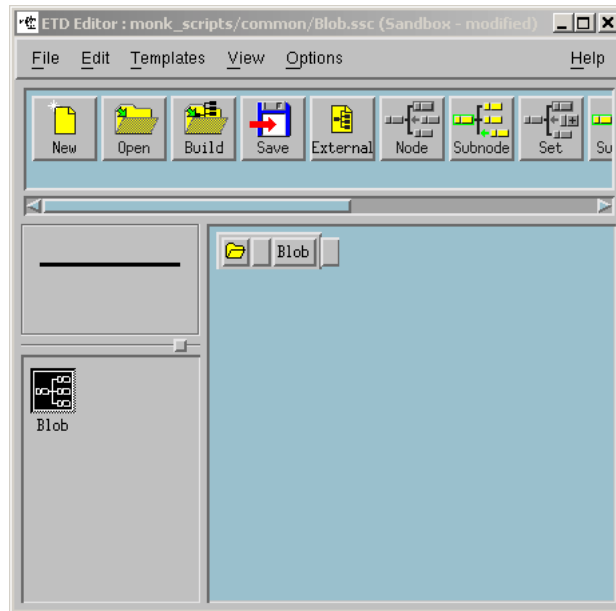
The procedure below describes how you create the Blob.ssc ETD. Before you start, you must have already created the MonkE2E schema as described in [“Creating the Schema” on page 72](#).

ETD structures can be complex, with many nodes and levels depending on the data type modeled. For simplicity and brevity, the data in this scenario has an uncomplicated structure with one node.

To create the Blob.xsc ETD

- 1 In the e*Gate Enterprise Manager, click **Default Editor** on the **Options** menu.
- 2 Click **Monk** if necessary and click **OK**.
- 3 On the toolbar, click **ETD Editor** .
- 4 In the ETD Editor, click **New**  on the toolbar.
- 5 In the **File name** box, type **Blob.ssc**. and click **OK**.
- 6 Click **Node**  on the toolbar.

This adds a single root node named Blob to the ETD work space as shown below.




- 7 On the **File** menu, click **Save**.
- 8 On the **File** menu, click **Close** to close the ETD Editor.

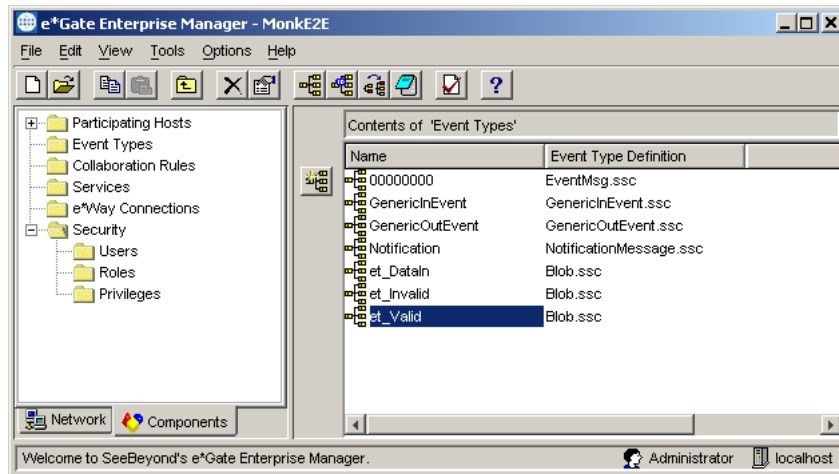
5.4.2 Creating the Event Types

The procedure below describes how you create the MonkE2E schema Event Types. The **et_DataIn** Event Type brings the data into e*Gate. The **et_Valid** Event Type routes data to the **ew_Valid** e*Way. The **et_Invalid** Event Type routes data to the **ew_Invalid** e*Way.

To create the Event Types

- 1 In the **Components** tab of the Enterprise Manager, click the **Event Types** folder.
- 2 Click **Create a New Event Type** .
- 3 In the **Name** box, type **et_DataIn** and click **OK**.
This adds **et_DataIn** to the Event Types pane.
- 4 In the Event Types pane, double-click **et_DataIn**.
The **Event Type - et_DataIn Properties** dialog box appears.
- 5 Click **Find**.
- 6 Double-click the **common** folder if necessary and double-click **Blob.ssc**.
- 7 Click **OK** to close the **Event Type - et_DataIn Properties** dialog box.
- 8 Repeat steps 1 through 7 to create the **et_Valid** and **et_Invalid** Event Types. Substitute **et_Valid** and **et_Invalid** for the Event Type name.

The Event Types pane now shows the newly created Event Types.



5.5 Creating the Collaboration Rules

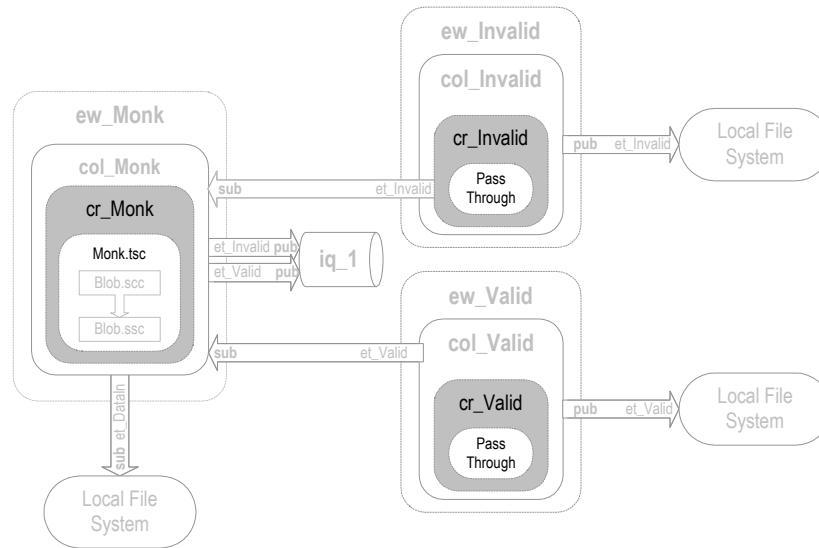
Collaboration Rules are used by the Collaborations that route the data. Collaborations that route data without change use Pass Through Collaboration Rules. Data that must be transformed in addition to being routed must use Collaboration Rules. These rules in turn use a Collaboration Service (programming environment) that allows data transformation.

e*Gate has several Collaboration Services such as Java, C, Monk, and others. The choice of a Collaboration Service depends on what you want to do with the data, as well as your available programming resources.

The Monk end-to-end scenario uses three Collaboration Rules:

- a Monk Collaboration Rules Component, **cr_Monk**, which sorts the data into valid and invalid Event Types
- two Pass Through Collaborations Rules, **cr_Invalid** and **cr_Valid**


The figure below shows where the Collaboration Rules fit into the schema.



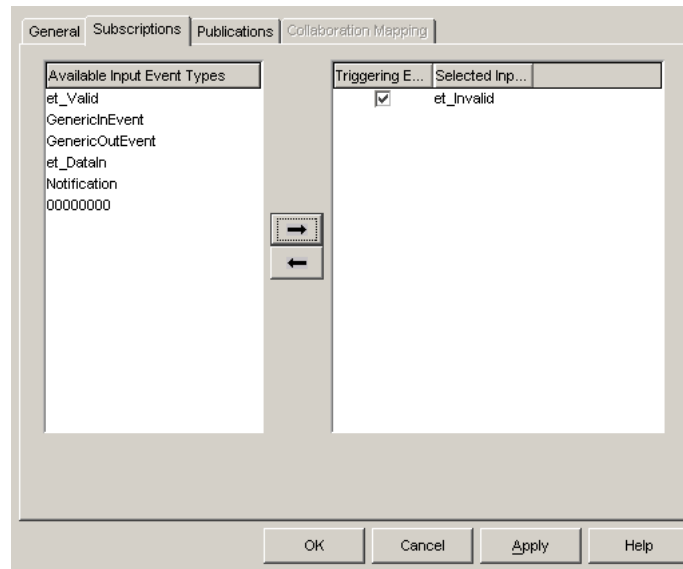
5.5.1 Creating the Pass Through Collaboration Rules

The procedure below describes how to create the **cr_Invalid** and **cr_Valid** Pass Through Collaboration Rules for the Monk scenario.

To create the Pass Through Collaboration Rules

- 1 In the **Components** tab of the e*Gate Enterprise Manager, click the **Collaboration Rules** folder.
- 2 Click **Create New Collaboration Rules** .
- 3 In the **Name** box, type **cr_Invalid** and click **OK**.
cr_Invalid displays in the Collaboration Rules pane.
- 4 Double-click **cr_Invalid** in the Collaboration Rules pane.
The **Collaboration Rules - cr_Invalid Properties** dialog box appears.
- 5 Click the **Subscriptions** tab.

- Under **Available Input Event Types**, click **et_Invalid**, and click the right arrow as follows.



- Click the **Publications** tab.
- Under **Available Output Event Types**, click **et_Invalid**, and click the right arrow.
- Click **OK** to close the **Collaboration Rules - cr_Invalid Properties** dialog box.
- Repeat steps 2 through 9 to create the **cr_Valid** Collaboration Rules component. Substitute **cr_Valid** for the Collaboration Rule name and substitute **et_Valid** for the Event Type.


5.5.2 Creating the cr_Monk Collaboration Rule Component

This section describes how you create the Collaboration Rules component **cr_Monk**. Creating **cr_Monk** consists of the following steps:

- Adding the component.
- Specifying the Collaboration Rules script.

Adding the cr_Monk Collaboration Rule Component

To add the **cr_Monk** Collaboration Rule component

- In the **Components** tab of the e*Gate Enterprise Manager, click the **Collaboration Rules** folder.
- Click **Create New Collaboration Rules** .
- In the **Name** box, type **cr_Monk** and click **OK**.
- Double-click **cr_Monk** in the Collaboration Rules pane.
- In the **Service** list in the **General** tab, click **Monk**.
- Click the **Subscriptions** tab.


- 7 Under **Available Input Event Types**, click **et_DataIn**, and click the right arrow.
- 8 Click the **Publications** tab.
- 9 Under **Available Output Event Types**, click **et_Invalid**, and click the right arrow.
- 10 Under **Available Event Types**, click **et_Valid**, and click the right arrow.
- 11 Click the **General** tab.
- 12 Under **Collaboration Rules**, click **New**.
- 13 In the **File name** box in the **New** dialog box, type **Monk.tsc**.
- 14 Verify that the other settings are **SeeBeyond Collaboration Rules (.tsc)** and **Blob.ssc** as the source ETD and destination ETD, and click **OK**.

The **Collaboration Rules Editor** window displays **Monk.tsc**. You can now add the **cr_Monk** Collaboration Rules script as described in the next section.

Specifying the cr_Monk Collaboration Rules Script

The procedure below describes how you specify the **cr_Monk** script to implement the business logic that validates the data. The data is valid if it is a number and invalid if it is not a number. You use the Monk scripting language to create the **cr_Monk** script.

To specify the **cr_Monk** Collaboration Rules script

- 1 In the **Collaboration Rules Editor** window, click **If**  on the toolbar.
An **If...Else** rule appears in the Rules pane.
- 2 Replace **<test>** in the condition portion of the **IF** rule with the following.

```
(number? (get ~input%Blob))
```

This tests whether the data in the input Event is a number.
- 3 Click the blue line below the **IF** line.
- 4 On the **Rules** menu, click **Add Function**.
- 5 In the **FUNCTION** line, replace **<Functions>** with the following.

```
(iq-put "et_Valid" (get ~input%Blob) (list "et_DataIn") 0 0 0)
```



This retrieves the input data and repackages it as an **et_Valid** Event Type and publishes it to an IQ using **iq-put**.
- 6 Click the blue line below the **ELSE** line.
- 7 On the **Rules** menu, click **Add Function**.
- 8 Replace **<Functions>** with the following.

```
(iq-put "et_Invalid" (get ~input%Blob) (list "et_DataIn") 0 0 0)
```

This retrieves the input data and repackages it as an **et_Invalid** Event Type and publishes it to an IQ using **iq-put**. The Rules pane shows the script as follows:

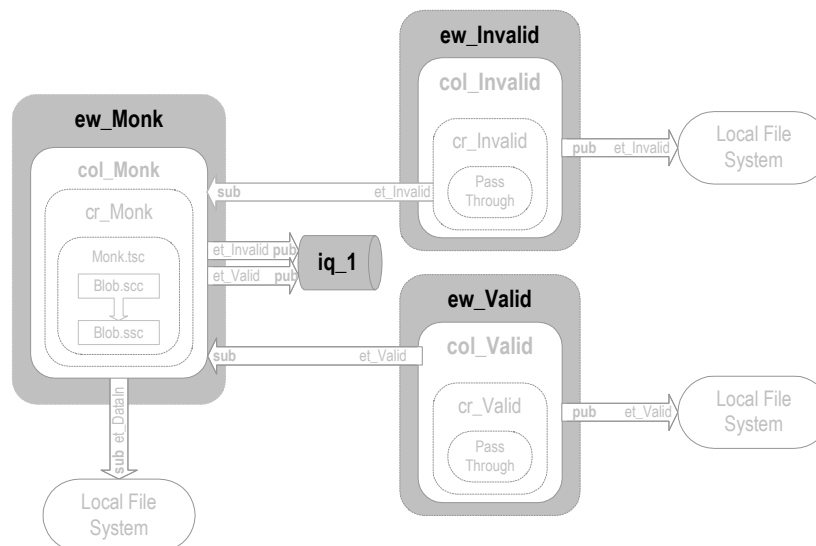

- **ew_Valid** e*Way
- **iq_1** IQ Manager



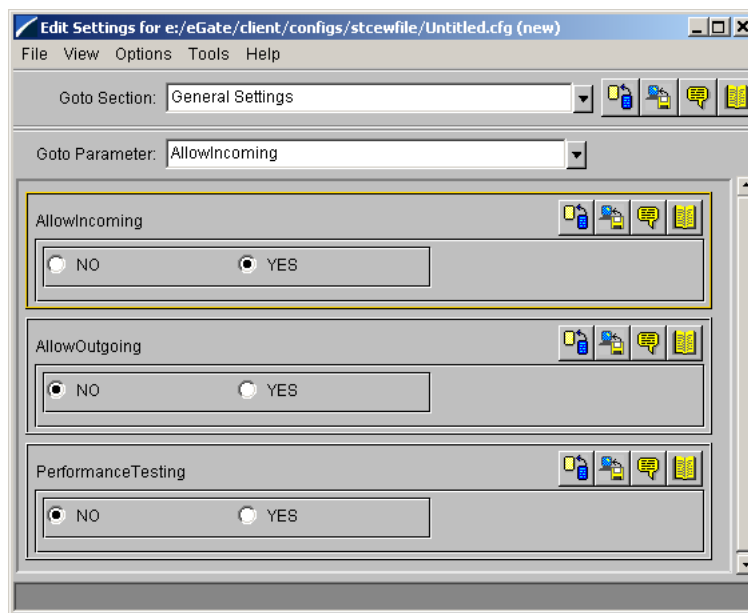
All e*Ways in the MonkE2E schema are File e*Ways. File e*Ways connect to external file systems to read and write files.

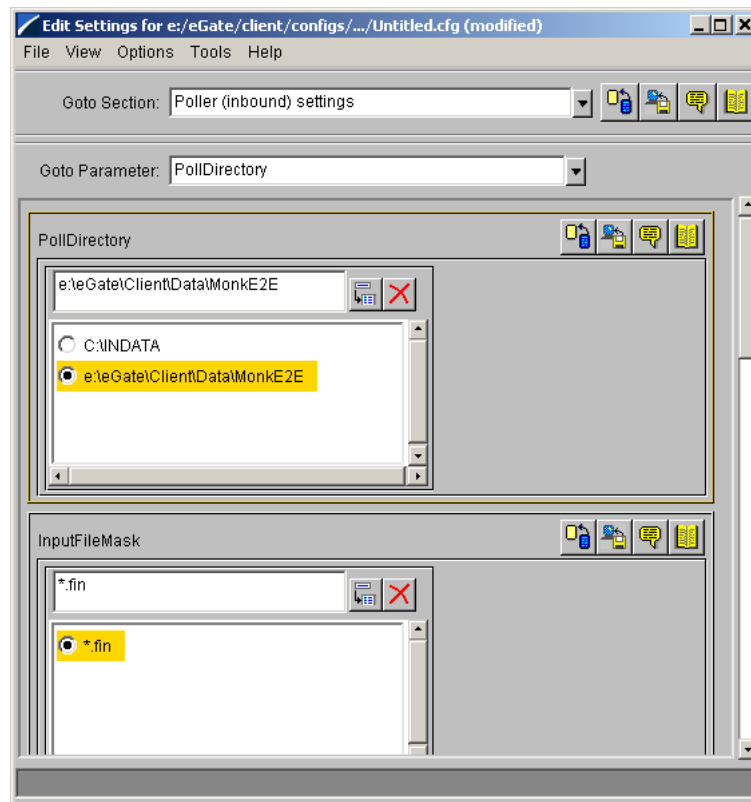

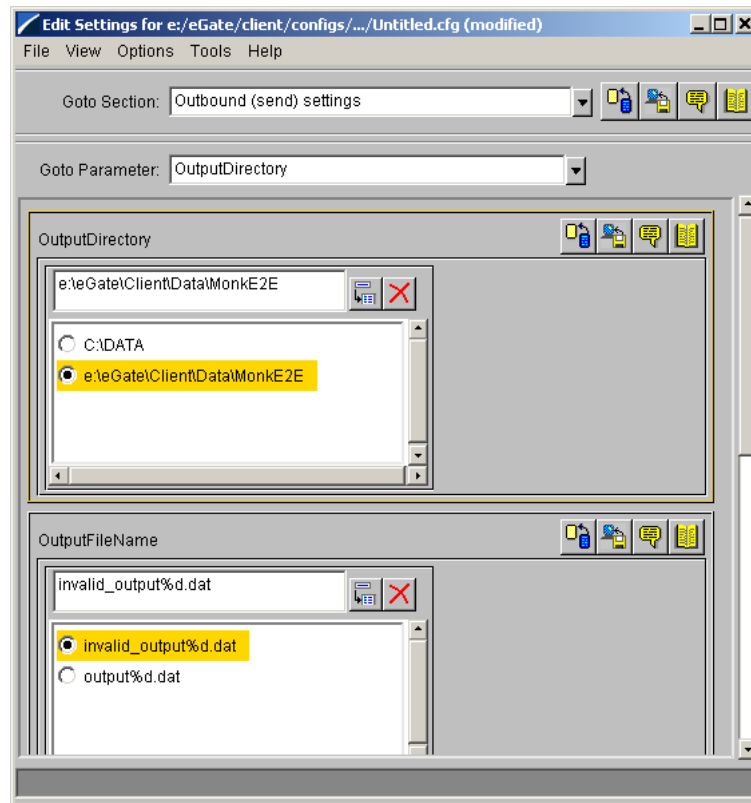

- 4 In the **OutputDirectory** box, type *drive:\eGatefolder\Client\Data\MonkE2E* and press ENTER.

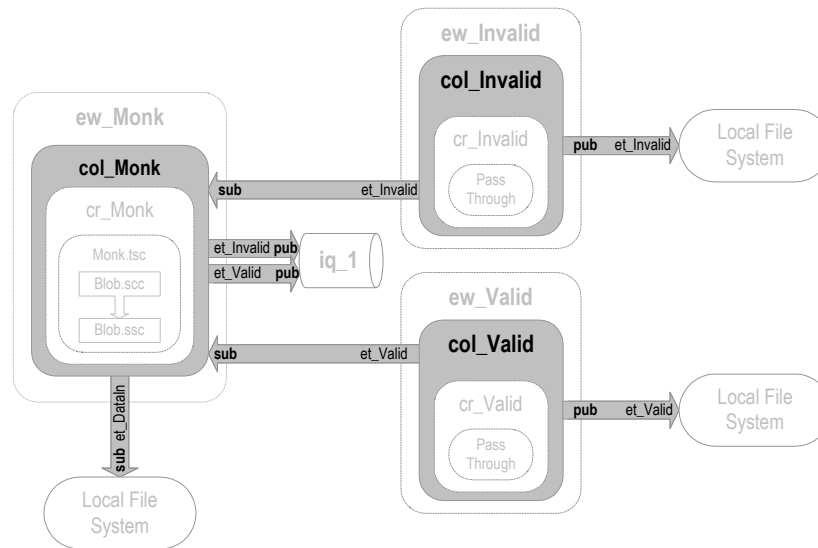

5.7 Adding the Collaborations

The Collaborations route the data through e*Gate. Typically, you configure the Collaborations in upstream to downstream order: the **col_Monk** Collaboration must be configured before configuring either the **col_Invalid** or **col_Valid** Collaborations.

5.7.1 Adding the col_Monk Collaboration

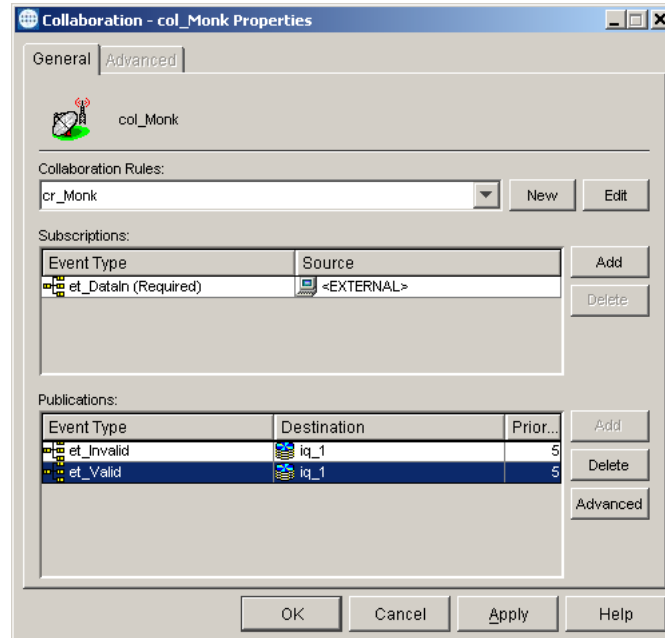
The procedure below describes how you add the **col_Monk** Collaboration. The **col_Monk** Collaboration brings the data into e*Gate and routes it depending on the whether the data is valid or invalid.

To add the **col_Monk** Collaboration

- 1 In the **Components** tab of the e*Gate Enterprise Manager, expand the **Participating Hosts** folder and the Control Broker (*hostname_cb*).
- 2 Click the **ew_Monk** e*Way.
- 3 Click **Create a New Collaboration** .
- 4 In the **New Collaboration Component** dialog box, type **col_Monk** and click **OK**.
- 5 Double-click **col_Monk**.
The **Collaboration - col_Monk Properties** dialog box displays.
- 6 In the **Collaboration Rules** list, click **cr_Monk**.
- 7 Under **Subscriptions**, click **Add**.
This adds a row to the **Subscriptions** area.
- 8 Click the row in the **Event Type** column and click **et_DataIn**.
- 9 Click the row in the **Source** column and click **<EXTERNAL>**.
- 10 If a message appears regarding journal expiration time, click **No**.
- 11 Under **Publications**, click **Add**.
- 12 In the **Event Type** column, click **et_Invalid**.
- 13 In the **Destination** column, click **iq_1**.

- 14 Under **Publications**, click **Add**.
- 15 In the **Event Type** column, click **et_Valid**.
- 16 In the **Destination** column, click **iq_1**.

The **Collaboration - col_Monk Properties** dialog box now displays as follows:




- 17 Click **OK** to close the **Collaboration - col_Monk Properties** dialog box.

5.7.2 Adding the col_Invalid Collaboration

The procedure below describes the **col_Invalid** Collaboration. The **col_Invalid** Collaboration subscribes to **et_Invalid** Events published by **col_Monk**. It publishes them to **<EXTERNAL>**.

To add the **col_Invalid** Collaboration


- 1 In the **Components** tab of the e*Gate Enterprise Manager, expand the **Participating Hosts** folder and the Control Broker (*hostname_cb*).
- 2 Click the **ew_Invalid** e*Way.
- 3 Click **Create a New Collaboration** .
- 4 In the **New Collaboration Component** dialog box, type **col_Invalid** and click **OK**.
- 5 Double-click **col_Invalid**.
- 6 In the **Collaboration Rules** list, click **cr_Invalid**.
- 7 Under **Subscriptions**, click **Add**.
- 8 Click the row in the **Event Type** column and click **et_Invalid**.
- 9 Click the row in the **Source** column and click **col_Monk**.
- 10 Under **Publications**, click **Add**.

- 11 In the **Event Type** column, click **et_Invalid**.
- 12 In the **Destination** column, click **<EXTERNAL>**.
- 13 Click **OK** to close the **Collaboration - col_Invalid Properties** dialog box.

5.7.3 Adding the col_Valid Collaboration

The procedure below describes how you add the **col_Valid** Collaboration. The **col_Valid** Collaboration subscribes to **et_Valid** Events published by **col_Monk**. It publishes them to **<EXTERNAL>**.

To add the **col_Valid** Collaboration

- 1 In the **Components** tab of the e*Gate Enterprise Manager, expand the **Participating Hosts** folder and the Control Broker (*hostname_cb*).
- 2 Click the **ew_Valid** e*Way.
- 3 Click **Create a New Collaboration** .
- 4 In the **New Collaboration Component** dialog box, type **col_Valid** and click **OK**.
- 5 Double-click **col_Valid**.
- 6 In the **Collaboration Rules** list, click **cr_Valid**.
- 7 Under **Subscriptions**, click **Add**.
- 8 Click the row in the **Event Type** column and click **et_Valid**.
- 9 Click the row in the **Source** column and click **col_Monk**.
- 10 Under **Publications**, click **Add**.
- 11 In the **Event Type** column, click **et_Valid**.
- 12 In the **Destination** column, click **<EXTERNAL>**.
- 13 Click **OK** to close the **Collaboration - col_Valid Properties** dialog box.

5.9 Creating the Input Data File

Follow the procedure below to create the sample input data file. The schema uses this file to bring data into e*Gate.

To create the input data file

- 1 Use a text editor such as Notepad to create a text file with the following information:

```

error
```

The Collaboration Rule used by the **ew_Monk** e*Way tests the data for validity. The data contains both valid (numeric) and invalid data (characters) for the test.

- 2 In Windows Explorer, open the *drive*:\eGatefolder\Client folder, where *drive* is the drive where e*Gate is installed and where *eGatefolder* is the folder where e*Gate is installed. For example: c:\eGate\Client.
- 3 In the **Client** folder, create a folder named **Data**.
- 4 Open the data folder and create a folder named **MonkE2E**.
- 5 Save the file as **MonkE2Einput.txt**.

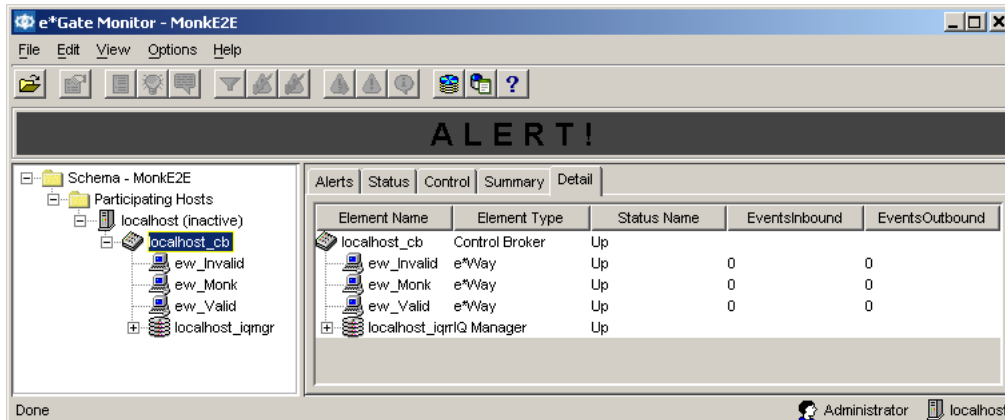
5.10 Starting the Schema

- 1 Use the following command to start the Control Broker from a command line.

```
stccb.exe -rh hostname -rs MonkE2E -ln hostname_cb -un username -
up password
```

- 2 Start the e*Gate Monitor and open the **MonkE2E** schema.
- 3 Expand the **Schema - MonkE2E** folder, the **Participating Hosts** folder, and then click the Control Broker (*hostname_cb*).

- Verify that all the components are running by checking that the Status Name for each component lists **Up** as shown in the screen below.



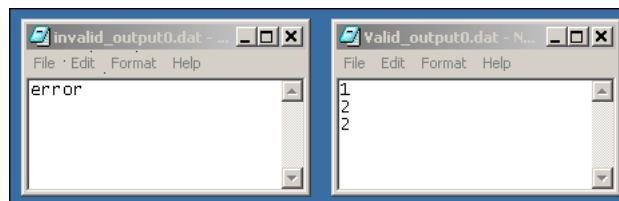
5.11 Testing the Schema

To test the schema

- In Windows Explorer, open the *drive*:\eGatefolder\Client\Data\MonkE2E folder, where *drive* is the drive where e*Gate is installed and where *eGatefolder* is the folder where e*Gate is installed. For example: c:\eGate\Client\Data\MonkE2E.
- Change the file extension of **Monke2Einput.txt** to **.fin**.
- Click **Yes** when the confirmation message appears.
- Verify that the extension changes to **~in** indicating that the **ew_Monk** e*Way retrieved the file.

Almost immediately, the **Invalid_output0.dat** and **Valid_output0.dat** output files appear in the folder, indicating the schema ran successfully.

- Verify that the output files contain the information shown in the screen below.



5.12 Troubleshooting

If you do not get the expected results, do the following:

- Double-check your schema. Use the table at [“Reviewing the Complete Schema” on page 87](#). Make sure that you created and configured all the components as directed in the instructions.
- Use the e*Gate Monitor to confirm that all of the components are running; manually start any that may not have started correctly.
- If a component starts successfully but halts immediately, the most likely cause is misconfiguration. Check the following:
 - ♦ Does each e*Way have an executable file and a configuration file associated with it?
 - ♦ Does each Event Type have an ETD file assigned?
 - ♦ Do the validating Collaboration Rules have the Monk service assigned, and the proper Collaboration Rules file both created and assigned?
 - ♦ Is the IQ Manager running, and did you configure both IQs?
- If all of the components start and stay running, the most likely problem is that the validation logic in the **Inbound** e*Way’s Collaboration Rules script is not working properly. Use the Collaboration Rules Editor and check that you have created the file in accordance with the procedure in [“Creating the cr_Monk Collaboration Rule Component” on page 78](#).

If you encounter a problem and are unable to solve it with [“Reviewing the Complete Schema” on page 87](#), refer to [“Debugging and Log Files” on page 92](#) to start the trace or error log component in your schema.

Debugging and Log Files

One of the easiest ways to debug your e*Gate configuration is through the use of log files. All executable components—BOBs, e*Ways, IQ Managers, and Control Brokers—have the ability to create log files that contain whatever level of debugging information you select.

6.1 Where To Find Log Files

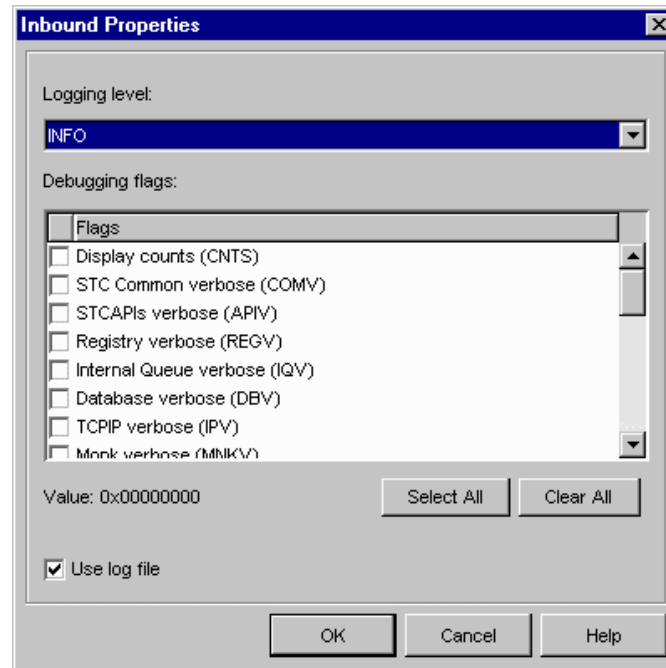
All log files are stored in the `\eGate\client\logs` directory on the Participating Host running the elements that generate the log entries. Logs are named after the component that creates them; for example, the component **Inbound_eWay** creates a log file called **Inbound_eWay.log**.

6.2 Generating Log Files

To configure a component to generate a log file:

- 1 In the e*Gate Enterprise Manager window, select the component that you want to configure and display its properties.
- 2 Select the **Advanced** tab, then click **Log**.
- 3 Select the desired logging options (see [Figure 1 on page 93](#)).

Figure 1 Logging Options



You can view a component’s log using any text editor, and you can view the log while the component is still running. However, depending on the editor, you may need to re-read the file to “refresh” your view of the log data. You cannot get log updates “on the fly.”

The most common error most first-time e*Gate developers will find in a log file is, “Unable to load module configuration.” This message means that you have created an e*Gate component but not assigned both an executable file and a configuration file to it.
