Oracle Business Process Management Suite (Oracle BPM Suite) Overview

This chapter provides a general overview of the Oracle BPM Suite, explains Oracle BPM user personas, Oracle BPM components, integration with Oracle Business Process Analysis (BPA) Suite, and the development lifecycle of a process. Finally, it describes typical uses cases of the Oracle BPM Suite from process modeling to run time.

1.1 Introduction to the Oracle BPM Suite

The Oracle BPM Suite provides an integrated environment for developing, administering, and using business applications centered around business processes.

The Oracle BPM Suite provides the following:

- Enables you to create process models based on standards with user friendly applications. It enables collaboration among process developers and process analysts. Oracle BPM supports BPMN 2.0 and Business Process Execution Language (BPEL) from modeling and implementation to run time and monitoring.
- Enables process analysts and process owners to customize business processes and Oracle Business Rules.
- Provides a web-based application for creating business processes, editing Oracle Business Rules, and task customization using predefined components.
- Expands business process management to include flexible, unstructured processes. It adds dynamic tasks and supports approval routing using declarative patterns and rules-driven flow determination.
- Enables collaboration provided by Oracle Business Process Management Process Spaces, which drives productivity and innovation.
- Unifies different stages of the application development life cycle by addressing end-to-end requirements for developing process-based applications. Oracle BPM

unifies the design, implementation, run time, and monitoring stages based on an Service Component Architecture (SCA) infrastructure. This allows different personas to participate through all stages of the application life-cycle.

See Section 1.2, "Oracle BPM User Personas" for more information about the user personas defined for the Oracle BPM Suite.

The Oracle BPM Suite provides a seamless integration of all stages of the application development life cycle from design time and implementation to run time and application management.

The Oracle BPM Suite is layered on the Oracle SOA Suite and shares many of the same product components, including:

- **Business Rules**
- **Human Workflow**
- Oracle Adapter Framework for Integration

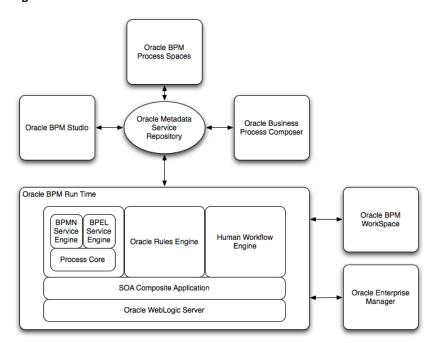


Figure 1-1 The Oracle BPM Suite

Figure 1–1 shows a high-level architectural view of the Oracle BPM Suite.

1.2 Oracle BPM User Personas

Different stages of application development life cycle require interaction from different types of users. Table 1–1 outlines typical users of Oracle BPM Suite and their responsibilities. It also lists the components of the Oracle BPM they would use to perform their work.

These user personas are used within the examples in this guide.

Table 1-1 Oracle BPM User Persona

User Persona	Description		
Process analyst	Process analysts are responsible for creating the initial flow of a business process and documenting its steps. This also includes identifying and defining the Key Performance Indicators (KPIs) and high-level rules that define the routing artifacts of the business process. This persona can also perform simulations to calculate and estimate the return on investment.		
	Process analysts typically use the Oracle Business Process Analysis Suite or Business Process Composer to create process models. They can also use process analyst role within Oracle BPM Studio.		
Process developer	Process developers are responsible for implementing the process models created by process analysts. Each step in the process requires an implementation. The process developer is responsible for integrating the business process with back-end applications such as databases.		
	Process developers typically use Oracle BPM Studio to model and implement the components of a business application. They may occasionally use Oracle Business Process Composer (Business Process Composer) for modeling basic processes.		
Business administrator	Business administrators are responsible for administering the BPM infrastructure. Typical activities include the installation and setup of BPM environments and the overall management of the Oracle BPMN Service Engines that are hosting the business processes.		
	This persona can be delegated the responsibilities for administering the organizational assets such as users, groups, organization units, calendars and holidays.		
	The main tool used by business administrators is the Oracle Enterprise Manager and automated tools such as Ant. Business administrators also use Oracle Business Process Management Workspace (Process Workspace) to manage organization units, role assignments and perform other activities like creating workflow advanced routing declarations		
Process owner	Process owners are responsible for controlling and managing deployed business processes. They are responsible for the overall supervision of the running business process. They often use metric analysis tools such as dashboards to understand the current state of the managed business processes.		
	Process owners typically use Process Workspace. They also use Business Process Composer to change the behavior of a process by editing Oracle Business Rules. They may also use the Oracle BAM console to view metrics dashboards.		
Process participant	Process participants are the people who use the business applications created with the Oracle BPM Suite.		
	Process participants typically use Process Workspace or Process Spaces.		

1.3 Oracle BPM Suite Components

This section provides a general description of the major components of the Oracle BPM Suite. See Section 1.5, "Introduction to the Application Development Life Cycle" for information about how these components interact within the application development process.

1.3.1 Process Modeling and Implementation

This section describes the applications and components used to model and implement business processes and process-based business applications.

The Oracle BPM Suite provides two primary applications for modeling and implementing business processes: Oracle BPM Studio and Oracle Business Process Composer.

Note: Oracle BPM can also integrate business processes created using the Oracle Business Process Analysis Suite. See Section 1.4, "Oracle Business Process Analysis (BPA) Suite" for more information.

1.3.1.1 Oracle BPM Studio

Oracle BPM Studio is a component of the Oracle BPM Suite that provides a user friendly environment where process analysts can design business process models and run process simulations. Oracle BPM Studio supports Business Process Management Notation (BPMN) 2.0.

Oracle BPM Studio also enables process developers to create working process-based applications. These applications are Oracle BPM projects that are integrated as Service Integration composite applications.

You can use Oracle BPM Studio to implement business processes with other Oracle components such as adapters, human workflow and business rules. You can then deploy these processes to Oracle BPM run time.

Oracle BPM Studio is a part of the Oracle JDeveloper IDE. Oracle BPM Studio enables IT users to use a single integrated tool to model and edit business processes, implement the required IT elements, and deploy applications to the run-time environment.

Oracle BPM Studio also provides a BPM role that enables business users to use a simplified version of Oracle JDeveloper that displays only functionality relevant to process design.

See the Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business *Process Management* for more information.

1.3.1.2 Oracle Business Process Composer (Business Process Composer)

Business Process Composer is a Web-based application that enables business users to collaborate with process developers and designers. It provides a user friendly environment for editing processes and process templates created in Oracle BPM Studio.

Process developers can create a catalog of preconfigured components such as services, tasks, and rules in Oracle BPM Studio. This catalog can be included in project templates that process analysts can use to create new projects using Business Process Composer.

After creating a project based on a project template, process analysts can incorporate business catalog elements and perform other required edits defined by the project template. Process analysts can then deploy these project to the Oracle BPM run time.

Business Process Composer also enables process analysts to create process blueprints. These are initial drafts of a process that can be used by process developers who use Oracle BPM Studio to add further implementation details and refinement to the project.

Business Process Composer also enables you to edit Oracle Business Rules at run time. This is important because policies tend to evolve faster than business processes.

See the Oracle Fusion Middleware Business Process Composer User's Guide for Oracle Business Process Management and Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management for more information.

1.3.1.3 Oracle Metadata Service (MDS) Repository

MDS provides a repository that is used to store data about applications deployed within an Oracle Fusion Middleware environment. Oracle BPM uses this repository, called Oracle Business Process Management Metadata Store, to store information about deployed applications.

Oracle BPM also uses a separate MDS partition to share projects and project templates between process analysts and process developers. Figure 1–1, "The Oracle BPM Suite" shows how the MDS repository fits within the overall Oracle BPM architecture.

1.3.1.4 Oracle BPM Projects

Oracle BPM projects are containers for the business processes and related resources used to create a process-based business application. An Oracle BPM project can contain the following:

- Organizational data
- Activity guides
- BPMN process models
- Business catalog
- Simulation models
- Other resources

Oracle BPM projects are deployed at run time as Service Integration composite applications. For more information on working with projects and Service Integration composite applications see the following documentation:

- "Working with Projects and Project Templates" in Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management
- "Working with Projects and Project Templates" in Oracle Fusion Middleware Business Process Composer User's Guide for Oracle Business Process Management
- Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite

1.3.2 Oracle BPM Run Time Components

Oracle BPM Run Time is responsible for controlling deployed applications. Oracle BPM run time includes the following components:

1.3.2.1 Oracle BPM Engine

The Oracle BPM Engine provides a run-time environment for running business processes. It provides native support for both BPMN and BPEL processes.

The BPM engine is composed of three separate components:

- **BPMN** Engine The BPMN engine provides an environment for running BPMN processes.
- **BPEL Engine**

The BPEL engine provides an environment for running BPEL processes.

Process Core

The Process Core provides engine functionality that is shared by the BPMN and BPEL engines. Some of the key functionality performed by the process core includes:

- Manage security
- Generate audit trails
- Invoke services
- Manage persistence

1.3.2.2 Oracle Human Workflow

Many end-to-end business processes require human interactions with the process. For example, humans may be needed for approvals, exception management, or performing activities required to advance the business process. The human workflow service provides features such as:

- Task routing to users, groups or application roles.
- Deadlines, escalations, notifications, and other features required for ensuring the timely performance of a task.
- Task forms for presentation of tasks to end users through a variety of mechanisms, including a workspace and portals.
- Organization, filtering, prioritization, dispatching rules and other features required for end users to productively perform their tasks.

1.3.2.3 Oracle Business Rules

Oracle Business Rules are a component of the Oracle SOA Suite that enable dynamic decisions at run time allowing, among other features, applications to rapidly adapt to regulatory and competitive pressures. This increased agility is possible because process analysts using Oracle Business Rules can create and change business rules that are separated from the application code. By using Oracle Business Rules, process analysts can change business rules without stopping business processes. Also, externalizing business rules enables process analysts to manage business rules directly, without involving process developers.

1.3.2.4 Oracle WebLogic Server

Oracle WebLogic Server is an application server that provides a platform for creating and running J2EE-compliant applications.

1.3.2.5 Oracle Enterprise Manager

The Oracle Enterprise Manager is a Web-based application that enables system administrators to control and manage applications running on the Oracle SOA Suite. Enterprise Manager enables business administrators to configure and manage business applications and process instances.

1.3.3 Oracle BPM Suite Process Participant Applications

The following sections describe the components of the Oracle BPM Suite that are used by process participants to perform their day-to-day work. These applications enable

process participants to interact with running business applications managed by Oracle BPM run time.

1.3.3.1 Oracle Business Process Management Workspace (Process Workspace)

Process Workspace enable process participants to interact with the applications you create using Oracle BPM. The Process Workspace user interface provides tabs for each of the following:

- Tasks: This page enables process participants to view and work with their assigned tasks.
- **Process Tracking**: This page enables process participants to view running process instances.
- Standard Dashboards: This page provides out-of-the-box dashboards for monitoring process performance, task performance, and workload.
- **Custom Dashboards**: This page enables process participants to define and use custom dashboards based on the measurement data generated by process instances.

Process Workspace also enables business administrators to configure and maintain organizations and roles. See the Oracle Fusion Middleware User's Guide for Oracle Business Process Management for more information.

1.3.3.2 Oracle Business Process Management Process Spaces (Process Spaces)

Process Spaces is a collaborative workspace built on top of Oracle WebCenter PortalSpaces and enables more productive BPM by increasing collaboration.

See the Oracle Fusion Middleware User's Guide for Oracle Business Process Management for more information.

1.3.4 Other Oracle BPM Suite Components

The following sections describe other components of the Oracle BPM Suite.

1.3.4.1 Process Analytics

Business Process Analytics enables process participants to monitor the performance of running process-based applications. It measures the key performance indicators defined in a BPM project and stores them in a database. Process participants and analysts can view the metrics stored in the process analytics databases using Process Workspace dashboards or Oracle BAM.

1.3.4.2 Guided Business Processes

Guided Business Processes enable process analysts and developers to group the interactive activities in your BPM process into a set of milestones that are meaningful to the process participants. They outline the steps the process participants must complete, hiding the complexity of the business process.

1.4 Oracle Business Process Analysis (BPA) Suite

The Oracle Business Process Analysis Suite is a separate Oracle product suite based on the Aris platform from IDS Scheer. It provides comprehensive modeling, analysis, and

simulation capabilities for enterprise wide business processes. It also supports capturing business architecture artifacts such as strategic objectives, goals, higher level KPIs, risks and controls, and conceptual models such as value chain diagrams.

Additionally, the Oracle Business Process Analysis Suite supports the following:

- Alignment of business processes with a business strategy.
- Service discovery and linking to business processes. Drives service requirements for the Oracle SOA Suite.
- Loading and creating simulation scenarios which enable you to determine optimal resource allocation. Simulation enables you to perform throughput analysis, activity based costing, and resource utilization. Additionally, you can create simulation analysis reports for easy analysis of simulation results.
- Comprehensive version management including check-in, check-out, and change management capabilities.

The business architecture defined by the Oracle Business Process Analysis Suite is the formal link between strategic objectives and the actual business applications created using Oracle BPM. The Oracle Business Process Analysis Suite supports modeling of business architecture artifacts such as strategy maps, goals, objectives, risk and controls and linking them to business processes.

This provides the ability to prioritize efforts, justify decisions, and trace activities of the business process improvement initiatives to strategic goals of the business, hence improving business and IT alignment. It provides tremendous value because it offers a clear understanding of which BPM projects to undertake, which processes are currently most strategic to the company, and which services are most aligned with the business strategy.

The Oracle Business Process Analysis Suite complements the functionality of the Oracle BPM Suite by adding orthogonal dimensions to the modeling phases including organization goals. See the Oracle BPA Quick Start Guide for more information.

Processes created in the Oracle Business Process Analysis Suite can be imported into the Oracle BPM Suite. Using Oracle BPM Studio, you can integrate your business process with other Oracle technologies including adapters, business rules, and human tasks.

See the Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management for more information on using business processes created in Oracle Business Process Analysis within Oracle BPM Studio.

1.5 Introduction to the Application Development Life Cycle

This section outlines the stages of the development life cycle of an Oracle BPM application. It describes how different components of Oracle BPM are used within each stage.

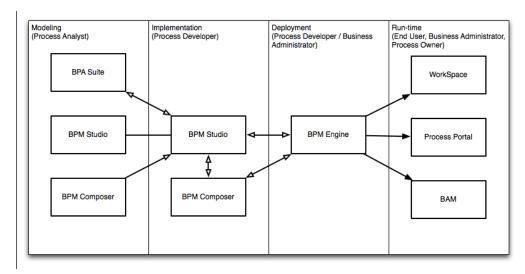


Figure 1–2 Stages of the Oracle BPM Application Development Life Cycle

Figure 1–2 lists the four stages of the application development life cycle, the user personas applicable to each stage, and the Oracle BPM tools and applications that are used.

1.5.1 Process Modeling

The first stage of the application development life cycle is process modeling. During this stage a process analyst creates process models based on real-word business processes and problems.

Oracle BPM provides three distinct tools for modeling business processes. Each tool has a different role within the Oracle BPM Suite. The tool you use depends on your business requirements, the stage of the application development cycle, and your user persona.

Oracle BPM Studio

Oracle BPM Studio runs on the Oracle JDeveloper IDE platform. Oracle BPM Studio provides a process analyst role that displays a simplified set of JDeveloper functionality that focuses on designing process models.

Oracle BPM Studio enables process analysts and process developers to design and implement detailed process flows that are deployed to Oracle BPM run time and run as working applications. Additionally, detailed process flows from Oracle Business Process Analysis Suite or Business Process Composer can be brought inside Oracle BPM Studio for further implementation, then deployed to the Oracle BPM run time.

Oracle Business Process Composer

Business Process Composer is a collaboration tool that enables process analysts to collaborate with process developers.

Oracle Business Process Analysis Suite (BPA)

The Oracle Business Process Analysis Suite enables you to create robust models of your business processes from high-level models of your entire organization down to lower level business processes that you can implement as running processes.

See Section 1.6, "Oracle BPM Use Cases" for more information about how each of these tools fit within the typical Oracle BPM uses cases. See Oracle Fusion Middleware Business Process Composer User's Guide for Oracle Business Process Management and Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management for more information about how Business Process Composer and Oracle BPM Studio interact within the application development life cycle.

1.5.2 Implementation

After process analysts model business processes, process developers are responsible for creating business applications based on these models. Using Oracle BPM Studio, process developers implement reusable services and integrate other business systems.

Implementation may include the following types of tasks generally performed by process developers:

- Data mapping and transformation
- System fault handling
- Designing and implementing user interfaces using Oracle Human Workflow
- **Designing Oracle Business Rules**
- Creating dashboards

After a process developer finishes the implementation, the application is compiled and deployed like other Service Integration composite applications. It can be compiled and deployed using Oracle BPM Studio.

1.5.3 Deployment

Deployment is the process of transferring an Oracle BPM project from the development environment to the run-time environment. This can be either a testing or production run-time environment.

After finishing the integration of business processes with back-end systems and reusable services, process developers create and compile a working process-based application. This application is then deployed to Oracle BPM Run Time.

Oracle BPM Suite contains the following typical scenarios for deploying to Oracle **BPM Run Time:**

Deployment directly from Oracle BPM Studio

Applications created with Oracle BPM can be deployed directly to the run-time environment like any other Service Integration composite application. This is typically performed by a process developer using Oracle BPM Studio within a test or development environment.

See the Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite for more information about deploying Service Integration composite applications.

Deployment directly from Business Process Composer

Oracle BPM enables you to deploy projects created from project templates directly to the same run time environment where Business Process Composer is installed. When creating a project, you can specify an approval workflow that must be completed before the project is deployed.

You can deploy from Business Process Composer when it is installed in the same server infrastructure as Oracle BPM Run Time. This enables process analysts to deploy and test process-based business applications. The is generally done in a testing environment.

Deployment using an exported SAR file

Oracle BPM Studio and Business Process Composer enable you to export applications using a SAR file. The SAR file can be deployed to a run time environment by business administrators using Oracle Enterprise Manager.

In a production environment, this is generally how applications are deployed.

Deployment Using the WebLogic Scripting Tool (WLST) Oracle BPM provides customized WLST commands for managing and deploying Oracle BPM projects.

1.5.4 Oracle BPM Run Time

After an application is deployed, the run-time environment makes the Oracle BPM application available to process participants based on the roles assigned in the organization where the business processes were deployed. This stage is divided into these distinct functions:

User interaction

Process participants and process owners are responsible for interacting with the running application using Process Workspace.

Process analysts and owners can also monitor the process and revise Oracle Business Rules at run time using Business Process Composer.

Process management and monitoring

Process owners are responsible for monitoring and maintaining running processes using Process Workspace. Process analysts and owners use Oracle Business Process Analysis to monitor the real-time performance of business processes.

Process creation

Process participants who have the necessary permissions can create new processes using Oracle BPM Workspace or Oracle Process Spaces

System administration

Business administrators are responsible for maintaining running business applications and the overall run-time infrastructure using Oracle Enterprise Manager and the Oracle WebLogic Server administration console.

1.6 Oracle BPM Use Cases

This section describes typical uses cases of the Oracle BPM Suite from process modeling to run time.

1.6.1 Use Case: Using Oracle BPM Studio to Create Project Templates

This use case involves using Oracle BPM Studio to create project templates. These templates are used by process analysts to create new projects using Business Process Composer.

Typical Workflow for Using Oracle BPM Studio to Create Project Templates

- Determine the business requirements (process analyst).
- Model the required business processes using Oracle BPM Studio (process analyst or process developer)
 - A process analyst can use the Process Analyst role in Oracle JDeveloper.
- 3. Implement the processes by integrating each element of the process with back-end systems and reusable services (process developer).
- **4.** Create a project template using Oracle BPM Studio (process developer)

- **5.** Publish the project template to the Oracle BPM MDS repository (process developer).
- **6.** Create a new Oracle BPM project based on a project template (process analyst).
- 7. Implement the required reusable services defined by the project template (process analyst).
- Deploy the project to Oracle BPM run time (process analyst).

1.6.2 Use Case: Using Oracle BPM Studio to Model Processes and Deploy an **Application**

This use case involves using Oracle BPM Studio to create process models. These models are used to create working business applications that are deployed to the Oracle BPM Run Time.

Typical Workflow for Using Oracle BPM Studio to Model Processes

- 1. Determine the business requirements (process analyst).
- 2. Model the required business processes using Oracle BPM Studio (process analyst or process developer)
 - A process analyst can use the Process Analyst role in Oracle JDeveloper.
- **3.** Run a simulation to test and improve process performance. (process analyst / process developer).
- 4. Implement the processes by integrating each element of the process with back-end systems and reusable services (process developer).
- **5.** Compile the Oracle BPM project as a composite application (process developer).
- **6.** Deploy the application to the run-time environment (process developer, business administrator).
- 7. Interact with the deployed processes as part of a running business application (process participants, process owner).
- Maintain and monitor the running process-based applications (business administrator, process owner).

1.6.3 Use Case: Using Business Process Composer to Create Process Blueprints

This use case involves creating process blueprints using Business Process Composer. These blueprints are then shared with process developers who import them into Oracle BPM Studio, where they perform further refinement and implementation.

Typical Workflow for Using Business Process Composer to Create Process **Blueprints**

- 1. Create process blueprints using Business Process Composer (process analyst).
- Provide implementation details for the business process and prepare the process-based business application for deployment (process developer).
- **3.** Create project templates and publish them to the Oracle BPM Metadata Store repository using Oracle Business Process Management Studio (process developer).
- **4.** Create a project based on a the project template (process analyst).
- 5. Edit the project as defined by the edit policies of the project template (process analyst).

6. Deploy the project to Oracle BPM Run Time (process analyst, process administrator).

1.6.4 Use Case: Using Business Process Composer to Revise Oracle Business Rules

This use case involves using Business Process Composer to edit Oracle Business Rules at run time. After an application is deployed, process analysts and owners can open the deployed project and edit Oracle Business Rules.

Typical Workflow for Using Process Composer to Revise Oracle Business Rules

- Model a set of business processes (process analyst).
- Implement and deploy an application (process developer).
- Edit the Oracle Business Rules at run time using Business Process Composer. (process owner).

1.6.5 Use Case: Using the Oracle Business Process Analysis Suite to Model Your **Business Processes**

This use case involves using the Oracle Business Process Analysis Suite to model your business processes. These processes can be imported into Oracle BPM Studio.

Typical Workflow for Using the Oracle Business Process Analysis Suite and **Oracle BPM Suite to Model Processes**

- Determine the business requirements (process analyst).
- 2. Design your business architecture by capturing strategic objectives, process maps, value chain diagrams using Oracle Business Process Analysis (process analyst).
- **3.** Perform strategic analysis to determine potential process candidates for Oracle BPM projects. (process analysts)
- Design detailed process flows for the process candidates identified previously (process analyst)
- 5. Import your process models into Oracle BPM Studio (process analyst, process developer).
- **6.** Implement the processes by integrating each process component with back-end systems and reusable services (process developer).
- **7.** Deploy the business processes, as a BPM project, to the run time environment (process developer, business administrator).
- **8.** Interact with the deployed processes as part of a business application (process participant, process owner)
- Maintain the processes (business administrator, process owner)

Process Workspace is a customizable web-based interface enabling users to access and manage tasks and process instances according to their roles and responsibilities.

2.1 Understanding Process Workspace

Table 2–1 lists and describes the users for whom Process Workspace is designed.

Table 2–1 Users of Oracle Business Process Management Workspace

User Profile	Description
Process Participants	This is the most basic profile, common to all users. It enables you to:
	 Organize, find, claim, and perform work assigned or delegated either to you or to your group
	 Delegate work to another user
	 Create and manage personal rules—for example, whom to send tasks to when you are on vacation
	 Define and share views
	 Manage personal preferences
	 View reports and dashboards
	These users may be spread throughout the organization or work outside the company.
	A process participant may be one who not only initiates the process, but can also track its progress and, if appropriate, withdraw it.

User Profile	Description
Process Owners	Users who manage one or more business process. They act on tasks belonging to the process but assigned to other users, in addition to their own end-user access. They want to know how process instances are moving in those processes. To get this perspective, they typically use dashboards.
	These users usually reside on the business side of the house as part of the operations organization. They may also be supervisors.
Administrators	Includes two types of administrative users:
	Business administrators: Users responsible for administering Process Workspace—for example, adding mapped attributes, changing the look and feel, or ensuring that the web application is both running and accessible. Administers tasks that are in an errored state, for example, tasks that must be reassigned or suspended. They can also change application preferences and map attributes, and manage rules for any user or group, in addition to their own end-user access. They typically need access to Fusion Middleware Control Console as well as to the computers where Process Workspace resides.
	Process administrators: Users responsible for administering processes—for example, creating shared views; assigning or removing roles, permissions, and groups; and mapping roles.
Supervisors	Users with other process participants reporting to them. To ensure that process instances execute as expected, supervisors can:
	 Access staff work
	 Reassign and delegate work as needed
	 Handle escalations from individuals reporting to them
	 Generate reports regarding work distribution and productivity
	 Specify extended user properties

Process analysts typically use the Oracle Business Process Analysis Suite or Business Process Composer to create process models. They can also use process analyst role within Oracle BPM Studio.

Process developers typically use Oracle BPM Studio to model and implement the components of a business application. They may occasionally use Oracle Business Process Composer (Business Process Composer) for modeling basic processes.

2.2 Starting and Logging In to Process Workspace

To start Process Workspace, you must have installed Oracle SOA Suite, and the Service Integration server must be running. See your installation documentation for more information.

To start and log into Process Workspace:

1. Go to

http://host_name:port_number/bpm/workspace/

The host_name is the name of the host computer on which Oracle SOA Suite is

The port_number is the one used at installation.

2. Enter the user name and password.

You can use the preseded user name to log in as an administrator. If you have loaded the demo user community in the identity store, then you can use other users such as jstein or jcooper.

The user name and password must exist in the user community provided to JAZN.

3. Click Login.

Notes:

- If you expect to have a large number of users using Process Workspace simultaneously, then set the session time-out value to no more than 5 minutes. To do this, expand the Process Workspace .ear file, open the web.xml file, and update the time-out parameter.
- If user identities are stored in Microsoft Active Directory, then at times authentication can fail due to the inability of Oracle WebLogic Server, where Process Workspace is running, to communicate with the Active Directory installation. This can occur when Oracle WebLogic Server and Active Directory are in separate domains.

To resolve this issue, add the entry for the Active Directory host's address to the /etc/hosts file on machine where Process Workspace is running.

2.3 Navigating Process Workspace

Figure 2–1 shows Process Workspace as it first appears by default when you log in.

At the highest level, Process Workspace provides four default tabs:

- Tasks
- **Activity Guides**
- Process Tracking
- Standard Dashboards

It also provides a link in the top right toolbar for performing administration.

In addition to the default tabs, you can create your own custom tabs, with each one appearing as a separate page in Process Workspace. For more information about creating custom tabs, see Chapter 6, "Creating and Editing Custom Pages in Process Workspace".

An administrator can choose whether to show or hide the default tabs. The administrator can also specify which tab page is displayed when the user logs in. For information on hiding and showing default tabs, see Section 9.1.8, "How to Show or Hide the Default Tab Pages in Process Workspace"

2.3.1 About the Process Workspace Tasks Page

After a user logs in, the Home page displays the **Tasks** page by default. The **Tasks** page displays tasks for the user based on the user's permissions and assigned groups and roles.

Within the **Tasks** page, the **My Tasks** page and the **Inbox** are displayed by default. The actions allowed from the Actions list depend on the logged-in user's privileges.

The Tasks page enables you to do the following:

- Perform authorized actions on tasks in the worklist, acquire and check out shared tasks, define personal to-do tasks, and define subtasks.
- Filter tasks in a worklist view based on various criteria.
- Work with standard work queues, such as high priority tasks, tasks that are due soon, and so on. Work queues enable users to create a custom view to group a subset of tasks in the worklist—for example, high priority tasks, tasks due in 24 hours, expense approval tasks, and more.
- Define custom work queues.
- Gain proxy access to part of another user's worklist.
- Define custom vacation rules and delegation rules.
- Enable group owners to define task dispatching rules for shared tasks.
- Collect a complete workflow history and audit trail.
- Use digital signatures for tasks.

Note: If you change a user's privileges in Oracle Enterprise Manager Fusion Middleware Control Console while the user is logged in to Process Workspace, the changes take effect only after a subsequent login by the user. This is true for situations in which there are two active worklist sessions: one in which the user is logged in before the privileges are changed, and one in which the same user logs in after the privileges are changed. In the first case, the changes to the user's privileges do not take effect while the user is logged in. In the second case, when the user logs in to the second instance of Process Workspace, the changes to the user's privileges do take effect.

2.3.1.1 Navigating the Process Workspace Tasks Page

This page lists all the tasks and work items assigned to you, depending on your role. For example, all users will see the My Tasks, Initiated Tasks and Administrative Tasks pages. Only supervisors will see the My Staff page. The Tasks page has these sections, as shown in Figure 2–2:

- Task navigator on the left
- Task list on the upper half of the right side
- Task details on the lower half of the right side

2.3.1.2 The Process Workspace Task Details Page

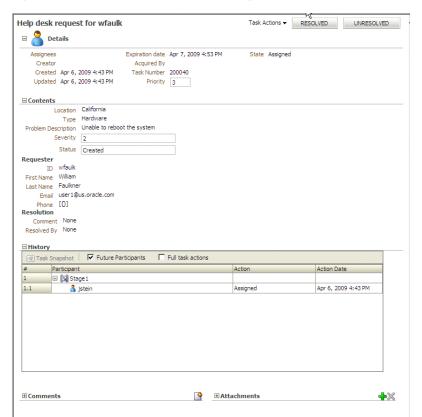


Figure 2-3 Example of a Task Details Page

Figure 2–3 shows an example of a Task Details page. This page is invoked by selecting a task from the inbox on the Process Workspace Tasks page.

The task details page has the following components:

- Basic information including the title of the task—for example, Help Desk Request for wfaulk—task number, creator, assignees, state, created date, the person who acquired the task, priority, expiration date, and other flex fields.
- Action buttons—For custom actions defined in the human task—for example, **Resolved** and **Unresolved** for a help desk request or **Approve** and **Reject** for a loan request. For the administrator, task initiator, or manager, Withdraw may also
- Other Actions—System task actions, beyond the custom actions defined for the task—as described in Table 2–3.

Table 2-3 System Task Actions

Action	Description
Claim	If a task is assigned to a group or multiple users, then the task must be claimed first. Claim is the only action available in the Action list for group or multiuser assignments. After a task is claimed, all applicable actions are listed.
Escalate	If you are not able to complete a task, you can escalate it and add an optional comment in the Comments area. The task is reassigned to whomever is specified by the administrator. If no escalation path is specified, then the task is escalated to your supervisor (up one level in a hierarchy).
Pushback	Use this action to send a task down one level in the workflow to the previous assignee.
Reassign	If you are a manager, you can delegate a task to reportees. A user with BPMWorkflowReassign privileges can delegate a task to anyone.
Release	If a task is assigned to a group or multiple users, it can be released if the user who claimed the task cannot complete the task. Any of the other assignees can claim and complete the task.
Renew	If a task is about to expire, you can renew it and add an optional comment in the Comments area. The task expiration date is extended one week. A renewal appears in the task history. The renewal duration for a task can be controlled by an optional parameter. The default value is P7D (7 days).
Submit Information and Request Information	Use these actions if another user requests that you supply more information or to request more information from the task creator or any of the previous assignees. If reapproval is not required, then the task is assigned to the next approver or the next step in the business process.
Suspend and Resume	If a task is not relevant, you can suspend it. These options are available only to users who have been granted the BPMWorkflowSuspend role. Other users can access the task by selecting Previous in the task filter or by looking up tasks in the Suspended status. A suspension is indefinite. It does not expire until Resume is used to resume working on the task.
Withdraw	If you are the creator of a task and do not want to continue with it, for example, you want to cancel a vacation request, you can withdraw it and add an optional comment in the Comments area. The business process determines what happens next. You can use the Withdraw action on the home page by using the Creator task filter.

- Content—The payload. The fields displayed are specific to how the human task was created.
- Short History—Provides a graphical view of a task flow and lists all versions created by the following tasks:
 - Initiate task
 - Reinitiate task

- Update outcome of task
- Completion of task
- Erroring of task
- Expiration of task
- Withdrawal of task
- Alerting of task to the error assignee

You can include the following actions in the short history list by modifying the shortHistoryActions element.

- Acquire
- Ad hoc route
- Auto release of task
- Delegate
- Escalate
- Information request on task
- Information submit for task
- Override routing slip
- Update outcome and route
- Push back
- Reassign

- History Details—The approval sequence and the update history for the task.

To see all actions performed, including those that do not change the task, such as adding comments, check Full History.

- Comments and Attachments:
 - Comments entered by various users who have participated in the workflow. A newly added comment and the commenter's user name are appended to the existing comments. A trail of comments is maintained throughout the life cycle of the task. To add a comment, you must have permission to update the task.

For information about how to add a comment, see Section 3.7, "Adding Comments and Attachments to Tasks in Process Workspace"

Attachments are documents or reference URLs associated with a task. These are typically associated with the workflow as defined in the human task or attached and modified by any of the participants using the task list. To add or delete an attachment, you must have permission to update the task. When

adding file attachments, you can use an absolute path name or browse for a

2.3.1.2.1 Task History The task history maintains an audit trail of the actions performed by the participants in the workflow and a snapshot of the task payload and attachments at various points in the workflow. The short history for a task lists all versions created by the following tasks:

- Initiate task
- Reinitiate task
- Update outcome of task
- Completion of task
- Erroring of task
- Expiration of task
- Withdrawal of task
- Alerting of task to the error assignee

You can include the following actions in the short history list by modifying the shortHistoryActions element.

- Acquire
- Ad hoc route
- Auto release of task
- Delegate
- Escalate
- Information request on task
- Information submit for task
- Override routing slip
- Update outcome and route

Figure 2–4 History: Graphical View

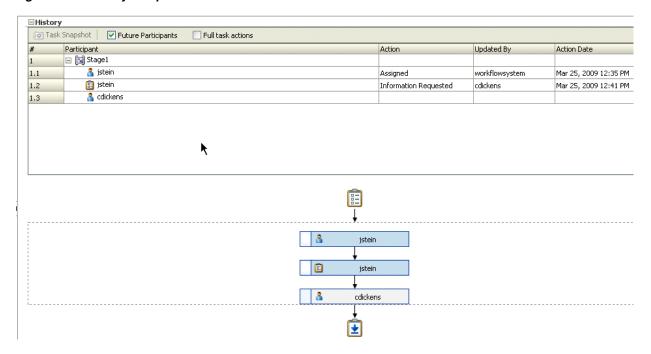


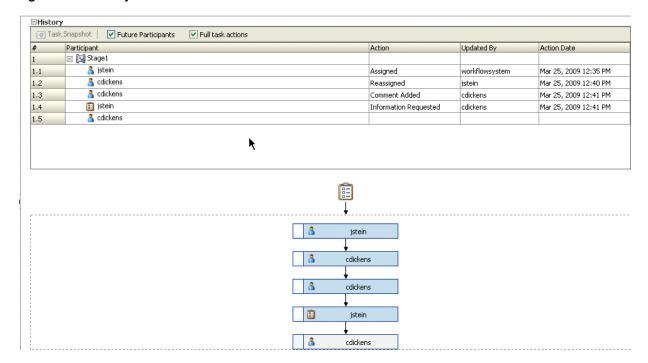

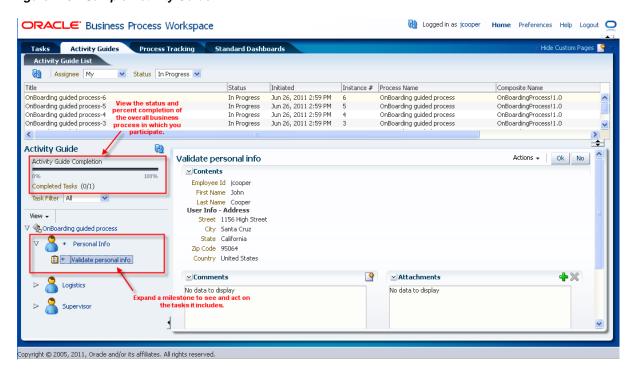

2.3.2 About the Process Workspace Activity Guides Page

Activity guides organize your tasks into milestones. Each milestone is a specific set of tasks for you to complete, either on your own or in collaboration with others. For each milestone, the activity guide tells you which tasks to complete and in which order. You complete a milestone by completing all the tasks it contains for you. Depending on the nature of the task, you can save an unfinished task and resume it later.

Figure 2–6 shows an example of an activity guide.

Using an activity guide, you can:

- Expand a milestone to see and act on the tasks it includes.
- View the status and percent completion of the overall business process in which you participate.

2.3.3 About the Process Workspace Process Tracking Page

Use the Process Tracking page to interact with business processes based on the roles assigned to you.

Using the Process Tracking tab, you can do the following:

- View the list of process instances pending in your inbox.
- Execute tasks. That is, carry out a human task on a particular instance.
- Search for instances by different criteria.
- Save the searches as a view.
- View the details of an instance, including the audit trail.
- Create a new instance, if you have permission to do so.
- Attach a file to an instance.
- Add notes to an instance.

The Process Tracking page has these sections:

The Applications panel, which shows the list of applications available to you. Here you can perform basic Process Workspace actions, such as creating a new instance performing a given activity, or sorting applications.

Hovering over the name of an application in the Applications panel displays a tool tip with the application's full name and revision number.

The applications available in Process Workspace depend on the process design and the roles assigned to the user currently logged in. The list of available applications also depends on the BPM processes that are deployed and running. If no processes are running, or if you are not a participant able to execute an application in any of the processes currently running, then the applications panel is empty.

In the applications panel, you can sort either of the following:

- Only the default versions of applications
- All active versions of applications

You can sort either by name or by process version. You can filter the same applications by entering in the **Search** field either full or partial names or full or partial versions.

- The Views panel, on the lower left half, displays the views available to you in an expandable tree
- The Pending Components panel shows all suspended processes. If a new version of a process is deployed, and the previously deployed process has instances not yet migrated to the new version, then the previously deployed process is suspended. To resume it, either migrate or suspend any non-migrated instances. For information about resuming suspended processes, see "Resuming a Suspended Process" in Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management.
- The Work Items panel, on the upper right half, shows the task items corresponding to the view you have selected in the Views panel. In this panel, you can choose the columns that are presented in a given view. A particular column arrangement is known as a presentation. Clicking Add/Remove columns displays the Presentation dialog box in which you can define columns.

- The Work Item Detail panel, on the lower right half, shows detailed information about a work item that you have selected in the Work Items panel. It has these sections:

- Details: Shows the priority, process name, when the instance is due to complete, status, creation time, and the assignee if any.
- Open Activities: Shows the status of any gateways with threads that are still running.
- Audit Trail: Shows audit details in either a list view, a tree view, or graphical view. You can select the type of activity or sub-process you want to audit: human activities, service activities business rule activities, subprocesses, events, gateways, script activities, other activities, or all of the above.

If the process includes an input or output payload, then you can display the audit details for that message in a pop-up. Clicking on a particular activity displays the task history.

For more information about viewing audit details, see Section 4.3.1, "Viewing the Audit Trail in Process Workspace."

- Comments: Enables you to add comments to the process instance.
- Attachments: Enables you to add attachments to the process instance.

2.3.4 About the Process Workspace Standard Dashboards Page

Dashboards provide analytical information to monitor process execution as well as user workloads. They provide summary information and enable you to drill down to instance-specific information.

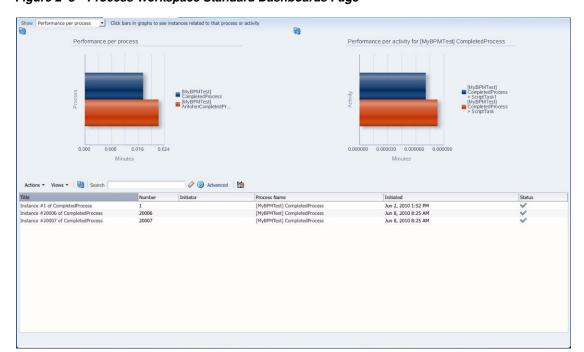


Figure 2–8 Process Workspace Standard Dashboards Page

Figure 2–8 shows the Standard Dashboards page.

Figure 2-9 Administration Link

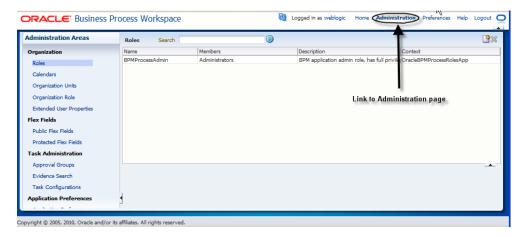

3.1 What You Need to Know When Acting on Tasks in Process Workspace

Here are a few things to keep in mind when acting on tasks:

If the human task was designed to permit ad hoc routing, or if no predetermined sequence of approvers was defined, then the task can be routed in an ad hoc

fashion in the worklist. For such tasks, a **Route** button appears on the task details page. From the Route page, you can look up one or more users for routing. When you specify multiple assignees, you can select whether the list of assignees is for simple (group assignment to all users), sequential, or parallel assignment.

If you are a developer and want more information about designing tasks to permit ad hoc routing, see Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite.

Parallel tasks are created when a parallel flow pattern is specified for scenarios such as voting. In this pattern, the parallel tasks have a common parent. The parent task is visible to a user only if the user is an assignee or either an owner or a creator of the task.

The parallel tasks themselves (referred to as subtasks) are visible to whomever the task is assigned, just like any other task.

You can view the subtasks from a parent task. In such a scenario, the task details page of the parent task contains a **View SubTasks** button. The SubTasks page lists the corresponding parallel tasks.

In a voting scenario, if any of the assignees updates the payload, the comments, or the attachments, then the changes are visible only to the assignee of that task. A user who can view the parent task (such as the final reviewer of a parallel flow pattern), can drill down to the subtasks and view the updates to the subtasks made by the participants in the parallel flow.

In the worklist, you provide the percentage of votes required for approval.

If a human task was set up to require a password, then when you act on it, you must provide the password.

Note: Any kind of change to the task details page, such as changing a priority or adding either a comment or an attachment, requires you to save the change.

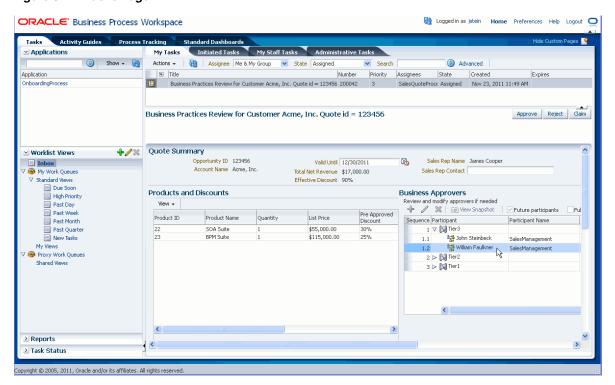
3.2.1 Viewing Task Details in Process Workspace

You perform most tasks in Process Workspace by using the Task Details page.

To display the Task Details page:

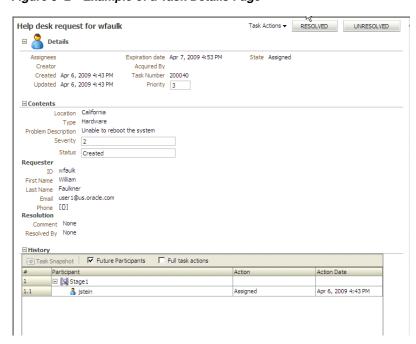
1. In the Home page, select the Tasks page, expand the Worklist Views section, and select Inbox. The right pane displays the My Tasks page as shown in the example in Figure 3–1. This page lists all the tasks and work items assigned to you, depending on your role. For example, all users can see the My Tasks, Initiated Tasks and Administrative Tasks pages. Only supervisors can see the My Staff page and only process owners can see the Owner Tasks page.

To display the details of a task inline, select the task in the right pane. The details are displayed in the lower right pane. To display the task details in a pop-up window, double-click the task. Figure 3–2 shows an example of a Task Details page.

3.2.1.1 Performing System Actions in Process Workspace

The action bar of the Task Details page displays system actions, which are available on all tasks based on the user's privileges. Table 3–1 lists system actions.

Table 3-1 System Task Actions

Action	Description
Claim	Use this action to claim a task that is assigned to a group or multiple users. Claim is the only action available in the Task Action list for group or multiuser assignments. After a task is claimed, all applicable actions are listed.
Escalate	Use this action to escalate a task that is assigned to a group or multiple users. You can add an optional comment in the Comments area. The task is reassigned to whomever is specified by the administrator. If no escalation path is specified, then the task is escalated to your manager (up one level in a hierarchy).
Pushback	Use this action to send a task down one level in the workflow to the previous assignee.
Reassign	Use this action to assign a task to someone else. If you are a manager, you can delegate a task to reportees. A user with BPMWorkflowReassign privileges can delegate a task to anyone.
Release	Use this action to release a claimed task. If a task is assigned to a group or multiple users, it can be released if the user who claimed the task cannot complete the task. Any of the other assignees can claim and complete the task.
Renew	Use this task to extend a task's expiration date. You can add an optional comment in the Comments area. The task expiration date is extended 1 week. A renewal appears in the task history. The renewal duration for a task can be controlled by an optional parameter. The default value is P7D (7 days).
Submit Information and Request Information	Use these actions if another user requests that you supply more information or to request more information from the task creator or any of the previous assignees. If reapproval is not required, then the task is assigned to the next approver or the next step in the business process.
Suspend and Resume	Use these actions to suspend or restart a task. These options are available only to users who have been granted the BPMWorkflowSuspend role. Other users can access the task by selecting Previous in the task filter or by looking up tasks in the Suspended status. A suspension is indefinite. It does not expire until Resume is used to resume working on the task.
Withdraw	Use this action to cancel a task. If you are the creator of a task and do not want to continue with it, for example, you want to cancel a vacation request, you can withdraw it and add an optional comment in the Comments area. The business process determines what happens next. You can use the Withdraw action on the home page by using the Creator task filter.

3.2.2 Customizing the Task List in Process Workspace

You can customize your task list in several ways, including adding worklist views, selecting which columns to display, and displaying a subset of the tasks based on filter criteria.

To increase the number of tasks retrieved, resize the task list display area.

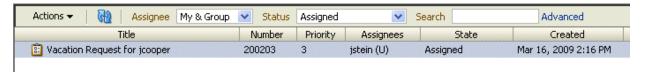

3.2.2.1 How to Filter Tasks

Figure 3–3 shows the filter fields.

Filters are used to display a subset of tasks, based on the following filter criteria:

Assignee

From the **My Tasks** page, select from the following:

- My: Retrieves tasks directly assigned to the logged-in user
- **Group**: Retrieves the following:
 - Tasks that are assigned to groups to which the logged-in user belongs
 - Tasks that are assigned to an application role that the logged-in user is assigned
 - Tasks that are assigned to multiple users, one of which is the logged-in
- My & Group: Retrieves all tasks assigned to the user, whether through direct assignment, or by way of a group, application role, or list of users
- **Previous**: Retrieves tasks that the logged-in user has updated
- **Reviewer**: Retrieves task for which the logged-in user is a reviewer

From the **Initiated Tasks** page, select **Creator**.

From the My Staff Tasks page, select Reportees.

From the **Administrative Tasks** page, select **Admin**.

- Status: Select from the following: Any, Assigned, Completed, Suspended (can be resumed later), Withdrawn, Expired, Errored (while processing), Alerted, or Information Requested.
- Search: Enter a keyword to search task titles, comments, identification keys, and the flex string fields of tasks that qualify for the specified filter criterion.
- **Advanced**: Provides additional search filters.

Note: If a task is assigned separately to multiple reportees, when a manager looks at the My Staff Tasks list, the manager sees as many copies of that task as the number of reportees to whom that task is assigned.

To filter tasks based on assignee or status:

Select options from the **Assignee** and **Status** lists. The task list is automatically updated based on the filter selections.

To filter tasks based on keyword search:

- Enter a keyword to search task titles, comments, identification keys, and the flex string fields of tasks that qualify for the specified filter criterion.
- Press **Enter** or click **Refresh**.

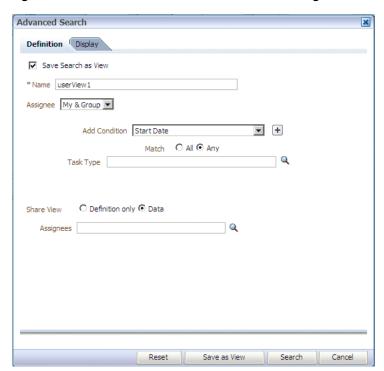
To filter tasks based on an advanced search:

Mapped attribute labels can be used in an advanced search if you select task types for which mapped attribute have been defined.

Figure 3-4 Worklist Advanced Search: Definition Page



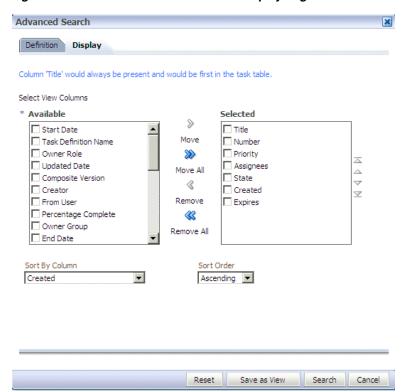


Figure 3–5 Worklist Advanced Search: Display Page

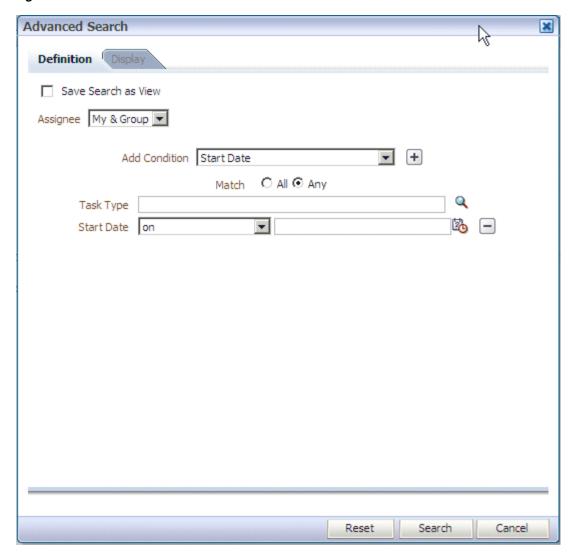

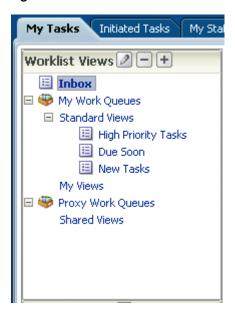

Figure 3-10 Worklist Views

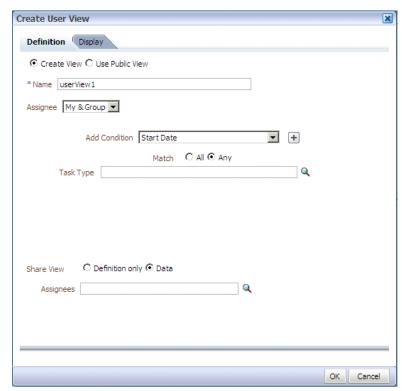

- **Add to Standard Views**—This option applies to administrators only. Administrators select this option to create the view as a standard view, which then appears in the **Standard Views** list for *all* worklist users.
- Assignee—Select My, Group, My&Group, Previous, or Reviewer.
- **Add Condition**—Select a filter from the list and click **Add**. For example, if you select **startDate**, and click **Add**, then a calendar and a list including **on**, **equals**, not equals, greater than, less than, and so on appears.
- **Task Type**—Browse for a task type or leave the field blank for all types. Mapped attribute labels can be selected in the query and display columns dialog boxes if the selected task types have mapped attribute mappings defined.
- Match—Select All or Any to match the conditions you added.
- **Share View**—You can grant access to another user to either the definition of this view, in which case the view conditions are applied to the grantee's data, or to the data itself, in which case the grantee can see the grantor's worklist view, including the data. Sharing a view with another user is similar to delegating all tasks that correspond to that view to the other user; that is, the other user can act on your behalf. Shared views are displayed under Proxy Work Queues.
- **Assignees**—Specify the users (grantees) who can share your view.

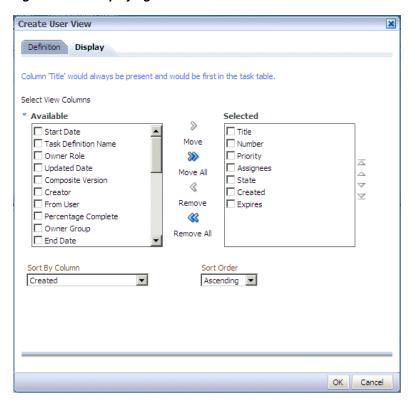


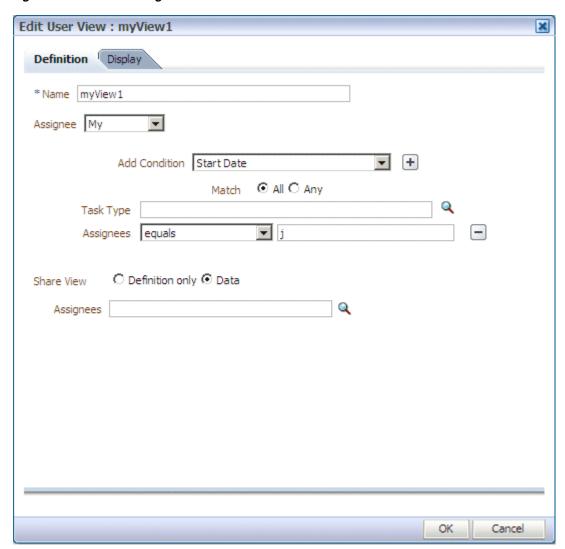
Figure 3-12 Displaying Fields in a Worklist View

- 3. Use the Display page of the Create User View dialog box, shown in Figure 3–12, to customize the fields that appear in the view.

- Select View Columns—Specify which columns you want to display in your task list. They can be standard task attributes or mapped attributes that were mapped for the specific task type. The default columns are the same as the columns in your inbox.
- **Sort by Column**—Select a column on which to sort.
- **Sort Order**—Select ascending or descending order.
- Click **OK**.

To customize a worklist view:

- In the **Worklist Views** section, click the view name.
- Click the **Edit** icon.
- Use the **Definition** and **Display** pages of the Edit User View dialog box to customize the view, as shown in Figure 3–13 and Figure 3–14, and click **OK**.

When you select and move items from the **Available Columns** list to the **Selected Columns** list (or vice-versa), the items remain selected. Therefore, if you select items to move back, the previously selected items are also moved. Ensure that you deselect items after moving them between the lists if you intend to move additional columns.

3.3 Claiming and Releasing Tasks in Process Workspace

If a task is assigned to a group or multiple users, then the task must be claimed first. Claim is the only action available in the Task Action list for group or multiuser assignments. After a task is claimed, all applicable actions are listed.

If a task is assigned to a group or multiple users, it can be released by the user who claimed it. Any of the other assignees can then claim and complete the task.

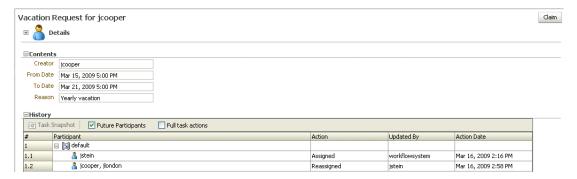
To claim and release tasks:

To claim a task, open it in the Task Details page, then click the **Claim** button.

Similarly, to release a task, open it in the Task Details page, then click the **Release** button.

Figure 3–15 shows part of a Task Details page with the Claim button in the upper right corner.

Figure 3-15 Claiming a Task

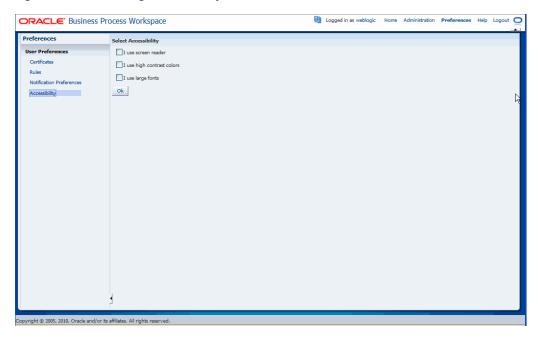


3.4 Setting Accessibility Preferences in Process Workspace

- In the upper right corner of Process Workspace, click **Preferences**.
- In the Configuration Areas panel, select Accessibility. The Select Accessibility page appears in the right pane as shown in Figure 3–16.

3.5 Providing a Digital Certificate in Process Workspace

A digital certificate establishes the participant's credentials. It is issued by a certification authority (CA). It contains your name, a serial number, expiration dates, a copy of the certificate holder's public key (used for encrypting messages and digital signatures), and the digital signature of the certificate-issuing authority so that a recipient can verify that the certificate is real.

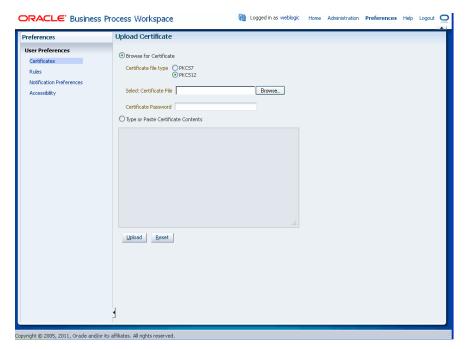
To provide a digital certificate:

- In the upper right corner of Process Workspace, click **Preferences**.
- In the navigation bar on the left, click **Certificates**.
- 3. Upload the certificate to use to sign your decision, as shown in Figure 3–17.

When signing a task outcome using your certificate, you must upload the entire chain of certificates through Process Workspace as a . P7B (PKCS7 format) file, not just the one certificate issued to you by the certificate issuer. The entire chain can be exported through Internet Explorer. Mozilla Firefox does not let you export the chain as a . P7B file. Therefore, you can perform the following steps:

- Export the chain from Mozilla Firefox as a . P12 file (PKCS12 format that also contains your private key).
- Import the . P12 file in Internet Explorer.
- Export it again from Internet Explorer as a . P7B file.
- Upload it through Process Workspace.

Note the following important points when providing your certificate to the system. Otherwise, you cannot use your certificate to sign your decisions on tasks.

- The PKCS7 file format is a binary certificate format. Select this option if you have a standalone certificate file stored on your disk.
- The PKCS12 file format is a keystore format. Select this option if you have your certificate stored inside a keystore.
- If you want to copy and paste the contents of the certificate, select **Type or Paste Certificate Contents** and paste the BASE64-encoded text into the field. Do not paste a certificate in any other format into this field. Likewise, if you choose to upload a certificate, do not upload a BASE64-encoded certificate. Only PKCS12- and PKCS7- formatted files are supported for uploads.

- **4.** Return to the task list by clicking the **Home** link in the upper right corner of Process Workspace.
- **5.** Click a task to approve or reject.

The task details are displayed.

Click either **Approve** or **Reject**.

Details about the digital signature are displayed.

- **7.** For a task that has a signature policy, click **Sign**.
 - The Text Signing Report dialog box appears.
- **8.** Select the certificate from the list to use to sign your decision.
- **9.** Enter the master password of the Web browser that you are using.
- Click OK.

The Web browser signs the string displayed in the upper half of the Text Signing Request with the certificate you selected and invokes the action (approval or rejection) that you selected. The task status is appropriately updated in the human workflow service.

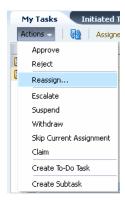

3.6 Reassigning and Delegating Tasks in Process Workspace

To reassign or delegate a task:

1. From the **Actions** list, select **Reassign**, as shown in Figure 3–18.

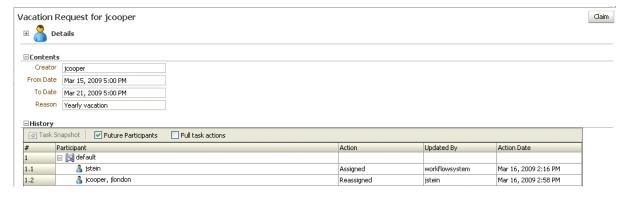
Figure 3-19 Reassigning a Task

A supervisor can always reassign tasks to any of his reportees.

Move names to the **Selected** area and click **OK**.

You can reassign to multiple users or groups. One of the assignees must claim the task, as shown in Figure 3–20.

Note: When task details have been upgraded from an earlier release, you may see a "Request Failed" error when executing the Reassign action. Actually, the reassign completes, and when you click OK again, a popup says the task is already assigned.

To eliminate the error message, upgrade your taskflow applications by opening them in Oracle JDeveloper, then redeploy the taskform.

3.7 Adding Comments and Attachments to Tasks in Process Workspace

You can add comments and attachments to a task by using the Task Details page.

For details about the Task Details page, see Section 2.3.1.2, "The Process Workspace Task Details Page"

To add a comment to a task:

- 1. In the Tasks tab page, from the worklist pane, select the task to which you want to add a comment. The details for that task appear.
- In the Comments section of the Task Details page, click **Create**. The Create Comment dialog box appears as shown in Figure 3–21.

- 3. In the Create Comment dialog box, enter your comment, then select to share the comment with either of the following:
 - Only task participants. This option shares the comment with previous and future assignees of this particular task.
 - All process participants. This option shares the comment with all participants in the process, regardless of the tasks assigned to them.

Note: If you are the initiator of the task, then your comment is shared with all process participants and not only with task assignees. The option to share with only task participants is not available to you.

4. Click OK.

To add an attachment to a task:

- 1. In the Tasks tab page, from the worklist pane, select the task to which you want to add an attachment. The details for that task appear.
- In the Attachments section of the Task Details page, click **Add**. The Add Attachment dialog box appears.
- 3. In the Add Attachment dialog box, select to share the attachment with either of the following:
 - Only task participants. This option shares the attachment with previous and future assignees of this particular task.
 - All process participants. This option shares the attachment with all participants in the process, regardless of the tasks assigned to them.
- **4.** Select the attachment type.

If the task is *not* using Oracle WebCenter Content, then you see the following options:

- URL. Selecting this option opens fields in which you specify the name and URL of the file.
- Desktop File. Selecting this option opens a search field from which to browse for the file on your computer.

If the task is using Oracle WebCenter Content, then you see the following options:

- URL. Selecting this option opens fields in which you specify the name and URL of the file.
- Upload File to WebCenter Content. Selecting this option uploads the desktop file to Oracle WebCenter Content. When you select it, another dialog box prompts you for some or all of the following depending on how the task is modeled:
 - Description (optional)
 - Folder name: The folder in WebCenter Content server where the attachment is uploaded. You must type the full folder path in WebCenter Content server
 - Document type: From this list, select the WebCenter Content document
 - Account (optional): From this list, select the account name.
 - Revision (optional): Type an integer for revision.
 - Release date (optional): Select the date at which the document is released. Prior to this date, the WebCenter Content document is not visible to WebCenter Content users.
 - Expiration date (optional): The date when the document expires. After this date, the WebCenter Content document is no longer visible to Oracle WebCenter Content users.
- Associate WebCenter Content Document. Selecting this option opens another dialog box prompting you for the document identifier. You can search for it by clicking the spyglass icon and, once you have located it, clicking **OK**.

Once you have selected the attachment type, click **OK**.

To delete an attachment from a task:

- 1. In the Tasks tab page, from the worklist pane, select the task from which you want to delete an attachment. The details for that task appear in the Task Details pane.
- 2. In the Task Details pane, in the Attachments section, select the attachment you want to delete and click **Delete**. The Delete Attachment dialog box prompts you to confirm the deletion.
- 3. Click OK.
- **4.** In the Task Details pane, from the Actions list, select **Save** as shown in Figure 3–22. The attachment is deleted from the task.

Note: If the attachment is stored in a content server such as WebCenter Content, then it is not deleted from the content server. If the attachment is stored in the SOA workflow repository, then you can access it by viewing the task snapshot from the task history.

3.8 Requesting Information in Process Workspace

To request information:

1. From the Task Actions list, select Request Information, as shown in Figure 3–23.

Note: If you are in a multi-tenancy environment, search for a user simply by the user identifier and not by the tenant identifier. For example, if the user identifier is jstein and the tenant identifier is company_name.jstein, you would search by using jstein.

Click **OK**.

3.9 Setting Rules, Vacation Periods, and Notification Preferences in **Process Workspace**

Rules act on tasks, either a specific task type or all the tasks assigned to a user or group. To set rules, from the Process Workspace toolbar, select **Preferences**. The Preferences window appears as shown in Figure 3–26.

A rule cannot always apply to all circumstances in which it is used. For example, if a rule applies to multiple task types, it may not be possible to set the outcome for all tasks, because different tasks can have different outcomes.

Rules are executed in the order in which they are listed.

If a rule meets its filter conditions, then it is executed and no other rules are evaluated. For your rule to execute, you must be the only user assigned to that task. If the task is assigned to multiple users (including you), the rule does not execute.

You cannot specify business rules for ToDo tasks.

3.9.1 How to Create User Rules in Process Workspace

To create a user rule:

- 1. From the Process Workspace toolbar, select **Configuration**. The **Configuration Areas** window is displayed.
- In the User Preferences area, click **Rules**. The My Rules and Other Rules pages appear in the right pane. The My Rules page is selected.
- 3. In the My Rules page, in the Rules section, select My Rules. The My Rule screen appears in the right pane.
- Provide a name for the rule.
- If the rule is a vacation rule, select **Use as a vacation rule**. The start and end dates of the rule are automatically synchronized with the vacation period.

For instructions about setting a vacation period that is synchronized with the vacation rule, see Section 3.9.3, "How to Enable a Vacation Period in Process Workspace."

- **6.** In the **Apply only to task type(s)** field, browse for task types to which the rule applies. If a task is unspecified, then the rule applies to all tasks. If a task type is specified, then any mapped attribute mapped for that task type can be used in the rule condition.
- **7.** Select **Execute rule only between these dates** and provide rule execution dates.
- **8.** In the **IF** area, add rule conditions. These are filters that further define the rule, such as specifying that a rule acts on priority 1 tasks only, or that a rule acts on tasks created by a specific user. The conditions can be based on standard task attributes and any mapped attributes that were mapped for the specific tasks. See Section 9.2.1.1, "How to Specify Mapped Attributes" for more information.
- **9.** In the **THEN** area, select actions to be taken. User rules do the following actions:
 - **Reassign to**—You can reassign tasks to subordinates or groups you manage. If you were granted the BPMWorkflowReassign role, then you can reassign tasks to any user or group.
 - **Delegate to**—You can delegate to any user or group. Any access rights or privileges for completing the task are determined according to the original user who delegated the task. (Any subsequent delegations or reassignments do not change this from the original delegating user.)
 - **Set outcome to**—You can specify an automatic outcome if the workflow task was designed for those outcomes, for example, accepting or rejecting the task. The rule must be for a specific task type. If a rule is for all task types, then this option is not displayed.
 - **Take no action**—Use this action to prevent other more general rules from applying. For example, to reassign all your tasks to another user while you are on vacation, except for loan requests, for which you want no action taken, then create two rules. The first rule specifies that no action is taken for loan requests; the second rule specifies that all tasks are reassigned to another user. The first rule prevents reassignment for loan requests.

10. Click Save.

The new rule appears under the **My Rules** node.

3.9.2 How to Create Group Rules in Process Workspace

Creating a group rule is similar to creating a user rule, with the addition of a list of the groups that you (as the logged-in user) manage. Examples of group rules include:

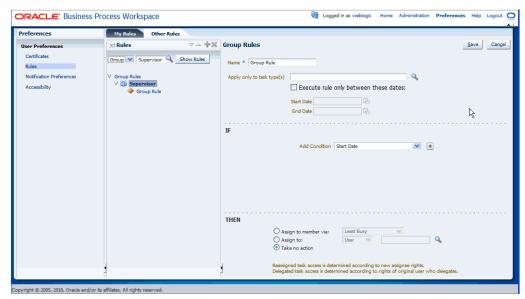
- Assigning tasks from a particular customer to a member of the group
- Ensuring an even distribution of task assignments to members of a group by using round-robin assignment
- Ensuring that high-priority tasks are routed to the least busy member of a group Group rules do the following actions:
- Assign to member via—You can specify a criterion to determine which member of the group gets the assignment. This dynamic assignment criterion can include round-robin assignment, assignment to the least busy group member, or assignment to the most productive group member. You can also add your custom functions for allocating tasks to users in a group.

- Assign to—As with user rules, you can assign tasks to subordinates or groups you directly manage. If you have been granted the BPMWorkflowReassign role, then you can reassign tasks to any user or group (outside your management hierarchy).
- Take no action—As with user rules, you can create a rule with a condition that prevents a more generic rule from being executed.

To create a group rule:

- 1. From the Process Workspace toolbar, select **Preferences**. The Preferences window is displayed.
- 2. In the User Preferences area, click **Rules**. The My Rules and Other Rules pages appear in the right pane. The My Rules page is selected.
- **3.** Click the **Other Rules** tab.
- **4.** Select **Group** from the list.
- **5.** Enter a group name and click the **Search** icon, or enter a group name. The Identity Browser dialog box opens for you to find and select a group.
- Select the group name under the **Group Rules** node and click **Add**, as shown in Figure 3–27.

- **7.** Provide group rule information and click **Save**.
 - Provide a name for the rule.
 - Browse for task types to which the rule applies.
 - Provide rule execution dates.
 - In the **IF** area, add rule conditions.
 - In the THEN area, select the actions to be taken: (Assign to member via, **Assign to**, or **Take no action**), as shown in Figure 3–27.

The new rule appears under the **Group Rules** node.

3.9.3 How to Enable a Vacation Period in Process Workspace

You can set a vacation period so that you are removed from automatic task assignment during the dates you specify.

Vacation rules are not executed for ToDo tasks. See Section 3.9.1, "How to Create User Rules in Process Workspace" for how to set a vacation rule that is synchronized with the vacation period.

To enable a vacation period:

- Click the **Preferences** link. The Preferences page appears.
- In the User Preferences panel, click **Rules**. The right pane displays the Rules panel with the My Rules page selected. Adjacent and to the right of the My Rules page, the Vacation Period page appears.
- 3. Select Enable vacation period.
- Provide start and end dates.
- Click **Save**. The vacation period is enabled.

3.9.4 Specifying Notification Settings

You can configure the notification settings to control how, when, and where you receive messages in cases when you have access to multiple communication channels (delivery types). Specifically, you can define messaging filters (delivery preferences) that specify the channel to which a message should be delivered, and under what circumstances.

For example, you might want to create filters for messages received from customers with different Service Level Agreements (SLA), specifying to be notified through business phone and SMS channels for customers with a premium SLA and by EMAIL for customers with a nonpremium SLA.

3.9.4.1 Messaging Filter Rules

A messaging filter rule consists of rule conditions and rule actions. A rule condition consists of a rule attribute, an operator, and an associated value. A rule action is the action to be taken if the specified conditions in a rule are true.

3.9.4.1.1 Data Types Table 3–4 lists data types supported by messaging filters. Each attribute has an associated data type, and each data type has a set of predefined comparison operators.

3.9.4.2 Rule Actions

For a given rule, a messaging filter can define the following actions:

- **Send No Messages**: Do not send a message to any channel.
- Send Messages to All Selected Channels: Send a message to all specified channels in the address list.
- Send to the First Available Channel: Send a message serially to channels in the address list until one successful message is sent. This entails performing a send to the next channel when the current channel returns a failure status. This filter action is not supported for messages sent from the human workflow layer.

3.9.4.3 Managing Messaging Channels

In Oracle BPM Worklist, messaging channels represent both physical channels, such as business mobile phones, and also email client applications running on desktops. Specifically, Oracle BPM Worklist supports the following messaging channels:

- **EMAIL**
- IM
- **MOBILE**
- SMS
- **VOICE**
- WORKLIST

Note the following about message channels:

- Addresses for messaging channels are fetched from the configured identity store.
- SMS and MOBILE notifications are sent to the mobile phone number.
- VOICE notifications are sent to the business phone number.
- No special notification is sent when the messaging channel preference is WORKLIST. Instead, log in to Oracle BPM Worklist to view tasks.
- EMAIL is the default messaging channel preference when a preferred channel has not been selected.

You can use the Messaging Channels tab to view, create, edit, and delete messaging channels.

3.9.4.3.1 Viewing Your Messaging Channels You can display your existing messaging channels.

To view messaging channels:

- **1.** Click the **Preferences** link.
- Click the **Notification Preferences**.
- **3.** Click the **Messaging Channels** tab.

The My Messaging Channels list appears (Figure 3–28) and displays the following information:

- **Name**: The name of the messaging channel.
- **Type**: The type of messaging channel, such as EMAIL or SMS.
- **Address**: The address for the channel, such as a phone number or email address.
- **Default**: Specifies whether this channel is the default messaging channel.

Click **View > Columns** and select the columns to display or hide.

You can also click **View > Reorder Columns** to display a dialog to reorder the displayed columns.

Messaging channel names and addresses are retrieved from the underlying identity store, such as Oracle Internet Directory.

3.9.4.3.2 Creating, Editing, and Deleting a Messaging Channel Oracle BPM Worklist uses an underlying identity store, such as Oracle Internet Directory, to manage messaging channels and addresses. Therefore, you cannot directly create, modify, or delete messaging channels using Oracle BPM Worklist.

To perform these actions, contact the system administrator responsible for managing your organization's identity store.

3.9.4.4 Managing Messaging Filters

You can use the **Messaging Filters** tab to define filters that specify the types of notifications you want to receive along with the channels through which to receive these notifications. You can do this through a combination of comparison operators (such as is equal to, is not equal to), attributes that describe the notification type, content, or source, and notification actions, which send the notifications to the first available messaging channels, all messaging channels, or to no channels (effectively blocking the notification).

For example, you can create a messaging filter called *Messages from Lise*, that retrieves all messages addressed to you from your boss, Lise. Notifications that match all of the filter conditions might first be directed to your business mobile phone, for instance, and then to your business email if the first messaging channel is unavailable.

3.9.4.4.1 Viewing Messaging Filters You can display your existing messaging filters.

To view your messaging filters:

- **1.** Click the **Notification** tab.
- **2.** Click the **Messaging Filters** tab.

The My Messaging Filters list appears (Figure 3–29) and displays the following information:

- **Filter Name**: The name of the messaging filter
- **Description**: An optional description of the messaging filter

Click **View > Columns** and select the columns to display or hide.

You can also click **View > Reorder Columns** to display a dialog to reorder the displayed columns.

3.9.4.4.2 Creating Messaging Filters To create a messaging filter:

1. Click Create.

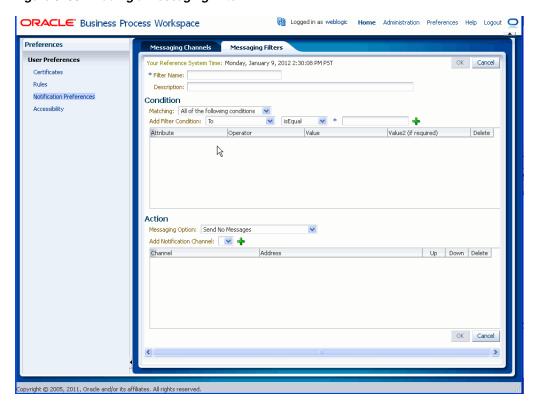


Figure 3-30 Adding a Messaging Filter

 - **Description**: An optional description for the messaging filter.
- Define the filter conditions using the lists and fields in the **Condition** section, as follows:
 - Select whether notifications must meet all of the conditions or any of the conditions by selecting either the All of the following conditions or the Any of the following conditions options.
 - Select the attribute from the list.
 - Select the operator, such as **isEqual**, from the list.
 - Type the value of the condition in the text box. d.
 - Click **Add** to add the condition to the list.
 - Repeat these steps to add more filter conditions. To remove a filter condition, click Delete.
- Select from the following messaging options in the **Action** section:
 - **Send No Messages**: Do not send a message to any channel.
 - Send Messages to All Selected Channels: Send a message to all specified channels in the address list.
 - Send to the First Available Channel: Send a message serially to channels in the address list until one successful message is sent. This entails performing a send to the next channel when the current channel returns a failure status.

- **5.** To set the delivery channel, select a channel from the **Add Notification Channel** list and click **Add**. To remove a channel, click **Delete**.
- **6.** Use the up and down arrows to prioritize channels. If available, the top-most channel receives messages meeting the filter criteria if you select Send to the First Available Channel.

Click OK.

The messaging filter appears on the My Messaging Filters page. The My Messaging Filters page enables you to edit or delete the channel. Click Cancel to dismiss the dialog without creating the filter.

3.9.4.4.3 Editing a Messaging Filter To edit a messaging filter:

- 1. Select the filter on the My Messaging Filters page.
- 2. Click Edit.
- Click **OK** to update the messaging filter. Click **Cancel** to dismiss the dialog without modifying the filter.

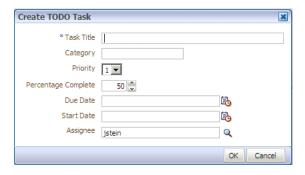
3.9.4.4.4 Deleting a Messaging Filter To delete a messaging filter:

- Select the filter on the My Messaging Filters page.
- Click **Delete**. A confirmation dialog appears.
- Click **OK** to delete the messaging filter. Click **Cancel** to dismiss the dialog without deleting the filter.

3.10 Creating ToDo Tasks and Subtasks in Process Workspace

Use the Create ToDo Task dialog, shown in Figure 3–31, to create a top-level ToDo task for yourself or others. This task is not associated with a business task.

Figure 3–31 The Create ToDo Task Dialog



ToDo tasks appear in the assignee's **Inbox**.

You can create ToDo tasks that are children of other ToDo tasks or business tasks. A ToDo task can have only one level of child ToDo tasks. When all child ToDo tasks are 100% complete, the parent ToDo task is also marked as completed. If the parent ToDo task is completed, then child ToDo tasks are at 100% within the workflow system. If the parent is a business task, the child ToDo is not marked as completed. You must set the outcome and complete it. If you explicitly set a ToDo task to 100%, there is no aggregation on the parent task.

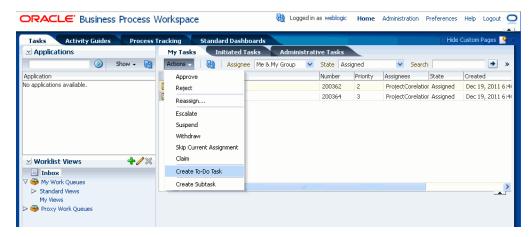
ToDo tasks can be reassigned, escalated, and so on, and deleted (logical delete) and purged (physical delete). Reassignment, escalation, and so on of the parent task does not affect the assignment of any child ToDo tasks. The completion percentage of a ToDo task can be reset to less than 100% after it is completed.

Assignment rules (such as vacation rules) are not applied to ToDo tasks. You cannot specify business rules for ToDo tasks.

To create a ToDo task:

From the **Actions** list, select **Create TODO Task**, as shown in Figure 3–32.

Figure 3–32 Creating a ToDo Task



- Provide details in the Create ToDo Task dialog, shown in Figure 3–31, and click OK.
 - **Task Title**: Enter anything that is meaningful to you.
 - **Category**: Enter anything that is meaningful to you.
 - **Priority**: Select from 1 (highest) to 5 (lowest)
 - **Percentage Complete**: This attribute indicates how much of the task is completed. 100% sets the attribute as completed.
 - **Due Date**: The due date does not trigger an expiration. You can also see overdue tasks. The start date need not be the current date.
 - **StartDate**: The task start date.
 - **Assignee**: You can assign yourself or someone else.

3.11 Acting on Tasks that Require Passwords in Process Workspace

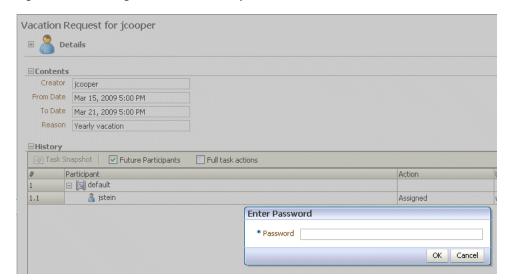


Figure 3–33 Acting on a Task That Requires a Password

If a human task was set up to require a password, then when you act on it, you must provide the password when prompted, as shown in Figure 3–33.

3.12 Acting on a Task that Requires a Digital Signature in Process Workspace

Oracle Business Process Management Workspace supports the signature policy created in the human task:

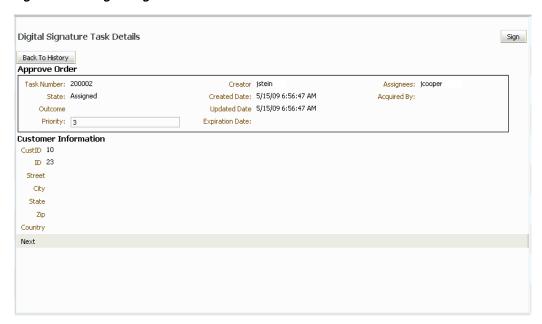
- No signature required Participants can send and act on tasks without providing a signature.
- **Password required** Participants must specify their login passwords.
- **Digital certificate (signature) required** —Participants must possess a digital certificate before being able to send and act on tasks. A digital certificate contains the digital signature of the certificate-issuing authority so that anyone can verify that the certificate is real. A digital certificate establishes the participant's credentials. It is issued by a certification authority (CA). It contains your name, a serial number, expiration dates, a copy of the certificate holder's public key (used for encrypting messages and digital signatures), and the digital signature of the certificate-issuing authority so that a recipient can verify that the certificate is real.

The evidence store service is used for digital signature storage and nonrepudiation of digitally-signed human workflows.

For more information about digital signatures and the evidence store service, see Section 3.14, "Evidence Store Service and Digital Signatures".

When you act on a task that has a signature policy, the **Sign** button appears, as shown in Figure 3–34.

Figure 3-34 Digital Signature Task Details

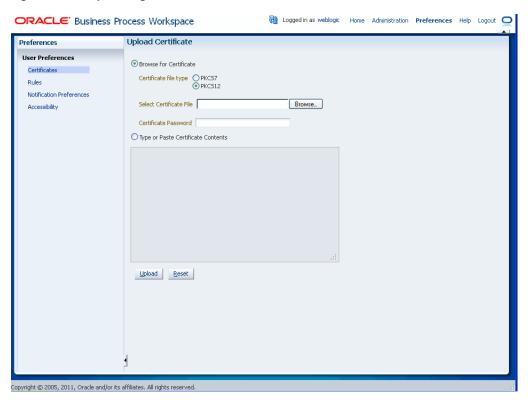


To use a certificate for digitally signing tasks, you must first upload the certificate.

To upload a certificate for a digital signature:

- In the upper right corner of Oracle BPM Worklist, click **Preferences**.
- In the navigation bar on the left, click **Certificates**.
- Upload the certificate to use to sign your decision, as shown in Figure 3–35. 3.

Figure 3-35 Uploading a Certificate



When signing a task outcome using your certificate, you must upload the entire chain of certificates through Oracle BPM Worklist as a . P7B (PKCS7 format) file, not just the one certificate issued to you by the certificate issuer. The entire chain can be exported through Internet Explorer. Mozilla Firefox does not enable you to export the chain as a . P7B file. Therefore, you can perform the following steps:

- Export the chain from Mozilla Firefox as a .P12 file (PKCS12 format that also contains your private key).
- Import the . P12 file in Internet Explorer.
- Export it again from Internet Explorer as a . P7B file.
- Upload it through Oracle BPM Worklist.

Note the following important points when providing your certificate to the system. Otherwise, you cannot use your certificate to sign your decisions on tasks.

- The PKCS7 file format is a binary certificate format. Select this option if you have a standalone certificate file stored on your disk.
- The PKCS12 file format is a keystore format. Select this option if you have your certificate stored inside a keystore.
- If you want to copy and paste the contents of the certificate, select **Type or Paste Certificate Contents** and paste the BASE64-encoded text into the field. Do not paste a certificate in any other format into this field. Likewise, if you choose to upload a certificate, do not try to upload a BASE64-encoded certificate. Only PKCS12 and PKCS7 formatted files are supported for uploads.
- **4.** Return to the task list by clicking the **Home** link in the upper-right corner of Process Workspace.
- **5.** Click a task to approve or reject. The task details are displayed.
- Click either **Approve** or **Reject**. Details about the digital signature are displayed.
- 7. For a task that has a signature policy, click **Sign**. The Text Signing Report dialog appears.
- **8.** Select the certificate from the list to use to sign your decision.
- **9.** Enter the master password of the web browser that you are using.
- Click OK.

The web browser signs the string displayed in the upper half of the Text Signing Request with the certificate you selected and invokes the action (approval or rejection) that you selected. The task status is appropriately updated in the human workflow service.

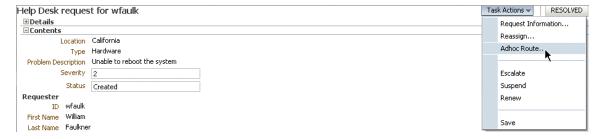
3.13 Routing Tasks in Process Workspace

If the human task was designed to permit ad hoc routing, or if no predetermined sequence of approvers was defined, then the task can be routed in an ad-hoc fashion in the worklist. For such tasks, a **Route** button appears on the task details page. From the Route page, you can look up one or more users for routing. When you specify multiple assignees, you can select whether the list of assignees is for simple (group assignment to all users), sequential, or parallel assignment.

To route a task:

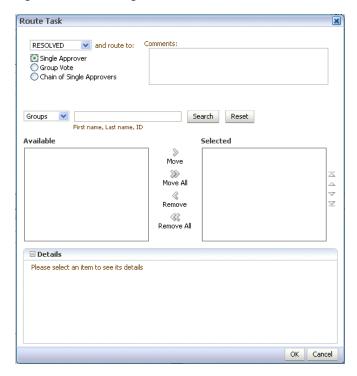
1. From the **Task Actions** list, select **Adhoc Route**, as shown in Figure 3–36.

Select an action and a routing option, as shown in Figure 3–37.

- **Single Approver**: Use this option for a single user to act on a task. If the task is assigned to a role or group with multiple users, then one member must claim the task and act on it.
- Group Vote: Use this option when multiple users, working in parallel, must act, such as in a hiring situation when multiple users vote to hire or reject an applicant. You specify the voting percentage that is needed for the outcome to take effect, such as a majority vote or a unanimous vote, as shown in Figure 3–38.

- **Chain of Single Approvers**: Use this option for a sequential list of approvers. The list can comprise any users or groups. (Users are not required to be part of an organization hierarchy.)
- **3.** Add optional comments for the next participant on the route.
- Provide or search for user or group names; then move the names to the **Selected**
- 5. Click OK.

3.14 Evidence Store Service and Digital Signatures

The evidence store service is used for digital signature storage and nonrepudiation of digitally-signed human workflows. A digital signature is an electronic signature that authenticates the identity of a message sender or document signer. This ensures that the original content of the message or document sent is unchanged. Digital signatures are transportable, cannot be imitated by others, and are automatically time-stamped. The ability to ensure that the original signed message arrived means that the sender cannot repudiate it later. Digital signatures ensure that a human workflow document:

- Is authentic
- Has not been forged by another entity
- Has not been altered
- Cannot be repudiated by the sender

A cryptographically-based digital signature is created when a public key algorithm signs a sender's message with a sender's private key.

During design time, signatures are enabled for the task. During runtime in Process Workspace, when a user approves or rejects the task, the web browser:

- Asks the user to choose the private key to use for signing.
- Generates a digital signature using the private key and task content provided by Oracle BPM Worklist.

Notes:

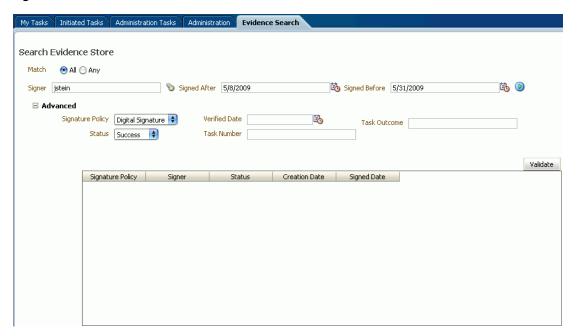
- The certificate refers to a Personal Information Exchange Syntax Standard (PFX) file that includes a certificate and a private key, and is protected by a simple text password. PFX specifies a portable format for storing or transporting a user's private keys, certificates, miscellaneous secrets, and so on.
- The possession of a private key that corresponds to the public key of a certificate is sufficient to sign the data, because the signature is verifiable through the public key in the certificate. However, no attempt is made to correlate the name of a user of a certificate with the person updating it. For example, user jstein can sign using the private key of user cdickens if jstein has that private key.

The following digital signature features are supported:

- PKCS7 signatures based on X.509 certificates
- Browser-based, digitally-signed content without attachments

You can search the evidence store, as shown in Figure 3–39.

4.1 Initiating Process Instances in Process Workspace

To initiate a process instance, you begin with the Applications panel located at the top of the navigation pane.

To initiate a process:

In the Process Tracking page, in the Applications panel, click the process you want to initiate. The dialog box for that process instance appears.

Note: If your browser has pop-up blocking enabled, then enable pop-ups for task flow servers; otherwise the application does not launch and the dialog box does not appear.

2. Create any comments or add any attachments.

To add a comment:

a. In the Comments section, click **Create**. The Create Comment dialog box appears.

- **b.** Enter your comment and click **OK**. The comment is added at the process level.
- To add an attachment:
- In the Attachments section, click **Add**. The Add Attachment dialog box
- **b.** Select the attachment type. If you select Desktop File, a dialog box enables you to enter the path name of the file or browse to find it. If you select URL, you are prompted for the name of the file and the URL.
- After you have specified the attachment, click **OK**. The attachment is added at the process level.

The process instance is initiated and is assigned to you as the initiator.

4.2 Searching for Process Instances in Process Workspace

You can perform either a basic search or an advanced search for process instances. This section contains these topics:

- Section 4.2.2, "How to Perform an Advanced Search for Process Instances"

4.2.1 How to Perform a Basic Search for Process Instances

For a basic search, you enter all or part of the name of a process instance in the Search field.

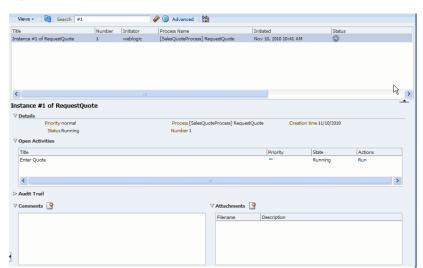
To perform a basic search for a process instance:

Select the Process Tracking page and, in the Search field, enter all or part of the name of the instance for which you are searching. Note that the search results are based on the Description column of the Process Tracking page.

To retrieve a list of all instances, enter a percent sign (%).

Search results are displayed as shown in the example in Figure 4–1.

Figure 4-1 Search Results



The Details section displays the priority, process name, when the instance is due to complete, status, creation time, and the assignee.

If the process instance has any gateways resulting in multiple threads (paths) that are still running, the Open Activities section display the status of each thread.

The Audit Trail section displays audit information—in either tabular form, tree view, or graphically depending on your selection.

4.2.2 How to Perform an Advanced Search for Process Instances

You can perform a search based on one or more conditions you specify.

To perform an advanced search for a process instance:

- 1. In the Process Tracking page, click **Advanced**. The Advanced Search dialog box appears.
- 2. From the Processes list, select each of the processes you want to include in the view.
- **3.** From the Assigned list, select one of the following: Anyone, at Any Role; Me, or Unassigned in my Role(s); Me.
- From the Status list, select one the following:

Table 4–1 Add View Status List

Status	Description	
All	Displays all instances.	
All Open	The work items displayed include all instances that have the following status: In Process, Pending Migration, Suspended, and Errored.	
In Process	The work item is active; it has not reached the end of the process.	
Completed	The work item reached the end of the process.	
Aborted	The work item is no longer active, and did not reach the end of the process.	
Errored	The work item has thrown an exception during processing.	
Pending Migration	The work item is awaiting migration to a new implementation.	
Suspended	The work item is in suspended state. An item is suspended if a new implementation of the same composite revision is deployed, and the previously deployed composite has some components with the newer BPM process definition.	

5. Click OK.

4.3 Viewing the Details of a Process Instance in Process Workspace

The ability of a user to see process instances depends on the user's roles. Table 4-2 maps the various roles to their corresponding levels of visibility.

Table 4–2 Visibility into Process Instances

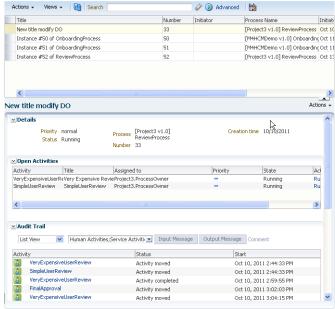

Administrator—that is, a user with the WorkflowAdmin role or the Administrator role	Can see all information related to all process instances
Process owner	At any given time, can see the instance details of the process instance

To view the details of a process instance:

In the Process Tracking page, from the process instance list, select the instance whose details you want to view. The Work Item Detail panel opens in the lower right section of the page as shown in Figure 4–2.

4.3.1 Viewing the Audit Trail in Process Workspace

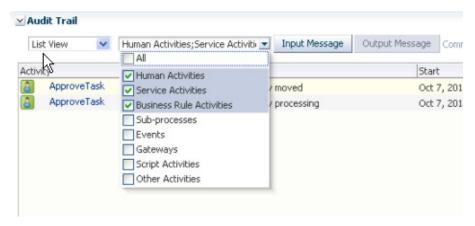
The Audit Trail section of the Work Item Details panel displays audit details in a list view, a tree view, or a graphical view. Select the view from the list in the upper left corner of the Audit Trail section as shown in Figure 4–3.

You can select the type of activity, sub-process, gateway, or event you want to audit. To do this, select from the list at the top of the Audit Details section as shown in Figure 4–4.

If you are an administrator or process owner, and if the selected activity includes an input or output payload, then you can display the input or output message for that activity. To do this, select the activity, then click either Input Message or Output **Message**, The message appears in a pop-up as shown in Figure 4–5.

4.3.2 Associating Comments and Attachments with a Process Instance in Process Workspace

To associate a comment with a process instance:

- 1. From the worklist, select the process instance with which you want to associate a comment.
- In the details panel, in the Comments section, click **New**.
- Enter your comment and click **OK**.

To associate an attachment with a process instance:

- 1. From the worklist, select the process instance with which you want to associate an attachment.
- 2. In the details panel, in the Attachments section, click New. The Add Attachment dialog box appears.
- **3.** In the Description field, optionally enter a description for the attachment.
- In the Filename field, enter the path to the file, or click **Browse** to navigate to it.
- 5. Click OK.

Note:

- If you add an attachment to a process instance, and later delete it from the corresponding task, then the attachment is also deleted from the process instance.
- In an environment with servers clustered for high availability purposes, file uploading is not supported in the event of a failover. If the active server shuts down, then the uploading process is not assumed by the other server, and the upload fails.

4.4 Performing a Bulk Operation in Process Workspace

In this release, the only available bulk operation you can perform is Cancel.

To perform a bulk operation:

- 1. In the Process Tracking page, from the process instance list, select several instances. In the Instance Details panel, a message indicates how many instances are currently selected to be processed. Also, the Actions list is updated with the options that can be performed over the group of instances that were selected.
- Select the operation in the Actions list. The selected operation is performed on the instances you specified.

4.5 Canceling a Process Instance in Process Workspace

Only process owners can cancel a process instance.

To cancel a process instance:

From the Actions list at the end of the row for the instance you want to cancel, select Cancel.

Select the instance and, from the Actions list on the toolbar of the Process Tracking page, select Cancel

4.6 Customizing the Presentation of Process Instances in Process Workspace

A presentation is the column arrangement used when viewing instances in the Work Items panel. You can use an existing presentation or create a new one to be associated with that view.

You can choose the columns that are presented in any view displayed in the Work Items panel.

To customize the presentation of a process instance:

- **1.** From the Views panel, select the view whose presentation you want to customize. The view is displayed in the Work Items panel.
- 2. From the Work Items toolbar, click **Edit Presentation**. This displays the Presentation dialog box in which you can select and sort the columns in your presentation.
- **3.** From the Available Columns list, select the columns you want to include in your view and move them to the Presentation Columns list by clicking the right arrow.
- To sort the columns:
 - Select an individual item in the Presentation Columns list.
 - **b.** Move it into place by using the vertical arrows to the right of the list.
 - Repeat for each column you want to sort.
- 5. Click OK.

Note: The Work Items panel displays process instances in two places: in the Process Tracking page and when using the Standard Dashboards page. You can customize the presentation of this panel as it appears in both places. However, if you first change the presentation in the Process Tracking page, and then change the presentation in the Standard Dashboards page, the latter configuration overrides whatever presentation you have configured in the Process Tracking page. When you navigate back to the Process Tracking page, the presentation will be whatever you configured in the Standard Dashboards page.

Working with Activity Guides in Process Workspace

This chapter describes activity guides in Oracle Business Process Management Workspace. They can organize and lead you through the various processes in which you have assigned tasks.

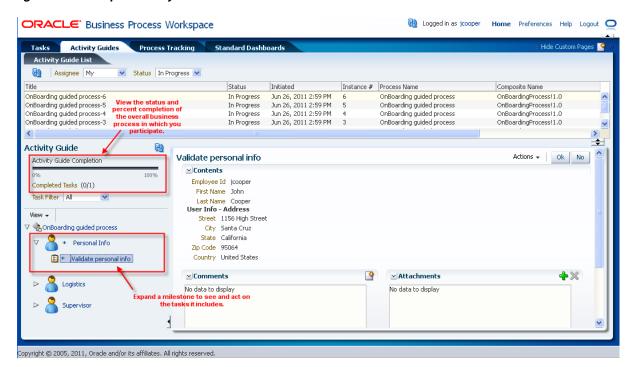

5.1 Understanding Activity Guides

Activity guides organize your tasks into milestones. Each milestone is a specific set of tasks for you to complete, either on your own or in collaboration with others. For each milestone, the activity guide tells you which tasks to complete and in which order. You complete a milestone by completing all the tasks it contains for you. Depending on the nature of the task, you can save an unfinished task and resume it later.

Figure 5–1 shows an example of an activity guide.

Figure 5–1 Sample Activity Guide



Using an activity guide, you can:

- Expand a milestone to see and act on the tasks it includes.
- View the status and percent completion of the overall business process in which you participate.

5.1.1 Why Use Activity Guides

As in the example in Figure 5–1, an activity guide can help organize the tasks involved in an onboarding process. The activity guide moves the user through the correct sequence of steps in the process. In this example, one milestone is *Personal Info*, which includes the task *Validate personal info*.

In an activity guide, users can act on only those tasks presently needing their attention in the current milestone. Once they have completed all their tasks for that milestone, they can act on the tasks for the next milestone. They cannot act on tasks in future milestones or on those assigned to other users.

5.2 Navigating Activity Guides

When you select the Activity Guides tab, the tab page displays the Activity Guide List.

The upper section of the Activity Guide List shows a process list displaying all the processes currently moving through the system.

- To get the latest updates to these processes, click the refresh Activity Guide process list icon.
- To filter the data for the Assignee, select from the following:
 - My: Retrieves all activity guide process instances that have active tasks assigned to the logged-in user and those that report to that user.

- **Reportees**: Retrieves all activity guide process instances that have active tasks assigned to those that report to the logged-in user
- **Previous**: All activity guides processes instances whose tasks have been completed by the logged-in user
- To filter the data according to the status of the processes, select one of the following:
 - In Progress
 - Completed
 - **Errored**

Table 5–1 lists and describes the columns in the process list displayed in the Activity Guide List subtab.

To display a process activity guide in the lower section of the page, select the process from the process list. To display a process activity guide in a separate tab page, right-click the process in the process list and select **Open in separate tab**. This separate tab page refreshes to whatever process you later select from the process list.

The left section of the activity guide displays the guide's navigation panel described in Table 5–2.

The right section of the activity guide displays the details of the selected node in the activity guide process tree.

5.3 Showing or Hiding the Activity Guide Tab Page

If you are an administrator, you can specify whether to show or hide the Activity Guide tab page. If you choose to show it, you can make it the default tab when a user logs in.

For instructions on how to show or hide the Activity Guide tab, and to make it the default, see Section 9.1.8, "How to Show or Hide the Default Tab Pages in Process Workspace".

Creating and Editing Custom Pages in Process Workspace

This chapter describes how to customize the default layout in Oracle Business Process Management Workspace, and also how process designers and administrators can create new layouts and associate them with different sets of roles. This enables them to define the experience for the various kinds of users of each project.

A layout is a set of pages. It contains information about the pages it contains and about the panels each page contains.

Process Workspace provides its own default layout, but you can customize that layout by adding new pages and panels.

You can choose which pages to hide or show by selecting from the **Hide Tabs** list in the toolbar.

Depending on your roles, you may see several layouts at the same time.

6.1.1 How to Create a Custom Page in Process Workspace

To create a custom page:

- 1. In the upper right corner of Process Workspace, click **Add Page**. The new page appears.
- 2. In the upper right corner of the new page, click **Add Panel**. The Add Panel dialog box appears with the Applications item selected, as shown in Figure 6–1.

You can choose the type of application panel to add: application, dashboard, or process instance.

6.1.2 How to Add an External URL to a Customized Page in Process Workspace

You can set your customized page to open an external web page such as cnn.com or oracle.com. To do this, in the newly created page, select Show External URL and add the URL.

Note: Do not enter the external URL of a website that has frame bursting enabled. To include such websites, add them as external applications as explained in Section 9.1.7, "How to Enable Customized Applications and Links in Process Workspace."

6.1.3 How to Add an Applications Panel to a Customized Page in Process Workspace

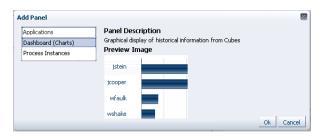
To add an Applications panel to a customized page:

- 1. From the Add Panel dialog box, select Applications, then click **Ok**. The Applications panel appears on the page.
- Specify the name of the Applications panel and any configurable properties.
- Click **Apply**.

6.1.4 How to Add a Dashboards Panel to a Customized Page in Process Workspace

From the Add Panel dialog box, you can also select Dashboards (Charts), as shown in Figure 6–2.

Figure 6–2 Adding a Dashboards (Charts) Panel



This dialog box enables you to include either charts or a chart selector in your new page. Choosing either one provides you with the corresponding preview image.

To add a Dashboards panel to a customized page:

- From the Add Panel dialog box, select Dashboards (Charts), then click **Ok**. The Dashboards panel appears on the page.
- In the **Panel label** section, specify the name of the Dashboards panel.
- In the **Panel properties** section, from the **Data Source** list, select a data source for this dashboard panel. The default options are:
 - Workload per Process
 - Performance per Process
 - Workload per Participant
 - Performance per Participant

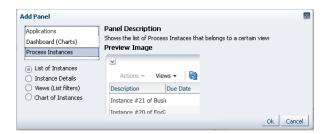
You can also specify a custom data source. To do this:

- In the Dashboards panel, in the Panel Properties section, to the right of the **Data Source** field, click the spy-glass icon. The Data Sources dialog box appears.
- In the navigator pane on the left, click **New**. A Data Source dialog box appears for you to create a new data source.
- Specify the fields as described in Section 7.2.1, "Specifying Graph Content."
- When you are finished specifying the data source, click **Ok**.
- Specify the action to be triggered when clicking the graph or widget. Options are:
 - Update another widget: Updates any widget configured to listen to this widget
 - Update a view: Updates any view configured to listen to this widget
- Specify any communication that is to take place with other panels. For information, see Section 6.2, "Establishing Communication Between Panels in Process Workspace" on page 6-6.

6.1.5 How to Add a Process Instance Panel to a Customized Page in Process Workspace

From the Add Panel dialog box, you can select Process Instances, as shown in Figure 6–3.

Figure 6–3 Adding a Process Instances Panel



Selecting this option enables you to include one of the following types of process instance panels in your new page: list of instances, instance details, views (list filters), and chart instances. Choosing any one of these displays the corresponding preview image.

To add a Process Instance panel:

- 1. From the Add Panel dialog box, select Process Instances, select the type of Process Instances panel, then click Ok. The type of Process Instances panel you selected appears on the page.
- **2.** In the **Panel label** section, specify the name of the Process Instance panel.
- If the **Panel properties** section appears for the type of panel you selected, set the properties as required.
- Specify any communication that is to take place with other panels. For information, see Section 6.2, "Establishing Communication Between Panels in Process Workspace."

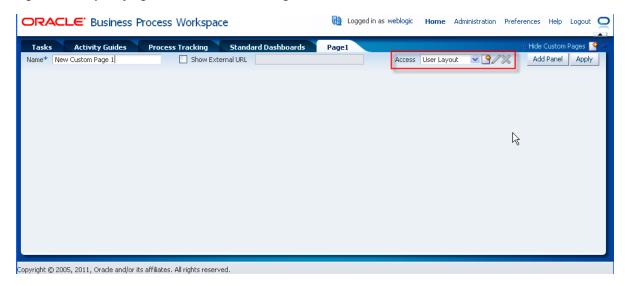
6.1.6 How to Grant and Manage Access to Customized Pages in Process Workspace

An administrator can specify the roles that can access a custom page that the administrator has created. Non-administrative users cannot grant access to custom pages.

To specify access to a custom page:

1. In the custom page you are adding, next to the Access field, click Add Access Properties.

Figure 6–4 Specifying Access to a Custom Page



The Add Access Properties dialog appears.

- In the Add Access Properties dialog box:
 - Enter an identifier and a name for this page layout.
 - From the Roles list on the left, select the roles to which you are granting access in this layout. Move them to the list on the right and click **OK**.

Note:

- Only an administrator can grant access to custom pages that the administrator has created. Non-administrative users cannot grant access to custom pages.
- To grant access to a role, you yourself must be associated with that role, otherwise it will not appear in the Role list.

The layout you have just created appears in the Access list. That layout now specifies the roles with access to this custom page.

To edit access properties for a custom page:

- In the custom page you are adding, next to the Access field, click **Edit Access Properties**. The Edit Access Properties dialog box appears.
- Enter your changes, then click **OK**. The layout as you have just edited it appears in the Access list. It now specifies the roles with access to this custom page.

Note: You can add new roles to a layout without removing previously granted roles.

To delete access properties for a custom page:

In the custom page you are adding, next to the Access field, click **Delete Access** Properties.

If the layout is a custom one, then you are prompted to confirm the deletion.

To maintain the custom page for the current user when a custom layout is deleted, the user must first save the page to the default layout. Only then should the user create the custom layout, modify the page, and save it to the new layout. If the user does not first save the page to the default layout, then the page is deleted for all members of the roles defined in the custom layout, including the current user.

If the user had right away created the custom layout and set it on the page before saving the page, then

Any custom pages previously associated with this custom layout remain, but are now associated with the default layout.

If the custom page uses the default layout, then the custom page is deleted. Users previously authorized to see this custom page will no longer see it.

6.2 Establishing Communication Between Panels in Process Workspace

You can establish communication between two panels so that an action in one panel is triggered by an action in the other. For example, you can configure a Process Instance panel to listen for actions that occur in a View List panel. Then, when a user selects a given view in the View List panel, that action triggers the use of that view in the Process Instance panel.

6.2.1 How to Establish Communication Between Panels in Process Workspace

To establish communication between panels, you configure one panel, designed with listening capabilities, to monitor actions in one or more source panels. An action occurring in a source panel then triggers an action in the listening panel.

Note: Communication can be established only between panels on the same page.

To establish communication between panels:

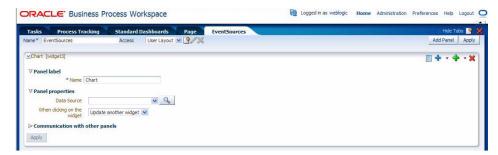
- 1. In the custom page, click **Edit Mode**. The entire page is available for editing.
- 2. Create a source panel and select the appropriate option from the **Data Source** list.
- **3.** Create a listening panel. This time, do not select anything from the **Data Source**
- 4. Expand Communication with other panels, and, in the Selected event sources window, select the source panel created in step 2.
- **5.** In each panel, click **Apply**.

Once you have done this, any action in the source panel triggers a corresponding action in the listening panel. For example, when two dashboard panels are communicating, clicking any graphical bars in the source panel triggers the use of that view in the listening panel.

6.3 Editing Custom Pages and Panels in Process Workspace

Figure 6–5 shows an example of a custom page as it initially appears, with the panel available for editing.

Figure 6–5 Example of a Custom Page



The custom page has three sections:

- Panel Label, which has a text field for specifying a name for the page
- Panel Properties, which has a field labeled Data Source, in which you can enter all or part of the name of a data source. You can also click the adjacent Browse button to search for a data source. This section also has a field labeled When clicking on the widget. It has an adjacent list from which you select the action you want triggered when clicking a widget.
- Communication with Other Panels described in Section 6.2.1, "How to Establish Communication Between Panels in Process Workspace"

This editable display of the panel enables you to define the name and properties for the new page and establish communication with other panels. In addition, the icons in the upper right corner of the new page enable you to:

- Switch to View Mode—that is, the manner in which the page is ordinarily viewed. After you switch to View Mode, you can switch back to Edit Mode.
- Move the panel up, right, left, or down.
- Add another panel to the right, left, above, or below this one.
- Remove this panel.

7.1 Using Standard Dashboards

Standard dashboards are the graphs and drill-downs based on data previously computed in a process cube schema. They reflect the standard metrics gathered during the execution of a process.

In each of the standard dashboards, clicking a bar graph in the left pane causes data to be displayed graphically in the right pane. Clicking an item in the right pane displays certain data in the Work Items panel in the lower pane. This section explains how each type of dashboard operates.

You can customize the presentation of the Work Items panel in the lower pane. For information on how to do this, see Section 4.6, "Customizing the Presentation of Process Instances in Process Workspace".

7.1.1 Participant Dashboards

Two types of standard participant dashboards enable you to analyze:

- The workload of participants
- The performance of participants

7.1.1.1 Participant Workload Dashboard

Figure 7–1 shows an example of a participant workload dashboard.



Figure 7–1 Participant Workload Dashboard

The left panel of a participant workload dashboard displays the total number of active instances waiting for completion for each participant across all processes. When you drill down into the chart for a specific participant, the right panel displays the total number of active instances waiting for completion by process for either the selected participant or the selected role. The last drill-down displays the active instances waiting for completion for either the selected participant or the selected role and process.

Note: In this release, participant information in a workload dashboard is for the physical role corresponding to the swimlane for the task. When the swimlane role is not defined, the corresponding participant information is null.

7.1.1.2 Participant Performance Dashboard

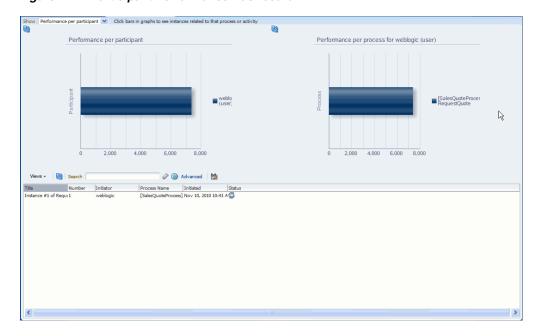


Figure 7-2 Participant Performance Dashboard

Figure 7–2 shows a participant performance dashboard.

The left panel of a participant performance dashboard displays the average time taken by participants across all processes. When you drill down into the chart for a specific participant, the right panel displays the average time taken to complete instances by process for the selected participant. The last drill-down displays the list of completed instances for either the selected participant or the selected role and process.

> **Note:** In this release, for processes that have user tasks with multiple users, user information is captured only for the last user that updated the task.

7.1.2 Process Dashboards

Two types of standard process dashboards enable you to analyze:

- The number of process instances waiting for completion
- The average time taken per process

7.1.2.1 Process Workload Dashboard

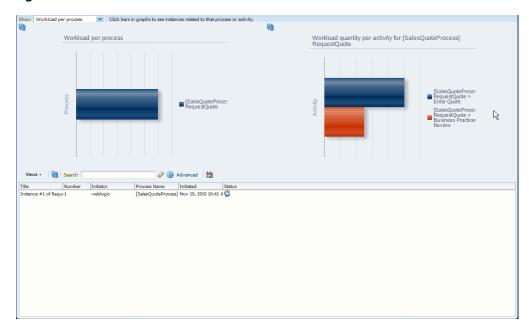


Figure 7-3 Process Workload Dashboard

Figure 7–3 shows a process workload dashboard.

The left panel in the process workload dashboard displays the total number of active instances waiting for completion per process. When you drill down into a specific process, the right panel displays the total number of active instances waiting for completion for activities in the selected process. The last drill-down displays the active instances waiting for completion for the selected activity and process.

7.1.2.2 Process Performance Dashboard

The left panel in the process performance dashboard displays the average time taken per process. When you drill down into a specific process, the right panel displays the average time taken to complete by activities in the selected process. The last drill-down displays the completed instances for the selected activity and process.

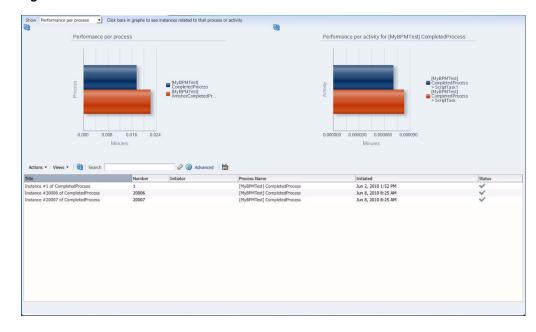


Figure 7–4 Process Performance Dashboard

Figure 7–4 shows a process performance dashboard.

7.2 Creating Custom Dashboards

As with standard dashboards, custom dashboards are the graphs and drill-downs based on data previously computed in a process cube schema. They reflect the standard and user-defined metrics gathered during the execution of the process. They enable you to define new graphs using both standard metrics and user-defined metrics specified by using business indicators.

For instructions about adding a custom dashboard, see Section 6.1.1, "How to Create a Custom Page in Process Workspace" on page 6-2.

7.2.1 Specifying Graph Content

Graph content is specified by defining a data source.

Specify the following data source information:

- Name: Provide a data source identifier
- Title: Provide the title used while displaying the data source
- Graph Type: Select one of the following list of graph types:
 - Area
 - Percent Area
 - Stacked Area
 - Horizontal Bar
 - Horizontal Percent Bar
 - Horizontal Stacked Bar
 - Bar

- Percent Bar
- Stacked Bar
- Line
- Percent Line
- Stacked Line
- Pie
- Pie Bar
- Multiple Pie
- Process: Select the process from the list. All business indicators associated with the selected process become available for the data source definition.
- Data Type: Select one of the following supported data types:
 - Workload
 - Activity and Measurement Sampling
 - **Process Level Sampling**

Dimensions

Series: Specify the dimension.

Use Range: Select to use ranges for dimensions with ranges.

Group: Specify the dimension used to group the dimensions used in a series.

Use Range: Select to use ranges for dimensions with ranges.

Drilldown to Series

Use Range: Select to use ranges for dimensions with ranges.

Note: If a new process is deployed while you have a dashboards page open, the new process will not be listed in the Data Sources dialog box until you log out of Process Workspace and then log back

Filters

You can add filter conditions based on the measure variables, series, and groups. You can add the filter condition only if a process is selected from the Process list. If "All" is selected in the Process list, then the Filters section is disabled.

Note: If you add a filter for business indicators, that filter filters out the values initially based on the condition given. Aggregation—either the sum or the average—then applies to the resulting set of items.

For example, if the user tries to compute the average of all business indicator values greater than 1000, the user will set a filter for this—for example: BI <Greater or equals> 1000 and set Operation type as "avg". The result is that the business indicator values greater than 1000 are collected first, and then the computation for the average calculation takes place.

8.1 Managing the Availability of Users in Process Workspace

If a user is unavailable for a period of time and must delegate some or all assigned tasks to another user, then the user rules can automatically reassign the tasks based on certain conditions. More specifically, if a user is going on vacation, a vacation period can be associated with a rule to create a vacation rule.

For more information about creating user rules, see Section 3.9.1, "How to Create User Rules in Process Workspace."

For more information about setting a vacation rule, see Section 3.9.3, "How to Enable a Vacation Period in Process Workspace.".

8.2 Distributing Work among Users in a Group

To distribute work among users in a group, you create a rule for that group. Creating a group rule is similar to creating a user rule, with the addition of a list of the groups that you, as the logged-in user, manage.

For information about creating user rules, see Section 3.9.1, "How to Create User Rules in Process Workspace."

Examples of group rules include:

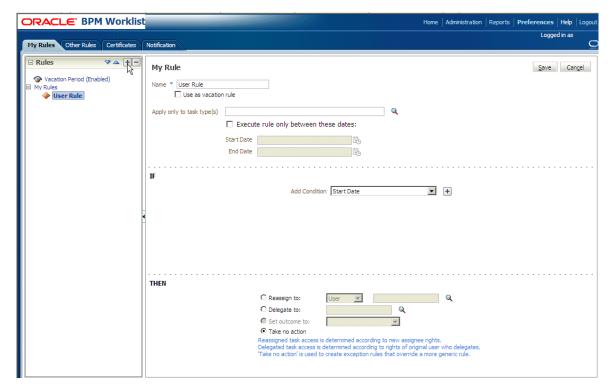
- Assigning tasks from a particular customer to a member of the group
- Ensuring an even distribution of task assignments to members of a group by using round-robin assignment
- Ensuring that high-priority tasks are routed to the least busy member of a group

For information about creating a group rule, see Section 3.9.2, "How to Create Group Rules in Process Workspace".

8.3 Setting Rules

Rules act on tasks, either a specific task type or all the tasks assigned to a user or group. Figure 8-1 shows where you set rules, including vacation rules (different from the vacation period settings described in Section 3.9.3, "How to Enable a Vacation Period in Process Workspace").

Figure 8-1 Creating a Rule



A rule cannot always apply in all circumstances in which it is used. For example, if a rule applies to multiple task types, it may not be possible to set the outcome for all tasks, since different tasks can have different outcomes.

Rules are executed in the order in which they are listed. Rules can be reordered by using the up and down buttons in the header, as shown in Figure 8–1.

If a rule meets its filter conditions, then it is executed and no other rules are evaluated. For your rule to execute, you must be the only user assigned to that task. If the task is assigned to multiple users (including you), the rule does not execute.

You cannot specify business rules for ToDo tasks

8.3.1 How To Create User Rules

Specify the following when creating a user rule:

- Rule name
- If the rule is a vacation rule. See Section 3.9.3, "How to Enable a Vacation Period in Process Workspace," for how to set the vacation period that is synchronized with the vacation rule.
- Which task or task type the rule applies to—If unspecified, then the rule applies to all tasks. If a task type is specified, then any attributes mapped for that task type can be used in the rule condition.
- When the rule applies
- Conditions on the rule—These are filters that further define the rule, such as specifying that a rule acts on priority 1 tasks only, or that a rule acts on tasks created by a specific user. The conditions can be based on standard task attributes and any mapped attributes that have been mapped for the specific tasks. See Section 9.2.1.1, "How to Specify Mapped Attributes," for more information.

User rules do the following actions:

- **Reassign to—**You can reassign tasks to subordinates or groups you manage.
- **Delegate to**—You can delegate to any user or group. Any access rights or privileges for completing the task are determined according to the original user who delegated the task. (Any subsequent delegations or re-assignments do not change this from the original delegating user.)
- **Set outcome to**—You can specify an automatic outcome if the workflow task was designed for those outcomes, for example, accepting or rejecting the task. The rule must be for a specific task type. If a rule is for all task types, then this option is not displayed.
- **Take no action**—Use this action to prevent other more general rules from applying. For example, to reassign all your tasks to another user while you are on vacation, except for loan requests, for which you want no action taken, then create two rules. The first rule specifies that no action is taken for loan requests; the second rule specifies that all tasks are reassigned to another user. The first rule prevents reassignment for loan requests.

To create a user rule:

- Click the **Preference**s link
 - The **My Rules** tab is displayed.
- In the **Rules** area, click **My Rules** and click **Add**.
- In the **My Rule** area, do the following and click **Save**:
 - Provide a name for the rule.
 - Select **Use as a vacation rule** if you are creating a vacation rule. The start and end dates of the rule are automatically synchronized with the vacation period.
 - Browse for task types to which the rule applies.
 - Select Execute rule only between these dates and provide rule execution
 - In the **IF** area, add rule conditions.

In the THEN area, select actions to be taken: Reassign to, Delegate to, Set **outcome to**, or **Take no action**), as shown in Figure 8–2.

The new rule appears under the **My Rules** node.

8.3.2 How To Create Group Rules

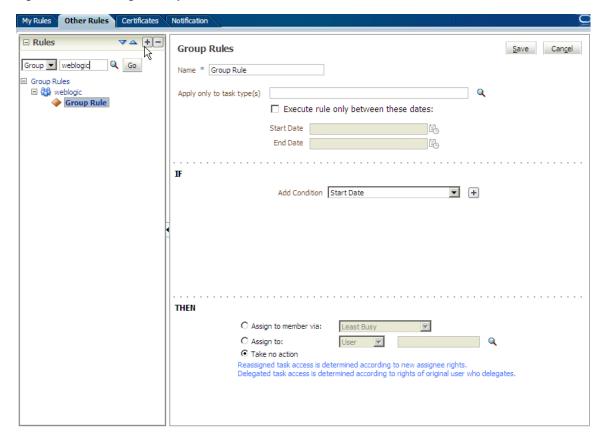
Creating a group rule is similar to creating a user rule, with the addition of a list of the groups that you (as the logged-in user) manage. Examples of group rules include:

- Assigning tasks from a particular customer to a member of the group
- Ensuring an even distribution of task assignments to members of a group by using round-robin assignment
- Ensuring that high-priority tasks are routed to the least busy member of a group Group rules do the following actions:
- **Assign to member via**—You can specify a criterion to determine which member of the group gets the assignment. This dynamic assignment criterion can include round-robin assignment, assignment to the least busy group member, or assignment to the most productive group member. You can also add your custom functions for allocating tasks to users in a group.
- **Assign to**—As with user rules, you can assign tasks to subordinates or groups you directly manage.
- **Take no action**—As with user rules, you can create a rule with a condition that prevents a more generic rule from being executed.

To create a group rule:

- Click the **Preference**s link
- Click the **Other Rules** tab.
- Select **Group** from the list.
- Enter a group name and click the **Search** icon, or enter a group name. The Identity Browser opens for you to find and select a group.
- Select the group name under the **Group Rules** node and click **Add**, as shown in Figure 8–2.

Figure 8–2 Creating a Group Rule



- Provide group rule information and click Save.
 - Provide a name for the rule.
 - Browse for task types to which the rule applies.
 - Provide rule execution dates.
 - In the IF area, add rule conditions.
 - In the THEN area, select the actions to be taken (or none) (Assign to member via, Assign to, or Take no action), as shown in Figure 8–2.

The new rule appears under the **Group Rules** node.

8.4 Setting Assignment Rules for Tasks with Multiple Assignees

If a task has multiple assignees, then assignment rules are not evaluated for the task, and the task is not automatically routed. This is because each of the task's assignees can define assignment rules, which can potentially provide conflicting actions to take on the task. Only tasks that are assigned exclusively to a single user are routed by the assignment rules.

For example, consider the following sequence:

- A rule is created for user cdickens to reassign all assigned requests to user jstein.
- User jcooper reassigns the allocated tasks to cdickens and cdoyle.
- Cdickens claims the task, and the task appears in their inbox.

The task is not automatically reassigned to jstein. The task is routed to jstein, following the assignment rule set for cdickens, if user jcooper explicitly re-assigns the task only to cdickens instead of reassigning the task to multiple users (cdickens and cdoyle).

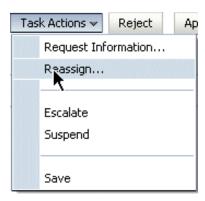
8.5 Reassigning or Delegating Tasks in Process Workspace

A supervisor can reassign or delegate tasks to reportees. A user with BPMWorkflowReassign privileges can delegate a task to anyone.

To reassign or delegate a task:

1. From the **Task Actions** list, select **Reassign**, as shown in Figure 8–3.

Figure 8–3 Reassigning a Task



2. Select Reassign or Delegate.

Delegate differs from Reassign in that the privileges of the delegate are based on the delegator's privileges. This function can be used by managers' assistants, for example.

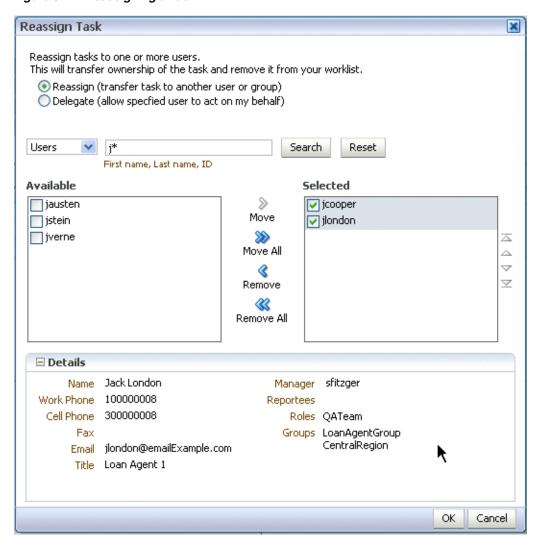


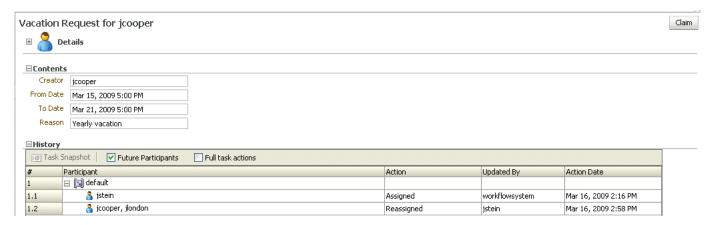
Figure 8-4 Reassigning a Task

Provide or browse for a user or group name, as shown in Figure 8–4.

A supervisor can always reassign tasks to any of his reportees.

Move names to the **Selected** area and click **OK**.

You can reassign to multiple users or groups. One of the assignees must claim the task, as shown in Figure 8–5.

Figure 8-5 Claiming a Task



When task details have been upgraded from an earlier release, you can see a "Request Failed" error when executing the Reassign action. Actually, the reassign completes, and when you click OK again, a popup says the task is already assigned.

To eliminate the error message, upgrade your taskflow applications by opening them in Oracle JDeveloper, then redeploy the task form.

8.6 Using Reports to Manage Workflows in Process Workspace

Reports are available on the Tasks page in the Reports panel. Report results cannot be saved.

Figure 8–6 shows the Reports panel displaying the standard report types available.

8.7 Using Dashboards to Manage Workflows in Process Workspace

Dashboards provide a variety of analytical information about the workload on users for the different processes being executed. For example, if a specific user has many tasks assigned to her, and she is making little progress, this would indicate that all those corresponding processes are blocked. Having this information enables you to reassign those tasks to someone else and, if necessary some user or group routing rules can be specified to manage the issue in the short term.

For more information about dashboards, see Chapter 7, "Using Dashboards in Process Workspace".

8.8 Handling Escalations in Process Workspace

Escalations are among the system actions you can perform from the Task Details page.

For more information about the Task Details page, see Section 2.3.1.2, "The Process Workspace Task Details Page".

If a user escalates a task, it is automatically assigned to whomever is specified in the escalation path.

The escalation path is specified by the administrator. If no escalation path is specified, then the task escalates to the user's supervisor who can reassign it from there.

If a task is assigned to a role, but none of the role members have claimed the task, then the task is escalated as specified in the escalation path for that role. If the task is assigned to a role and a role member has claimed the task, then the escalation goes to the role member's supervisor.

For information about how an administrator specifies the escalation path, see Section 10.5.2, "How to Specify the Escalation Path for a Role".

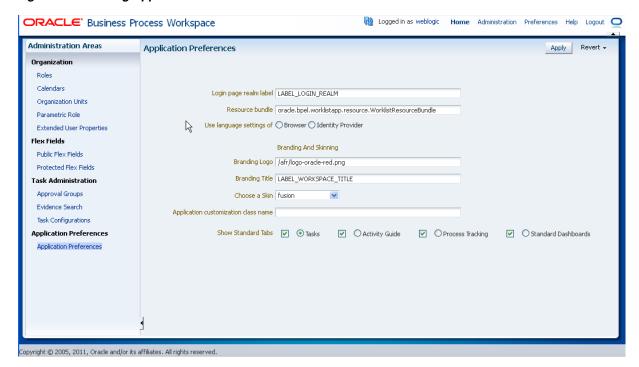

9.1.1 How to Specify the Login Page Realm Label in Process Workspace

If the identity service is configured with multiple realms, then, when a user logs in to Oracle BPM Worklist, the login page displays a list of realm names. LABEL_LOGIN_ REALM specifies the resource bundle key used to look up the label to display these realms.

You can change the term *realm* to fit the user community—terms such as *country*, company, division, or department may be more appropriate. To change the term realm, customize the resource bundle, specify a resource bundle key for this string, and then set the **Login page realm label** parameter to point to that resource bundle key.

For information about customizing the resource bundle, see Appendix B, "Customizing a Resource Bundle".

For information about specifying a resource bundle, see Section 9.1.2, "How to Specify the Resource Bundle in Process Workspace."

9.1.2 How to Specify the Resource Bundle in Process Workspace

The resource bundle provides the strings displayed in the Worklist Application. By default, the class path to the resource bundle is:

As an administrator, you can add or modify strings shown in the application by creating a custom resource bundle. You can then use the Resource Bundle field in the Application Preferences page to specify the class path to your custom resource bundle.

For more information about customizing the resource bundle, see Appendix B, "Customizing a Resource Bundle."

9.1.3 How to Specify the Language Locale Information in Process Workspace

From the Application Preferences page, you can specify how the Process Workspace display language is determined. Information about the language locale can be derived from either the user's browser or the identity provider that stores information on worklist users.

You reach the Application Preferences page by clicking **Administration** on the global toolbar at the very top of Process Workspace, then, under Administration Areas, selecting **Application Preferences**. The Application Preferences panel appears in the right pane. To specify the display language, in the Use language settings of field, select either **Browser** or **Identity Provider**.

9.1.4 How to Specify a Branding Logo in Process Workspace

A branding logo is the image displayed in the top left corner of every page of the Worklist Application. The Oracle logo is the default, and you can change it to one of your choosing.

Note: The ideal image size is 120px x 40px (length x width) for proper display. Although images with high resolution and size are compressed to fit the branding logo size, smaller images display better.

To specify the branding logo:

Do one of the following:

- Refer to an external image-hosting website. To do this: In the Branding Logo field, enter the URL of the image.
- Upload an image to a particular location on the server and, in the **Branding Logo** field, enter its relative path, for example, /afr/my_logo.png.
- Refer to an image from the shared library. To do this: In the **Branding Logo** field, enter the path of the logo name as found in the shared library, for example, /my_ logo.png

Note: Customizing the branding logo from either the Worklist Application or Process Workspace changes the logo in both applications. For example, if you change the logo from Worklist Application, then the Process Workspace logo is changed automatically.

For more information about deploying images in a shared library, see Appendix D, "Deploying Images and JAR files as Part of a Shared Library JAR file".

9.1.5 How to Specify the Branding Title in Process Workspace

You can specify the title for your site, changing the default title, BPM Worklist, to one that you choose.

To specify the branding title:

Do one of the following:

- In the **Branding Title** field, enter a simple string for your title.
- In the **Branding Title** field, enter a label that refers to a key-value pair in the Resource Bundle. In this way, you can internationalize your title, for example, LABEL WORKLIST TITLE.

9.1.6 How to Choose a Skin in Process Workspace

A skin determines the look and feel of your graphical interface.

To choose a skin:

Do one of the following:

- From the **Choose a Skin** list, select one of the default ADF skins
- Upload your own customized skin .css file in a .JAR file and deploy it as a part of shared library. Then, when you restart your application from the console, your custom skin appears in the **Choose a Skin** list.

To create a customized skin:

Create a directory structure similar to the following example:

```
C:\temp\META-INF\adf\oracle\skin\images
    META-INF\skins\custom.css
    META-INF\trinidad-skins.xml
```

Note that, in this example, you can change the word custom to the name of your own customized skin.

2. Make sure the content of trinidad-skins.xml file is as follows:

3. Create the .JAR file by issuing the following command from the c:\temp directory:

Copy this Jar file to the directory /scratch/username/sharedLib.

Note: Refer to the images in your CSS file this way:

../adf/oracle/skin/images/example.gif (with the two trailing dots).

This allows the search for the META-INF root to start one directory above the META-INF/skin directory in which the .css file is located.

9.1.7 How to Enable Customized Applications and Links in Process Workspace

For Process Workspace, you can create customized external applications and links that become available in the External Applications panel. Moreover, in both Process Workspace and the Worklist Application, you can specify the columns that appear in the Task Details pane.

To enable customized applications:

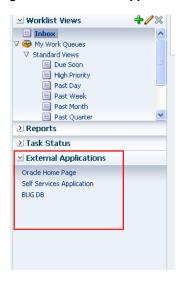
- In the Application Preferences page, enter the class name of your custom application in the **Application customization class name** field.
- Restart the application from the console.

Depending on your customization, you can now see it's effects.

If your customization is for Process Workspace and involves either creating an external application or specifying inbox columns in the Task Details pane or both, you will see the following:

Your custom application listed in the External Applications panel of the Process Workspace Home page as shown in Figure 9–3.

9.1.8 How to Show or Hide the Default Tab Pages in Process Workspace

If you are an administrator, you can specify whether to show or hide the Process Workspace standard tabs, for example, Tasks, Activity Guides, Process Tracking, and Standard Dashboards. Also, from the tabs you decide to show, you can select the one to be the default tab when a user logs in.

To Show or Hide the Standard Process Workspace Tabs:

- Select Administration, then Application Preferences.
- From the **Show Standard Tabs** row, select the checkboxes for the tabs you want to show, or deselect them for the tabs you want to hide.
- From the tabs you decide to show, specify which is the default tab when a user logs in. Do this by selecting the radio button next to the check box for that tab. If you do not select a default tab, then the standard tabs will not show or hide as you specified.

Figure 9–4 shows the Application Preferences page with the **Show Standard Tabs** row highlighted. It calls out a check box for selecting a tab to show or hide, and a radio button for selecting a tab to be the default at user login.

9.2.1 Managing Mapped Attributes (Flex Fields) in Process Workspace

Human workflow mapped attributes (formerly referred to as flex fields) store and query use case-specific custom attributes. These custom attributes typically come from the task payload values. Storing custom attributes in mapped attributes provides the following benefits:

- They can be displayed as a column in the task listing
- They can filter tasks in custom views and advanced searches
- They can be used for a keyword-based search

For example the Requester, PurchaseOrderID, and Amount fields in a purchase order request payload of a task can be stored in the mapped attributes. An approver logging into Process Workspace can see these fields as column values in the task list and decide which task to access. The user can define views that filter tasks based on the mapped attributes. For example, a user can create views for purchase order approvals based on different amount ranges. If the user must also retrieve tasks related to a specific requester or a purchase order ID, the user can specify this in the keyword field and perform a search to retrieve the relevant tasks.

For the mapped attributes to be populated, an administrator must create mapped attribute mappings, as follows:

- Specify a label for the mapped attribute to be populated.
- Map the payload attribute that contains the data to the label.

These mappings are valid for a certain task type. Therefore, each task type can have different mapped attribute mappings. After the mapping is complete and a new task is initiated, the value of the payload is transferred to the mapped attribute that has just been mapped. Tasks initiated before the mapping do not contain the value in the mapped attribute. Only top-level simple type attributes in the payload can be transferred to a mapped attribute. Complex attributes or simple types nested inside a complex attribute cannot be promoted. It is important to define the payload for a task in the Human Task Editor, keeping in mind which attributes from the payload may must promoted to a mapped attribute. All text and number mapped attributes are automatically included in the keyword-based search.

Essentially, the Human Task Editor is used only when defining the payload for a task. All other operations are performed at runtime.

Directory naming is not available concomitantly with the flex file naming convention.

Note: Mapped attributes must be defined before instances of the business process are generated. Only instances generated after mapped attributes are created reflect the correct mapped attributes. Older instances of the business process do not reflect subsequent mapped attribute changes.

For more information about how to map mapped attributes, see Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite.

9.2.1.1 How to Specify Mapped Attributes

An administrator, or users with the necessary privileges, can use mapped attributes, shown in Figure 9–5, to transfer data from the payload to inline mapped attributes. By promoting data to mapped attributes, the data becomes searchable and can be displayed as columns on the task list.

Administrators and users with the appropriate privileges can map both public and protected mapped attributes. They see both a Public Flex Fields node and a Protected Flex Fields node in the Administration panel as shown in Figure 9–5.

Figure 9–5 Specifying a Mapped Attribute

To create labels:

To create a mapped attribute mapping, an administrator first defines a semantic label, which provides a more meaningful display name for the mapped attribute. Click Add to use the Create Label dialog box shown in Figure 9–6.

Figure 9-6 Creating a Label



As the figure shows, **labelName** is mapped to the task attribute **TextAttribute1**. The payload attribute is also mapped to the label. In this example, the **Text** attribute type is associated with labelName. The result is that the value of the Text attribute is stored in the **TextAttribute3** column, and **labelName** is the column label displayed in the user's task list. Labels can be reused for different task types. You can delete a label only if it is not used in any mappings.

A mapped payload attribute can also be displayed as a column in a custom view and used as a filter condition in both custom views and workflow rules. The display name of the payload attribute is the attribute label that is selected when doing the mapping.

Note the following restrictions:

- Only simple type payload attributes can be mapped.
- A mapped attribute (and thus a label) can be used only once per task type.
- Data type conversion is not supported for the number or date data types. For example, you cannot map a payload attribute that is assigned the string datatype to a label that is assigned the datatype number.

To browse all mappings:

1. Click Browse all mappings.

2. Select a row in the label table to display all the payload attributes mapped to a particular label.

To edit mappings by task type:

- 1. Click **Edit mappings by task type**, optionally provide a task type, and click Search.
- **2.** Select a task type and click **OK**.
- With the task type displayed in the **Edit mappings by task type** field, click **Go**.
- Select a mapping label and click **Select**.

9.2.2 Administering Approval Groups in Process Workspace

An approval group consists of a name and a predefined set of users configured to act on a task in a certain pattern. This pattern is similar to a human workflow routing slip pattern where users can act on tasks in serial or parallel. An approval group also can contain a nested approval group in the pattern.

The name of an approval group is necessary when specifying the approval group list builder as discussed in Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management. The pattern configured in the approval group is used by default to order the users who must act on the task. However, when creating the list builder, the default pattern can be overridden by specifying the voting method.

The sections that follow describe the user interface that enables users with administrator rights to manage approval groups.

9.2.2.1 How to View Approval Groups

To view approval groups:

- 1. From the Process Workspace toolbar, click **Administration**. The Administration Areas panel appears in the left pane.
- 2. Under Task Administration, click **Approval Groups**. The Groups page appears in the right pane.
- In the navigation pane of the Approval Groups page, select an approval group. A details page for that approval group appears in the right pane, similar to the one shown in Figure 9–7.

9.2.2.2 How to Search for an Approval Group

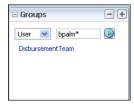
You can search for an approval group either by user name or group name.

To search by user name: 1.From the Process Workspace toolbar, click **Administration**. The Administration Areas panel appears in the left pane.

- Under Task Administration, click **Approval Groups**. The Approval Groups page appears in the right pane.
- Select **User** from the list.
- Enter the full user name for the user in the field. (You also can perform a wildcard search (*) with a partial user name.)
- Click the action (>) button.

A list of all approval groups to which the user belongs displays in the left pane, as shown in Figure 9–8.

Clicking the approval group name refreshes the details pane on the right with the structure of that group.

To search by group name: 1.In the left pane, select **Group** from the list.

- **2.** Enter the full group name in the field. (You also can perform a wildcard search (*) with a partial group name.)
- **3.** Click the action (>) button.

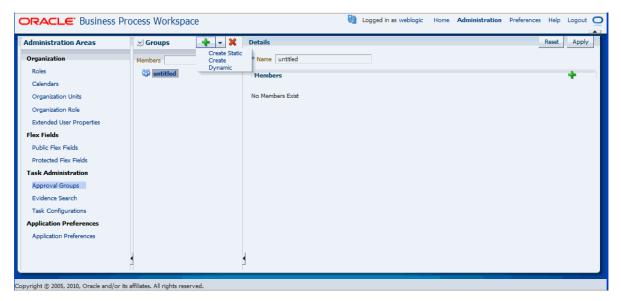
A list of all matching approval groups displays in the left pane.

Clicking on the approval group name refreshes the Details pane on the right with the structure of that group.

9.2.2.3 How to Add a Static Approval Group

To add a static approval group: 1.Click the Add (+) button and select Create Static from the list, as shown in Figure 9–9.

- **2.** Enter a new name for the group.
- Click **Apply**.

You can add members to the new approval group.

9.2.2.4 How to Add a New Member to a Static Approval Group

Members of a static approval group can be either users or other approval groups.

To add a new user member to an approval group: 1. From the Details page shown in Figure 9–10, click the **Add** (+) icon.

The other icons enable you to edit, delete, and reorder members in the approval sequence.

The Add to Group dialog box appears.

- 2. Select User.
- **3.** Do one of the following:
 - Enter a full user name and click **OK**.

The dialog box closes and the new member appears in the **Members** section of the **Details** pane.

- Click the magnifying glass to search for a user. If you click the magnifying glass, an Identity Browser pop-up dialog appears.
- **4.** Select **Users** from the list.
- **5.** Enter a full name in the text-entry field and click **Search**. (You also can perform a wildcard search (*) with a partial user name.)
 - The Identity Browser dialog refreshes and the search results appear.
- **6.** Choose a user from the list.
 - The details for that user appear in the **Details** section of the dialog.
- 7. Click OK.
- **8.** Click **OK** again to close the Add to Group dialog.

A node representing the selected user appears in the approval group structure in the **Members** section of the **Details** pane.

You can add more members to the approval group by repeating the steps above. The resulting approval group structure will look similar to the one shown in Figure 9–10.

9.2.2.5 How to Delete a Member from an Approval Group

To delete a member from an approval group: 1.Choose the appropriate member node from the approval group structure.

2. Click the **Delete** icon.

The approval group structure refreshes and the member node has been deleted.

9.2.2.6 How to Move an Approval Group's Members

To change the sequence order of an approval group: 1.Choose a member node to

2. Use the Push Member Up (^) and Push Member Down (v) icons to move the member to the desired location.

9.2.2.7 How to Nest Approval Groups

Nesting an approval group means making it part of another approval group.

To nest an approval group: 1.Click the Add icon.

- 2. Select Approval Group.
- **3.** Click the magnifying glass.

Another Add to Group dialog box appears.

4. From the left pane, choose the approval group you want to add.

Its structure appears in the right pane.

- Click OK.
- **6.** Click **OK** again to close the Add to Group dialog box.

The new approval group appears in the approval group's structure.

9.2.2.8 How to Rename an Approval Group

To rename an approval group: 1.Enter the new name of the approval group in the Name field.

2. Click Apply.

The name change is reflected in other approvals groups in which this approval group is nested.

9.2.2.9 Using Dynamic Approval Groups

Dynamic Approval Groups provide a way to create approval groups through a custom Java class at runtime. This requires the following:

- Writing a custom dynamic approval group class for the custom implementation by the developer
- Registering the custom dynamic approval group using the worklist apps UI by the IT department
- Making the class file available in a globally well known directory that is part of the Service Integration class path

9.2.2.9.1 How to Write a custom Dynamic Approval Group Class To define a dynamic approval group, the user must define an implementation class using the interface file IDynamicApprovalGroup.java, defined by AMX for dynamic approval groups in the package *oracle.bpel.services.workflow.task*. This package contains only one public method that gets the approval group members. The Task object will be the only input parameter. The primary key list can be obtained from the task task/systemAttributes/collectionTarget.

9.2.2.9.3 How to Make the Custom Dynamic Approval Group Class Available To make the class file available in a globally well-known directory that is part of the Service Integration class path, put your class files in the following WebLogic Server directory:

9.2.2.9.4 How to Add a Dynamic Approval Group The following procedure explains how to add a dynamic approval group.

- 1. In the left pane, click the Add (+) button and select Create Dynamic from the list
- Enter a name and a class for the group.
- Click **Apply** to save the group.

9.2.2.10 How to Delete an Approval Group

To delete an approval group: 1.In the Approval Group page, choose the approval group you want to delete.

2. Click the **Delete** (-) button.

A confirmation dialog box appears.

3. Click OK.

The approval group is deleted.

Note: If the approval group you deleted is nested in other approval groups, it also is deleted from those parent groups.

9.2.3 Using Task Configuration in Process Workspace

Task Configuration in Process Workspace lets business users and administrators review the rules that were configured automatically by the workflow designer. These predefined rules can be changed for a specific customer based on the customer's applicable corporate policies.

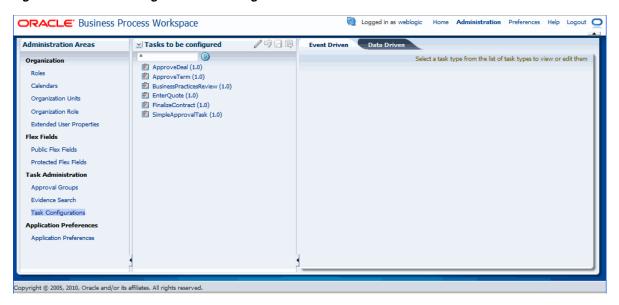
For example, if a corporate policy requiring two levels of approvals for expense amounts greater than 1000 is changed to a policy requiring three levels, the customer can use this web-based application to change the rule rather than having its IT department modify the rule in the underlying process and then deploy it again. Any change made to the rule will be applied starting with the next instance; instances that are already in progress will use the current rule definitions.

Task Configuration enables you to edit the event driven and data-driven rules associated with an approval flow at run time; that is, when the workflow has already been deployed.

To access the **Task Configuration** page:

- From the Process Workspace toolbar, click **Administration**. The Administration Panel appears in the left pane.
- In the Administration Panel, under Task Administration, click **Task Configuration**. The Task Configuration page appears in the right pane, as illustrated in Figure 9–12.

The **Tasks to be configured** section in the right pane lists all workflow tasks that have been configured to use approval-flow rules. It also provides a search capability. In the view mode, the right panel displays the default configuration and rules for overriding the approval-flow list builder configuration. The rule configurations are displayed based on the stages defined in the approval flow.

9.2.3.1 How to Edit Event-Driven Settings

This section contains information about event-driven settings (task metadata).

To edit an event-driven setting: 1.From the Process Workspace toolbar, click **Administration**. The Administration Panel appears in the left pane.

- In the Administration Panel, under Task Administration, click **Task Configuration**. The Task Configuration page appears in the right pane.
- In the **Tasks to be configured** pane, select a task. The main page refreshes in edit mode.
- Make your changes and click **Apply** to save them.

Note: An improper or incomplete rules definition in a list-creation rule set can cause runtime errors. Errors can be caused by the following:

- No rule was defined in the rule set.
- None of the conditions defined in the rule was met.

Ensure that rules are properly defined to handle all conditions.

9.2.3.1.1 How to Specify Routing Settings The Event Driven page contains a limited set of the routing options available in the Human Task Editor.

Approval aggregation requirements can be any of the following:

- None
- Once per task

Once per stage

9.2.3.1.2 How to Define Expiration and Escalation Policies Defining expiration and escalation policies in Process Workspace is similar to how it is done in the Human Task Editor. For more information, see the section "How to Escalate, Renew, or End the Task" in the chapter "Designing Human Tasks" in Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite.

9.2.3.1.3 How to Specify Notification Settings Creating or updating notification settings for a task in Process Workspace is similar to how it is done in the Human Task Editor. For more information, see the section "How to Specify Participant Notification Preferences" in the chapter "Designing Human Tasks" in Oracle Fusion Middleware Developer's Guide for Oracle SOA Suite.

9.2.3.1.4 How to Allow Task Access Access-rule settings can be set to control the actions a user can perform and is similar to how it can be done in the Human Task Editor. Content and action permissions can be specified based on the logical role of a user, such as creator (inititator), owner, assignee, and reviewers.

For more information, see Oracle Fusion Middleware Modeling and Implementation Guide for Oracle Business Process Management.

9.2.3.2 How to Edit Data-Driven Settings

To edit a data-driven setting (a rule or condition):

- 1. From the Process Workspace toolbar, click **Administration**. The Administration Panel appears in the left pane.
- 2. In the Administration Panel, under Task Administration, click Task **Configuration**. The Task Configuration page appears in the right pane.
- **3.** In the Task Configuration page, select the **Data Driven** page.
- **4.** In the **Tasks to be configured** pane, select a task.

The right panel refreshes in edit mode.

- **5.** Do any of the following:
 - Add
 - Update
 - Delete
 - Change assertions (which depend on the type of list builder for which the rule has been configured)
 - Add variables
- When you have finished making your changes, click **Apply**.

The changes are saved to the rule definitions in the rules dictionary.

9.2.3.2.1 How to Add a Variable To add a variable:

1. In the Data Driven page, click **Add variable**.

The Add Variable window appears.

- **2.** Enter a name for the variable.
- **3.** Click the down arrow to select a variable type from the list.

The types displayed in the list correspond to those that are available in the rule dictionary (built-in and others that have been registered).

- **4.** Enter a value.
- 5. Click OK.

The variable can now be used to define conditions.

9.2.3.2.2 How to Define Conditions You can set the left and right sides of a condition by selecting operands from condition browsers. Clicking the magnifying glass icon displays the browsers.

The operator for comparing the operands of the condition will change based on the type of operand selected for the left side of the condition.

You also can define more complex conditions using the Expression Builder.

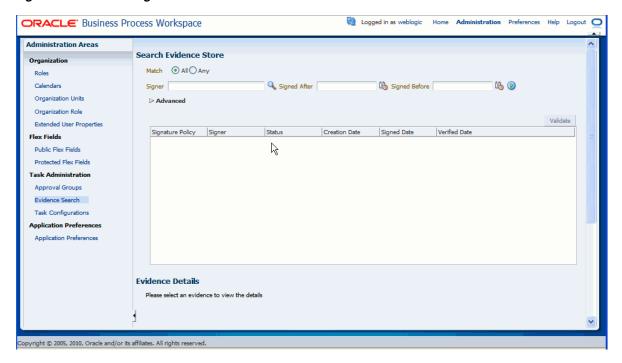
9.2.4 Using Evidence Search in Process Workspace

The evidence store service is used for digital signature storage and nonrepudiation of digitally signed human tasks.

To search the evidence store:

- In the Process Workspace toolbar in the upper right corner, click **Administration**. The Administration Areas panel appears in the left pane.
- 2. In the Administration Areas panel, under Task Administration, select Evidence **Search**. The Evidence Search page appears in the right pane, as shown in Figure 9–13.

3. Fill in the search fields, then click **Search Evidence Store**.

9.2.5 Managing Exceptions in Process Workspace

Under certain circumstances—for example, an employee who has left the company being assigned to a task—an exception can occur. When an exception occurs, the task gets put into an alerted state. The task then gets assigned to the error assignee or, if one is not specified, to the administrator.

For information about configuring the error assignee, see Oracle Fusion Middleware *Developer's Guide for Oracle SOA Suite.*

There are other scenarios in which an exception can happen.

9.3 Using the User Metadata Migration Utility

The user metadata migration utility, hwfMigrator, is a tool that automates the process of migrating workflow user-configurable data from one Service Integration server to another by executing a shell script. The tool also includes a property file that contains key-value pairs and all the input parameters required to perform the migration operation. You customize the property file and then perform the migration by executing the shell script.

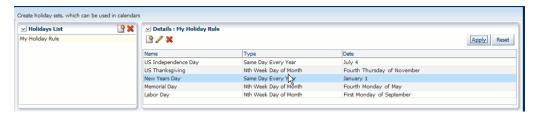
10.1 Understanding Deployment of Organization Entities in Process **Workspace**

For information about organizational units, see Oracle Fusion Middleware Modeling and *Implementation Guide for Oracle Business Process Management.*

When a process is deployed, the various organization entities—for example, the organizational unit, calendar, and so on—are created. Those entities can then be modified only through Process Workspace. Later, when the process is redeployed, data in Oracle BPM Studio does not overwrite any changes made during run time.

10.2 Managing Holiday Rules in Process Workspace

Figure 10-1 Holiday Rules



Business holidays are collections of holidays that can be applied to calendar rules. Then, when computing the duration of a process, the calendar takes into account the specified holidays.

You can create as many holiday rules as needed for different calendar rules. For example, if you apply holiday rules for India, the United States, and China to a given calendar, then those various national holidays are taken into account when the duration of a process is computed.

When you create a business holiday rule, you specify the holiday name, date, and holiday type. Table 10–1 lists and describes the holiday types.

Table 10-1 Holiday Types

Holiday Type	Description	
Same Day Every Year	On the same day each year	
Current Year	In the current year only	
Nth Week Day of Month	In a specified week, on a specified day, in a specified month each year—for example, in the United States, Thanksgiving Day is celebrated each year on the fourth Thursday of November	
Nth Day of Reference Holiday	On a day in relation to another specified holiday—for example, on the day after Thanksgiving Day	
Closest week day	The closest day to a given date—for example, in the United States, the Independence Day holiday may be celebrated on the weekday closest to the Fourth of July.	

To create a holiday rule:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- In the Organization panel, click **Calendars**. The Calendars page appears.
- In the Holidays List section, click **Add a Holidays List**. The Add a Holidays List dialog prompts you for the name of the new holiday list.
- **4.** Enter the name of the new holidays list and click **OK**. The new holidays list appears in the holidays list.
- **5.** Select the new holidays list. The details for the new list appear in the right pane.
- In the holiday details section, click **Add a Holiday**. A row appears for you to specify the attributes of the new holiday.
- Specify the name of the holiday, and the day on which the holiday occurs each year. Options for specifying holiday occurrence are described in Table 10–1.

Click **Apply**. The new holiday rule is configured according to your specifications.

To edit a holiday rule:

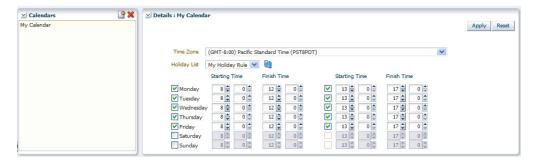
- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- In the Organization panel, click **Calendars**. The Calendars panel appears in the right pane.
- In the Holidays List section, select the holiday rule you want to edit. The details page for the rule appears in the right pane.
- Change the settings, and click **Apply**. The holiday rule is now modified according to your specifications.

To delete a holiday rule:

- From the Process Workspace toolbar, select Administration. The Administration Areas panel appears.
- 2. In the Organization panel, click **Calendars**. The Calendars panel appears in the right pane.
- In the Holidays List section, select the holiday rule you want to delete. The details for the rule appears in the right pane.
- Click **Delete Holiday Rule**. The holiday rule is now deleted.

10.3 Managing Calendar Rules in Process Workspace

Figure 10-2 Calendar Rules



A business calendar defines a work pattern for each day and a work week structure for each week. In addition, a calendar also defines non-working days by using business holiday rules—that is, the business calendar and holiday rule together define the work period.

When you create a business calendar, you define the following:

- Calendar name
- Time zone
- Working days in week
- Start time and end time for each day
- Optional holiday rule

You can create as many calendars as necessary.

You can specify a business calendar for a role and organizational unit association. For example, you can specify that the InsuranceAgents role in the US-California organizational unit follows the US-California business calendar.

To create a calendar rule:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- 2. In the Organization panel, click Calendars. The Calendars page appears in the right pane.
- 3. In the Calendars section, click Add a Calendar Rule. The Add a Calendar Rule dialog prompts you for the name of the new calendar rule.
- **4.** Enter the name of the new calendar rule, and click **OK**. The new calendar rule appears in the Calendars list.
- 5. Select the new calendar rule. The details for the new rule appears in the right
- **6.** Specify the following:
 - The time zone
 - The holiday rule, if any, that applies
 - The appropriate starting and finishing times
- 7. Click **Apply**. The new calendar rule is now configured according to your specifications.

To edit a calendar rule:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- **2.** In the Organization panel, click **Calendars**. The Calendars page appears in the right pane.
- 3. Select the calendar rule you want to edit. The details page for the new rule appears in the right pane.
- Change the settings, and click **Apply**. The calendar rule is now modified according to your specifications.

To associate a calendar rule with a role and an organization unit:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- **2.** In the Organization panel, click **Roles**. The Roles panel displays a list of the roles you are authorized to administer.
- 3. In the Details panel, in the Calendars section, click Associate a new calendar rule to an organization unit for the application role. Calendar and Organization Unit lists appear in the Calendar section.
- 4. Using Calendar and Organization Unit lists, specify the calendar and organization unit to which you want to associate this role.
- 5. Click Apply.

To associate a calendar with an organization unit:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- Under Organization, click **Organizational Units**. The Organizational Units panel appears.
- **3.** Select the organizational unit with which you want to associate a calendar rule. The details for that organizational unit appear in the right pane.
- **4.** In the Details panel, from the Calendars list, select the calendar to associate with this organizational unit.
- **5.** Click **Apply**.

To delete a calendar rule:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- 2. In the Organization panel, click **Calendars**. The Calendars panel appears in the right pane.
- 3. In the Calendars section, select the calendar rule you want to delete. The details for the rule appears in the right pane.
- **4.** Click **Delete Calendar**. The calendar is now deleted.

10.4 Managing Other Users' or Groups' Rules (as an Administrator) in **Process Workspace**

Administrators can make changes to rules. This can be useful for correcting a problem with a rule. For example, for a user who no longer works for the company, you can set up a rule automatically assigning that user's tasks to another user or group.

To create a rule for another user or group:

- From the Process Workspace toolbar, click **Configuration**. From the Configuration panel, in the Rules section, click **Rules**.
- **2.** Click the **Other Rules** tab.

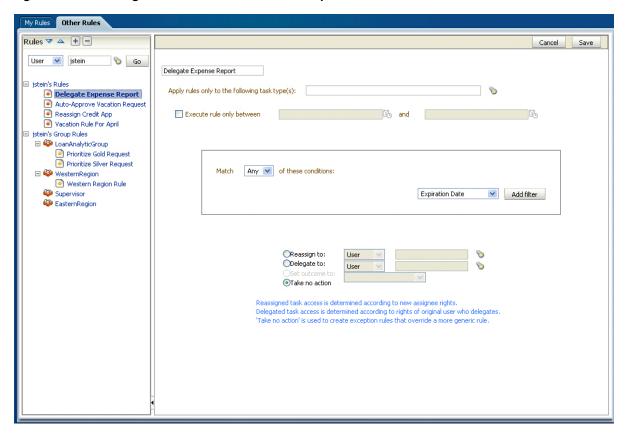
Figure 10–3 Creating Rules for Another User or Group

- Search for the user or group for whom rules are to be created, as shown in Figure 10–3.

- Click a user rules node, or click a group name (for a group rule).
- Click the **Add** icon to create a rule.

6. Provide rule information, as shown in Figure 10–4, and click **Save**.





10.5 Managing Roles in Process Workspace

Roles are created as application roles under the application OracleBPMProcessRolesApp. There are two types:

- Swimlane roles: Each swimlane role in a BPM process is created during design time in Oracle BPM Studio. It is then mapped to an application role that is created during deployment. This mapping cannot be changed after deployment.
 - Members for these application roles can be defined and updated before deployment by using Oracle BPM Studio or after deployment by using Process Workspace.
 - In this release, swimlanes define the default task assignee and how to initiate a process if the initiator task pattern is used. During runtime, only members of those roles can perform actions such as viewing and acting on tasks and initiating processes.
- Application roles: These represent any roles in the organization, and they can be created in addition to the swimlane roles defined during design time. An application role can be used as a task assignee or as a grantee of another application role. They can be created by using either Oracle BPM Studio or Process Workspace.

When you create a role, you define both the role name and the grantees of the role. The grantees can be users, groups, or other application roles.

10.5.1 How to Add New Application Roles

To add a new application role:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- 2. In the Organization panel, click **Roles**. The Roles panel displays a list of the roles you are authorized to administer.
- **3.** In the upper-right corner of the Roles panel, click **Add a new application role**. The Add Role dialog box appears.
- Specify a name, and, optionally, a description for the new role. Click **OK**. The new role is now listed in the Roles panel.
- To grant this role to users, groups or application roles, follow the steps in Section 10.5.3, "How to Grant and Revoke Roles".
- 6. To associate a calendar and its corresponding organizational unit with this new role, in the Calendar section:
 - Select Associate a new calendar rule to an organization unit for the application role.
 - b. From the Calendar list, select the calendar you want to associate with this new
 - **c.** From the Organization Unit list, select the unit that you want to associate with the calendar you just specified.

Note: When a calendar is associated with an organization unit for a role, this calendar overrides the calendar associated with the calendar page when the particular role is used.

10.5.2 How to Specify the Escalation Path for a Role

An administrator can specify the path an escalated task is to follow.

For more information about the escalation path, see Section 8.8, "Handling Escalations in Process Workspace".

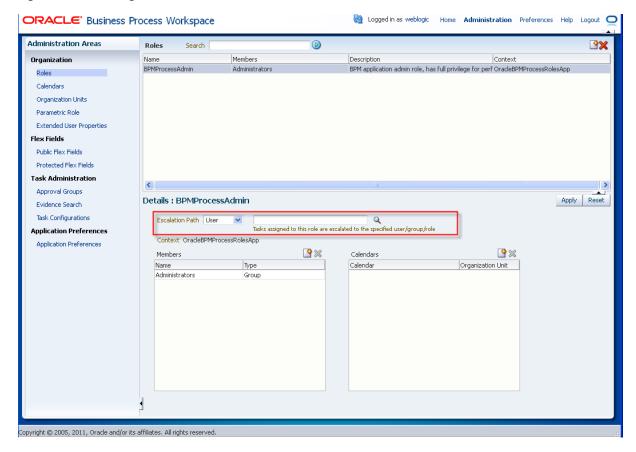
To specify an escalation path:

- 1. From the toolbar at the top of the Process Workspace, click **Administration**. The Administration Areas page appears. In the navigation pane, Roles is highlighted, and the corresponding information appears in the right pane.
- 2. If you want to set the escalation path for an existing role, select that role from the list. The corresponding information appears in the lower half of the right pane.

If you are creating a new role, click **Add a new role** and follow the instructions in Section 10.5.1, "How to Add New Application Roles" on page 10-7. The new role appears in the list, and its corresponding information appears in the lower half of the right pane.

Figure 10–5 shows the Roles window with the **Escalation Path** fields highlighted.

- From the list, select either User, Group, or Role. You may also enter or browse for a specific name.
- **4.** When you have specified the escalation path, click **Apply**.

10.5.3 How to Grant and Revoke Roles

You can grant roles to, and revoke them from, users, groups, or application roles

To grant a role to a user, group, or application role:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- **2.** In the Organization panel, click **Roles**. The Roles panel displays a list of the roles you are authorized to administer.
- **3.** Select a role. The Details panel displays the details for the selected role.
- In the Members section, click **Grant the role to user, group, or role.**
- Specify the parameters of your search, click **Search**, then select the user, group, or application role to whom you want to grant this role. The Details section for your selection appears.
- Click **OK**. The user or group you specified now appears in the Members box.

To revoke a role from a user, group, or application role:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- In the Organization panel, click **Roles**. The Roles panel displays a list of the roles you are authorized to administer.
- **3.** Select a role. The Details panel displays the details for the selected role.
- In the Members section, click **Revoke the role from user, group, or role.**
- Click **OK**. The user or group you specified no longer appears in the Members box.

Note: If, during design time, you update a process by removing a member from a role and then re-deploy the process, the member you removed is still listed as a member of that role. This is because permission to remove members from roles is limited to administrators during runtime.

10.5.4 How to Create and Manage Role-Specific Views and Layouts

For information about creating a role-specific layout, see Section 6.1, "Creating Custom Pages in Process Workspace"

10.6 Managing Parametric Roles in Process Workspace

Parametric roles are logical roles created by the administrator. Members of parametric roles are dynamically evaluated at runtime by specifying them as a parametrized query.

Parametric roles can be based only on process roles that are created by process deployment or created by using the Administration panel in Process Workspace. More specifically, they can be based on any role defined in the application context OracleBPMProcessRolesApp that is already seeded and displayed in the Roles section of the Administration panel.

Parametric roles define either members of an organizational unit or the assignees of a task.

10.6.1 Parametric Roles Used for Querying Members of an Organization Unit

These parametric roles are groups of users specified by using a query—for example, all grantees of role InsuranceAgent with expertise in HomeInsurance where expertise is an extended user property.

The query can contain one or more of the following parts:

- Group membership
- Role membership
- Extended user properties from which users select from a list of pre-defined values For information about extended user properties, see Section 10.7, "Managing Extended User Properties in Process Workspace".

Note: Deleting an extended user property already in use by an parametric role causes an error when administering that role.

10.6.2 Parametric Roles Used in Assigning Tasks

Parametric roles have one or more defined parameters that specify the type of person to whom a task can be assigned—for example, a task can be assigned as a parallel task to all users belonging to the Western region and whose skillsets include JAVA. The assignees that are returned by the dynamic parametric role can be used for any type of list builder—for example, sequential, parallel, or management chain.

The parameter values are defined at design time either as plain values or XPath expressions.

10.6.3 How to Create a Parametric Role

To create a parametric role:

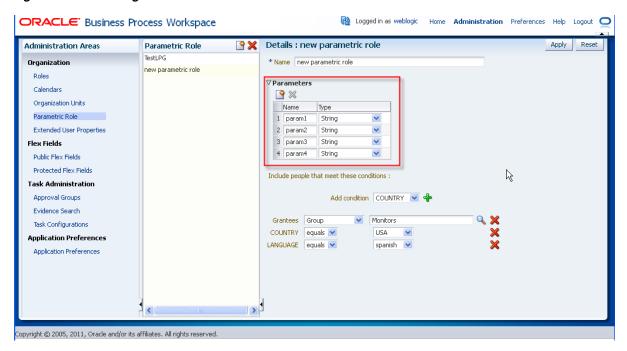
- 1. From the Process Workspace toolbar, click **Administration**. The Administration Areas panel appears in the left pane.
- Select **Parametric Role**. The Parametric Role panel appears in the right pane.
- In the Parametric Role panel, click **Create Parametric Role**. This opens an editable Details panel.
- Enter a name for this parametric role.
- If you do not want this parametric role to be attached to a task assignee, then skip to Step 6.

If you want this parametric role to be attached to a task assignee, then you must define the parameters to specify the assignee.

To define parameters for a parametric role used in assigning a task:

Expand Parameters and click Add Parameter. A table prompts you for the name and type of the parameter as in the example in Figure 10–6.

Figure 10–6 Defining Parameters



Define the parameter by specifying the name and type. To add another parameter, click Add Parameter again and repeat.

Note: You are not required to use any or all of the parameters that you define.

Once a parameter is defined, the role is treated as a parametric role regardless of whether the defined parameters are used in a query.

- To specify the users you want to associate with this role, you first configure the conditions for their inclusion. To do this, select a condition from the list. The listed conditions include:
 - The application role or group to which the users must belong.
 - The extended user properties the users must match. You specified the extended user properties in Section 10.7, "Managing Extended User Properties in Process Workspace"
 - Any parameters you may have defined for a parametric role used in assigning a task. When you begin entering a value, the list of defined parameters appears next to the field as in the example in Figure 10–7.

If you want to use a defined parameter as a condition, select from the list or enter the name of the parameter preceded by a dollar sign (\$).

Once you have selected one or more conditions, click **Add Criteria Row**. The condition you specified appears in the list of users you want to include. You can then specify the filter for that condition.

7. From the Grantees list, select either **Groups** or **Application Roles**.

If you select **Groups** specify the name of the group in either of the following ways:

- Enter the name of the group in the text field
- Click **Select Group** to begin a search. If you do the latter, then the Select Group dialog box appears. Specify your search, or use an asterisk (*) as a wildcard, then click **OK**.

The group you specified is listed as the grantee of this parametric role.

If you select **Application Role**:

- From the **Application Role** list, select OracleBPMProcessRolesApp.

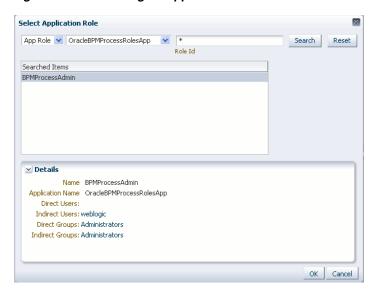


Figure 10–8 Selecting an Application Role

- If you know the role identifier of the grantee, then enter it in the **Role Id** field. If you do not know the role identifier of the grantee, then you can click **Select Application Role** to perform a search. The Select Application dialog box appears as shown in the example in Figure 10–8.

In the **RoleID** field, enter an asterisk (*) and click **Search**. The search results appear in the Searched Items box.

When you select each item in the Searched Items box, more detailed information appears in the Details box.

- **c.** Select the application role and click **OK**. The role you specified is listed as the grantee of this parametric role.
- **8.** Click **Apply**.

10.6.4 How to Modify a Parametric Role

To modify a parametric role:

- From the Process Workspace toolbar, click **Administration**. The Administration Areas panel appears in the left pane.
- Select **Parametric Role**. The Parametric Role panel appears in the right pane.
- 3. From the Parametric Role panel, select the role you want to modify. The Details panel for that role appears to the right.
- Enter the new values for the role just as you did when you created the role. See "To create a parametric role:" on page 10-10.
- Click **Apply**.

10.6.5 How to Delete a Parametric Role

To delete a parametric role:

- 1. From the Process Workspace toolbar, click Administration. The Administration Areas panel appears in the left pane.
- **2.** Select **Parametric Role**. The Parametric Role panel appears in the right pane.
- From the Parametric Role panel, select the role you want to delete. The Details panel for that role appears to the right.
- **4.** Click **Delete Parametric Role** and, when prompted, confirm the deletion.

10.7 Managing Extended User Properties in Process Workspace

Extended user properties are used in defining parametric roles, which are described in Section 10.6, "Managing Parametric Roles in Process Workspace.".

Typically, users have some properties specified in Oracle Internet Directory or some other LDAP directory. Often, however, additional properties specific to their organization and roles are necessary. At times, these properties are added on demand when newer business processes are created. At that time, it might not be possible to extend the company's global LDAP directory. In these cases, extended user properties are useful. For example, you can specify that a given user with the sales representative role is located in California. Although, from a functional point of view, there is only one role, the individual user is associated with a property, and that property has a value assigned for that user.

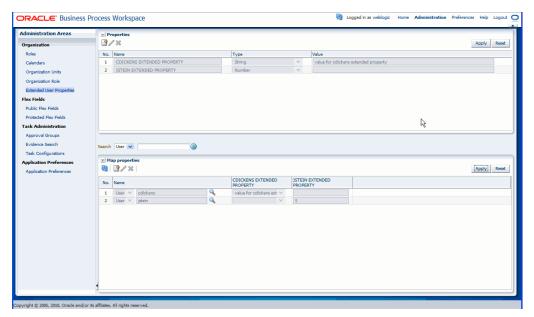


Figure 10-9 Extended User Properties

Figure 10–9 shows the Extended User Properties page.

Extended user properties can be assigned to users, groups, or roles.

When you create extended user properties, you define the following:

- Property name
- Property type, which can be of the following data types: string, number, date and free form text. String data types are enumerated values. Free form strings can have any value.
- Enumeration in case of a string data type. Note that only string-typed properties can be assigned values at the time of definition and only those values can be assigned to users when the property is associated with a user.

After properties are defined, they can be associated with any user. During association, values must be assigned to the property for that user

Only users who have Administrator privileges can define new properties.

To add extended user properties:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- In the Organization panel, click Extended User Properties. The Extended User Properties page appears in the right pane.
- In the **Properties** pane, click **Add Property**. Property fields appear in the table.

An Extended User Property has the following fields:

- Name—The name can be any user defined string that is meaningful to the user or the company. Case does not matter. The system will convert all names to uppercase.
- Type—The type field is a drop-down list from which the user must select the data type of the values that the property is expected to hold when it is associated with various users in the organization.
- Value—The value field is meaningful only when the property is assigned the data type string because only string typed properties can be assigned enumerations of values. This value can be a comma-delimited list.
 - For all other data types (number, date, and freeform text) no values can be assigned to the property.

For number, date, and freeform text-typed properties, a value is assigned to the property only when the property is associated to a user and the value assigned can be different for each user.

After you specify the property, click **Apply**. A column for this property appears in the Map Properties pane.

To modify extended user properties:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- In the Organization panel, click **Extended User Properties**. The Extended User Properties page appears in the right pane.
- In the **Properties** pane, select the property you want to edit, then click **Edit Property**. The row for that property becomes editable.
- Enter your changes, then click **Apply**.

To delete extended user properties:

Note: Deleting an extended user property already in use by an parametric role causes an error when administering that role.

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- **2.** In the Organization panel, click **Extended User Properties**. The Extended User Properties page appears in the right pane.
- In the Properties pane, select the property you want to delete, then click **Delete** Property. A Confirm Delete dialog box advises you that deleting a property will dissociate this property from and associated user, if any. If you are sure you want to proceed, click Yes.

4. In the Properties pane, click **Apply**.

To associate extended user properties to users:

- To specify the user with whom this property is to be associated, in the Map Properties pane, click **Add User**. The User field appears.
- Specify the user. You can do this either by entering the user identifier in the field or by clicking **Select User**, and, in the Identity Browser window that appears, performing a search for the user and clicking **OK**.
- If the property is a string type, then, in the Map Properties pane, from the column for the property, select the property to assign to this user. If the property is a number, enter the appropriate value in the text field.

Note: The **All** check box means that you wish to assign all the values defined on the string property to a particular user. It does not mean that you are assigning all the properties defined in the system to the user. The purpose of the All check box must be understood in the context that a user can be assigned multiple values for a string and a freeform text-typed property. For string-typed properties the values that you can assign to a user are enumerated at the time of property definition itself and the All checkbox enables you to assign all of them to a user at once. Freeform text-typed properties do not have any values defined on them. To assign multiple values to a freeform text-typed property at the time of associating it to a user, enter the multiple values and separate each value by a comma.

After you map the property to the user, in the Map Properties pane, click **Apply**.

10.8 Managing Organizational Units in Process Workspace

An organizational unit represents departments or divisions within an organization. Organizational units can contain child organizational units, creating a hierarchy that corresponds to your organization.

When you create an organizational unit, you define the following:

- Organizational unit name
- Time zone
- Members of the organizational unit, which can include users, groups, application roles, or parametric roles
- Optional parent organizational unit
- Optional business calendar

When a process is associated with an organizational unit, only members of that organizational unit and its children can see that process and the tasks initiated by it.

Note: A manager is not a member of an organizational unit by default. The manager must be added to the organizational unit in order to see the processes and the tasks within it.

If a process is associated with an organizational unit, then the tasks initiated by the process can use the business calendar associated with the organizational unit. Please see Section 10.3, "Managing Calendar Rules in Process Workspace" for more information.

To create an organizational unit:

- From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- Under Organization, click **Organizational Units**. The Organizational Units panel appears.
- 3. From the Add Organizational Unit list, select either Root Organization Unit or Child Organization Unit. The Create New Org Unit dialog box prompts you for the name of the organizational unit.

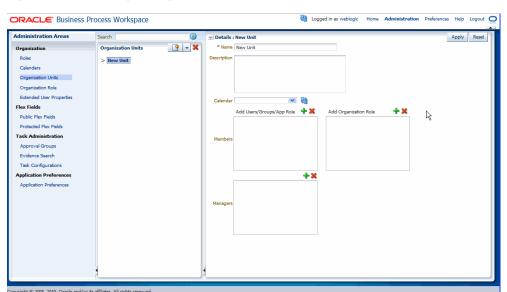


Figure 10–10 Adding an Organizational Unit

- Enter the name of the organizational unit, and click **OK**. The new organizational unit appears in the Organizational Units list as shown in Figure 10–10.

- In the right pane, in the Details section for the new organizational unit, do the following:
 - Optionally provide a description of the newly created organizational unit.
 - **b.** From the Calendar list, select a calendar rule to associate with this organizational unit.
 - For information about adding a calendar rule, see Section 10.3, "Managing Calendar Rules in Process Workspace".
 - **c.** In the Members window, click **Add new member**. The Select Member dialog box prompts you to search for a user or group to add to this organizational unit.
 - **d.** Enter the name of the user or group you want to add, then click **Search**. From the Available column, select one or more members you want to add, and use the arrow button to move them to the Selected column. Click **OK**. The members you added appear in the Members window.

- e. Similarly, in the Managers window, select Add new member. The Select Manager dialog box prompts you to search for a user or group to add to this organizational unit.
- f. Enter the name of the manager you want to add, then click **Search**. From the Available column, select one or more managers you want to add, and use the arrow button to move them to the Selected column. Click **OK**. The managers you added appear in the Members window.
- **6.** Click **Apply**.

To edit an organizational unit:

- 1. From the Process Workspace toolbar, select **Administration**. The Administration Areas panel appears.
- Under Organization, click **Organizational Units**. The Organizational Units panel appears.
- In the Organization Units panel, select the organizational unit you want to edit.

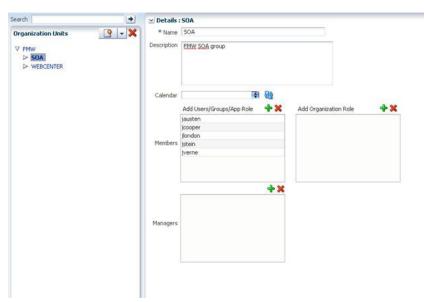


Figure 10-11 Organization Units Details Panel

In the right pane, in the Details section for the new organizational unit, make the changes you want, then click Apply.

To delete an organizational unit:

11.1 Understanding Process Spaces

Process Spaces is a workspace built on top of Oracle WebCenter Portal: Spaces. It enables greater collaboration by combining the content from the panels in Process Workspace with an additional workspace in which you can collaborate in the development of process models.

WebCenter Portal provides group spaces that support discrete communities of any size that are organized around an area of interest or a common goal. WebCenter Portal also provides various collaborative services enabling document sharing, discussions, wikis, lists, links, tagging, and real-time collaboration services such as presence and instant messaging.

As a combination of WebCenter Portal and Process Workspace functionalities, Process Spaces provides WebCenter group spaces that are designed specifically for modeling and executing business processes. In addition to these, Process Spaces also uses the collaborative services of WebCenter Portal.

For information about Oracle WebCenter Portal, see Oracle Fusion Middleware User's *Guide for Oracle WebCenter Portal: Spaces.*

11.1.1 Oracle WebCenter Portal Group Spaces for Business Process Management

Process Spaces provides these WebCenter Portal group spaces specifically for business process management:

- A process workspace—For process participants to collaborate on relevant processes and instances based on their roles. This enables, for example, a group of sales representatives within a given region to share documents and information about various customers, the products they are buying, their requirements and history.
- A process modeling space—For domain analysts to collaborate on various aspects of modeling business processes. This enables, for example, experts from various

departments to jointly develop processes that reflect the needs of their various departments.

A process instance space—Created on an ad hoc basis for long-running instances, it displays specific instances that require a high level of collaboration over time.

You can customize these group spaces based on functional teams, granting access only to a relevant set of users with the appropriate roles. After you specify these user sets, only the relevant processes are included in the space.

11.2 Starting and Logging In to Process Spaces

To start Process Spaces, you must have installed Oracle SOA Suite and the Service Integration server must be running. See Oracle Fusion Middleware Installation Guide for Oracle SOA Suite and Oracle Business Process Management Suite for more information.

To start and log in to Process Spaces:

1. Go to

http://host_name:port_number/webcenter/

The host_name is the name of the host computer on which Oracle WebCenter Portal is installed.

The port_number is the one used at installation.

2. Enter the user name and password.

You can use the preseeded user to log in as an administrator. If you have loaded the demonstration user community in the identity store, then you can use other users such as jstein or jcooper.

The user name and password must exist in the user community provided to JAZN.

3. Click Login.

11.3 Navigating Process Spaces

Tabs in Process Spaces are customizable depending on your roles—for example, an administrator can add or remove panels in any given page.

11.3.1 About the Process Spaces Process Workspace

The Process Spaces Process Workspace includes a Home page and a Process Tracking page.

11.3.1.1 The Process Workspace Home Page

After a user logs in, depending on the user's roles and privileges, the Process Spaces Home page displays the user's tasks and related panels, as shown in Figure 11–1.

Included in the various panels of the Home page is the Available Processes panel, which displays the processes the user is authorized to execute. The Home page also displays the task inbox and dashboards (charts), and several standard panels of WebCenter Portal.

11.3.1.2 The Process Workspace Process Tracking Page

Selecting the Process Tracking page provides process-related information, as shown in Figure 11–2. Depending on the user's roles and privileges, this page displays the process instance list and various other panels including available processes and dashboards. It also includes a number of standard WebCenter Portal panels.

11.3.2 The Modeling Space in Process Spaces

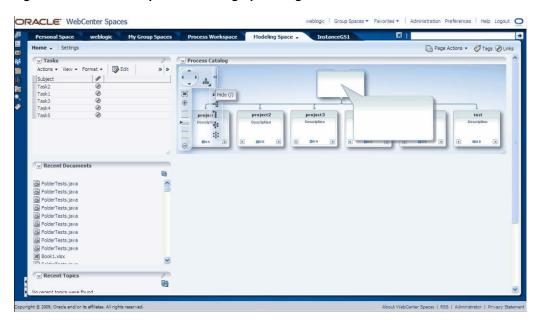


Figure 11–3 Process Spaces Modeling Space Page

The Process Spaces Modeling Space page enables users to collaborate on process definition. In this page users can, for example, comment on potential bottlenecks of a deployed process and discuss improvements. Figure 11–3 shows a Process Spaces Modeling Space page.

This page includes the Process Catalog, which graphically displays the various processes in the project. Each process is represented by a square. Navigation arrows within a given square enable you to find more information about the process it represents. The page also includes a number of panels that are standard to WebCenter Portal.

11.3.3 The Process Instance Space in Process Spaces

The Process Instance Space allows users to collaborate on a process instance. Usually the process instance space is used for a long-running process instance that involves many ad hoc activities and collaboration.

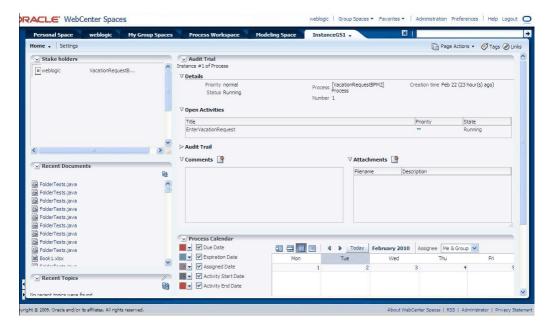


Figure 11–4 Process Spaces Process Instance Page

Figure 11–4 shows a process instance page showing the stakeholders of the process instance, audit trail of the instance, and the process instance calendar.

The default Process Workspace can also be customized just like any group space.

To create a customized default group space from the Process Workspace template, customize and then save the template. To customize the template, first create a group space from it, then customize, save, and publish it as Process Workspace Template.

12.15 Subscribing to a Process Workspace Group Space in Process **Spaces**

When Oracle Business Process Management Process Spaces is installed, users are not granted access to Process Workspace by default. To access the Process Workspace group space, the user logs in to Process Workspace and performs a search for discoverable spaces. From the search results, the user selects a Process Workspace and is asked to choose a role. Available roles are: Viewer, Participant, and Moderator.

The Participant and Viewer roles can be self-subscribed—that is, when the user chooses the role, the user is granted that role automatically. When the user chooses the Moderator role, that request is submitted to the administrator for approval.

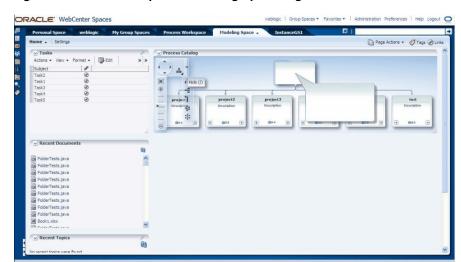


Figure 13-1 Process Spaces Modeling Space Page

Panel	Description
Stakeholders	Lists any user who has acted on the process, including the initiator
Recent Documents	Lists the most recently created or modified files in the entire root folder of the active content repository connection to the page
Recent Topics	Lists recent discussion topics, popular topics, watched topics, and watched forums
Audit Trail	Shows the details for this instance including any open instances. Enables you to add comments and attachments.
Process Calendar	Shows different dates associated with a process—for example: activity start date, activity end date, and human task dates such as assigned date, expiration date, and due date.

14.7 Customizing a Process Instance Space in Process Spaces

Like other templates, the process instance template can be customized. Unlike other templates, the process instance template cannot be used to create other group spaces manually. It is used by the system to create a group space that is connected to a specific process instance.

The created group space can be customized just like any other Oracle WebCenter Portal group space. However, because there is instance-specific data—namely, a process instance identifier link—you should not modify the group space attribute that is added as part of its creation.

15.1 Understanding Custom Dashboards in Process Spaces

Dashboards provide analytical information to monitor process execution as well as user workloads. They provide summary information.

From within Process Spaces, you can create and edit custom dashboards.

For information about custom dashboards and how they are created in Process Workspace, see Section 7.2, "Creating Custom Dashboards."

15.2 Creating a Custom Dashboard in Process Spaces

To develop a custom dashboard in Process Spaces, you use the Process Dashboard taskflow found in the WebCenter Portal Resource Catalog.

15.2.1 How to Create a Custom Dashboard in Process Spaces

You can create one or more custom dashboards in either a new or an existing custom page.

To create a custom dashboard in Process Spaces

- In the Process Workspace home page of Process Spaces, from the **Actions** list, select either **Edit page** or **Create a new page**.
- Click **Add Content**. The Add Content dialog appears.
- Open the Process Workspace Resources folder and add Process Dashboard. The Process Dashboard region now appears in Process Workspace.
- 4. In the Process Dashboard region, click Edit. The Component Properties dialog box appears.
- 5. In the Component Properties dialog box, next to the Widget ID field, select the spyglass icon. The Pick a Value dialog box appears.

- 6. From the Pick a Value dialog box, you can either create a new data source or select an existing data source.
 - To create a new data source, in the Widget ID panel, select the **Add** icon. A Widget ID page appears in the right pane.
 - To select an existing data source, select from the list in the Widget ID panel. The corresponding page appears in the right pane.

For information about specifying the data source, see Section 7.2.1, "Specifying Graph Content."

Once you have selected and specified the data source, click **Save and Close**. This returns you to the Component Properties dialog box. The Widget Id field is now filled in with the value for the data source you just selected.

Click **OK**. This returns you to the Process Dashboard region, which now contains the data source you just specified.

Note: If the space containing the custom dashboard is shared between different users, then the custom dashboard is visible only to users with permission to see the data corresponding to that dashboard. You grant permissions for the data source from Process Workspace.

16.1 Understanding Roles and Permissions in Process Spaces

Both Oracle WebCenter Portal and Oracle Business Process Management Process Spaces use an identity store, each with a different set of application roles. Process Spaces group spaces come with default WebCenter Portal roles—for example: moderator, participant viewer, and public user. However, an administrator can create more roles and provide appropriate permissions to them.

For more information about creating roles and providing permissions, see *Oracle* Fusion Middleware User's Guide for Oracle WebCenter Portal: Spaces.

16.2 Understanding Task Flows in Process Spaces

Task flows in Process Spaces display the same information available in Process Workspace. These are reusable components that have been consumed in Oracle WebCenter Portal so they can be used in Process Spaces.

For more information about the various task flows and their parameters, see Appendix A, "Creating Custom ADF Applications with Oracle Business Process Management Workspace Task Flows."

16.3 Editing Pages in Process Spaces

To use Process Spaces specific group spaces and templates, use the BPM Process Spaces Catalog. The BPM Process Spaces Catalog includes all the resources from the default group space catalog.

If you have upgraded from an earlier release and you want to edit the existing Process Spaces group space, you can either change the settings to use BPM Process Spaces

Catalog for the particular group space or change the settings globally so that all group spaces in the application use the BPM Process Spaces Catalog.

For information about how to use a resource catalog, see Oracle Fusion Middleware *User's Guide for Oracle WebCenter Portal: Spaces.*

BPM Process Spaces Catalog includes the following folders:

- **Process Work Space Resources**
 - Available processes: All available processes that a logged-in user can instantiate
 - Charts: Charts that show various statistics
 - Process instance list: All process instances a user can access
 - Task list: List of tasks that user has to act upon
- Process Instance Space Resources
 - Audit trail: Audit trail of a given instance in tabular and graphical forms
 - Process calendar: Calendar that shows various important dates for a given process instance. Also capable of showing dates for all process instances of a user in context.
 - Stake holders: List of stake holders for a given instance.
- **Process Modeling Space Resources**
 - Process catalog: Process catalog viewer that shows all published processes.

While there are no restrictions about using these task flows, they are grouped based on the group spaces to which they belong. However when a custom group space is created, you can mix and match the task flow.

For task flows to function correctly, you must pass the appropriate parameters to them. For configuring task flow parameters, see the Oracle WebCenter Portal documentation

For information about each task flow, see Appendix A, "Creating Custom ADF Applications with Oracle Business Process Management Workspace Task Flows."

You edit a page just as you would any other group space page. For more information, see Oracle Fusion Middleware User's Guide for Oracle WebCenter Portal: Spaces.

Each group space has a settings page for administering the group space. Process Workspace settings are configured to enable self-subscription for users. You can change these settings as needed. The rest of the default group space settings are similar to any other group space.

Different features available in Process Workspace are exposed as standalone reusable components, called task flows. This appendix provides basic information about the features in each task flow.

You can embed task flows in any Oracle Application Development Framework (ADF) application. These standalone task flows provide many parameters that enable you to build customized applications.

All the task flows are bundled in an ADF library that you can include in the application in which you are embedding.

Later, in Section A.5, "Samples: Customizing ADF Applications with Oracle Business Process Management Workspace Task Flows," a sample task flow using TaskListTaskFlow shows detailed steps for embedding the task flow in the application as well as customizing, deploying, and running it.

A.1.1.1 federatedMode

If you set this parameter to true, then the task list is shown in the federated mode. For the task flow to run in federated mode, you must pass the list of federated servers to the task flow. For instructions about how to pass a list of federated servers to the task flow, see Section A.1.1.2, "federatedServers".

A.1.1.2 federatedServers

To pass the federated servers list to the task flow, do one of the following:

Provide the client configuration file, wf_client_config.xml, in the class path The class path is either APP-INF\classes\wf_client_config.xml at the ear level or the WEB-INF\classes of the web application. The client configuration file contains all federated server details.

For a sample .wf_client_config .xml file, see Section A.6, "Sample: Wf_client_ config.xml File".

Construct a JAXB object that contains the federated servers list. This JAXB object can be passed to the task flow through the federatedServers parameter. The object should be returned by a backing bean method.

For a sample bean with the method returning the WorkflowServicesClientConfigurationType object, see Section A.7, "Sample: Bean with the Method Returning the WorkflowServicesClientConfigurationType Object"

If you provide both the client configuration file wf_client_config.xml and the JAXB object to the task flow, the JAXB object takes precedence.

A.1.1.3 showServerColumn

If the task flow is run in federated mode, the server column in the task list is not shown by default. To show the server column in the task list, this parameter must be passed as "true".

A.1.1.4 wfCtxID

This is a workflow context token string. It is used to create workflow context inside the task flow.

Note: If the application is SSO-enabled or is secured using ADF security, this parameter is not required. Otherwise, this parameter is required.

To get the workflow context identifier:

A.1.2 Certificates Task Flow

A digital certificate contains the digital signature of the certificate authority so that anyone can verify that the certificate is real. A digital certificate establishes the participant's credentials. It is issued by a certification authority. It contains your name, a serial number, expiration dates, a copy of the certificate holder's public key (used for encrypting messages and digital signatures), and the digital signature of the certificate-issuing authority so that a recipient can verify that the certificate is real

As Figure A-2 shows, when you want to sign a decision, you can upload your digital certificate. When signing a task outcome by using your certificate, you must upload not only the one certificate issued to you by the certification authority but the entire chain of certificates. Upload the chain as a . P7B (PKCS7 format) file.

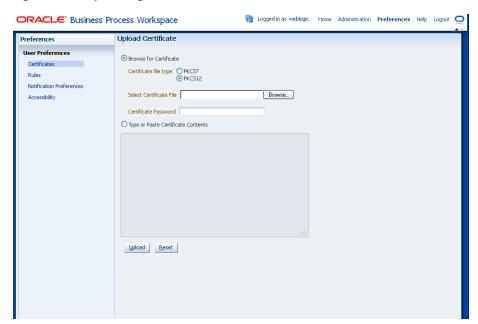


Figure A-2 Uploading a Certificate

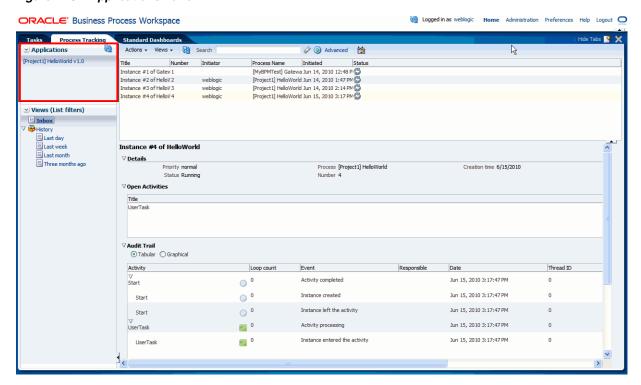

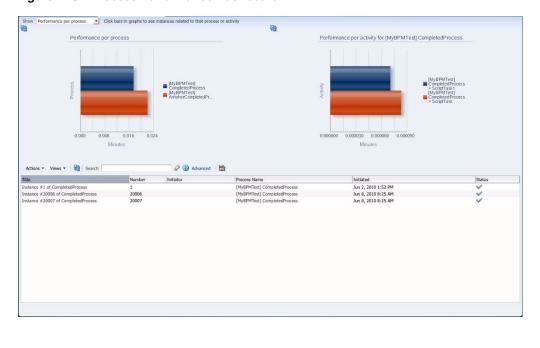


Figure A-5 Process Performance Dashboard

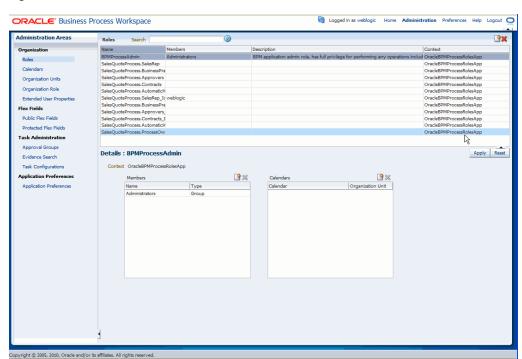


Figure A-6 Role Details Panel

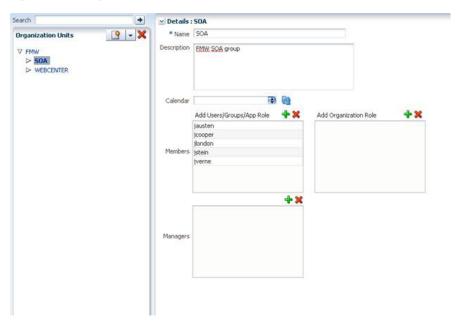

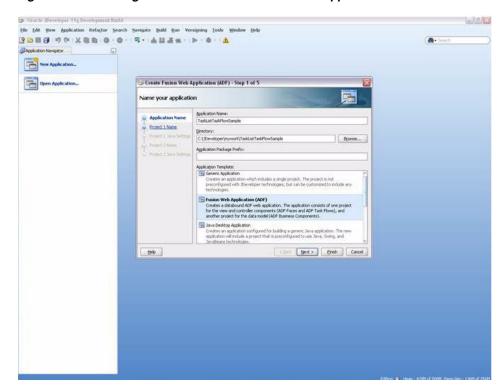


Figure A-8 Creating New Oracle Fusion Middleware Application

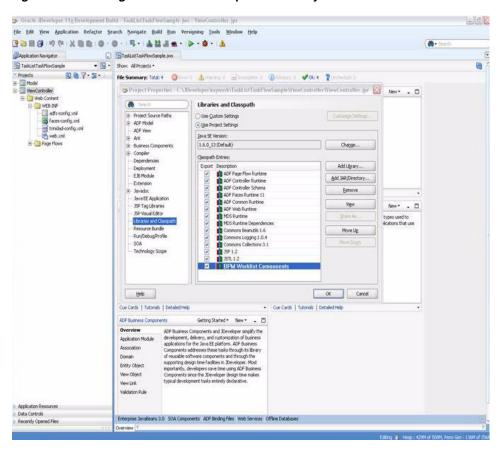
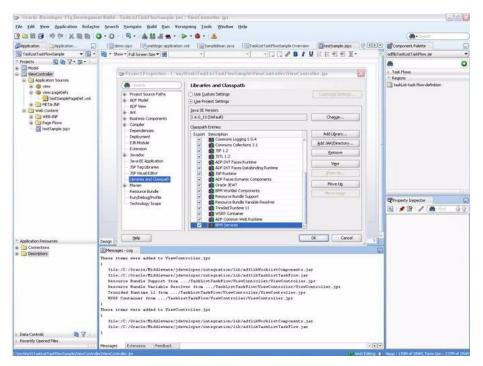


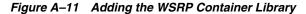
Figure A-9 Adding BPM Worklist Component Library

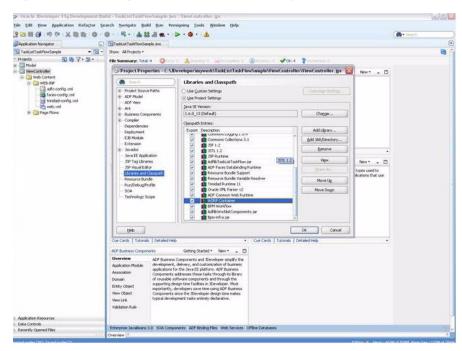

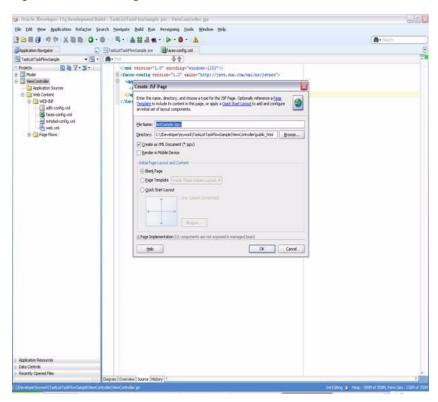


Figure A-12 Creating a a JSPX File

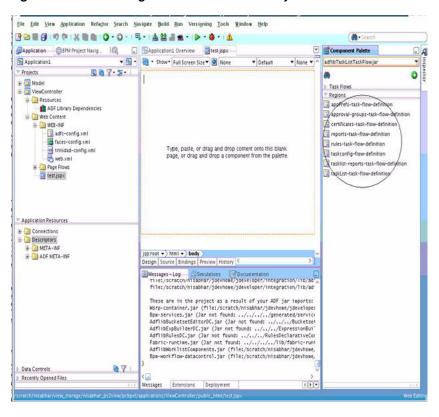


Figure A-13 Choosing adflibTaskListTaskFlow.jar

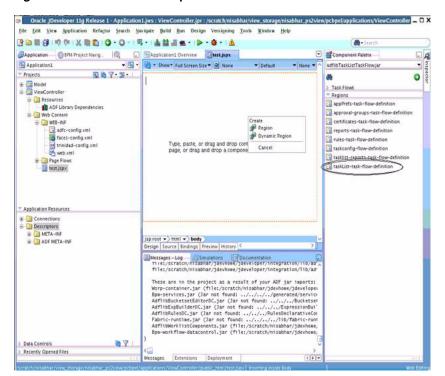


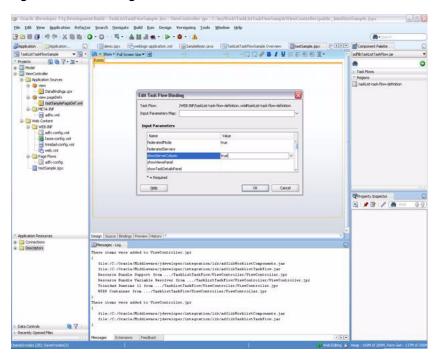
Figure A-14 Oracle JDeveloper with TaskList Task Flow on the JSPX Test Page

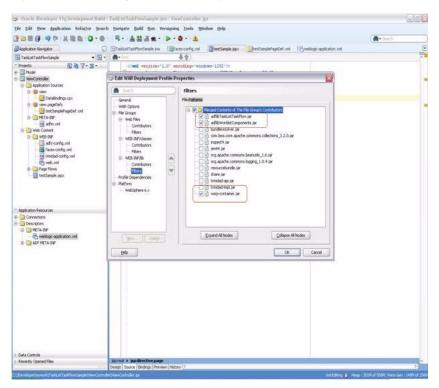

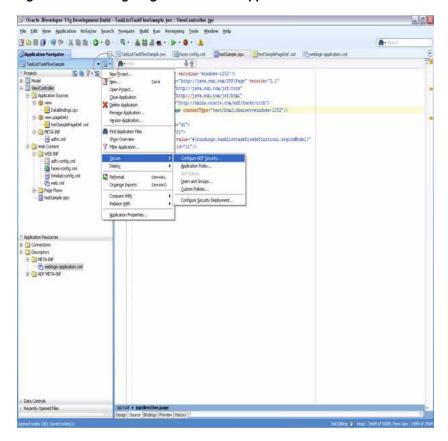


Figure A-17 Navigating to Secure the Application

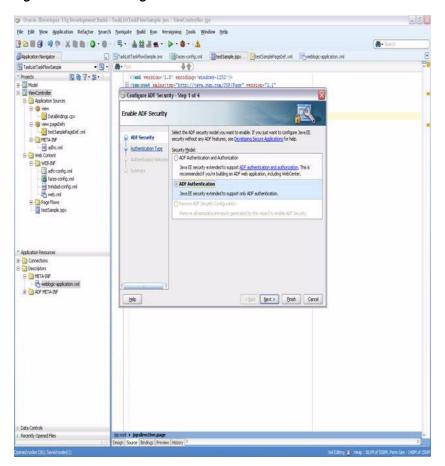


Figure A-18 Selecting ADF Authentication

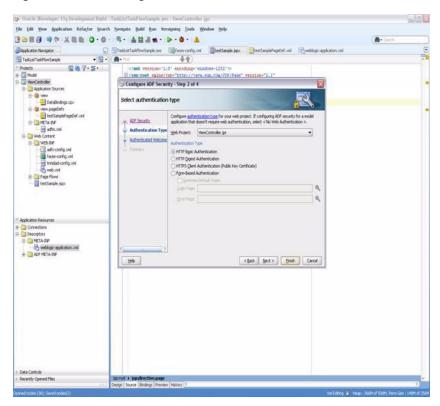


Figure A-19 Selecting HTTP Basic Authentication

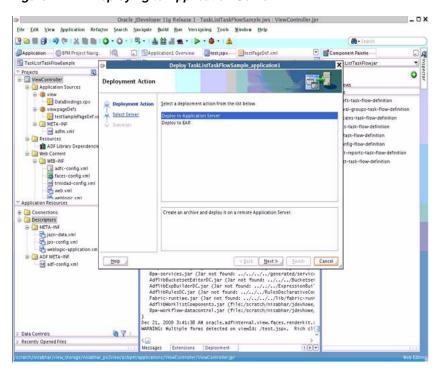


Figure A-21 Deploying to Application Server

- **17.** Select the server instance and click **Finish**.
- **18.** Access the following link, specifying the proper values for server and port. http://server:port/TaskListTaskFlowSample-ViewController-cont ext-root/faces/testSample.jspx.

A login popup appears. Log in as any user. The task list appears for the logged-in user as shown in Figure A-22.

If the task flow is used in federated mode, then the list of servers appear in the Show list. Selecting any combination of servers from the list refreshes the task list to show all the tasks belonging to the selected servers. If you passed the parameter showServerColumn as true, then the server column appears in the task list and indicates the server to which the task belongs.

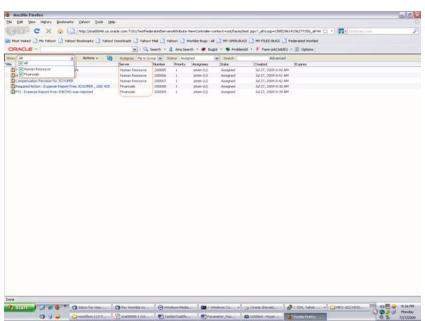


Figure A-22 Process Workspace Task List

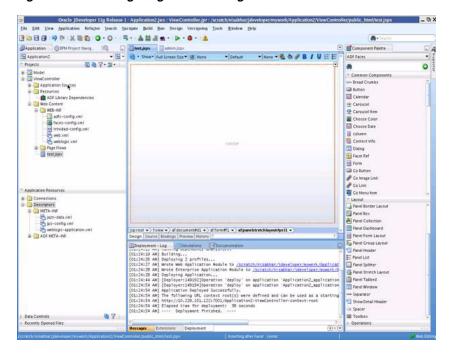


Figure A-23 Configuring the JSPX Page

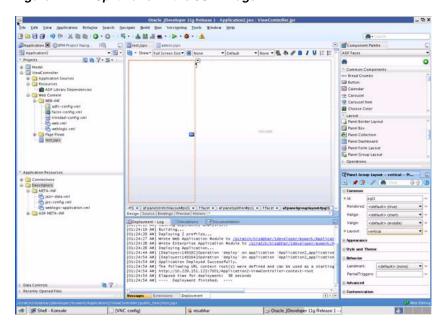


Figure A-24 Split Panel in the JSPX Page

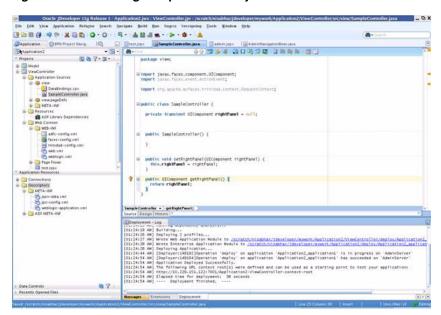


Figure A-25 Creating SampleController.java

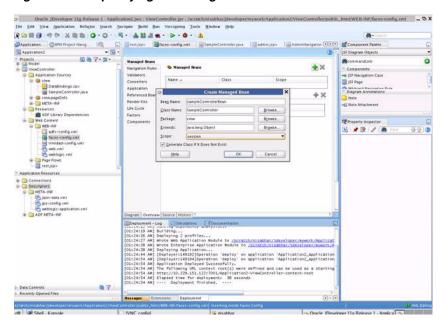


Figure A-26 Specifying the Managed Bean

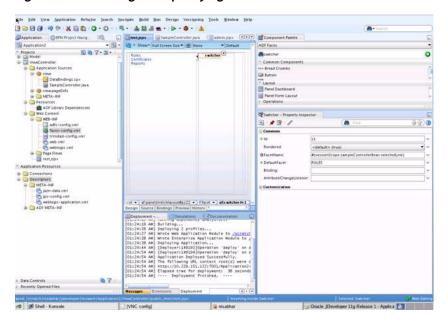


Figure A–27 Adding and Specifying a Switcher

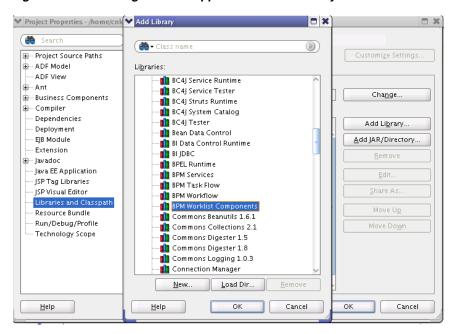


Figure B-3 Including Worklist Application in the Library

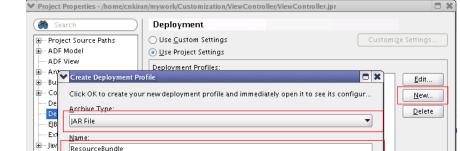

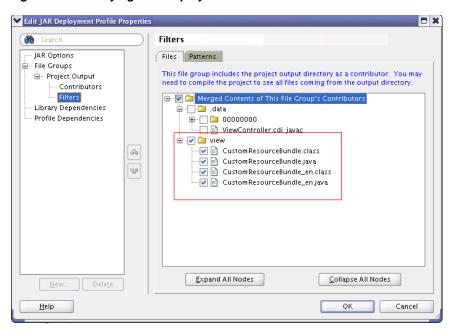
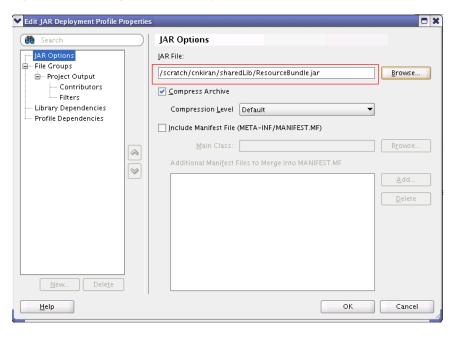


Figure B-6 Verifying JAR Deployment Profile

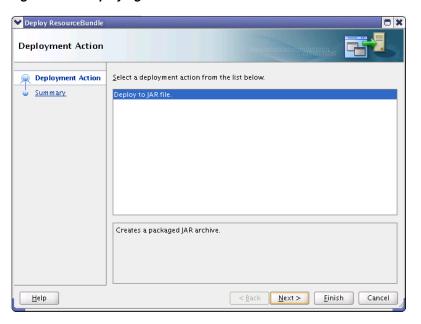


Figure B–8 Deploying the Resource Bundle

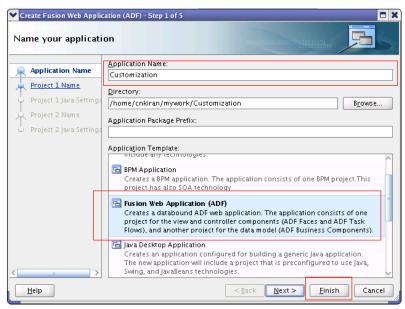

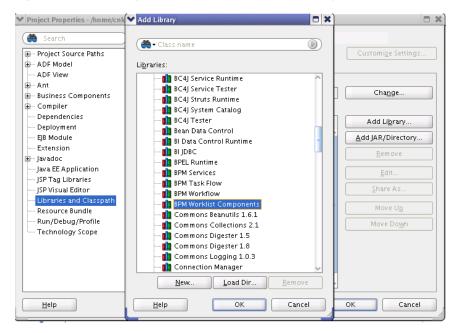

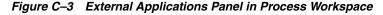

Deploying Images and JAR files as Part of a Shared Library JAR file

If you have customized an application, a skin, or a resource bundle, you need to deploy it as a JAR file within a shared library JAR file. This appendix explains how to do this.

D.1 How to Deploy Images and JAR Files as Part of a Shared Library JAR **File**

In this section, we use an example in which you include in a shared library JAR file the files you previously created:

- customSkin.jar as described in Section 9.1.6, "How to Choose a Skin in Process Workspace"
- customer-impl.jar as described in Appendix C, "Customizing Applications in Process Workspace and the Worklist Application"
- ResourceBundle.jar as described in Appendix B, "Customizing a Resource Bundle".

To deploy images and JAR files as part of a shared library JAR file:

- Create a temp directory, mkdir temp.
- Unzip all the jar files into the temp folder.

Once you do this, you can see a META-INF folder included in the temp folder.

To ensure that all required class files and other skin files are available in the shared library, package everything into the file custom.client.applib.jar. To do this, navigate to the temp directory and run the following command:

You have now created the shared library under the temp directory. It looks like this: temp/custom.client.applib.jar.

- Deploy custom.client.applib.jar on the Oracle WebLogic Server as a shared library. To do this: From the Oracle WebLogic Server Console, click **Deployments** and Install, navigate to the JAR file location, and deploy.
- Restart the Worklist Application or Process Workspace from the Oracle WebLogic Server. Figure D–1 shows the interface for restarting the Worklist Application.

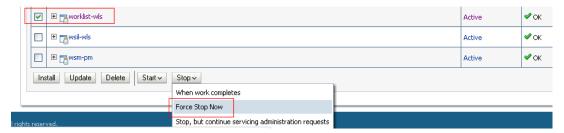
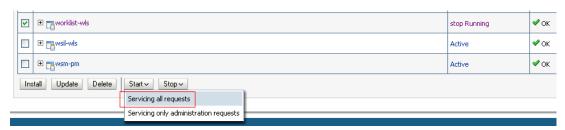
