# Release Notes

Oracle Preventive Controls Governor (PCG) is a set of four applications that run, and implement controls, within instances of Oracle E-Business Suite (EBS). These applications include:

- Form Rules, which modifies the security, navigation, field, and data properties of Oracle EBS forms.
- Flow Rules, which defines and implements business processes.
- Audit Rules, which tracks changes to the values of fields in database tables that underlie Oracle EBS.
- Change Control, which regulates changes to the values of fields in Oracle EBS forms.

In the background, PCG provides “Access Approvals” functionality employed by a separately installed product, Application Access Controls Governor.

## Resolved Issue

Version 7.3.4 of PCG is certified for Oracle Database 19c (12.2.0.3). You can't run PCG 7.3.4 with any earlier database version. This resolves bug 30808383.

## Installation and Patches

In general, you can install or upgrade to PCG 7.3.4 immediately if your EBS environment uses Linux 7 and a 19c database. But there's an exception: If you expect to use a Preventive Enforcement Agent (PEA) to support Access Approvals functionality in Advanced Access Controls Governor (AACG), wait to install or upgrade to PCG 7.3.4 until the next AACG patch (8.6.6.15000) is released.

An *Installation Guide* provides instructions for performing the base installation or upgrade of PCG 7.3.4. It's available in the Oracle Help Center ([docs.oracle.com](https://docs.oracle.com)).

After completing the base installation of PCG 7.3.4, apply mandatory patches 16896587 and 18411239. Patches are available on My Oracle Support ([support.oracle.com](https://support.oracle.com)). A readme file provided with each patch gives instructions on how to install it.

## Content and Documentation

Libraries of change-control rules are available for use with Preventive Controls Governor. There is one content file for each language supported by PCG.

Along with the *Installation Guide*, a *User Guide* and *Release Notes* are available in the Oracle Help Center.
