Chapter 1: Oracle Serialization and Tracking Process Integration Pack

This chapter provides an overview of the Oracle Serialization and Tracking Process Integration Pack and an overview of the Oracle Serialization and Tracking Process Integration Pack process flows.

Oracle Serialization and Tracking Process Integration Pack Overview

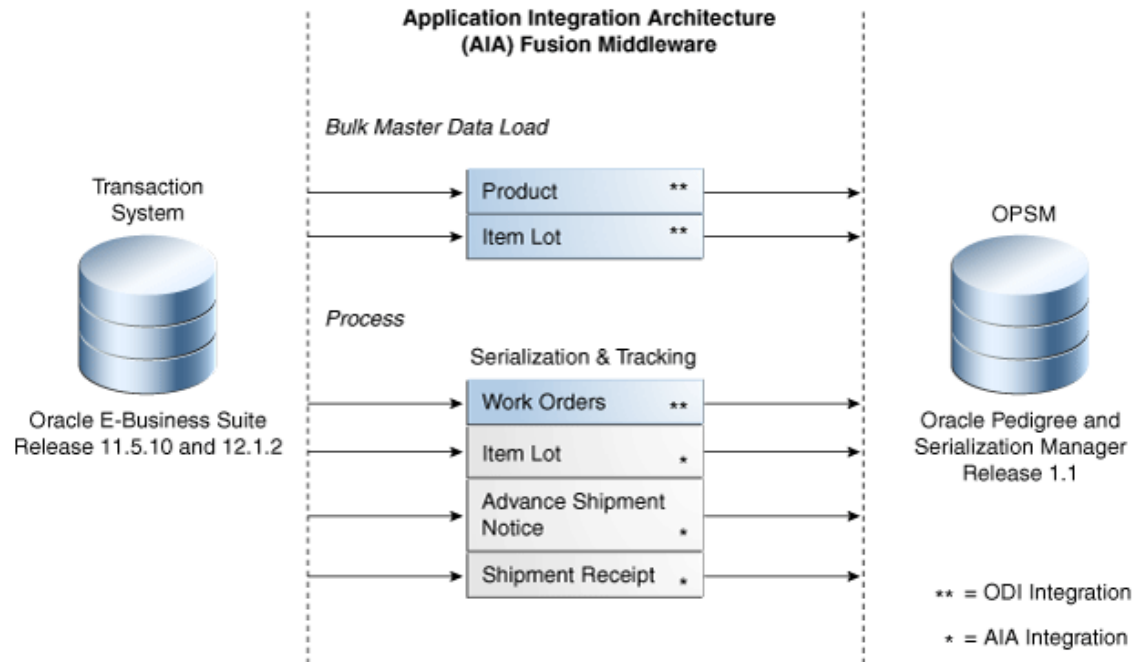
Oracle Pedigree and Serialization Manager (OPSM) is an application that enables companies to manage serialization of products and share serialized product data across the supply chain. OPSM can integrate with your existing manufacturing, shipping, and receiving transactional systems or it can operate as a standalone application. OPSM can support multiple transactional systems integrated to a single instance of OPSM. The multiple transactional systems may be multiple instances managed within your company or systems managed by your manufacturing and logistics partners. OPSM integrates with Oracle E- Business Suite to manage the business processes relevant to serialization and serialized item tracking. These processes are manufacturing, packaging, shipping, receiving, and return.

The initial integrations between OPSM Release 1.1 and Oracle E-Business Suite Release 11.5.10 and 12.1.2 are designed to address the primary process flows around the synchronization of product and lot information, creation of serials, and recording and/or tracking of serialized item events.

The initial integrations record and/or track the following events:

- Item and product definition synchronization
- Reserving serials for discrete manufacturing jobs and process manufacturing batches
- Synchronizing lot information
- Decommissioning serials when jobs or batches are cancelled or terminated
- Commissioning serials to the designated product and lot
- Shipping serialized items
- Receiving returned serialized items

The Oracle Serialization and Tracking Process Integration Pack contains these process integrations:

- Product Definition (includes Product Synchronization)
- Work Order Serialization
- Lot Synchronization
- Commission Serials
- Serialized Item Tracking (includes Advance Shipment Notice and Shipment Receipt)

Each one of these process integrations is discussed in detail in this implementation guide.

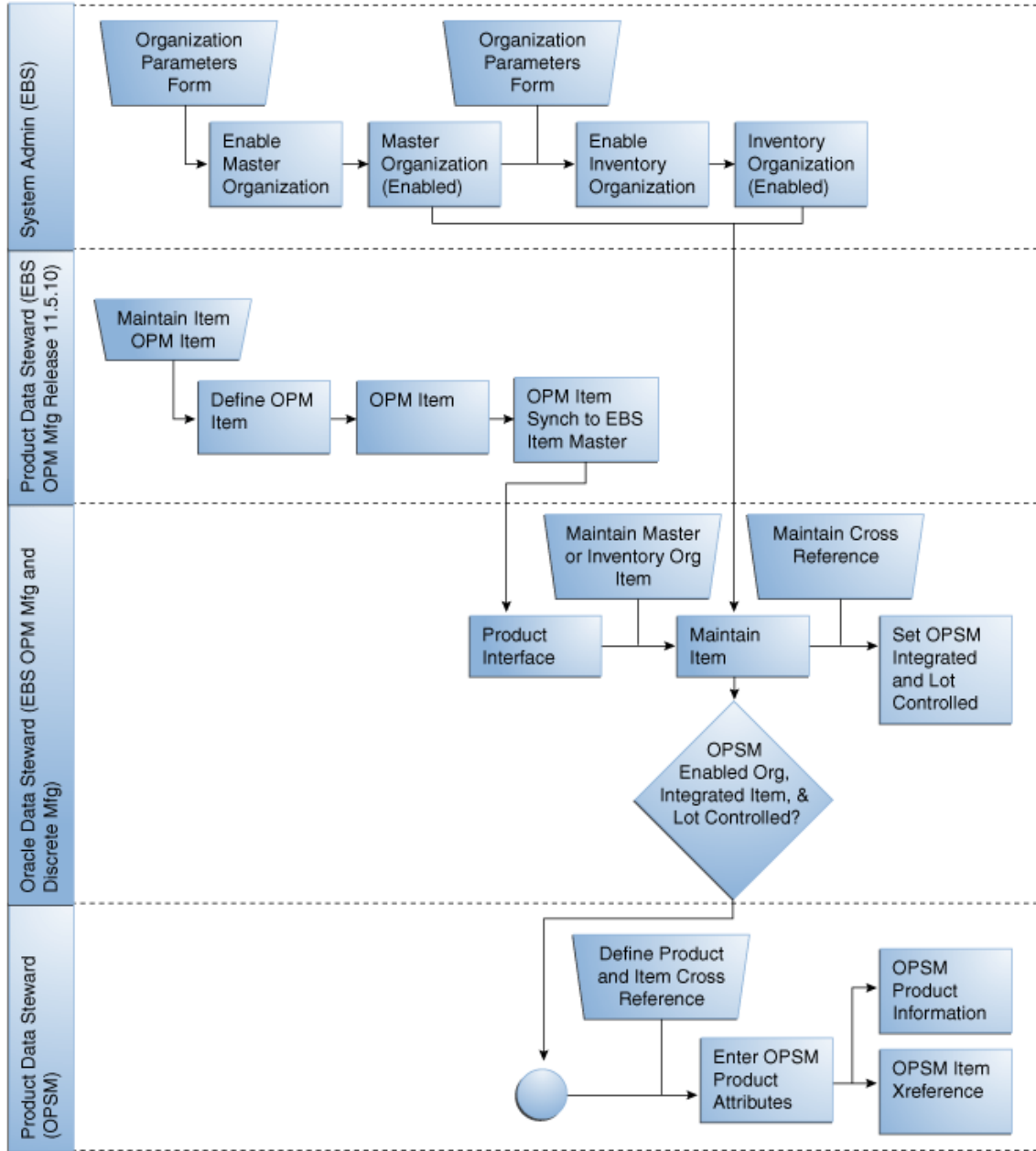
Product Definition Process Flows

The Product Definition process integration contains two process flows. The Product Definition process flow and the Product Synchronization process flow.

Product Definition

This diagram illustrates the Product Definition business process flow:

New products can be created directly in the Oracle Pedigree and Serialization Manager (OPSM) application with a cross reference to the item in one or more transactional systems (Oracle Inventory). OPSM is the central repository for product definitions. OPSM stores the attributes used to identify the product along with the required regulatory product attributes required to generate a pedigree. OPSM also stores product packaging level information and attributes that control serialization of the product packaging unit. The serialization process control attributes determine the serial type, serial generation overage amounts, and serial range control. In addition, process control attributes for the product determine if serials are tracked for transactions with no change of ownership, the creation of a pedigree, and whether the serials are generated by OPSM or externally for the product. Process controls for the product can be overridden by location.

Products can be defined in OPSM in these ways:

- Using the Maintain Products page in OPSM. Product information can be created, modified, or deleted using the OPSM product pages.
- Calling the OPSM Define Product and Item Cross Reference page from the Oracle Inventory Master Item window or from the Organization Item window.

The Source System Precedence setting in the OPSM system parameters controls whether product and product detail information can be updated from any source system or only from the owning source system. The owning source system is recorded on the product and product detail records.

- Using the batch product synchronization process between Oracle E-Business Suite and OPSM.

The Source System Precedence setting in the OPSM system parameters controls whether product and product detail information can be updated from any source system or only from the owning source system. The owning source system is recorded on the product and product detail records.

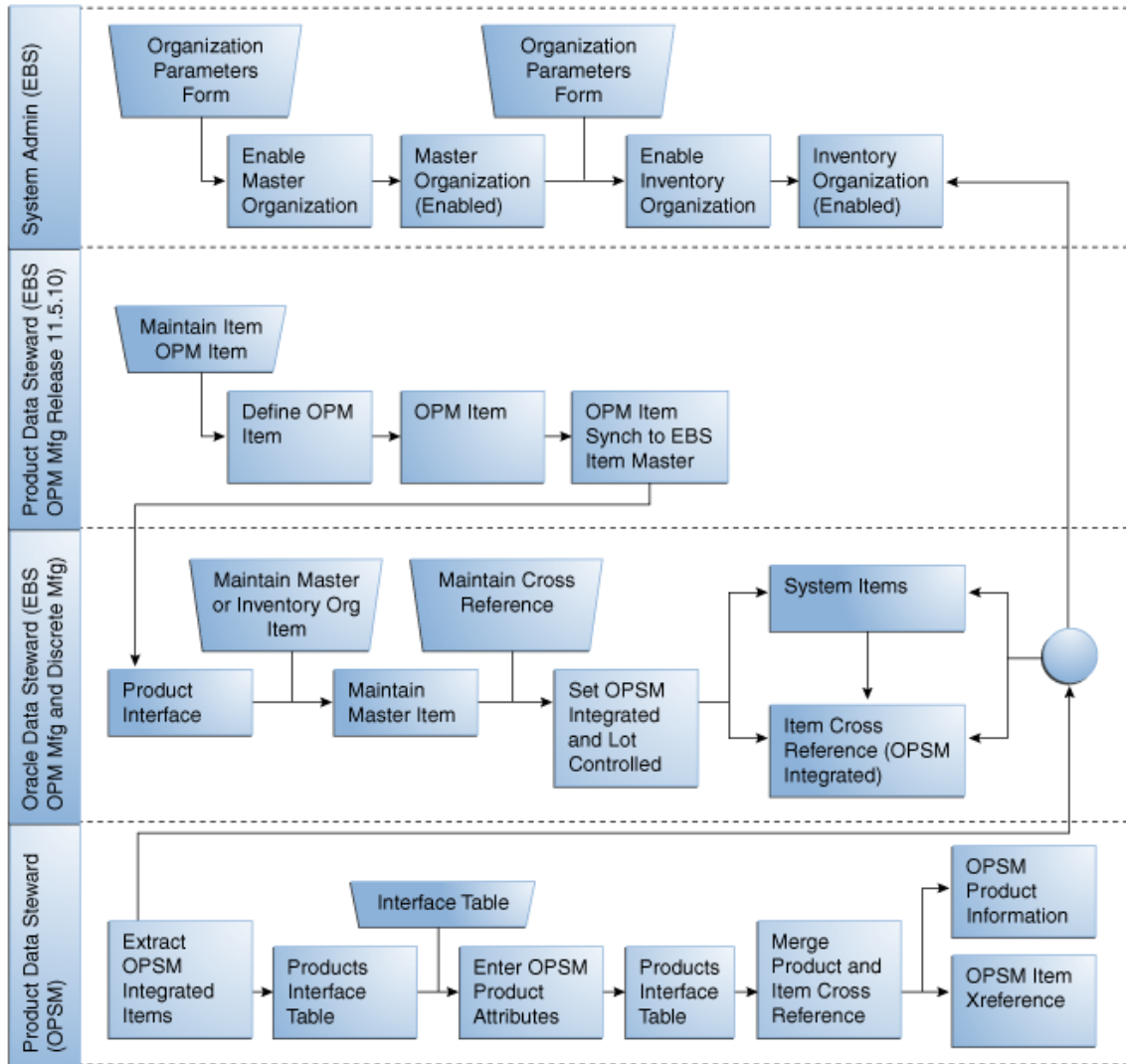

Product Synchronization

This diagram illustrates the Product Synchronization business process flow:

Product Synchronization business process flow

The batch product synchronization process is between Oracle E- Business Suite and OPSM. Items flagged as *OPSP Integrated* in the EBS Item Cross Reference are extracted to the OPSM Product Interface table. This table is used to further enrich the data with the OPSM specific product information, which is then loaded into the OPSM system.

The Source System Precedence setting in the OPSM system parameters controls whether product and product detail information can be updated from any source system or only from the owning source system. The owning source system is recorded on the product and product detail records.

The product synchronization process can occur for a full load or incremental load of the item information between the applications. The full load synchronizes all OPSP Integrated items between the two applications. The incremental load synchronizes only the items newly flagged as *OPSP Integrated* from the last time the synchronization process was performed between the two applications.

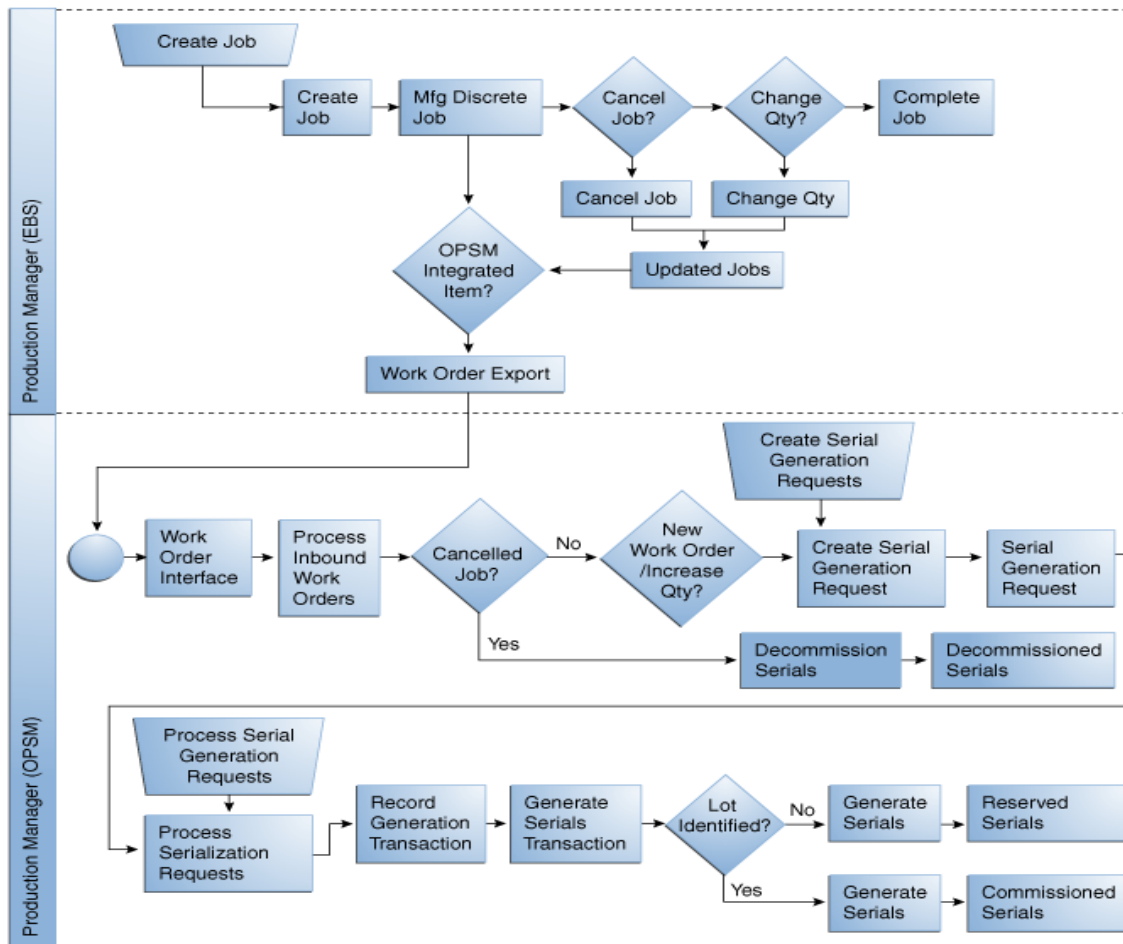

Work Order Serialization Process Flows

The Work Order Serialization process integration contains two process flows. The Work Order Serialization process flow for Oracle Discrete Manufacturing and the Work Order Serialization process flow for Oracle Process Manufacturing.

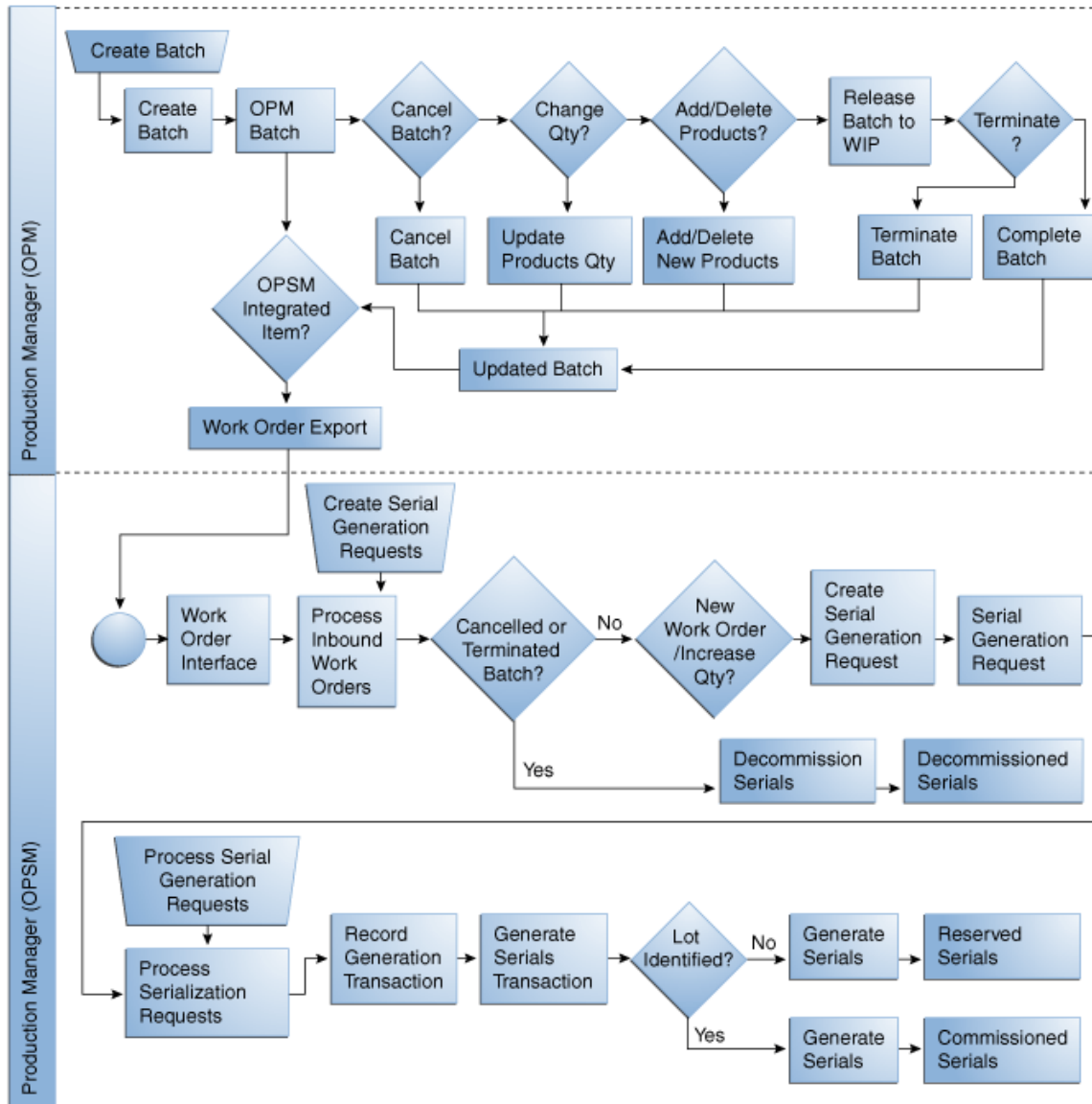
Work Order Serialization

Work Order Serialization Business Process Flow (Process Manufacturing)



Work Order Serialization business process flow (Process Manufacturing)

A work order is created in Oracle E-Business Suite for the manufacturing or packaging of the Oracle Pedigree and Serialization Manager (OPSM) serialized product. Based on user specified criteria, the work order is extracted by OPSM for the generation of serials. OPSM then generates serials for one or more products identified on the work order. The serials that are generated are stored in OPSM along with a transaction record of the serials generation that contains the work order reference information. Any changes to the work order that increases the output of the work order or identifies a new product results in a request for additional serials to be generated in OPSM. A reduction in the output quantity does not reduce the quantity of serials or change the status of the serials. If the work order is cancelled, the serials are *Decommissioned*. If the work order is terminated, serials that are at a *Reserved* status are decommissioned when the work order is closed. Serials are generated at either a *Reserved* or *Commissioned* status. If both the product and the lot are identified on the serial generation request, the serials are created as *Commissioned*. If either the product or lot is unknown or the lot has not been created in the transactional system and synchronized to OPSM, the serials are generated in a *Reserved* status.

Lot Synchronization Process Flows

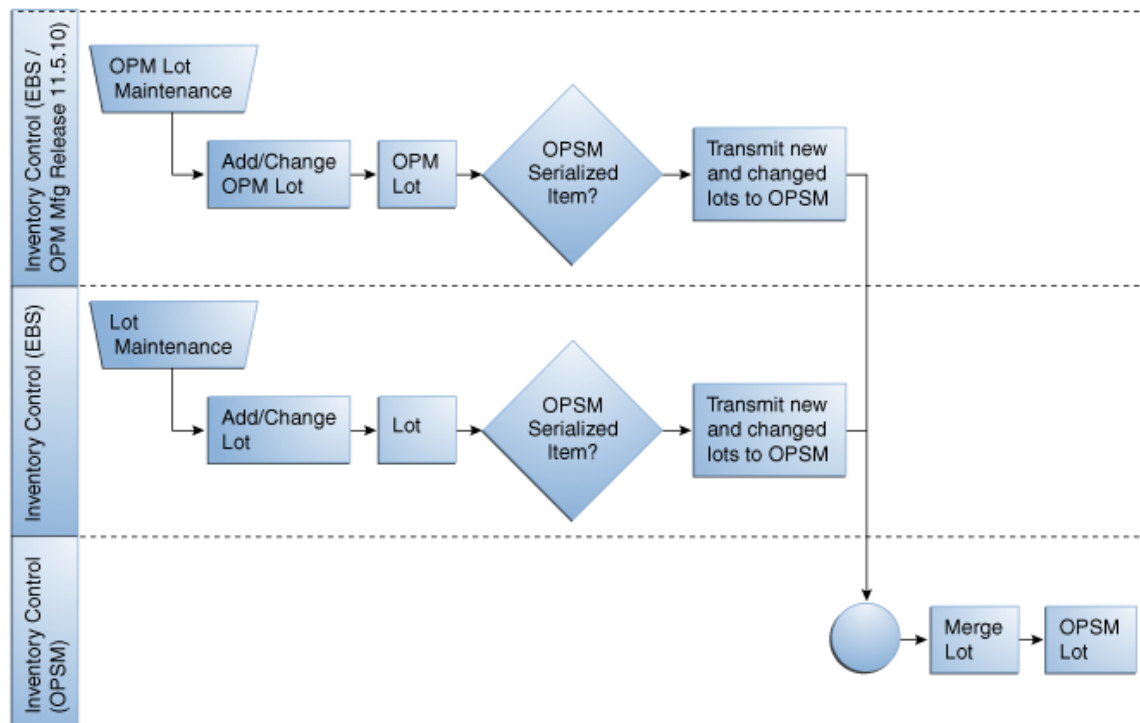
The Lot Synchronization process integration contains four process flows. The process flows are:

Lot Synchronization Business Process Flow



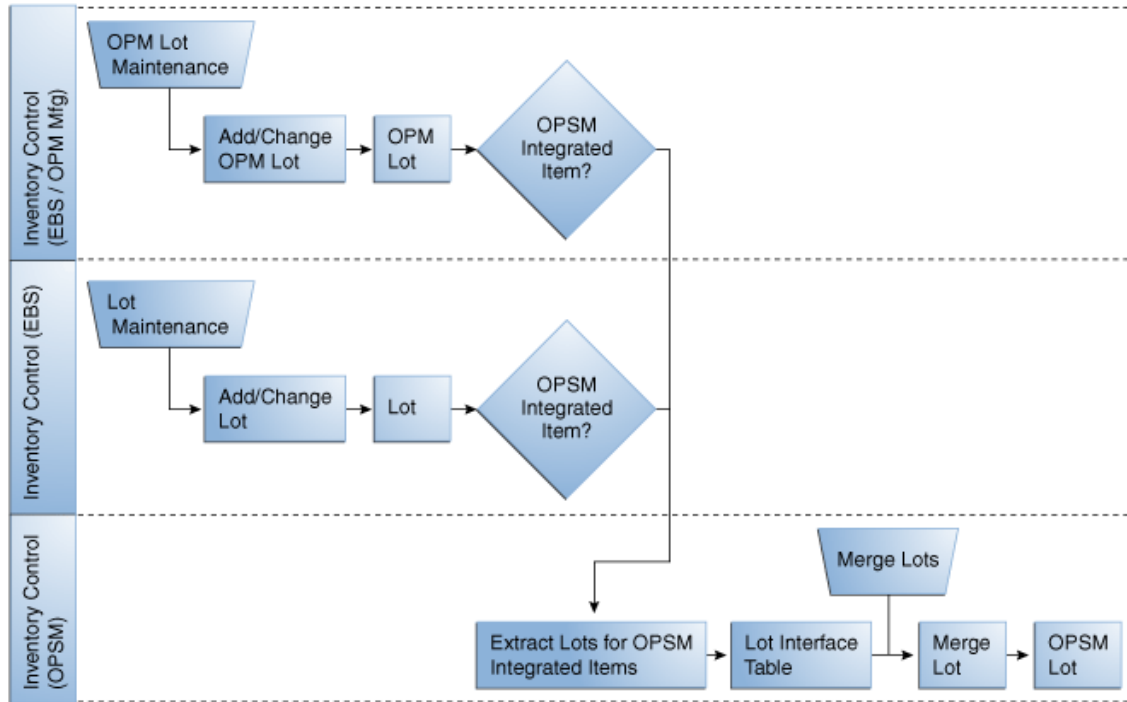
Real Time Lot Synchronization business process flow

Lot information is synchronized real-time to the Oracle Pedigree and Serialization Manager (OPSM) application from Oracle E- Business Suite when a lot is created or modified. Additional modification of the lot master data including the lot expiration date can occur post manufacturing. Changes to the lot information will continue to be synchronized independent of the manufacturing process.

Bulk Load Lot Synchronization

This diagram illustrates the bulk load Lot Synchronization business process flow for discrete and process manufacturing:

In addition, lot information can be bulk synchronized from Oracle E- Business Suite to OPSM using Oracle Data Integrator (ODI). The bulk lot synchronization process can occur for a full load or incremental load of the lot information between the applications. The full load synchronizes all lot information for OPSM Integrated items between the two applications. The incremental load synchronizes only the new or updated lot information from the last time the synchronization process was performed between the two applications.

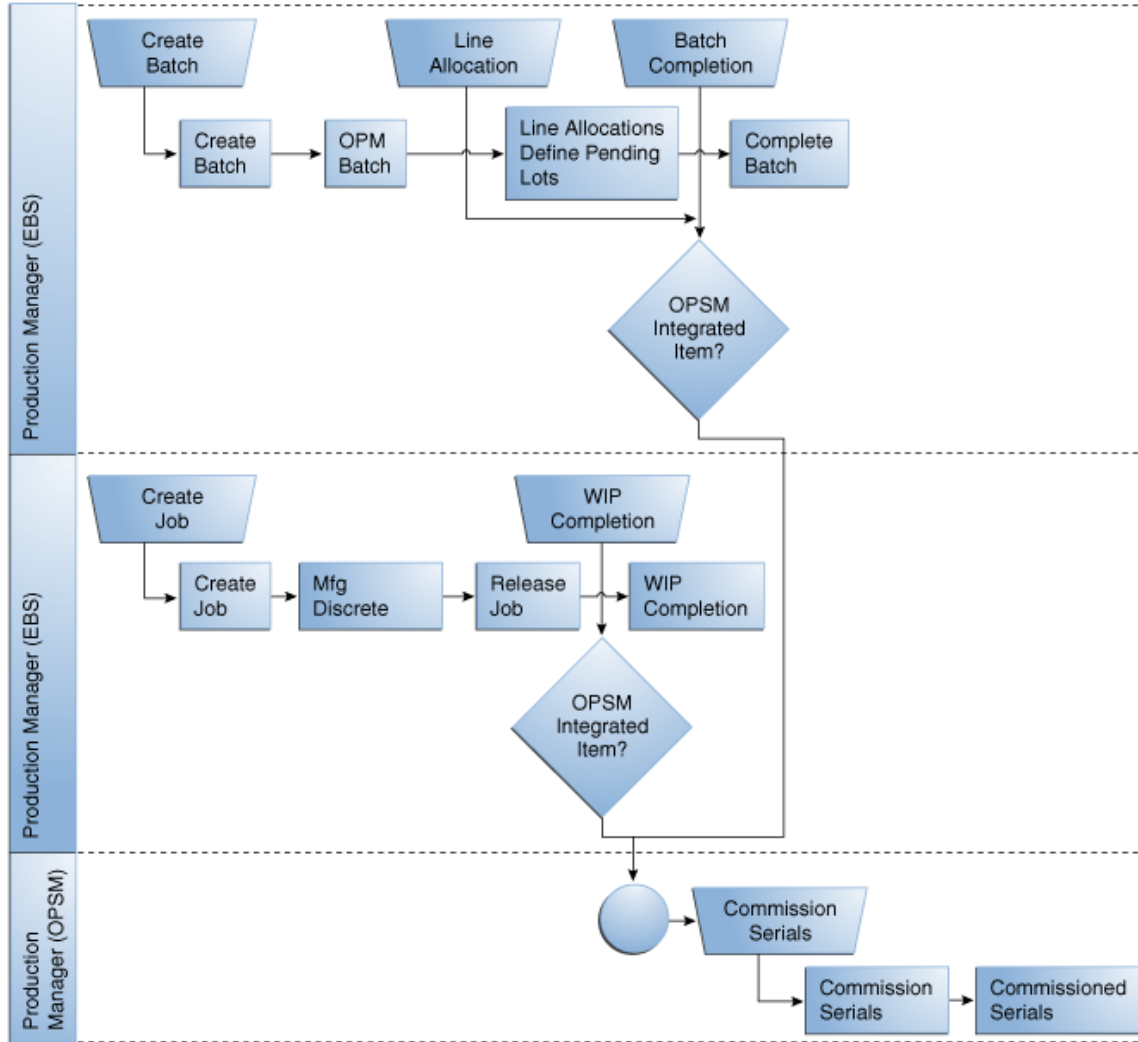
Commission Serials Process Flows

A work order (job or batch) is created in Oracle E-Business Suite (Oracle Discrete Manufacturing and Oracle Process Manufacturing) for the manufacturing of the Oracle Pedigree and Serialization Manager (OPSM) integrated item. During job completion or batch completion, you are able to invoke the OPSM Commission Serials page and commission the serials to the job or batch.

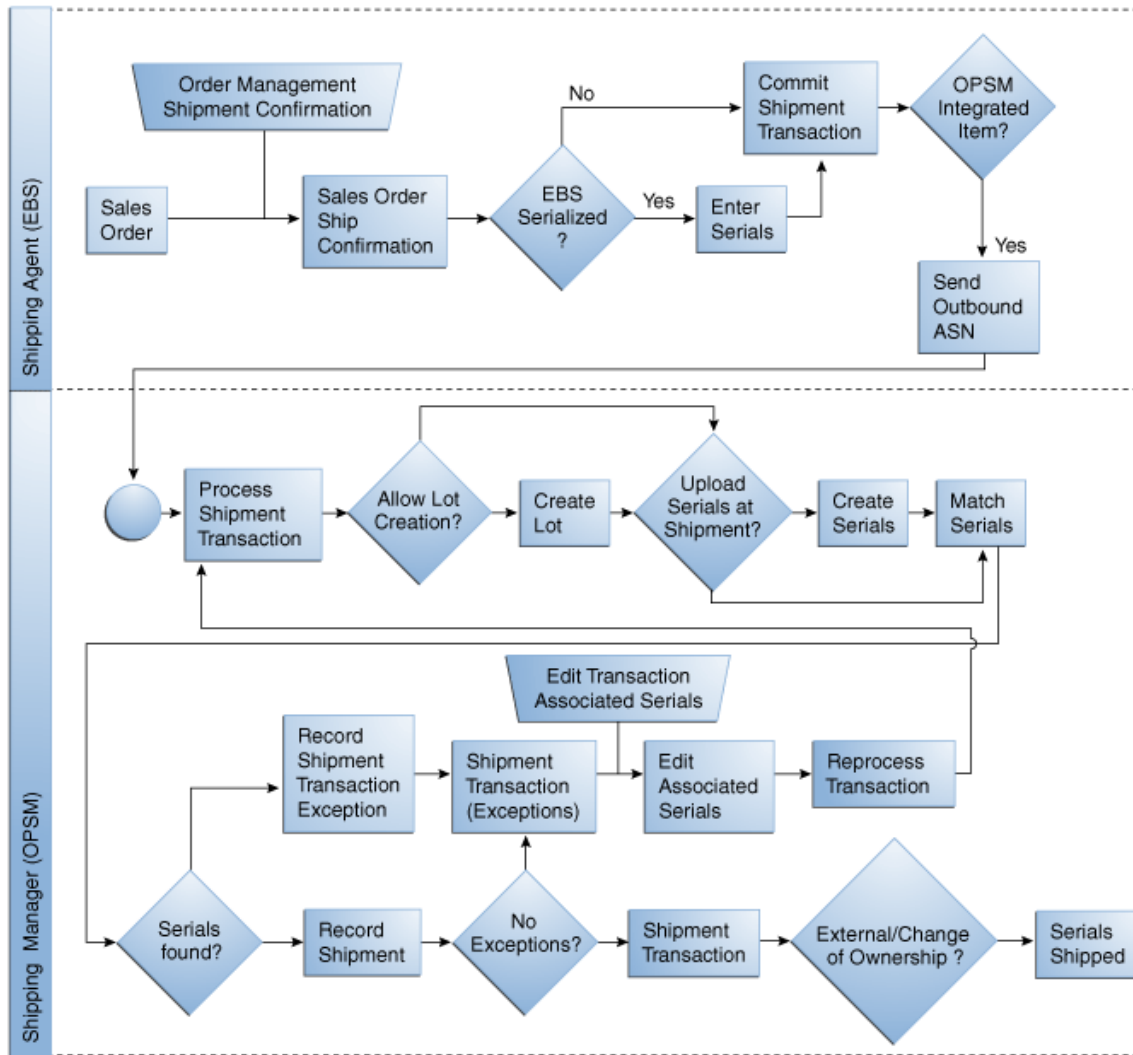
Serialized Item Tracking Process Flows

Serialized Item Tracking

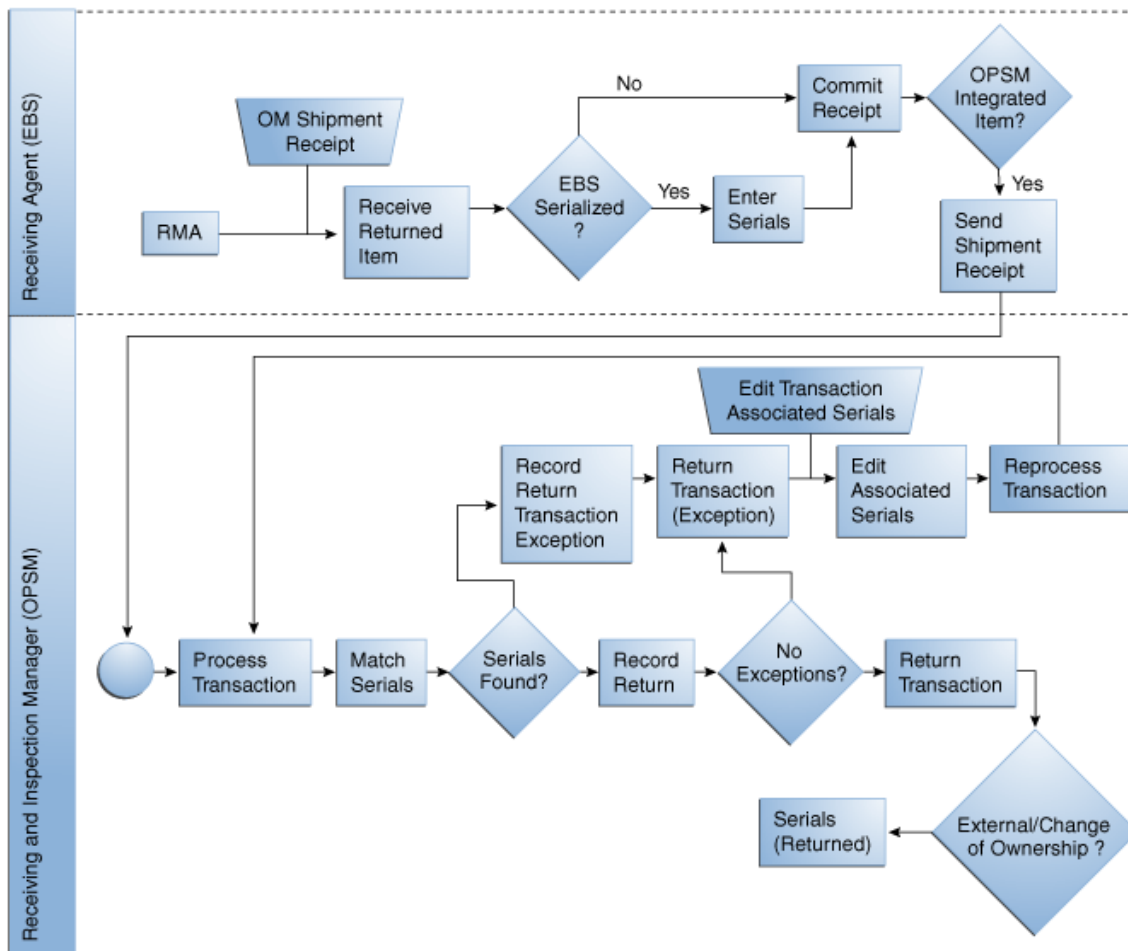
These diagrams illustrate the Shipment Transaction and Shipment Receipt (Return) Transaction business process flows:

Oracle Pedigree and Serialization Manager (OPSM) tracks the change of ownership of serialized items. This includes the change of ownership when an item is sold to or returned from an external customer. Optionally, OPSM will record shipments or returns to internal customers where there is no change of ownership. At ship confirmation, information about the shipped items including the associated serials, product packaging (inner serialized packages), and the product containerization (outer packaging layers) is transmitted to the OPSM application.

The OPSM application will optionally create the lot number at the time of shipment, record the shipment transaction, update the packaging hierarchy, associate the serials to the shipment transaction, and update the state of the serials to *Shipped*. Serials shipped to a customer designated for change of ownership are transmitted to the defined serial destinations. Serialized items returned from the customer will similarly be recorded. The OPSM application will log the Return transaction with the associated serials, update the packaging hierarchy, modify the state of the serials to *Returned*, and identify any exceptions such as, return of serials that were not previously shipped, or did not previously exist, and transmit the returned serials to the defined serial destination.

Note: Serials generated by Oracle E-Business Suite are created in OPSM at ship confirmation.

Chapter 2: Product Definition Process Integration

This chapter provides an overview of the Product Definition Process Integration and discusses:

- Product Definition process flow
- Product Synchronization process flow

Product Definition Process Integration Overview

The Oracle Pedigree and Serialization Manager (OPSM) application is the central repository for product definitions. New products can be created directly in the OPSM application with a cross reference to an item in Oracle E-Business Suite (Oracle Inventory). Keeping the product information and its item number cross-reference information up to date is crucial in a serialization environment.

The Product Definition Process Integration enables product and item number cross-reference information to be integrated and synchronized between Oracle E-Business Suite (Oracle Inventory) and OPSM. The Product Definition Process Integration supports these process flows:

- Product Definition:
 - A user can define item number information using the Master Item window or Organization Item window in Oracle E-Business Suite (Oracle Inventory) and integrate that information to OPSM by calling the OPSM Define Product and Item Cross Reference page through a menu option on the window. This option is only available for items marked with a Cross Reference Type of *OPSM INTEGRATED = YES* in Oracle Inventory.
 - A user can create product and item cross-reference information directly in OPSM by using the Maintain Products page. Product information can be created, modified, and deleted using pages in OPSM. This option is only available for items marked with a Cross Reference Type of *OPSM INTEGRATED = YES* in Oracle Inventory.
- Product Synchronization:
 - Using a Full Load Product Synchronization process all item number information is synchronized between Oracle E-Business Suite (Oracle Inventory) and OPSM. Oracle Data Integrator (ODI) takes all items marked with a Cross Reference Type of *OPSM INTEGRATED = YES* in Oracle Inventory and transfers them to the OPSM Product Interface table. The transferred records in the OPSM Product Interface table are further enriched with the OPSM Product Information, which is then loaded into OPSM.
 - Using an Incremental Load Product Synchronization process a subset of item number information is synchronized between Oracle E-Business Suite (Oracle Inventory) and OPSM. Oracle Data Integrator (ODI) takes all items newly flagged as *OPSM INTEGRATED=YES* since the last extract and transfers them to the OPSM Product Interface table. The transferred records in the OPSM Product Interface table are further enriched with the OPSM Product Information, which is then loaded into OPSM.

Solution Assumptions and Constraints

The solution assumptions and constraints for the Product Definition Process Integration are:

1. The Oracle Pedigree and Serialization Manager (OPSM) application is designed as a stand-alone application on Fusion 11g technology stack. OPSM does not have any dependencies on Fusion Applications or Fusion Applcore and foundation components.
2. Translations in Oracle E-Business Suite are not synchronized into OPSM. OPSM does not support translations of database content.
3. Item basic information is maintained in Oracle E-Business Suite and product details are maintained in OPSM.
4. The Oracle E-Business Suite Profile Option INV: Enable OPSM Checkbox is manually defined and enabled.
5. Master and Inventory organizations of an item are OPSM enabled in Oracle E-Business Suite (Oracle Inventory).
6. Multiple master organizations for synchronization are not supported.
7. Item cross reference type should be "YES" for the OPSM Integrated Item at the Master Organization and is not disabled at the item Inventory Organization level in Oracle E-Business Suite (Oracle Inventory).
8. Item must be lot controlled in Oracle E-Business Suite (Oracle Inventory) at the Master Item level for Product Synchronization and at the Organization level for Work Order Serialization, Commission Serials, Lot Synchronization, and Serialized Item Tracking.

Product Definition Process Flow

The Product Definition process flow enables you to create an OPSM Integrated item in Oracle E-Business Suite (Oracle Inventory) using the Master Item or Organization Item windows. From the Master Item window or the Organization Item window, the Oracle Pedigree and Serialization Manager (OPSM) Define Product and Item Cross Reference page can be called by selecting from the Tools menu the Define Product in OPSM option. This enables you to define all of the different attributes for the item in OPSM.

The product definition process flow does not use Oracle Data Integrator (ODI) or AIA. This process flow entails an Oracle E-Business Suite window to an OPSM page transfer.

Product Definition Process Flow

To Define a Product:

1. Define an item using the Master Item window in Oracle E-Business Suite (Oracle Inventory).

2. Define the item as lot controlled.

On the Inventory tab of the Master Item window, select **Full Control** for the Lot Control field.

3. Define the Item Cross Reference Type for the item as OPSM INTEGRATED.

Select Cross References from the Tools menu in the Master Item window and then select the Item Cross Reference Type of **OPSM INTEGRATED** using the Item Cross Reference Assignment window.

4. Clear the Applicable to All Organizations check box using the Item Cross Reference Assignment window.

5. Enable the item cross reference for the master organization level using the Item Cross Reference Assignment window.

Select **YES** for the Value field for the master organization.

6. Click the Define Flexfields icon.

The Item Cross-References window appears.

7. Enter the OPSM Serial Type as a flex field for the item cross reference and click the OK button.

For more information on setting up flexfield item cross references, see [Setting Up Oracle E-Business Suite](#).

8. Save your work in Oracle E-Business Suite (Oracle Inventory).

9. Invoke the OPSM Define Product and Item Cross Reference page.

Select Define Product in OPSM from the Tools menu in the Master Item window.

The OPSM Define Product and Item Cross Reference page is called asynchronously. After the OPSM page is called, you can close Oracle E-Business Suite (Oracle Inventory) and continue to define the product attributes in OPSM. The item number and description is passed to this page.

Note: This page can also be called from the Organization Item window.

10. Define the product and product detail or select an existing product and product detail in OPSM using the Define Product and Item Cross Reference page.

11. (Optional) Override the process controls by location for the product using the Product Process Controls and Location Overrides page.

Click the Product Location Override button on the Define Product and Item Cross Reference page.

12. Save your work in OPSM.

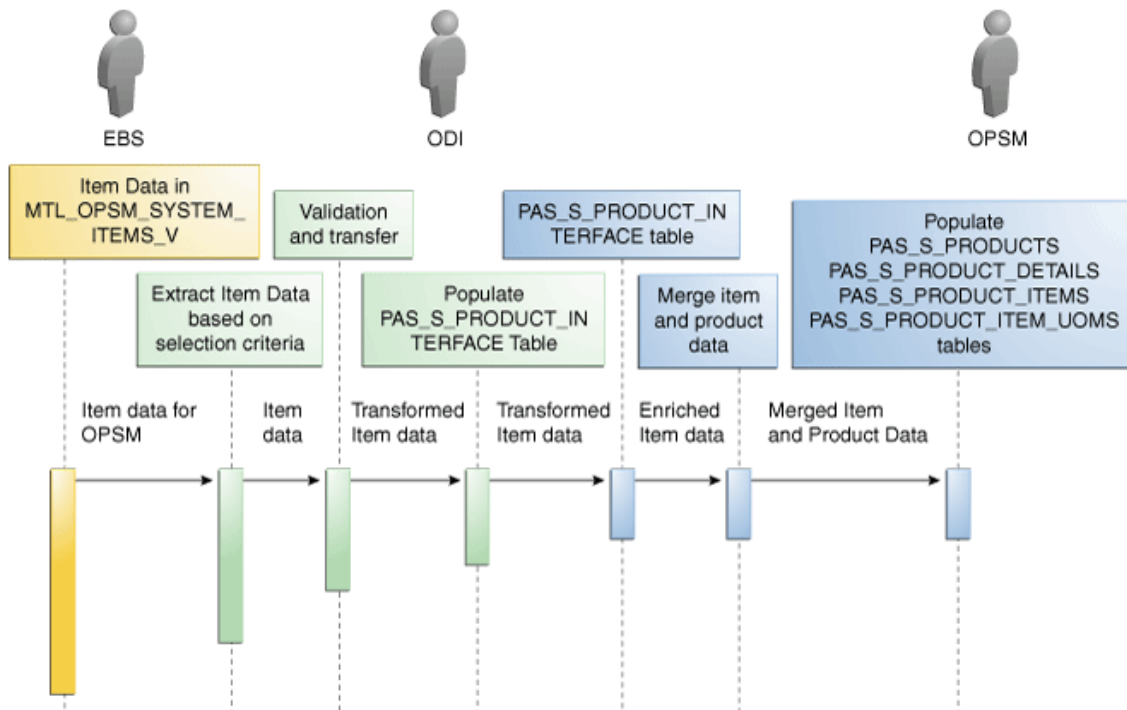
Product Synchronization Process Flow

The Product Synchronization process flows transfer OPSP Integrated items created in Oracle E-Business Suite (Oracle Inventory) to Oracle Pedigree and Serialization Manager (OPSP) using Oracle Data Integrator (ODI). Product Synchronization can occur for a full load of items or an incremental load (items newly flagged as *OPSP Integrated*) since the last data extract.

To synchronize item data from Oracle E-Business Suite to OPSP the ODI tool is used. The mode of transport is view to a table. For the ODI interface Oracle E-Business Suite MTL_OPSP_SYSTEM_ITEMS_V view is the source view and OPSP PAS_S_PRODUCT_INTERFACE table is the target table.

Product Synchronization Process Flow

This diagram illustrates the Product Synchronization sequence diagram:

To PERFORM Product Synchronization:

1. Define one or more items in Oracle E- Business Suite (Oracle Inventory).

2. Navigate to the OPSP Product Synchronization page.

System Setup > Product Synchronization

3. Run the Product Synchronization batch process.

Click the Submit New Instance button in the upper right hand corner of the Product Synchronization page.

4. Select the options for the Product Synchronization process.

- a. Select the Synchronization Action of **Extract Items**.
- b. Select the Extract Scenario Name representing a full or incremental load.
- c. Select the Source System where you are going to synchronize item information from into OPSP.

5. Click the OK button to initiate the Product Synchronization process.

If you selected an extract scenario representing a full load, the Product Synchronization Extract Items background process uses ODI (OracleEbiz To PAS ItemSync Interface) to pull item bulk data from the MTL_OPSP_SYSTEM_ITEMS_V view and transforms the data into the target OPSP Products Interface table format, and then transfers the data to the OPSP Products Interface table (PAS_S_PRODUCT_INTERFACE).

If you selected an extract scenario representing an incremental load, the Product Synchronization Extract Items background process uses ODI (OracleEbiz To PAS ItemSync Interface) to pull items newly flagged as *OPSP Integrated* since the last data extract from the MTL_OPSP_SYSTEM_ITEMS_V view and transfers the data to the OPSP Products Interface table (PAS_S_PRODUCT_INTERFACE).

If items have previously been synchronized to OPSP then:

- Item number from MTL_OPSP_SYSTEM_ITEMS_V view and item number from PAS_S_PROD_ITEM_DETAIL_UOM_V view need to match.
- Primary uom code of MTL_OPSP_SYSTEM_ITEMS_V view and item uom of PAS_S_PROD_ITEM_DETAIL_UOM_V view need to match.
- Source System from MTL_OPSP_SYSTEM_ITEMS_V view and source system of PAS_S_PROD_ITEM_DETAIL_UOM_V view need to match.
- ODI will also populate the product information in OPSP Products Interface table (PAS_S_PRODUCT_INTERFACE).

Upon completion of processing, an email notification message is sent to the ODI administrator indicating the outcome of the processing and the appropriate counts of business transactions extracted and loaded. When an error occurs, the AIA error asynchronous BPEL process is called for error handling and notification.

6. Enrich the extracted data created from the Product Synchronization process using an Open Interface.

Enter an action code of MERGE and enter OPSP product data for each item number listed in the Open Interface.

You are modifying data directly in the OPSM Products Interface table (PAS_S_PRODUCT_INTERFACE) through the Open Interface.

7. Run the Product Synchronization process again in OPSM.

Click the Submit New Instance button in the upper right hand corner of the Product Synchronization page.

8. Select the options for the Product Synchronization process.

- a. Select the Synchronization Action of ***Merge Product and Item Cross Reference***.
- b. Select the Source System where you are going to synchronize item information from into OPSM.
- c. If the Source System Precedence in system parameters is set to *Owning Source System*, select the Disregard Source Systems Exceptions check box if you want the system to not notify you if source systems exceptions occur. This check box is not selected by default.

Both the product and the product details can be associated with an owning source system. Within the System Parameters in OPSM you have the ability to select the source system precedence. If you select to give source system precedence to the “owning source system” then no other system can update that data. For example, if the product’s owning source system is EBIZ_02 and an update comes in from EBIZ_01, the system issues an error because EBIZ_01 isn’t the owning source and the system parameter setup states that only the owning source can update the product.

If you select the Disregard Source Systems Exceptions check box that means you do not want to be notified if these types of exceptions occur. It does not mean that the system ignores source system precedence and updates the record anyway; it simply means that the error is not written to the error table and subsequently they will not display in the Job Instance Message area on the bottom part of the page. The record will still be cleared from the Product Interface table even though it was not successfully processed. If you do not select the Disregard Source Systems Exceptions checkbox, the system will record an error every time a source system precedence issue occurs and the messages will display in the Job Instance Message area. The records that are in error will remain in the Product Interface table.

9. Click the OK button to initiate the Product Synchronization process.

The Product Synchronization Merge Product Information background process takes the item number and product information that was enriched using the Open Interface from the PAS_S_PRODUCT_INTERFACE table and validate and insert the transformed data into the OPSM Product and Item Cross Reference tables (PAS_S_PRODUCTS, PAS_S_PRODUCT_DETAILS, PAS_S_PRODUCT_ITEMS, and PAS_S_PRODUCT_ITEM_UOMS).

10. Verify the Product Synchronization process results using the Edit Product page, Serial Generation Details tab in the OPSM application.

Maintain Products > Edit Action or Edit Product icon > Edit Product page > Click Serial Generation Details tab

Using the Edit Product page, you can view product and item cross-reference information.

Product Serialization Process Integration Overview

The Product Serialization process integration encompasses the Work Order Serialization process integration, the Lot Synchronization process integration, and the Commission Serials process integration.

This section provides overviews of Work Order Serialization process integration, Lot Synchronization process integration, Commission Serials process integration, and discusses the solution assumptions and constraints.

Product Serialization Process Integration Overview

Product Serialization involves the creation of serials based on the work order manufacturing yield prior to or during the production of the product and the commissioning of the serials to that actual physical product that is produced at completion. Initially, serials are created in OPSM in a *Reserved* status. The lot number associated with the serials may or may not be known when the serials are created. At completion, the lot is identified and the serials may be commissioned to the completed product, the product and lot number will be recorded on the serial and the serial will be set to a status of *Commissioned*. Optionally, the serials may be commissioned at any time from the initial creation of the serial up to and including the time of shipment.

Work Order Serialization

The Work Order Serialization process integration manages the creation of globally unique serials for manufactured products. The creation of the serials is loosely coupled to Oracle E-Business Suite. The serials are stored in the Oracle Pedigree and Serialization Manager (OPSM) system and linked to the production order by the order number, product, and lot identification. Serials are generated based on the planned manufacturing yield allowing for additional serials for manufacturing overages or scrapped items. Either product specific serials or non-product specific numeric serials can be generated. The system supports both sequential and random generation of serial numbers. Serials associated with cancelled work orders will be decommissioned. Reserved serials associated with a terminated batch process will be decommissioned when the terminated batch is closed. Serials can be sent to one or more serial destinations for label printing or other purposes.

Lot Synchronization

The Lot Synchronization process integration transfers lot information created and updated in Oracle E-Business Suite (Oracle Inventory and Oracle Process Manufacturing) to Oracle Pedigree and Serialization Manager (OPSM). When a new lot is created or an existing lot is updated in Oracle E-Business Suite, the lot details are synchronized to OPSM.

Lots created or updated in Oracle E-Business Suite (Oracle Inventory and Oracle Process Manufacturing) can be synchronized to OPSM in these ways:

- Real-time through the use of business events and a Java program.
- Bulk synchronized (full or incremental loads) using the Oracle Data Integrator (ODI). The mode of transport is view to a table.

Commission Serials

When completing a job in Oracle Discrete Manufacturing or a batch in Oracle Process Manufacturing you have the option to commission serials for the job or batch in Oracle Pedigree and Serialization Manager (OPSM). The Commission Serials process integration enables you to perform the commission process.

Using several windows in Oracle E-Business Suite (Oracle Discrete Manufacturing and Oracle Process Manufacturing), you can call the Commission Serials page in OPSM. Using the Commission Serials page, you can commission serials to a job or a batch. Serials are commissioned in OPSM when they are associated to a product and lot. Plus, the serials are given a *Commissioned* status.

This process integration does not use Oracle Data Integrator or AIA. This integration entails an Oracle E-Business Suite window to an OPSM page transfer.

Solution Assumptions and Constraints

The solution assumptions and constraints for the Product Serialization Process Integration are:

1. The Oracle Pedigree and Serialization Manager (OPSM) application is designed as a stand-alone application on Fusion 11g technology stack. The OPSM application does not have any dependencies on Fusion Applications or Fusion Applcore and foundation components.
2. Translations in Oracle E-Business Suite are not synchronized into OPSM. OPSM does not support translations of database content.

OPSM is integrated to both Oracle Discrete Manufacturing and Oracle Process Manufacturing (OPM).

OPSM is not integrated to Oracle Shop Floor Management (OSFM) or Oracle Flow Manufacturing.

3. Item basic information is maintained in Oracle E-Business Suite and product details are maintained in OPSM.
4. Master and Inventory Organizations of an item should be OPSM enabled in Oracle E-Business Suite (Oracle Inventory).
5. Item cross reference type OPSM INTEGRATED should be “YES” for the OPSM Integrated Item at the Master Organization and is not disabled at the item Inventory Organization level in Oracle E-Business Suite (Oracle Inventory).
6. All the required setup for discrete jobs and OPM batches is complete in the respective Oracle E-Business Suite applications.
7. Item must be lot controlled in Oracle E-Business Suite (Oracle Inventory) at the Master Item level for Product Synchronization and at the Organization level for Work Order Serialization, Commission Serials, Lot Synchronization, and Serialized Item Tracking.
8. Items have been synchronized to OPSM.
9. Lots have been synchronized to OPSM.
10. If items are serialized in Oracle E-Business Suite, the serials may be uploaded to OPSM at the time of shipment.
11. Oracle Process Manufacturing inventory does not support serials in Oracle E-Business Suite 11.5.10.

Work Order Serialization Process Flow (Discrete Manufacturing)

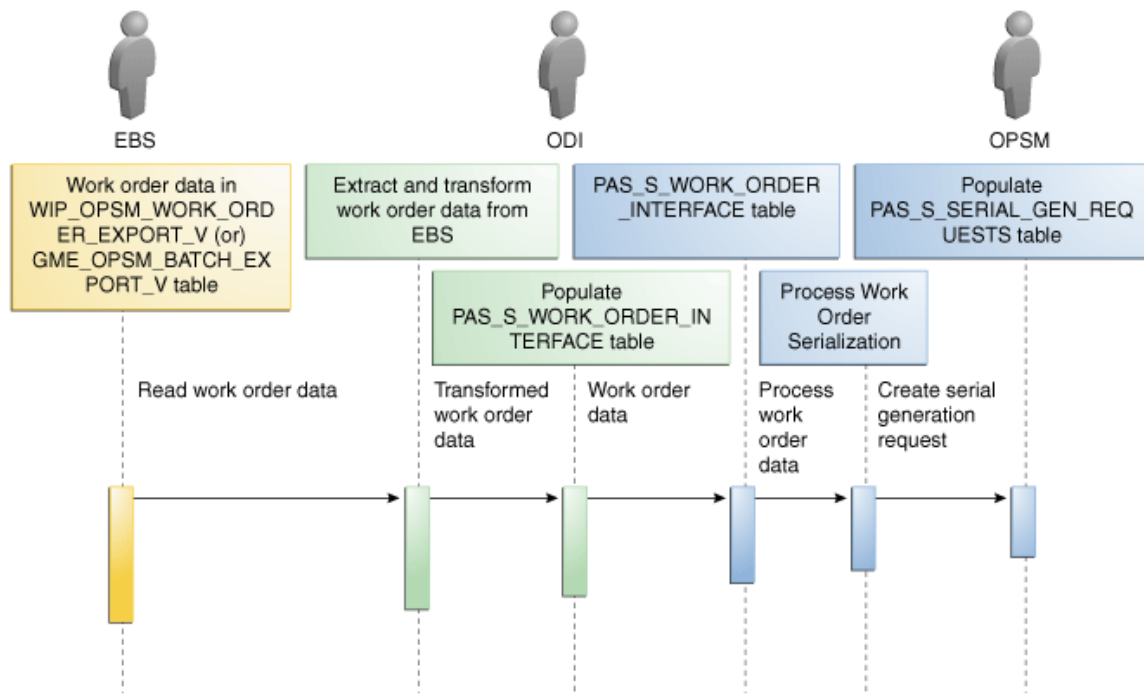
After a work order (job) is created or modified in Oracle E- Business Suite (Oracle Discrete Manufacturing), it is ready to be synchronized with Oracle Pedigree and Serialization Manager (OPSM) to generate, commission, or decommission serials for that particular work order. Oracle Data Integrator (ODI) extracts the discrete work order information for OPSM Integrated and lot controlled items and transfers the records to the Work Order Interface table. This information is sent to OPSM through the integration layer for serial generation in OPSM. The ODI mode of transport is view to a table. Work Order Serialization can occur for a full load of work orders or an incremental load (net new and changed work orders).

For every successful work order data transfer from Oracle E- Business Suite (Oracle Discrete Manufacturing), an email notification is sent to the ODI Administrator.

When an error occurs in the integration process that information is sent to the AIA AsyncErrorHandling BPEL process.

It then initiates the process to generate the serial generation request in OPSM.

If you selected an extract scenario representing an incremental load, the Work Order Serialization background process uses ODI (OracleEbizDiscreteMfg To PAS Product Serialization Interface) to pull net new and changed discrete work order information for the OPSM Integrated and lot controlled items from the Oracle Discrete Manufacturing WIP_OPSM_WORK_ORDER_EXPORT_V view and transforms the data into the target OPSM Work Order Interface table format, and then transfers the data to the OPSM Work Order Interface table (PAS_S_WORK_ORDER_INTERFACE). It then initiates the process to generate the serial generation request in OPSM.

Upon completion of processing, an email notification message is sent to the ODI administrator indicating the outcome of the processing and the appropriate counts of business transactions extracted and loaded. When an error occurs, the AIA AsyncErrorHandling BPEL process is called for error handling and notification.

6. Navigate to the OPSM Maintain Serial Generation Requests page.

Serials > Maintain Serial Generation Requests

7. Search for the serial generation requests that pertain to the work order.

Select the work order number in the Created Document field and click the Search button.

8. Select the serial generation request and submit the serial generation request for processing.

After the serial generation request is processed, it creates the serial numbers for the items on the work orders.

You are able to view all of the serial numbers that were created for the items on the work orders. The serial numbers are created in OPSM in a *Reserved* status or a *Commissioned* status if product and lot were identified. If a job has been cancelled, previously generated serials are decommissioned.

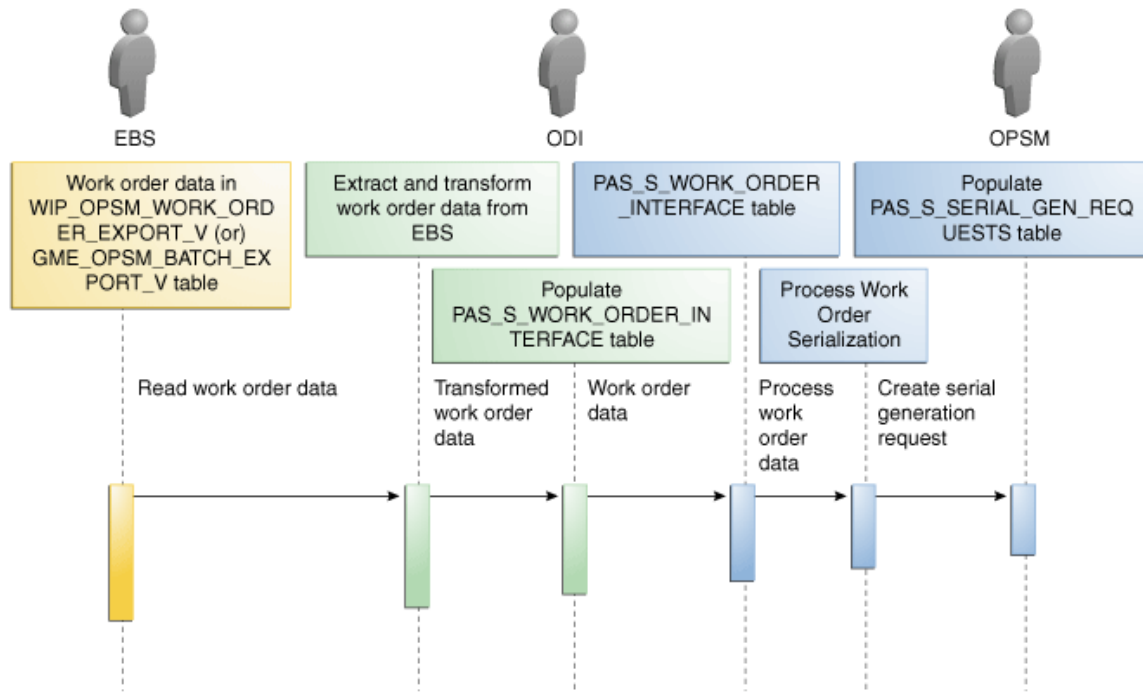

If a batch was cancelled, previously generated serials are decommissioned.

If a batch was terminated, serials in a *Reserved* status when the batch is closed are decommissioned. Serials at a *Commissioned* status will remain commissioned.

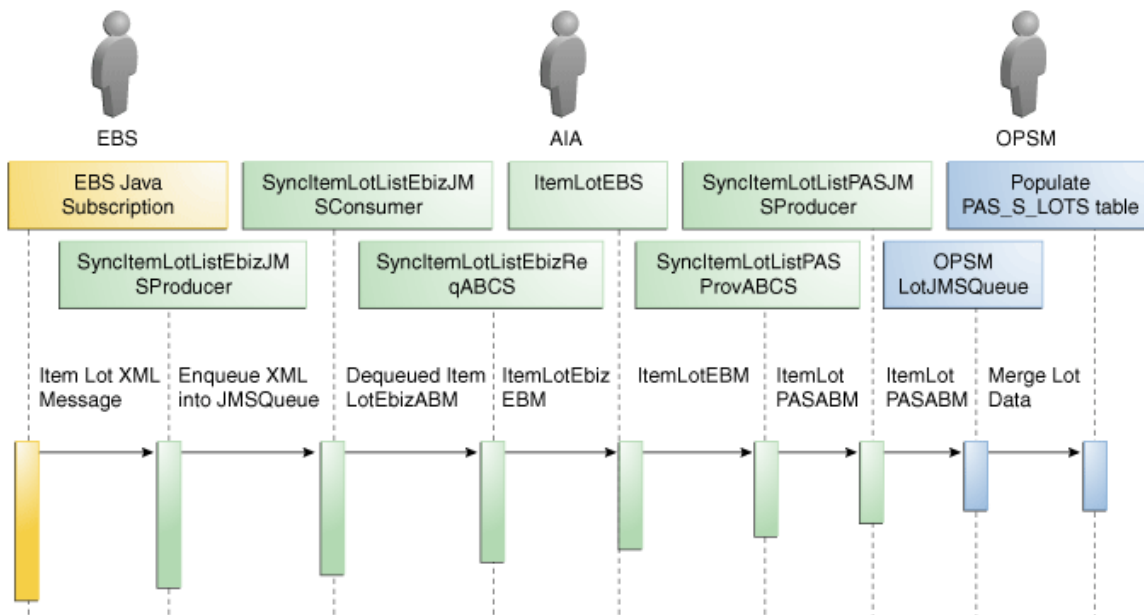

To Perform Real-Time Lot Synchronization (Discrete Manufacturing):

This window can be accessed from several Discrete Manufacturing windows such as, WIP Completions window and Misc Transactions window.

2. Enter new lot information or update existing lot information.

3. Save your work.

When a new lot is inserted or an existing lot is updated in the MTL_LOT_NUMBERS table, an Oracle Event Alert is triggered. The Oracle Event Alert calls a PL/SQL procedure that raises a Business Event. The Business Event executes the associated Java Subscription Rule Function. The Java program generates the XML payload and sends the XML payload to the endpoint URL.

If the lot fails to synchronize to OPSM, you can either change the lot to retrigger the real-time synchronization or execute the OPSM Bulk Lot Synchronization to resend the information from Oracle E-Business Suite to OPSM.

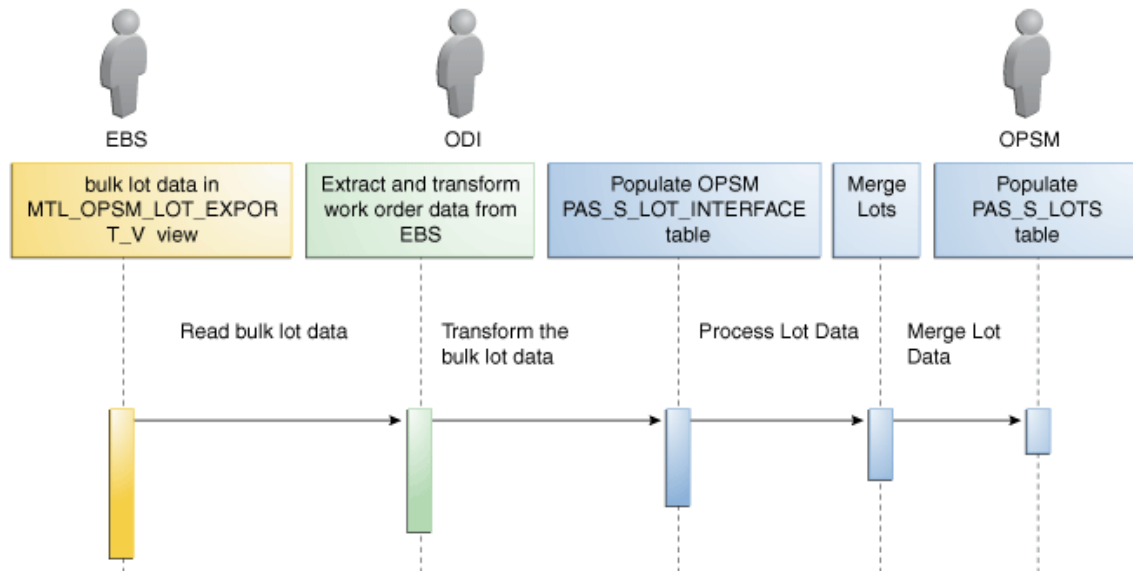

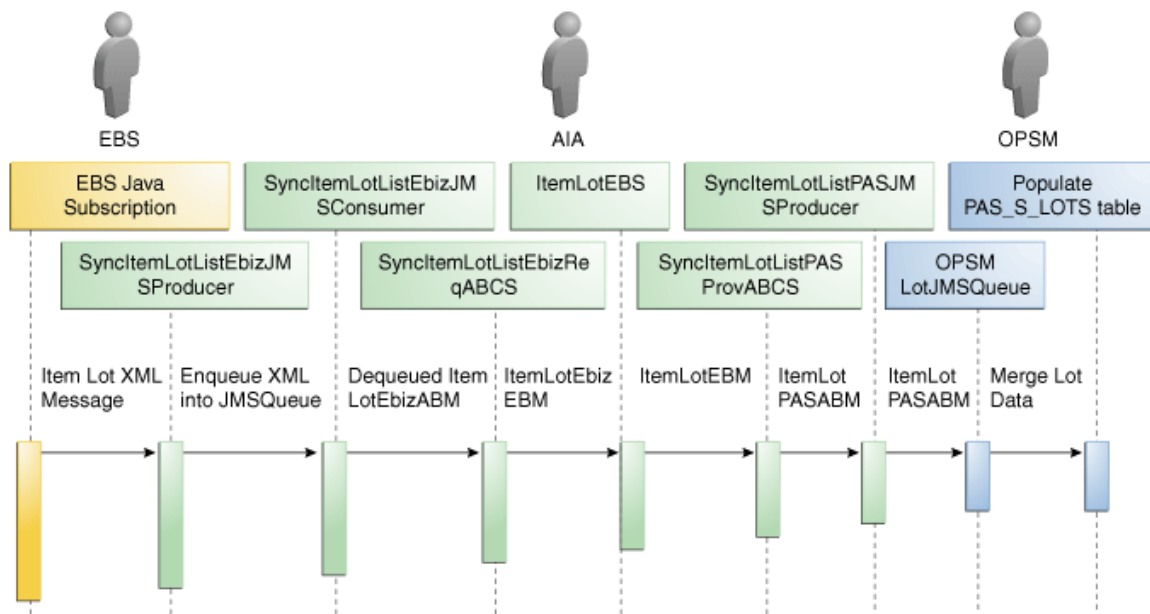

The XML payload is sent to the JMS producer in the AIA layer for synchronization. Through an OPSM MergeLot Web Service, the data is inserted in to the PAS_S_LOTS table.

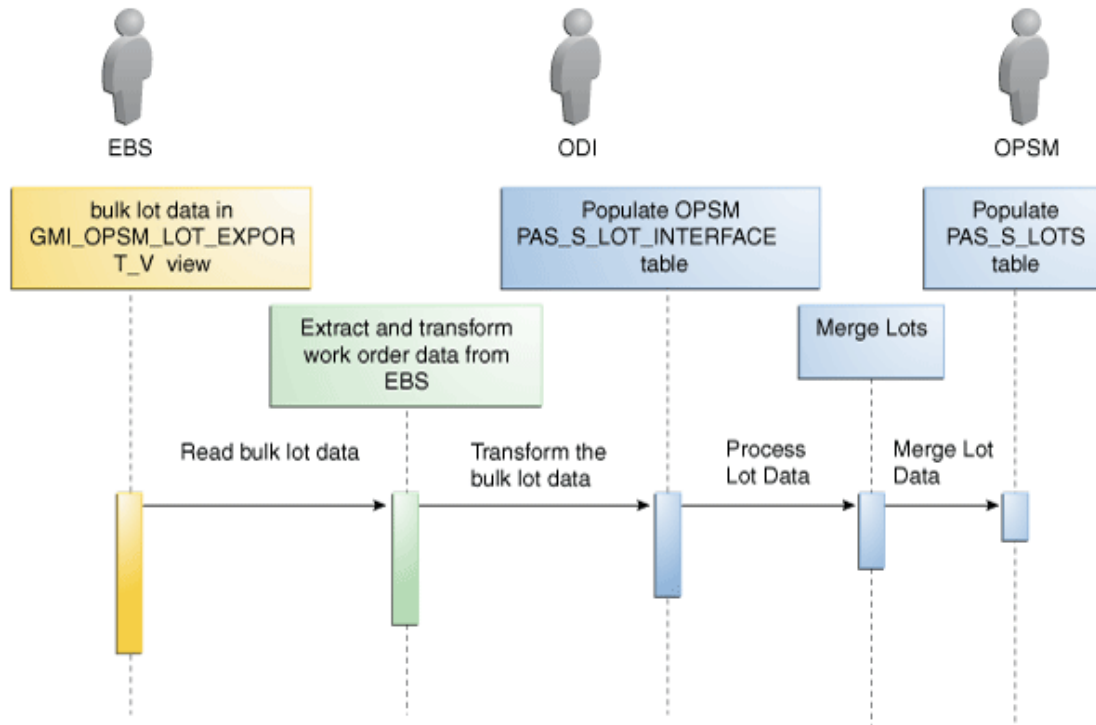

If you selected an extract scenario representing an incremental load, the Lot Synchronization background process uses ODI (Oracle Ebiz To PAS LotSync Interface) to pull net new and changed lot records from the Oracle Process Manufacturing GMI_OPSP_LOT_EXPORT_V view and transforms the data into the target OPSP Lot Interface table format, and then transfers the data to the OPSP Lot Interface table (PAS_S_LOT_INTERFACE).

Upon completion of processing, an email notification message is sent to the ODI administrator indicating the outcome of the processing and the appropriate counts of business transactions extracted and loaded. When an error occurs, the AIA AsyncErrorHandling BPEL process is called for error handling and notification.

6. Navigate to the OPSP Maintain Lots page and verify the Lot Synchronization process results.

SyncItemLotListEbizReqABCImpl

The SyncItemLotListEbizReqABCImpl service is a BPEL process, which receives ItemLotEbizABM as input from Oracle E-business Suite. This message is transformed to SyncItemLotListEBM, which also populates EBM Header and invokes ItemLotEBS.

PartnerLinkService(s)

- SyncItemLotListEbizReqABCImplExtension

This is an extensibility service, which takes SyncItemLotListEBM and ItemLotEbizABM as input and returns the same. This service enables the customer to filter, augment, and validate the input.

- **ItemLotEBS**

This service accepts SyncItemLotListEBM, which routes to either CAVS or SyncItemLotListPASProvABCImpl.

ItemLotEBS

The ItemLotEBS service is an Enterprise Business Service that routes all Item lot related actions (ItemLot and so on) to SyncItemLotListPASProvABCImpl.

This EBS service routes the SyncItemLotListEBM to SyncItemLotListPASProvABCImpl or CAVS based on the filter condition and operation.

SyncItemLotListPASProvABCImpl

The SyncItemLotListPASProvABCImpl service is a BPEL Process, which receives SyncItemLotListEBM as input from ItemLotEBS. This input SyncItemLotListEBM is transformed into ItemLotPASABM.

This is a single operation service, which receives SyncItemLotListEBM as a request from ItemLotEBS and does not return a response. This invokes the SyncItemLotListPASJMSProducer service.

PartnerLinkService(s)

- **SyncItemLotListPASProvABCImplExtension**

This is an extensibility service, which takes SyncItemLotListEBM and ItemLotPASABM as input and returns the same. This service enables the customer to filter, augment, and validate the input.

- **SyncItemLotListPASJMSProducer**

This service accepts ItemLotPASABM as input service and enqueues the ItemLotPASABM payload messages into OPSM JMS Queue. This service pushes the messages into the OPSMLotSynchQueue (which is available in OPSM application server).

Serialized Item Tracking Process Integration Overview

The Serialized Item Tracking process integration is used to record shipment transactions and shipment receipt return transactions of OPSM Integrated items from Oracle E-Business Suite to Oracle Pedigree and Serialization Manager (OPSM).

Shipping Transactions

When a delivery is ship confirmed in Oracle E-Business Suite, the outbound Advance Shipment Notice (ASN) is published from Oracle E-Business Suite to OPSM. The ASN contains the transaction details including the transaction date, transaction quantity, shipped item, lot, trading partners (sold to, shipped by, shipped to, and sold by), and supporting document information. It may also include the shipped item serials, component serials (genealogy), and the container packaging hierarchy. Based on the shipped to customer, the shipment transaction may be flagged to indicate whether a change of ownership has occurred or not.

OPSM processes the ASN recording the details of the shipment along with the serials, packaging hierarchy, and item genealogy. If OPSM has been configured to create serials at shipment, the shipped item serials and component serials created in Oracle E-Business Suite are uploaded into OPSM at the time of shipment. The packaging hierarchy from Oracle E-Business Suite is also updated in OPSM at the time of shipment. Optionally, the lot can be created as part of the shipment transaction as well. OPSM validates the serials associated with the transaction to verify the status, state, lot expiration date, existence of the serial, along with other edits. If the shipment is to a customer where a change of ownership occurs, the serials are updated to indicate they have been shipped. Optionally, shipments with no change of ownership can be recorded in OPSM. If no change of ownership occurs, the serials will remain in their current state.

When the transaction has been successfully processed, it contains the details of the transaction including transaction details, shipped items, serials, reference documents, trading partners, lot information and product information, container packing hierarchy, and the shipped item genealogy.

Shipping Receipts (Returns)

When the shipping receipt (return) transaction is processed, the returned product information is transmitted to OPSM through the shipment receipt. The return receipt transaction records the details of the return in OPSM including the returned items, serials, product information, reference documents, transaction quantity, date, and trading partners. If the shipment receipt contains the returned serials, the serials validation is performed to verify the serials were previously shipped, have not been decommissioned, and have not been flagged as counterfeit. Optionally, returns with no change of ownership can be recorded in OPSM. If no change of ownership occurs, the serials will remain in their current state.

Solution Assumptions and Constraints

The solution assumptions and constraints for the Serialized Item Tracking Process Integration are:

1. The Oracle Pedigree and Serialization Manager (OPSM) application is designed as a stand-alone application on Fusion 11g technology stack. OPSM does not have any dependencies on Fusion Applications or Fusion Applcore and foundation components.
2. Translations in Oracle E-Business Suite are not synchronized into OPSM. OPSM does not support translations of database content.
3. Item basic information is maintained in Oracle E-Business Suite and product details are maintained in OPSM.
4. Master and Inventory organizations of an item are OPSM enabled in Oracle E-Business Suite (Oracle Inventory).
5. Item cross reference type OPSM Integrated should be "YES" for the OPSM Integrated Item at the Master Organization and is not disabled at the item Inventory Organization level in Oracle E-Business Suite (Oracle Inventory).
6. Item must be lot controlled in Oracle E-Business Suite (Oracle Inventory) at the Master Item level for Product Synchronization and at the Organization level for Work Order Serialization, Commission Serials, Lot Synchronization, and Serialized Item Tracking.
7. Items have been synchronized to OPSM. As a result of the synchronization, a product with at least one product detail record that is cross-referenced to the item and primary UOM in Oracle E-Business Suite has been defined in OPSM.
8. Lots have been synchronized to OPSM.
9. Returns with transaction type DELIVER processed through API, Open interface, and Mobile, which calls the Receiving transaction Processor, will trigger the business event to send Shipment Receipt to OPSM.

10. Mobile device to OPSM integration (Oracle Mobile Supply Chain Applications (MSCA) and Oracle Warehouse Management System (WMS)) is not supported.
11. Identification of the OPSM serial number through a link to OPSM on the sales order return line is not supported.
12. Integration process for receipts is applicable only to customer returns (internal or external) or RMA's. It does not apply to supplier receipts, inter-org transfers, and internal sales orders.
13. Ship confirm process can be performed from other methods such as API and open interface.
14. Integration process for ASN (Advance Shipment Notice) is not applicable to inter-org transfers and internal sales orders.
15. WMS (Warehouse Management System) is not supported.
16. In the case where an item is serialized (serial control is set to *Predefined* or *At Receipt*), to get item genealogy the work order has to be completed using a mobile device to have a one-to-one relationship with the assembly and components.
17. When entering serials number in Oracle E-Business Suite and Shipment Confirmation or during Shipment Receipt Return, you must enter a list of serials, you cannot enter a range.

Shipment Transaction Process Flow

When an OPSM (Oracle Pedigree and Serialization Manager) tracked item is shipped in Oracle E-Business Suite, the transaction information is sent to the OPSM system in the form of an Advance Shipment Notice (ASN). This integration is achieved through the Serialized Item Tracking Process Integration (business events and AIA integration).

The ASN contains:

- Delivery details
- Serialized Containerization details (optional)
- Order details
- Item information
- Lot information
- Shipped Item Serials (optional)
- Serialized item genealogy (optional)

Serials associated with the shipment transaction can be identified in these ways:

- Entry of the shipped item serials in Oracle E-Business Suite during shipment confirmation. If serial generation is set to *At Sales Order Issue*, then either serials that only exist in OPSM can be entered or serials originating within Oracle E-Business Suite can be entered. If serial generation is set to either *At Receipt* or *Predefined*, then the serials originating from Oracle E-Business Suite will be sent to OPSM.
- Identification of the serialized shipping container in Oracle E-Business Suite during shipment confirmation. This assumes the serialized items are already associated to the serialized container in OPSM. When the shipment transaction is processed, inference will be used to identify the shipped item serials.

- Entry of the serials in the OPSM Maintain Transactions page by navigating from the Oracle E-Business Suite Shipping Transactions or Quick Ship windows to the OPSM Maintain Transactions page after the shipment transaction from Oracle E-Business Suite is recorded in OPSM.

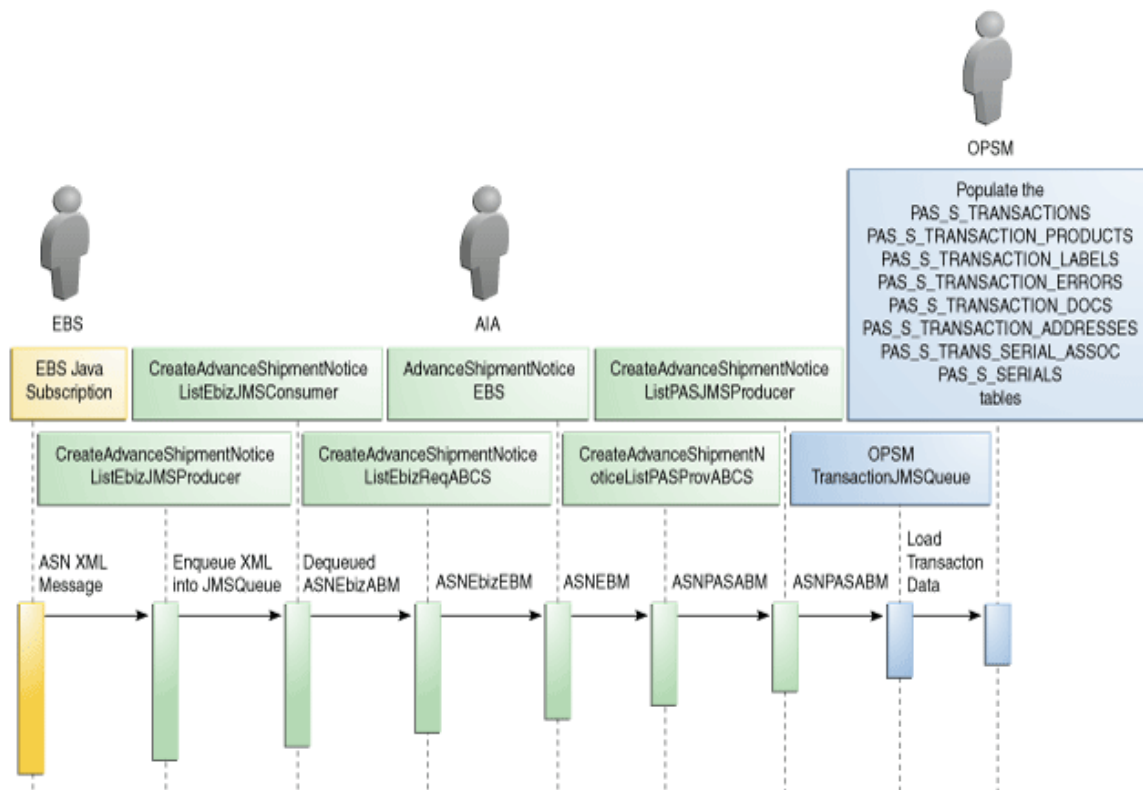

10. Select Ship Confirm in the Actions field and click the Go button.

The Confirm Delivery window appears.

11. Click the OK button.

The ship confirm process is done.

12. Navigate to the Shipping Interfaces window in Oracle E-Business Suite.

Whenever a delivery is shipped and the corresponding delivery details are interfaced to Inventory, a business event (oracle.apps.wsh.delivery.gen.interfaced) is triggered. The subscription of the business event submits a Java Rule Function if the delivery details have at least one OPSPM Enabled Item. This Java Rule Function in turn calls the PL/SQL API, which returns all the ASN data in Table type objects. Using this data a Java Program generates the XML Payload and sends it to the JMS Producer. All messages are tagged with the processing date and time of the event to ensure that the messages can be sequenced and processed in the correct order. If the XML Payload fails going to JMS Producer, then an Error Notification goes to SYSADMIN.

16. (Optional) Navigate to the Shipping Transactions window in Oracle E-Business Suite.

Note: Steps 17 - 20 are optional. If the serials have not been entered on the shipment transaction in Oracle E-Business Suite, the user can navigate to OPSPM to enter the serials directly in OPSPM.

Order Management Super User Process Operations (USA) > Order.Shipping > Transactions

This window is used to enter serials directly in Oracle Pedigree and Serialization Manager (OPSPM) if the items are serialized by OPSPM and the sales order delivery is closed.

17. (Optional) Enter Sales Order number in From Order Number field and click the Find button.

18. (Optional) Enter serial numbers using one of these methods:

Delivery Tab Method

- a. Select the Delivery tab.
- b. Select OPSPM Shipment Transaction from the Tools menu.

The OPSPM Maintain Transactions page appears with the shipment transaction information retrieved and displayed based on the Transaction Type, Location, Document, and Document Type. A separate shipment transaction will display in OPSPM for each delivery line.

- c. If the transaction is in an exception status, navigate to the Maintain Serial Associations page in OPSPM.

Click the Maintain Serial Associations button or select Maintain Serial Associations from the Actions menu for the transaction on the Maintain Transactions page.

- d. Add or delete serials or containers using the Maintain Serial Associations page.

The OPSPM Maintain Transactions page appears with the shipment transaction information retrieved and displayed based on the Transaction Type, Location, Document, Document Type, and Document Line. A single shipment transaction will display in OPSPM for the delivery line.

- c. If the transaction is in an exception status, navigate to the Maintain Serials Association page in OPSPM.

Click the Maintain Serial Associations button or select Maintain Serial Associations from the Actions menu for the transaction on the Maintain Transactions page.

- d. Add or delete serials or containers using the Maintain Serial Associations page.
- e. Save your work and return to the Maintain Transactions page.

19. (Optional) Reprocess the shipment transaction using the Maintain Transactions page.

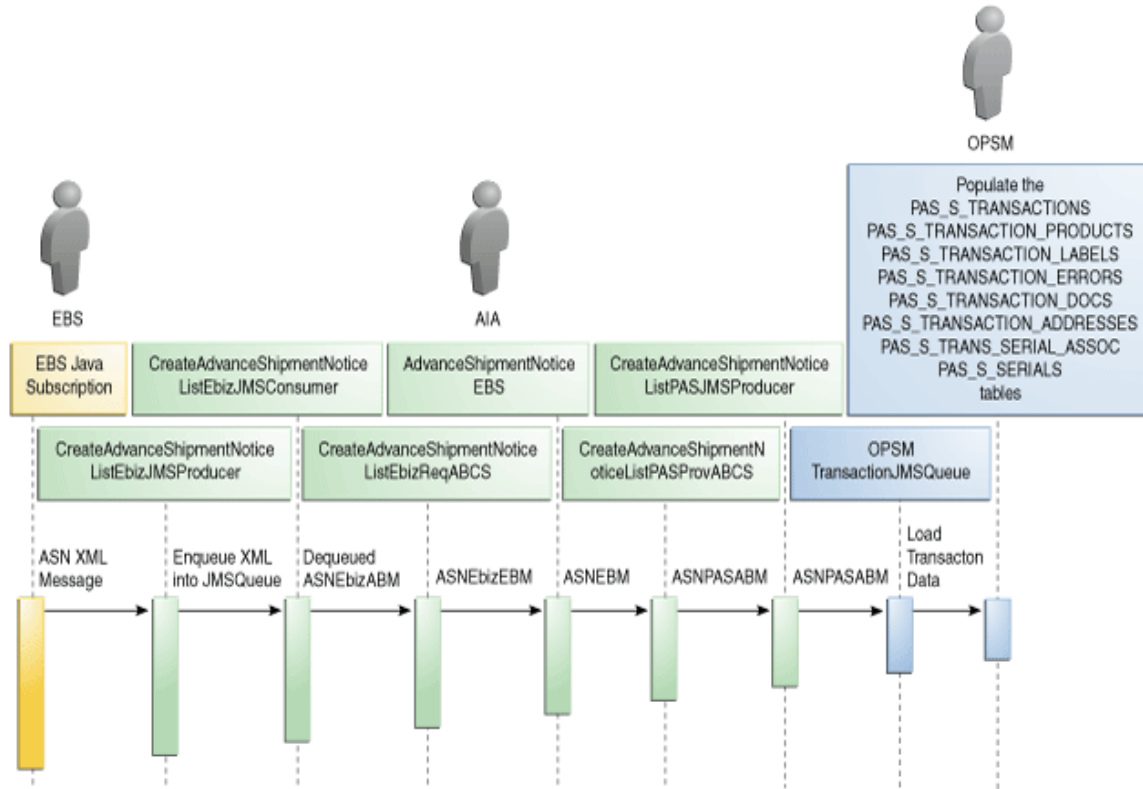

Serialized items and their quantities are synchronized during the receiving process between Oracle E-Business Suite and OPSM. The receipt transaction contains:

- Receipt details
- Item information
- Lot information
- Serials

Serials associated with the return receipt transaction can be identified in these ways:

- Entry of the returned item serials in Oracle E-Business Suite during receipt. If serial generation is set to *At Sales Order Issue*, then either serials that only exist in OPSM can be entered or serials originating within Oracle E-Business Suite can be entered. If serial generation is set to either *At Receipt* or *Predefined*, then the serials originating from Oracle E-Business Suite will be sent to OPSM.
- Entry of the serials in the OPSM Maintain Transactions page by navigating from the return receipt transaction to the OPSM Maintain Transactions page after the return receipt transaction from Oracle E-Business Suite is recorded in OPSM.

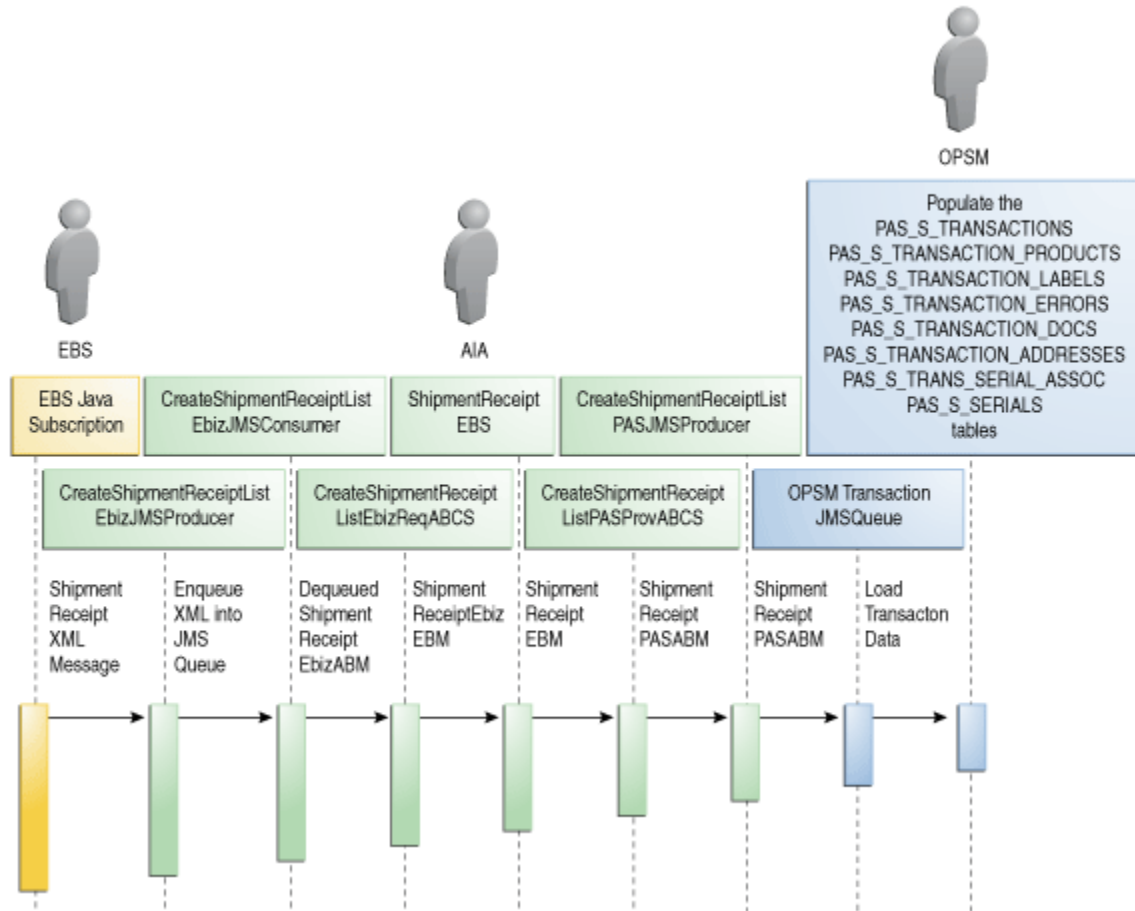

2. Navigate to the Receipts window.
Purchasing Super User Process Operations > Receiving > Receipts
3. Select the Inventory Organization where you want to perform the receipt process.
The Find Expected Receipts window appears.
4. Select the Customer tab.
5. Enter the following:
 - a. Enter the sales order number in the RMA Num field.
6. Click the Find button.

The Receipt Header window appears. New Receipt option appears by default.

7. Select the first line and enter the Subinventory for the line.
8. Click the Lot/Serial button.

The Lot Entry window appears.

The receipt transaction process is complete. The deliver transaction occurs and the items are sent to the specified inventory.

For the deliver transaction, the business event (oracle.apps.po.rcv.rcvtn.outbound) is raised which sends receipt and serials details for OPSM Integrated items from Oracle E-Business Suite to the endpoint URL in the AIA layer.

The receipt and serial details from the endpoint URL are processed in the AIA layer and then the required details are sent to OPSM.

Note: Steps 11 - 16 are optional. If the serials have not been entered on the shipment receipt (return) transaction in Oracle E-Business Suite, the user can navigate to OPSM to enter the serials directly in OPSM.

11. (Optional) Navigate to the Material Transaction window in Oracle E-Business Suite.

This window is used to call the OPSM page to enter the serials if the item is OPSM Serialized.

Each return line associated with an RMA Receipt transaction type and with an OPSM Integrated item is available for update to OPSM.

12. Invoke the Maintain Transaction page in OPSM.

Select OPSM Return Transaction from the Tools menu for a return line.

The OPSM Maintain Transactions page appears with the return transaction information retrieved and displayed based on the Transaction Type, Location, Document, and Document Type. A separate return transaction displays in OPSM for each receipt line.

13. If the transaction is in an exception status, navigate to the OPSM Maintain Serial Associations page.

Click the Maintain Serial Associations button or select Maintain Serial Associations from the Actions menu for the transaction on the Maintain Transactions page.

14. Add or Delete Serials or Containers using the Maintain Serial Associations page.

15. Save your work and return to the Maintain Transactions page.

16. Reprocess the return transaction using the Maintain Transactions page.

CreateAdvanceShipmentNoticeListEbizJMSProducer

The CreateAdvanceShipmentNoticeListEbizJMSProducer service is a Mediator service that enqueues Oracle E-Business Suite Advance Shipment Notice payload messages into the AIA layer. This service pushes the messages to the AIA_EbizAdvanceShipmentNoticeJMSQueue, which are consumed by the CreateAdvanceShipmentNoticeListEbizJMSPConsumer service.

Setting Up Flexfield Item Cross References, Profile Options, and Organization Parameters

Before you can use the Product Definition Integrations (Product Definition and Product Synchronization), certain information must be set up in Oracle E-Business Suite (Oracle Inventory). The information that needs to be set up in E-Business Suite (Oracle Inventory) is discussed in this section.

Setting Up System Parameters

Oracle Pedigree and Serialization Manager (OPSM) has two system parameters that determine how the Product Definition process integration (Product Definition and Product Synchronization) process operates. These two parameters are Owning Source System Default and Source System Precedence.

To Set Up System Parameters:

1. Navigate to the [OPSM Maintain System Parameters](#) page.

System Setup > Maintain System Parameters

2. Select a value for the [Owning Source System Default](#) field.

Use this field to specify the default setting for the Owning Source System field on the Maintain Products page. This field value defaults into the Source System attribute on the Product and Product Detail definition. This value indicates the transactional system from which the product originated.

Owning Source Systems are user defined using OPSM Lookup Type PAS_SOURCE_SYSTEM.

3. Select a value for the Source System Precedence field.

This field value indicates whether product or product detail information can be changed by any source system or only the owning source system. Source System Precedence values are:

- Any Source System: Selecting this option enables the product or product detail to be updated by any transactional system.
- Owning Source System: Selecting this option means that the product or product detail record can only be updated by the transactional system that created that record.

4. Save your work.

Setting Up ODI Extract Scenarios

The Product Definition process integration (Product Synchronization) process flow uses Oracle Data Integrator (ODI) for the integration between Oracle E-Business Suite and Oracle Pedigree and Serialization Manager. When you run the Product Synchronization process in OPSM, you must specify a synchronization action. If you select a synchronization action of Extract Items or Extract Items and Merge Product and Item Cross Reference, you must also enter an extract scenario name. The ODI process uses the extract scenario name to determine the data to be extracted.

Oracle delivers a few extract scenarios (EBS Full and EBS Incremental) to assist you with the product synchronization process flow. You can use these extract scenarios as-is or you can modify them to meet your requirements. In addition, you can create new extract scenarios.

Use this procedure to create a new extract scenario:

To Create a New Extract Scenario:

1. Access the database table `PAS_S_ODI_EXTRACT_DEF`.
2. Add a new extract definition to the database table.

These variables (by scenario) must have a record in the extract definition table.

Product Synchronization (Full and Incremental)

Scenario Name: `LOAD_ORACLEEBIZ_ITEM_DATA_TO_PAS_PKG`

Variables are:

- SCENARIO
- VERSION
- `ORACLEEBIZ_TO_PAS_PROJECT.PVV_FULL_LOAD_EXECUTION`

3. Access the database table `PAS_S_ODI_CONNECT_CONFIG`.

Verify that a record exists in this table. Add a record if one does not exist. This table contains connection information for ODI. You need information from the ODI installation process to add a record to this table.

4. Navigate to the OPSM Maintain Lookups page.

System Setup > Maintain Lookups

5. Search for the PAS_PRODUCT_EXTRACT Lookup Type.

6. Add a Lookup Code to the PAS_PRODUCT_EXTRACT Lookup Type that matches the extract definition that you created in Step 2.

7. Save your work.

8. Navigate to the OPSM Product Synchronization page.

The extract scenario you created is available for selection and use by the Product Synchronization process.

Implementing Oracle Data Integrator

ODI is a middleware integration tool used to transfer bulk data from Oracle E-Business Suite to the Oracle Pedigree and Serialization Manager (OPSM) system and also for data transfer between multiple Oracle E-Business Suite instances to the OPSM system.

Setting Up Locations

Before you can use the Product Serialization Process Integration, locations must be set up in Oracle Pedigree and Serialization Manager (OPSM). When transactional systems integrate to OPSM they need to identify the location when requesting serials or recording transactions against the serials. The location identifies the entity that has performed the transaction and defines the controls the system enforces on that entity.

At a minimum, you must define locations and products with their item cross references.

To Set Up Locations:

- Enter location information. To generate SGTIN-96 or SGTIN-198 serials, enter the Company Prefix.

The External Reference Identifier creates a cross reference of the OPSM Location to the Oracle E-Business Suite Inventory Org. Enter the Org Code used in Oracle E-Business Suite to identify the Inventory Org.

Setting Up Products and Item Cross Reference Information

Setting Up ODI Extract Scenarios

The Work Order Serialization and Lot Synchronization process integration process flows use Oracle Data Integrator (ODI) for the integration between Oracle E-Business Suite and Oracle Pedigree and Serialization Manager. When you run the Work Order Serialization or the Lot Synchronization process in OPSM, you must specify a synchronization action. If you select a synchronization action of Extract Work Orders, Extract Work Orders and Process Work Order Serialization, Extract Lots, or Extract Lots and Merge Lots you must also enter an extract scenario name. The ODI process uses the extract scenario name to determine the data to be extracted.

Oracle delivers a few extract scenarios. For Work Order Serialization, Oracle delivers the (EBS Discrete Full, EBS Discrete Incremental, EBS Process Full, and EBS Process Incremental) to assist you with the work order serialization process flow. For Lot Synchronization, Oracle delivers the (EBS Discrete Full, EBS Discrete Incremental, EBS R11 Process Full, and EBS R11 Process Incremental) to assist you with the Lot Synchronization process flow. You can use these extract scenarios as-is or you can modify them to meet your requirements. In addition, you can create new extract scenarios.

Working with Domain Value Maps

Domain value maps (DVMs) are a standard feature of the Oracle SOA Suite. They enable you to equate lookup codes and other static values across applications, for example, FOOT and FT or US and USA.

DVMs are static in nature, though administrators can add maps as needed. Transactional business processes never update DVMs; they only read from them. DVMs are stored in XML files and cached in memory at runtime.

DVM types are seeded for the Work Order Serialization and Lot Synchronization flows, and administrators can extend the list of mapped values by adding more maps. The DVM data should be synchronized with what the participating applications use. This synchronization should occur before any initial loads are run or any incremental transactional flows are initiated.

This is the DVM for the process integration for Work Order Serialization:

Handling Errors

Use the Oracle Pedigree and Serialization Manager (OPSM) Web Service Exceptions page to view exception messages that are generated when messages are processed by the OPSM Web Services (MergeLot Web Service and CreateTransaction Web Service). Exception messages are only created for exceptions or errors that are detected by the web service. If the web service processes successfully during the integration process, no message is recorded.

Note: If you call the Web Services directly without going through the AIA integration, you are not able to view exception messages using the OPSM Web Service Exceptions page. The Web Service Exceptions page is used to assist with the integration between OPSM and other transactional systems (Oracle E-Business Suite).

Web Service Exceptions Process Flow

An OPSM process continually monitors the integration message queue and then pulls the JMS messages from the queue and dequeues them. It then invokes the appropriate web service. If the web service fails, it creates a job instance message. Using the Web Service Exceptions page, you can view the job instance messages created by the web service. A web service can fail because the data that is being passed in the message is invalid or the data being passed is incorrect for the message. In addition, you can view the overall system problem errors or web services not running errors using the Web Service Exceptions page.

To View Web Service Exceptions:

1. Navigate to the OPSM Web Service Exceptions page.

- Transactions > Web Service Exceptions
- Serials > Web Service Exceptions

The Web Service Exceptions page appears. You can only view WEBSERVICES job types on this page.

2. Enter search criteria for the web service exceptions you want to view and click the Search button.

Use the Web Service Name field to search only for exceptions for the MergeLot or CreateTransaction Web Service. Otherwise, all web service exceptions appear.

All of the exceptions that match the search criteria appear in the Search Results: Job Instances table of the page.

3. Select a Job Instance ID that you want to view the messages for in the Search Results: Job Instances table.

The job instance messages for that specific web service job instance appear in the Job Instance Messages region of the page. Three job instance messages appear for each job instance. The messages provide this information:

- The first job instance message provides details indicating that the web service failed and provides the details (actual fields in the message) where the failure occurred. You can use this information to re-send the message through the transactional system (Oracle E-Business Suite).
- The second job instance message provides details indicating a partial explanation of the exception that was triggered by the web service. Only a portion of the exception text appears.
- The third job instance message provides details indicating which composite ID contains more details about the exception. You can view this composite ID within the Oracle Enterprise Manager application to view the entire SOA composite and BPEL flow.

If the SOA composite produces a fault (runtime fault and so on), the BPEL CatchAll activity grabs the fault and writes a job instance record and corresponding job instance message record. This job instance message provides details indicating which composite ID contains more details about the SOA composite fault. You can view this composite ID within the Oracle Enterprise Manager application to view the entire SOA composite and BPEL flow.

Setting Up System Parameters

Oracle Pedigree and Serialization Manager (OPSM) has a system parameter that determines if the lot can be created in OPSM as part of the shipment or return transaction processing.

To Set Up System Parameters:

1. Navigate to the OPSM Maintain System Parameters page.

System Setup > Maintain System Parameters

2. Select a value for Allow Lot Creation.

Select the check box to enable the lot to be created in OPSM as part of the shipment transaction processing. This setting only enables the lot to be created. It will not be updated based on the shipment transaction lot information.

Select the check box to enable the lot to be created in OPSM as part of the return transaction processing. This setting only enables the lot to be created. It will not be updated based on the return transaction lot information.

3. Save your work.

Setting Up Locations

Before you can use the Serialized Item Tracking Process Integrations, locations must be set up in Oracle Pedigree and Serialization Manager (OPSM). When transactional systems integrate to OPSM they need to identify the location when requesting serials or recording transactions against the serials. The location identifies the entity that has performed the transaction and defines the controls the system enforces on that entity.

At a minimum locations and products with their item, cross references must be defined.

To Set Up Locations:

1. Navigate to the OPSM Maintain Locations page.

System Setup > Maintain Locations

2. Select Create from the Actions menu or click the Create icon located at the top of the Search Results: Locations region.
3. Enter location information.
4. Enter the External Reference Identifier.

The External Reference Identifier creates a cross reference of the OPSM location to the Oracle E-Business Suite Inventory Org. Enter the Org Code used in Oracle E-Business Suite to identify the Inventory Org.

5. Enter the Default Label Type.

The Default Label Type will be the default for the container label on a shipment or return transaction.

6. Save your work.

Setting Up Products and Item Cross Reference Information

Before you can use the Serialized Item Tracking Process Integrations, products and their transactional source system item cross reference information must be set up in Oracle Pedigree and Serialization Manager (OPSM). If these products and item cross reference information have not been set up using the Product Synchronization or Product Definition processes, they can be set up directly in OPSM.

At a minimum locations and products with their item, cross references must be defined.

To Set Up Products and Item Cross Reference Information:

1. Navigate to the OPSM Maintain Products page.

System Setup > Maintain Products

2. Select **Create** from the **Actions** menu or click the **Create** icon located at the top of the **Search Results: Products** region.
3. Add product information, product details, and item cross reference details.

To create serials originating in Oracle E-Business Suite in OPSM at time of shipment, select the **Create Serials for Shipments** check box. This value may be overridden by product and location.

To record internal shipments, select the **Record Internal Shipments** check box. This value may be overridden by product and location.

To record internal returns, select the **Record Internal Returns** check box. This value may be overridden by product and location.

In the product details tab, define the serial type to identify the serial type expected on the shipment and return transactions. EPC Number and EPC filter may be required depending on the serial type selected.

4. Save your work.

Working with Domain Value Maps

Domain value maps (DVMs) are a standard feature of the Oracle SOA Suite. They enable you to equate lookup codes and other static values across applications, for example, FOOT and FT or US and USA.

DVMs are static in nature, though administrators can add maps as needed. Transactional business processes never update DVMs; they only read from them. DVMs are stored in XML files and cached in memory at runtime.

DVM types are seeded for the Serialized Item Tracking flows, and administrators can extend the list of mapped values by adding more maps. The DVM data should be synchronized with what the participating applications use. This synchronization should occur before any initial loads are run or any incremental transactional flows are initiated.

This is the DVM for the process integration for Serialized Item Tracking:

Handling Errors

Use the Oracle Pedigree and Serialization Manager (OPSM) Web Service Exceptions page to view exception messages that are generated when messages are processed by the OPSM Web Services (MergeLot Web Service and CreateTransaction Web Service). Exception messages are only created for exceptions or errors that are detected by the web service. If the web service processes successfully during the integration process, no message is recorded.

Note: If you call the Web Services directly without going through the AIA integration, you are not able to view exception messages using the OPSM Web Service Exceptions page. The Web Service Exceptions page is used to assist with the integration between OPSM and other transactional systems (Oracle E-Business Suite).

Web Service Exceptions Process Flow

An OPSM process continually monitors the integration message queue and then pulls the JMS messages from the queue and dequeues them. It then invokes the appropriate web service. If the web service fails, it creates a job instance message. Using the Web Service Exceptions page, you can view the job instance messages created by the web service. A web service can fail because the data that is being passed in the message is invalid or the data being passed is incorrect for the message. In addition, you can view the overall system problem errors or web services not running errors using the Web Service Exceptions page.

To View Web Service Exceptions:

1. **Navigate to the OPSM Web Service Exceptions page.**

- Transactions > Web Service Exceptions
- Serials > Web Service Exceptions

The Web Service Exceptions page appears. You can only view WEBSERVICES job types on this page.

2. **Enter search criteria for the web service exceptions you want to view and click the Search button.**

Use the Web Service Name field to search only for exceptions for the MergeLot or CreateTransaction Web Service. Otherwise, all web service exceptions appear.

All of the exceptions that match the search criteria appear in the Search Results: Job Instances table of the page.

3. **Select a Job Instance ID that you want to view the messages for in the Search Results: Job Instances table.**

The job instance messages for that specific web service job instance appear in the Job Instance Messages region of the page. Three job instance messages appear for each job instance. The messages provide this information:

- The first job instance message provides details indicating that the web service failed and provides the details (actual fields in the message) where the failure occurred. You can use this information to re-send the message through the transactional system (Oracle E-Business Suite).

- The second job instance message provides details indicating a partial explanation of the exception that was triggered by the web service. Only a portion of the exception text appears.
- The third job instance message provides details indicating which composite ID contains more details about the exception. You can view this composite ID within the Oracle Enterprise Manager application to view the entire SOA composite and BPEL flow.

If the SOA composite produces a fault (runtime fault and so on), the BPEL CatchAll activity grabs the fault and write a job instance record and corresponding job instance message record. This job instance message provides details indicating which composite ID contains more details about the SOA composite fault. You can view this composite ID within the Oracle Enterprise Manager application to view the entire SOA composite and BPEL flow.

Supporting Multiple Oracle E-Business Suite Source Systems

The Oracle Serialization and Tracking Process Integration Pack (PIP) supports data transfer from multiple Oracle E-Business Suite systems to a single Oracle Pedigree and Serialization Manager (OPSM) application. The delivered Oracle Serialization and Tracking PIP supports data transfer from a single Oracle E-Business Suite Release 11.5.10 system and a Release 12.1.2 system. You can configure more than two Oracle E-Business Suite systems in Oracle Data Integrator (ODI).

Use this procedure to configure more than two Oracle E-Business Suite systems in ODI:

Configuring More Than Two Oracle E-Business Suite Systems in ODI

To Configure More than Two Oracle E-Business Suite Systems in ODI:

1. Open the ODI Topology manager.
2. Click Insert Context on the Context tab.
3. Enter the new context name.
For example, EBIZ_03
4. Click Apply and OK.
5. Expand Oracle in the Physical Architecture tab.
6. Add a data server for the new Oracle E-Business Suite application database.
7. Add the physical schema for the Oracle E-Business Suite application database.
8. Add the new context that was created in step 3 in the Context tab of the physical schema and select the corresponding logical schema.
9. Add the new context (created in step 3) in the context column and add the existing logical schema name in logical schema column for the PASDS and WorkRepDS data servers.
10. Repeat step 9 for the LocationDS and WorkOrderStatusDS data servers available under XML technology.

Chapter 9: Setting Up Web Service Security for Oracle E-Business Suite Release 12.1.2

This chapter discusses how to:

Setting Up Web Service Security for Oracle E-Business Suite

Before you can modify the global security policies, Oracle E-Business Suite (EBS) Release 12.1.2 must be configured to send the user credentials.

This section discusses how to:

- Set up user credentials in EBS
- Set up subscriptions to business events.

Setting Up User Credentials in EBS

To Set Up User Credentials in EBS:

1. Run the following command using your user-defined values for the module, key, and password to store the password in FND Vault: The module is the text value that you want to use to do a FND_VAULT lookup of the user password. The key is the text value that you want to use to do a FND_VAULT lookup of the user password.

```
@$FND_TOP/sql/afvltput.sql < module> <key> <password>
```

2. Verify that the password has been stored successfully in FND Vault by running the following command:


```
select fnd_vault.get(< module>, <key>) from dual;
```

Setting Up Subscriptions to Business Events

To Set Up Business Event Subscriptions:

1. Navigate to the Business Event page.

3. In the Results table, click the Subscription icon.
4. In the Subscriptions page, click the edit icon for the subscription.
5. After the Update Subscriptions page appears, click the Next button.
6. In the Subscription Parameters section, create the following parameters with suitable values:
 - WFBES_SOAP_USERNAME: The username to be passed as part of the credentials.
 - WFBES_SOAP_PASSWORD_MOD: The module used to set up the password in FND Vault in the previous section.
 - WFBES_SOAP_PASSWORD_KEY: The key used to set up the password in FND Vault in the previous section.

Working with Oracle Web Service Manager Policies

Oracle Web Services Manager (OWSM) is a standards-compliant solution delivered as part of Oracle SOA Suite that enables you to centrally define and store declarative policies and enforce security and management policies through configurable agents.

OWSM policies can be attached to applications programmatically at design time. Also, during deployment it is possible to attach OWSM policies to SOA composites using the Oracle Enterprise Manager Fusion Middleware Control.
