## **Data Migration**

## Introduction

Data migration is the process of transferring data between storage types, formats, or computer systems. Data migration phases (design, extraction, cleansing, load, and verification) for applications of moderate to high complexity are commonly repeated several times before the new system is deployed. Data migration is applicable after the installation of the Oracle Financial Services (OFS) Economic Capital Advanced 1.1.1.1.0. The backup of all the tables is taken by the ML installer.

## **Data Migration Activities**

For the below mentioned tables, the backup is taken and data is deleted by pre\_model scripts. For more information on pre-model, see *OFS Economic Capital Advanced 1.1.1.1.0 Installation Guide*.

Ensure all the above mentioned back up tables are restored. For restoring data for Tables/Columns, execute "Post\_Model\_Scripts\Compile.sql". In restoration scripts, below mentioned default values are used. User can modify the scripts with the appropriate default values, if required. Also post successful restoration, user can drop the backup tables.
