Licensing Information

The Oracle Exadata Storage Server Software license includes the use of Hybrid Columnar Compression along with other features documented in *Oracle Exadata Storage Server Software User's Guide*.

Oracle Advanced Compression Option must be licensed to enable flash cache compression. Refer to *Oracle Database Licensing Information* for additional information.

Oracle Database is licensed separately. Refer to *Oracle Database Licensing Information* for additional information.

Capacity-On-Demand Information

Oracle Exadata Database Machine is shipped with all cores enabled on the database servers. Oracle allows a reduction in the number of active cores on the database servers, known as capacity-on-demand. The reduction is implemented during software installation using Oracle Exadata Database Machine Deployment Assistant (OEDA). The number of active cores can be increased at a later time, when more capacity is needed. Oracle Exadata Database Machine X4-2 database servers have two 12-core processors, for a total of 24 cores per server. Oracle Exadata Database Machine X4-8 Full Rack database servers have 15 cores per processor, for a total of 120 cores per server.

The capacity-on-demand feature disables a portion of the cores on one or more database servers in Oracle Exadata Database Machine. In order to use the capacity-on-demand feature, one of the following must occur within three months of installation:

- Purchase the Oracle technical support services necessary to enable eligibility for receipt of Oracle Platinum Services, and then continuously maintain those services.
- Install, and then continuously utilize Oracle Configuration Manager in connected-mode.

Restrictions for Capacity-On-Demand on Oracle Exadata Database Machine

The following capacity-on-demand restrictions apply to changing processor core count:

- Capacity-on-demand is available for Oracle Exadata Database Machine X4-2 and Oracle Exadata Database Machine X4-8 Full Rack systems.
- Oracle Exadata Database Machine X4-2 Eighth Rack is excluded from capacity-on-demand.

- Reducing the number of active cores lowers the initial software licensing cost. It does not change the hardware cost.
- The minimum number of processor cores that must be enabled is half of the physical cores on each processor. For Oracle Exadata Database Machine X4-2 systems, the minimum is 6 per processor (12 per database server). For Oracle Exadata Database Machine X4-8 Full Rack, the minimum is 8 per processor (64 per database server).
- Additional cores are increased in 2-core increments per server on Oracle Exadata Database Machine X4-2, and in 8-core increments on Oracle Exadata Database Machine X4-8 Full Rack. Database servers in the same system can enable a different number of cores.
- Capacity-on-demand may only be used to decrease the number of active processor cores during initial installation. After initial configuration, the processor core count can only increase on a system, up to the maximum. It is the customer's responsibility to acquire the additional software licenses.
- Oracle Exadata Database Machine purchased under Infrastructure as a Service (IaaS) is not eligible for capacity-on-demand.
