1 OFS AAI Release v8.0.6.5.0

OFS Analytical Applications Infrastructure Installation Guide (OFS AAI) Maintenance Level (ML) release v8.0.6.5.0 includes all the bug fixes and minor enhancements done since the previous GA (General Availability) release v8.0.6.0.0.

This ML release of OFS AAI can be installed on a setup with any Oracle Financial Services Analytical Applications (OFSAA) v8.0.6.0.0 Application Pack.

1.2 Pre Installation Requirements

- The minimum patch level installed must be OFS AAI Release **8.0.6.0.0**.
- Ensure that the unlimited cryptographic policy for Java is enabled during the installation of OFS AAI 8.0.6.0.0. For more information, see the *Enabling Unlimited Cryptographic Policy* section in the [OFS Analytical Applications Infrastructure Administration Guide](#).
- It is mandatory to install the OFSAAI 8.0.6.5.0 ML only on *Java 8 with JCE enabled*. Therefore, configure the Java version of the following to *Java 8 with JCE enabled*.
 - OFSAA Processing Tier (where the ML will be installed)
 - Web server (Tomcat/WebSphere/WebLogic)

NOTE To upgrade Java 7 in an existing OFSAA 8.0.6.x.x instance to Java 8, see *Appendix P* in the [OFS AAI Installation and Configuration Guide](#).

ATTENTION If the OFS Enterprise Case Management (OFS ECM) Application Pack is installed in your environment and the ECM Release 8.0.6.0.18 patch **31109777** is applied, then contact [My Oracle Support](#) before applying the OFS AAI 8.0.6.5.0 ML for information on the compatibility of the application with OFS AAI.

1.3 How to Install this Release

To install this release patch, follow these steps:

1. Log in to [My Oracle Support](#) and search for **30893495** under the Patches & Updates tab.
2. Download the OFSAA 8.0.6.5.0 OFS AAI ML Release archive file and copy to your OFSAA server in **Binary** mode.

NOTE There are different archive files for different operating systems such as AIX, Solaris, and RHEL/OEL.

3. Search and download the mandatory patch **31606017** from [My Oracle Support](#).
4. Log in to [My Oracle Support](#), search for the **33663417** Mandatory Patch in the **Patches & Updates** Tab and download it.

ATTENTION On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new

vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue.

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application, or apply an incremental patch.

5. Stop all the OFS AAI services. For more information, see the Starting/Stopping Infrastructure Services section in the [Oracle Financial Services Analytical Applications Infrastructure Installation & Configuration Guide 8.0.2.0.0](#).
6. Log in to the OFSAA server as a non-root user and navigate to the `$FIC_HOME` directory.
7. Assign WRITE permission to the files/directories such as commonscripts, EXEWebService, ficapp, ficweb, and ficdb using the command:


```
chmod -R 775 *
```
8. If you have the Unzip utility, skip to the next step or download the Unzip utility (OS-specific) and copy it in Binary mode to the directory that is included in your PATH variable, typically `$HOME` path or directory in which you have copied the 8.0.6.5.0 ML.
 - Uncompress the unzip installer file using the command:


```
uncompress unzip_<os>.Z
```

NOTE If you notice an error message “**uncompress: not found [No such file or directory]**” when the package is not installed, contact your UNIX administrator.

- Give EXECUTE permission to the utility using the command:


```
chmod 751 unzip_<os>
```

For example, `chmod 751 unzip_aix`
- 9. Extract the contents of the 8.0.6.5.0 ML archive file using one of the following commands:


```
unzip_<os> -a <name of the file to be unzipped>
```

Or

```
unzip -a <name of the file to be unzipped>
```

NOTE The above “-a” option is mandatory to unzip the archive file. For example: For AIX operating system, `unzip_aix -a p30893495_80650_AIX64.zip`

10. Navigate to the path where the folder OFS_AAI exists to give EXECUTE permission to the ML patch installer script using the command:

```
chmod 755 OFSAAIUpdate.sh
```

11. Complete the patch upgrade using the command:

```
./OFSAAIUpdate.sh
```

12. Verify if the ML patch is applied successfully by checking the log file generated in the `OFS_AAI/logs` directory. You can ignore error codes ORA-00001 and ORA-02292 in the log file. For any other errors, contact [My Oracle Support](#).

NOTE

For upgrade on Hive Infodom, you may encounter an exception "PL/SQL: ORA-00942: table or view does not exist". You can ignore this error.

13. Post successful installation of the ML, follow these steps:

- Clear the application cache. Navigate to the following path depending on the configured web application server and delete the files.
 - Tomcat:


```
<Tomcat installation folder>/work/Catalina/localhost/<Application name>/org/apache/jsp
```
 - WebLogic:


```
<WebLogic installation location>/domains/<Domain name>/servers/<Server name>/tmp/_WL_user/<Application name>
```
 - WebSphere:


```
<WebSphere installation directory>/AppServer/profiles/<Profile name>/temp/<Node name>/server1/<Application name>/<.war file name>
```

14. Delete the existing EAR/WAR file available in the `$FIC_HOME/ficweb` directory.

15. Install the OFSAAIRunner package. This is an optional step and applicable only if you have installed Oracle R Enterprise Edition (ORE). For more information, see [Installing OFSAAIRunner package with enhancements for OFS AAI 8.0.6.5.0](#).

16. Apply the mandatory patch **31606017. See the Readme available with the patch for further instructions on how to install and apply the patch.**

17. Apply the **33663417 Mandatory Patch.**

See the Readme that is packaged with the patch for further instructions on how to install and apply it.

18. Restart all the OFSAAI services. For more information, see the Starting/Stopping Infrastructure Services section in the [Oracle Financial Services Analytical Applications Infrastructure Installation & Configuration Guide 8.0.2.0.0](#).

19. Generate the application EAR/WAR file and redeploy the application onto your configured web application server. For more information on generating and deploying the EAR/ WAR file, see the Post Installation Configurations section in the [Oracle Financial Services Analytical Applications Infrastructure Installation & Configuration Guide 8.0.2.0.0](#).

2 Additional Configurations

2.1 Installing the OFSAAI Runner Package with Enhancements for OFS AAI 8.0.6.5.0

NOTE

1. This is a post-installation configuration and is applicable if you have installed Oracle R Enterprise (ORE) for Oracle Financial Services Enterprise Modeling (OFS EMF) Application.
2. This configuration is not applicable for Tomcat web server.

If OFS Enterprise Modeling is licensed and enabled in your OFSAA instance, uninstall the OFSAAI Runner package and reinstall the latest available OFSAAI Runner package. For details on uninstallation and reinstallation, see the Configuring Oracle R distribution and Oracle R Enterprise (ORE) section in the [Oracle Financial Services Analytical Applications Infrastructure Installation & Configuration Guide 8.0.2.0.0](#).
