1.1 Pre Installation Requirements

 You should have OFS GRC Application Pack version 8.0.1.0.0 as the minimum patch set level.

1.2 How to Apply This Maintenance Level Release?

Refer to the following instructions to install this maintenance patch.

- 1. Login to <u>https://support.oracle.com/</u> and search for 21967195 under the *Patches* & *Updates* tab.
- 2. Download the OFS GRC Application Pack 8.0.1.1.0 ML archive file and copy it to your OFSAA server in **Binary** mode.



NOTE: There are different archive files for different operating systems such as AIX, Solaris, and RHEL/OEL.

- 3. Stop all the OFSAAI services. For more information, see the *Start/Stop Infrastructure Services* section in <u>OFS GRC 8.0.0.0 Installation and Configuration Guide</u>.
- 4. Login to the OFSAA server as a non-root user and navigate to the \$FIC_HOME folder.
- Assign WRITE permission to the files/ folders such as commonscripts, EXEWebService, ficapp, ficweb, and ficdb in the **\$FIC_HOME** folder by executing the command:

```
chmod -R 775 *
```

- If you have Unzip utility, skip to the next step or download the Unzip utility (OS specific) unzip_<os>.Z from the location <u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in Binary mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the 8.0.1.1.0 ML.
 - Uncompress the unzip installer file using the command:

uncompress unzip_<os>.Z

NOTE: If you notice an error message "uncompress: not found [No such file or directory]" when the package is not installed, contact your UNIX administrator.

• Give EXECUTE permission to the utility using the command:

```
chmod 751 unzip_<os>
```

For example, chmod 751 unzip_aix

7. Extract the contents of the 8.0.1.1.0 ML archive file using either of the following commands:

unzip_<os> <name of the file to be unzipped>

OR

unzip <name of the file to be unzipped>

- 8. Go to /OFS_BGRC_PACK/OFS_BGRC/conf/PatchConfig.xml
- 9. Update the PatchConfig.xml for the below place holder tags mentioned.

10. Give EXECUTE permission to the ML patch installer script. Navigate to the folder OFS_BGRC_PACK and execute the command:

chmod 755 OFSAAIUpdate.sh

11. Execute the following command:

./OFSAAIUpdate.sh

NOTE: Verify if the ML is applied successfully by checking the log files generated under /OFS_BGRC_PACK/logs/OFSAAIUpdate.log & /OFS_BGRC_PACK/OFS_BGRC/logs/OFS_BGRC_LOG.log. In case of any errors, contact Oracle Support.

12. Post successful installation of the ML, perform the following steps:



- Clear the application cache. Navigate to the following path depending on the configured web application server and delete the files.
 - Tomcat:

<Tomcat installation folder>/work/Catalina/localhost/<Application name>/org/apache/jsp

Weblogic:

<Weblogic installation location>/domains/<Domain name>/servers/<Server name>/tmp/_WL_user/<Application name>

Websphere:

<Websphere installation directory>/AppServer/profiles/<Profile name>/temp/<Node name>/server1/<Application name>/<.war file name>

- 13. Delete the existing EAR/WAR file available in the folder \$FIC_HOME/ficweb.
- 14. Generate the application EAR/WAR file and redeploy the application onto your configured web application server. For more information on generating and deploying the EAR/ WAR file, refer to the *Post Installation Configuration* section in <u>OFS GRC</u> 8.0.0.0 Installation and Configuration Guide.
- 15. After successful installation of the ML, start all the OFSAAI services. For more information, refer to the *Start/Stop Infrastructure Services* section in <u>OFS GRC 8.0.0.0.0</u> <u>Installation and Configuration Guide</u>.
- 16. Deploy the RPD and Catalog OBIEE files present under *\$FIC_HOME/OBIEE* folder. For detailed steps, refer to Appendix M in <u>OFS GRC 8.0.0.0.0 Installation and</u> <u>Configuration Guide</u>.

1.3 Post Installation Configurations

On successful installation of OFSGRC v8.0.1.0.0, below post installation configurations are to be followed.

1.3.1 Test Data Execution

To Execute Sample User Scripts follow these steps:

- 1. Navigate to \$FIC_HOME/ficdb/Test_Data
- 2. Connect to config schema through sqlplus
- 3. Execute command @'Execution_order.txt'
- 4. Commit the change.
