3.1 Highlights

- Consolidates data from multiple, disparate source systems to provide a strategic enterprise-wide view across various business and operational segments
- Provides an underlying data model constructed specifically for the insurance industry.
- Delivers information management, reporting and advanced analytics to end-users through an easy-to-use Web application

OIPi utilizes OBIEE technology to present:

- Behavioral and performance trends of its target segments – Line of Businesses, Products, Regions, Intermediaries, Customers, Revenues, Expenses, Claims and so on
- Performance tracking using key business performance indicators
- Performance of the overall business, profitability, intermediaries and underlying customers
- Performance of Business against goal/budget and plans
- Efficiency of the intermediaries and business lines in terms of new business revenue and business retention. Most and least active and revenue generating intermediaries, sales channels, products and geographical locations.
- Most and least profitable line of business and products.

NOTE

The application (OIPi) current release contains some Analysis and Reports specific to General (P&C) Insurance Industry. Analysis and Reports pertaining to other Insurance Segments would be brought into subsequent releases.

3.3 Fixed Issues

There are no fixed issues as part of OIPi application Release 8.0.7.0.0.

3.4 Limitations/ Known Issues

The known issue/ limitation in OIPI application Release 8.0.7.0.0 is as follows:

- OBIEE Reports throw error: ORA-28094: SQL CONSTRUCT NOT SUPPORTED BY DATA REDACT on DB version 12.2.0.1.0.
- Table fct_policy_profitability is not populated with rep line code 1024. The corresponding v_metadata_code= 'MOIPI212'
- Map View Error in Reports
 - As a work-around, User needs to edit the analysis, auto correct the maps and save it.
- Corporate Performance: Issue with reports involving Ago function.
- Repline 153 for Investment Income is missing.
