This document highlights the major changes for Release 16.0.5 of Oracle Retail Xstore Suite.

Overview

Oracle Retail Xstore Suite 16.0.5 includes the products below.

Oracle Retail Xstore Point of Service

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

Oracle Retail Xstore Office

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

Functional Enhancements

This section describes the functional enhancements that have been added to Xstore Suite 16.0.5:

Italy Configuration Accelerator

The following functional enhancements have been implemented for the Country Pack Italy.

Registratore Telematico

The Registratore Telematico (RT) can now be used in addition to the Fiscal Printer (FP).

Electronic Invoice

The electronic invoice creation and export functions are now available.

France Configuration Accelerator

The following functional enhancements have been implemented for the Country Pack France.

Nomenclature des Activités Françaises (NAF) Code

The Nomenclature des Activités Françaises (NAF) code is printed on receipts.

Unit Price Tax

The unit price tax excluded is shown on invoices.

Suspended Receipts

Xstore Point of Service does not print receipts for suspended transactions.

Invoice Reference On Credit Notes

The invoice reference on credit notes includes the complete number of the original invoice including the prefix, for example, F072118000002.

Database Tampering Check

The database tampering check has been improved.

Terminal ID for Events

The length of the terminal ID can be configured to meet the requirements of the retailer.

Preflight Check

A new preflight check has been implemented. The preflight check validates if the following store properties are present:

- Système Informatique pour le Répertoire des Entreprises sur le Territoire (SIRET)
- Nomenclature des Activités Françaises (NAF)
- Taxe sur la Valeur Ajoutée (TVA)

These properties are mandatory for the receipt printing.

Log Records

An audit log record is written to the cfra_technical_event_log table for the following events:

- the period closing (daily/monthly) starts

- a sale is cancelled.

New Database Entries

The following columns have been added to the cfra_sales_total and cfra_sales_tnr_total table:

- real_perpetual_grand_total
- signature_version

Portugal Configuration Accelerator

The following functional enhancements have been implemented for the Country Pack Portugal.

Electronic Signature

The signature management and rebuild have been improved to better manage register offline conditions.

Technical Enhancements

The technical enhancements below have been added to the Oracle Retail Xstore Suite:

WebLogic

Xstore Office is now supported on WebLogic 12.2.1.3.

Tomcat

Xstore Office is now supported on Tomcat version 9.0.14.

Jetty

Xstore Office and Xstore Mobile are now supported on Jetty version 9.4.11.

Log4j

Xstore POS now supports Log4j 2.11.0.

POS Log

The POS Log has been enhanced for the return of a deposit during an extended transaction. For details on the POS Log changes, see the *Oracle Retail Point of Service POS Log Changes 16.0* document.
