This document highlights the major changes for Release 16.0.7 of Oracle Retail Xstore Suite.

## Overview

Oracle Retail Xstore Suite 16.0.7 includes the products below.

### Oracle Retail Xstore Point of Service

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

### Oracle Retail Xstore Office

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

## Functional Enhancements

## **Country Accelerator Germany**

The following enhancements have been added for the country accelerator Germany.

### **DSFinV-K Data Export**

You can set the DSFinV-K export so that the column headers are included in the CSV files now.

## **Country Accelerator Portugal**

The following enhancements have been added for the country accelerator Portugal.

### **Tax Free Quantity Limit**

The Tax Free quantity cannot be over 50 for the same item.

### **Tax Free**

The following tax free enhancements have been added.

### **Global Blue**

The list of required and optional fields is reviewed based on the latest information for each country.

### **Tax Free Eligibility Check**

The Tax Free Eligibility check was introduced for Northern Ireland residents.

## **Technical Enhancements**

The technical enhancements below have been added to the Oracle Retail Xstore Suite:

### **Tomcat**

Xstore Office is now supported on Tomcat version 9.0.45.

### **Jetty**

Xstore Office and Xstore Mobile are now supported on Jetty version 9.4.43.

### **Log4j**

Xstore POS now supports Log4j 2.17.1.

## **Defect Fixes and Documentation**

A defect fix is a modification to the base Oracle Retail Xstore Point of Service code (for example, a bug fix, a performance enhancement, a functional enhancement, or a technical enhancement). The file named DEFECT MODULE XREF Xstore Suite 16.0.7.xls lists every defect number and the modules and scripts that are added or modified in the release. Review the file carefully before applying this patch. Please note that scripts do not preserve data. Make sure that all data is backed up before you run any script.
