# **Overview**

Oracle Retail Xstore Suite 17.0.1 includes the products below.

# **Oracle Retail Xstore Point of Service**

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

### **Oracle Retail Xstore Office**

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

### **Functional Enhancements**

This section describes the functional enhancements that have been added to Xstore Suite 17.0.1:



#### **Xstore Point of Service**

The following functional enhancements have been made to Xstore POS version 17.0.1:

#### Check Authorization through EFTLink

Check payments can now be authorized on an Xstore POS system through EFTLink.

#### **Arabic Translations**

Xstore POS now includes Arabic translation files.

## **France Country Pack**

The following changes have been made in the country pack for France:

**Postal Code in Invoices and Credit Notes** A tax-free invoice or credit note cannot be created when there is no postal code in the primary address for the customer assigned to a transaction.

**Workstation Sales Summary** Workstation sales summary records are now maintained at daily, monthly, yearly and perpetual time periods.

**Transaction Sequence Number** Each sales transaction has a new, specific sequence number assigned to it. This transaction number is printed on the receipt.

**Certification Information** Xstore POS now has a menu option to display its certification number, a reference to the NF525 mark or logo, its certified system serial number, and the compliance version of the software and/or firmware.

**New Information on Receipts and Invoices** Receipts and invoices now include the following fields:

An Electronic Signature string.

**Note:** The Infocert Certification number is replaced by asterisks when the register is in training mode.

- Xstore POS software version
- Certification Logo

**Training Mode Indication on Receipts** When printing a receipt in training mode, the receipt displays the word, "Formation," indicating that it is a training receipt.

**Indication that Receipts are Not Valid for Collection** Non-sale extended transactions include the words, "NON VALABLE POUR ENCAISSEMENT," on the receipt. This indicates that the receipts are not valid for collection.

**Daily Close** Xstore POS now includes a daily close function used to create daily summaries and reports. This process also creates daily closure archive files.

**Monthly Close** Xstore POS now includes a monthly close function used to create monthly summaries and reports. This process also creates monthly closure archive files.

**Yearly Close** Xstore POS now includes a yearly close function used to complete end-of-fiscal-year functions. This process also creates yearly closure archive files.

#### **Portugal Country Pack**

The following features have been added to the Portugal country pack for Xstore POS:

Electronic Signature Receipts and invoices now include an electronic signature string

## **Xstore Mobile Point of Service**

Xstore Mobile Point of Service includes the following new features:

#### Linea Pro Sled

A Linea Pro sled is now supported by Xstore Mobile Point of Service on an iOS system.

Xenvironment	On a lead register connected to a large number of non-lead registers, the Xenvironment engine does not gradually increase its CPU usage during the day.	27500732
Airside	The airside invoice and credit note sequence numbers reset at the configured time in Xstore POS.	27532904
