This document highlights the major changes for Release 17.0.2 of Oracle Retail Xstore Suite.

Overview

Oracle Retail Xstore Suite 17.0.2 includes the products below.

Oracle Retail Xstore Point of Service

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

Oracle Retail Xstore Office

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

Functional Enhancements

The following functional enhancements are included in this release.

Germany Configuration Accelerator - Exporting Sales and Tax Data

Relevant sales and tax data can be exported from the Xstore Point of Service database, so that tax authorities can perform tax audits against retailers (tax payers).

Italy Configuration Accelerator

The following functional enhancements have been implemented for the Country Pack Italy.

Registratore Telematico and Registratore Telematico Server

The Fiscal Printer (FP) can be now replaced with the Registratore Telematico (RT) or with the Registratore Telematico Server (RTS).

Electronic Invoice

The Identification Code (IC) and/or the certified e-mail address (PEC) can be entered for electronic invoices.

Mexico Configuration Accelerator - Improved Log

The log messages between Xstore Point of Service and the third party provider have been improved.

Portugal Configuration Acceleration - WSDL location

The Shipping Web Service WSDL location has been changed.

Spain Configuration Acceleration - Exporting Sales Data (SII Suministro Inmediato Information)

During the store close procedure Xstore Point of Service exports sales data to the tax authorities.
