## **Overview**

Oracle Retail Xstore Suite 18.0.1 includes the products below.

## **Oracle Retail Xstore Point of Service**

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

### **Oracle Retail Xstore Office**

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

### **Functional Enhancements**

This section addresses the functional enhancements included in Oracle Retail Xstore Suite System Release 18.0.1.



# **France Configuration Accelerator**

The following functional enhancements have been implemented for the Country Pack France.

### Nomenclature des Activités Françaises (NAF) Code

The Nomenclature des Activités Françaises (NAF) code is printed on receipts.

#### **Unit Price Tax**

The unit price tax excluded is shown on invoices.

### **Suspended Receipts**

Xstore Point of Service does not print receipts for suspended transactions.

#### **Invoice Reference On Credit Notes**

The invoice reference on credit notes includes the complete number of the original invoice including the prefix, for example, F072118000002.

## **Database Tampering Check**

The database tampering check has been improved.

#### **Terminal ID for Events**

The length of the terminal ID can be configured to meet the requirements of the retailer.

## **Preflight Check**

A new preflight check has been implemented. The preflight check validates if the following store properties are present:

- Système Informatique pour le Répertoire des Entreprises sur le Territoire (SIRET)
- Nomenclature des Activités Françaises (NAF)
- Taxe sur la Valeur Ajoutée (TVA)

These properties are mandatory for the receipt printing.

### Log Records

An audit log record is written to the cfra\_technical\_event\_log table for the following events:

- the period closing (daily/monthly) starts
- a sale is cancelled

## **New Database Entries**

The following columns have been added to the cfra\_sales\_total and cfra\_sales\_tnr\_total table:

- real\_perpetual\_grand\_total
- signature\_version

#### **Xstore Office**

The following functional enhancements have been implemented:

#### System Manager

The System Manager menu allows a retailer to manage available system management options.

## **Credentials Storage**

The Credentials Storage function allows you to submit and store credentials to set up a connection with Oracle Retail Customer Engagement Cloud Service.

### **Store Authorization Manager Screen**

The Store Authorization Manager Screen has been implemented so that a retailer can easily access all store related functions from the same menu. The menu contains the Store Enrollment option.

#### **Store Enrollment**

The Store Enrollment function enables you to enroll all stores in the organization node to communicate with cloud services or to enroll all stores in organization node with Xstore Office Cloud Service.

### **OCDS Job History Data Retention**

The number of days to retain OCDS Job History data in the database can now be configured in the Xadmin Settings menu in Xstore Office.
