This document highlights the major changes for Release 19.0.3 of Oracle Retail Xstore Suite.

## Overview

Oracle Retail Xstore Suite 19.0.3 includes the products below.

### Oracle Retail Xstore Point of Service

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

### Oracle Retail Xstore Office

Oracle Retail Xstore Office is a central web-based management console that provides for the effortless management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

## Functional Enhancements

This section describes the functional enhancements that have been added to Xstore Suite 19.0.3:

### Spain Country Accelerator

The following functional enhancements have been implemented for the Country Pack Spain.

#### Cash Limit Configuration

A new cash threshold limit configuration has been implemented for Spain. The cash threshold limit is applied against the transaction amount, and not against the cash payment amount.

### France Country Accelerator

The following functional enhancements have been implemented for the Country Pack France.

#### Certification

Changes have been implemented to comply with NF525 2.2 certification.

### Mexico Country Accelerator

The following functional enhancements have been implemented for the Country Pack Mexico.

#### CFDI 4.0 Compliance

Changes have been implemented to comply with CFDI 4.0. The communication with third parties is now following REST technology instead of SOAP.

### Poland Country Accelerator

The following functional enhancements have been implemented for the Country Pack Poland.

#### Tax Free - New Data Requirement

Changes have been implemented to capture all new required tax free data to be compliant with legal and regulatory requirements.

### Xstore and Order Management System support REST Service

The integrated messages between Xstore and Order Management System now support REST.

## Middleware

Oracle Retail Xstore Suite Release 19.0.3 is supported for use with the following Middleware components:

- Tomcat 9.0.55
- Jetty 9.4.43
- Log4j 2.17.1

## Xstore Mobile

Xstore Mobile now supports iOS 15.

## Defect Fixes and Documentation

A defect fix is a modification to the base Oracle Retail Xstore Point of Service code (for example, a bug fix, a performance enhancement, a functional enhancement, or a technical enhancement). The file named **DEFECT\_MODULE\_XREF\_XSTORE\_19.0.3.xls** lists every defect number and the modules and scripts that are added or modified in the release.
