This document highlights the major changes for Release 4.8.8 of Oracle Retail Xstore Point of Service.

Note: The rebranding for the latest version of this documentation set is in development as part of post MICROS acquisition activities. References to former MICROS product names may exist throughout the existing documentation set.

Release Overview

This document contains the release notes for Oracle Retail Xstore Point of Service version 4.8.8 components. These release notes cover new features and enhancements for this version of Oracle Retail Xstore Point of Service, Oracle Retail Xstore Office, Oracle Retail Xpay, and Oracle Retail Xenvironment.

Important Information

Any customer currently running an earlier version of Xstore Point of Service 4.8 and/or Xenvironment 4.8 should upgrade to version 4.8.8 of both products as soon as possible.

Note: You must also upgrade Xenvironment to version 4.8.8. Xstore Point of Service 4.8.8 will not communicate with an earlier version of Xenvironment.

You must also upgrade JBoss 6 to the latest build.

If you are using Xstore Payment, you must also upgrade Xstore Payment to version 2.2.
