Java Standard Edition 7 Runtimes

Xstore Point of Service and Xenvironment now use the Java Standard Edition (SE) 7 Runtimes.

Multi-Threading Capability

In Xstore Office, the Xcenter broadcaster can now use multiple threads to handle data from the point-of-sale log.
