

This document highlights the major changes for Release 6.5.10 of Oracle Retail Xstore Suite.

## Overview

This document contains the release notes for Oracle Retail Xstore Suite version 6.5.10 components. These release notes cover new features, enhancements, and resolved issues for this version of Xstore Point of Service, Xstore Office, and Xenvironment.

## Important

Releases 6.5.1 through 6.5.3 of Xstore Point of Service, and Xstore Office were internal releases and were not released publicly.

The release numbers 6.5.5 through 6.5.9 for Xstore Point of Service, and Xstore Office were skipped to more closely align version numbers.

Releases 6.5.1 through 6.5.8 of Xenvironment were internal releases and were not released publicly.

Xstore Point of Service 6.5.10 can only communicate with Xenvironment 6.5.9.

Xenvironment 6.5.9 was released in conjunction with Xstore Point of Service 6.5.4, and the updates are described in the corresponding Release Notes.
