This document highlights the major changes for Release 6.5.4 of Oracle Retail Xstore Point of Service.

Release Overview

This document contains the release notes for Oracle Retail Xstore Suite version 6.5.4 components. These release notes cover resolved issues for this version of Xstore Point of Service, Xstore Office, and Xenvironment.

Important Information

Any customer currently running an earlier version of Xstore Point of Service 6.5 should upgrade to version 6.5.4 and any customer currently running an earlier version of Xenvironment 6.5 should upgrade to version 6.5.9 as soon as possible.

Note: You must also upgrade Xenvironment to version 6.5.9. Xstore Point of Service 6.5.4 will not communicate with an earlier version of Xenvironment.

You must also upgrade Apache to version 2.4.10 (build 57).

If you are using Jetty, you must upgrade to Jetty 8.1.8 (build 26).

If you are using Tomcat, you must upgrade to Tomcat 7.0.37 (build 19).

Releases 6.5.1 through 6.5.3 of Xstore Point of Service, and Xstore Office were internal releases and were not released publicly.

Releases 6.5.1 through 6.5.8 of Xenvironment were internal releases and were not released publicly.
