## **Functional Enhancements**

# Omnichannel Data Privacy Application Programming Interface Tool

The new Omnichannel Data Privacy API Tool that has been integrated with Xstore Office allows you to perform the following actions related to data privacy:

- End User Access and Other Requests (Data Access): The API tool allows you to request personal information for a specified person. The response to the request contains all personal data for the person.
- Data Removal: The API tool allows you to remove personal data for a specified person. The response to the request indicates whether the removal was successful.
- Anonymization: When removing personal data for a specified person, the system replaces the personal data with blank fields.

**Important:** The Omnichannel Data Privacy Application Programming Interface Tool must be installed on an application server running Java 8.

#### iOS 11

The Xstore Mobile Point of Service client application can now run on iOS 11 devices.
