

This document highlights the major changes for Release 7.1.2 of Oracle Retail Xstore Point of Service.

Release Overview

This document contains the release notes for Oracle Retail Xstore Point of Service version 7.1.2 components. These release notes cover new features and enhancements for this version of Oracle Retail Xstore Point of Service, Oracle Retail Xstore Point of Service Mobile, Oracle Retail Xstore Office, Oracle Retail Xstore Payment, and Oracle Retail Xenvironment.

Important Information

Any customer currently running an earlier version of Xstore Point of Service 7.1 and/or Xenvironment 7.1 should upgrade to Xstore Point of Service 7.1.2 and Xenvironment 7.1.1 as soon as possible.

Note: You must also upgrade Xenvironment to version 7.1.1. Xstore Point of Service 7.1.2 will not communicate with an earlier version of Xenvironment.

You must also upgrade Apache to version 2.4.10 (build 55).
