# **Overview**

Oracle Retail Xstore Suite 15.0.2 includes the products below.

#### **Oracle Retail Xstore Point of Service**

Oracle Retail Xstore Point of Service is a point-of-sale application that provides the capabilities to carry out day-to-day transactions and conduct daily store activities. Tasks such as scanning items, applying price adjustments, tendering, and printing receipts as well as processing returns and web orders can be performed. Store operations including opening the store, managing registers and tills, and closing the store can be handled through Oracle Retail Xstore Point of Service.

As part of Oracle Retail Xstore Point of Service, these release notes include information about Xstore Point of Service Mobile and Xenvironment.

#### **Oracle Retail Xstore Office**

Oracle Retail Xstore Office is a central web-based management console that provides for the facile management of the data and configurations that empower your associates. The user interface within Oracle Retail Xstore Office provides streamlined functionality that guides users through configuration changes, data changes, and deployments. Granular security access can create a custom experience for users of all access levels. Multiple support tools and alerts enable IT leaders to take a proactive approach to managing multiple installations.

# **Functional Enhancements**

This section describes the functional enhancements that have been added to Xstore Suite 15.0.2:

# **Omnichannel Data Privacy Application Programming Interface Tool**

The new Omnichannel Data Privacy API Tool that has been integrated with Xstore Office allows you to perform the following actions related to data privacy:

- End User Access and Other Requests (Data Access): The API tool allows you to request personal information for a specified person. The response to the request contains all personal data for the person.
- Data Removal: The API tool allows you to remove personal data for a specified person. The response to the request indicates whether the removal was successful.
- Anonymization: When removing personal data for a specified person, the system replaces the personal data with blank fields.

**Important:** The Omnichannel Data Privacy Application Programming Interface Tool must be installed on an application server running Java 8.

#### **Xstore Point of Service**

The following functional enhancements have been made to Xstore POS version 15.0.2:

#### **Customer Consent**

When collecting information about a customer, Xstore POS can be configured to ask the customer for their consent to having their data collected.

#### **Xstore Mobile POS**

The following enhancements are now available in Xstore Mobile POS:

#### Improve Help Desk Error Capabilities

When Xstore Mobile POS now encounters a help desk error, some errors now include a Continue button alongside the Configuration button, allowing the user to continue using the application without first entering the Configuration screen.

## France Country Pack

The following changes have been made in the country pack for France:

#### Postal Code in Invoices and Credit Notes

A tax-free invoice or credit note cannot be created when there is no postal code in the primary address for the customer assigned to a transaction.

#### **Workstation Sales Summary**

Workstation sales summary records are now maintained at daily, monthly, yearly and perpetual time periods.

#### **Transaction Sequence Number**

Each sales transaction has a new, specific sequence number assigned to it. This transaction number is printed on the receipt.

#### **Certification Information**

Xstore POS now has a menu option to display its certification number, a reference to the NF525 mark or logo, its certified system serial number, and the compliance version of the software and/or firmware.

#### New Information on Receipts and Invoices

Receipts and invoices now include the following fields:

An Electronic Signature string.

**Note:** The Infocert Certification number is replaced by asterisks when the register is in training mode.

- Xstore POS software version
- Certification Logo

#### **Training Mode Indication on Receipts**

When printing a receipt in training mode, the receipt displays the word, "Formation," indicating that it is a training receipt.

#### Indication that Receipts are Not Valid for Collection

Non-sale extended transactions include the words, "NON VALABLE POUR ENCAISSEMENT," on the receipt. This indicates that the receipts are not valid for collection.

#### **Daily Close**

Xstore POS now includes a daily close function used to create daily summaries and reports. This process also creates daily closure archive files.

#### **Monthly Close**

Xstore POS now includes a monthly close function used to create monthly summaries and reports. This process also creates monthly closure archive files.

#### **Yearly Close**

Xstore POS now includes a yearly close function used to complete end-of-fiscal-year functions. This process also creates yearly closure archive files.

#### **Xstore Point of Service**

Xstore POS has the following technical enhancements:

#### Log4j

Xstore POS now supports Log4j version 2.9.1.

## **Verifone Mobile Framework**

## **Xstore Mobile POS**

The following technical enhancements have been made to Xstore Mobile POS:

#### iOS 11

Xstore Mobile POS is now supported on iOS 11.

Xstore Office has the following technical enhancements:

#### **Tomcat**

Xstore Office is now supported on Tomcat version 8.5.23.

## **Jetty**

Xstore Office is now supported on Jetty version 9.4.2.
