1.2.1 New Parameters

The current release introduces a new parameter in the Global Settings page for Banking and Insurance installations. The newly introduced parameter, "Allow System To Execute ETL Jobs Till Latest Replicated Records for Initial load" decides whether recently modified data are to be replicated (value 'Y') or if data until 12AM are to be replicated (value 'N').

This release has introduced some performance improvements that has improved the performance of ETL jobs significantly.
