In Germany, run the GET_GDPDU_EXPORTS_V6.sql file to use the view to configure the export.For Austria, a Fiscal Printer Interface is now available. Each time an invoice prints the Fiscal Printer Interface activates communication with the fiscal control unit and a view collects the required information passed to the fiscal device.
