## 1.1 Oracle Banking Digital Experience Personal Loans Originations

This section describes the key enhancements of Oracle Banking Digital Experience Personal Loans Originations as part of the Oracle Banking Digital Experience Release 15.1.0.0.0.

### 1.1.1 Originations – Unsecured Personal Loan

With the introduction of Origination of Unsecured personal loan, Digital Banking users will be able to initiate loan origination through self service channel. It allows users to specify their loan requirements, provide their personal and financial details and submit the application for processing. Origination for Unsecured Personal Loan allows users to apply for loan without any collateral and is solely dependent on applicant's credit worthiness.

Existing bank customers as well as prospects can apply for personal loan online. Applicants can specify if loan application consists of any joint holders and specify their details in the application form.

The loan applicant's credit assessment is performed online and eligibility of the applicant is informed upfront.

## 1.1.2 Originations – Application Tracker

Oracle Digital Platform supports tracking application initiated through originations using a tracker. Oracle Banking Digital Experience platform also enabled a customer to view the current status of the application and take action accordingly.

- Applications for following products can be tracked through App Tracker
  - Unsecured Personal Loan (Lending product)

In addition to tracking the application status, user can also act on the pending actions with regards to the application such as providing additional preferences, uploading documents, accepting offers, etc.
