This document highlights the major changes for Release 5.2.073 of MICROS Locate.

Overview

MICROS Locate includes the following modules:

- Order Broker: Distributed order broker that determines inventory availability across the enterprise, and uses advanced business rules to select locations that can fulfill orders
- Supplier Direct Fulfillment: Web-based vend or portal enabling vendors to share purchase orders and shipping information to simplify drop shipment'
- Store Connect: Web portal that enables store associates to process and fulfill omni-channel orders
