This function is used to limit invoice printing to just the receipts issued on the current date.

## 2 Invoice printing block only for current date


### 2.1 Configuration

It is possible to enable the flag "Allow invoice printing only for sales with current date" in Geographic nodes, "Sales" section, in "Invoice options".

### 2.2 Operation

During the invoice printing phase from the receipt list, the operation will be blocked if the receipt has not been issued on the current day.



The receipt date will not be taken into consideration, but the issue date, thus it will be possible to print the invoice of a retrodated receipt.
