### **2.1 Configuration**

#### **2.1.1 Customers**

Using the table it will be possible to add the filters "96 - Nr.Reg" and "97 - Attributo fiscale" to the customer form.

#### **2.1.2 Invoices**

The new non-mandatory fields "Nr.Reg" and "Attributo fiscale" will be added during the invoice data entry request phase.

It is also possible to display and assign a value to the "Banca" field indicated on the customer's master data form.
