1 Introduzione

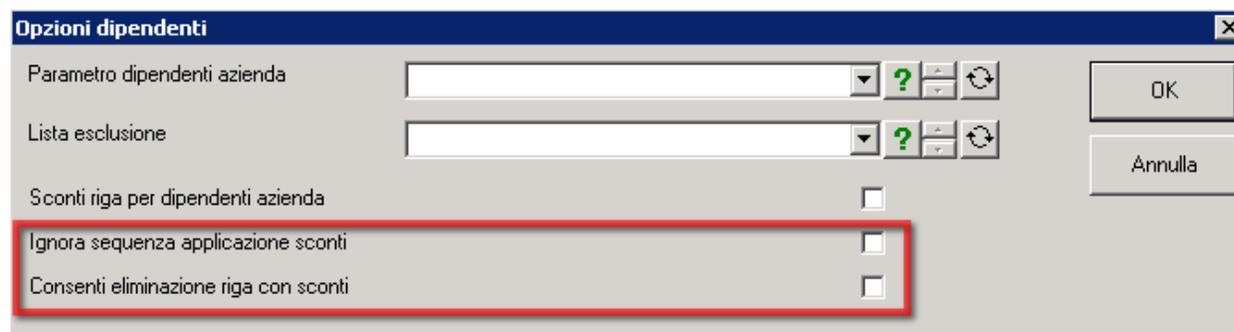
