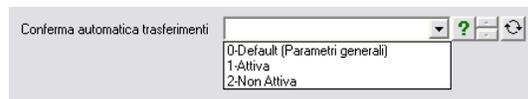
## 2 Definizione conferma automatica trasferimenti su causale

### 2.1 Configurazione

Sulla scheda della causale di magazzino introdurremo una nuova abilitazione. Non ci si può limitare ad un singolo "flag", in quanto le possibili opzioni possono essere tre:

- Utilizzare l'attuale abilitazione a livello di parametro generale.
- Attivare la gestione da causale (indipendentemente dall'abilitazione sui parametri generali).
- Non attivare la gestione (indipendentemente dall'abilitazione sui parametri generali).
