This document highlights the major changes and fixes for Release 1.10.0.10 of Oracle Retail Brand Compliance Management Cloud Service.

## Overview

Oracle Retail Brand Compliance Management Cloud Service is an integrated suite of applications designed to meet all aspects of sourcing, developing, and protecting retailer brands. The suite provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

The suite is composed of the following applications:

- myLibrary - enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- myProduct - supports the development of products and production specifications.
- myProject - supports the development of project briefs, plans, and workflow management.
- mySupplier - enables the identification, selection, and approval of suppliers.

## General Functional Enhancement

The following functional enhancement is included in this release:

## Improved Handling of Serving Quantities within Front of Pack Nutrition Labelling

Ref TRUNKONEEIGHT-484

The system now caters for products where the Serving Quantity is the same or less than the Front of Pack Per Serving threshold, for example, products such as red meat, poultry, or fish and therefore only the Per 100 column is declared. Should this be the case, the system now allows the Per Serving column to be removed from the Columns to be declared field.

## Fixed Issues

The following tables list issues fixed in this release:

**Table 1 General Fixed Issues**

Defect Number	Description
TRUNKONETEN-49	The business category selector used in various records now correctly observes the number of levels configured.
TRUNKONEEIGHT-462	An incorrect time zone was used when a time stamp was added to a Specification. A fix is applied so that the time stamp now uses the time zone specified in the user's profile when a user makes a change to a specification.
TRUNKONEEIGHT-486 Tesseract Ref 111937	A fix is applied to queries which are run to populate a user's Task App such that a timeout no longer occurs.

**Table 2 Administration Fixed Issues**

Defect Number	Description
TRUNKONEEIGHT-482	An error no longer occurs during a bulk glossary import, which contains data for Apps (found on the home page), when preparing a system for a new release.
TRUNKONEEIGHT-485 Tesseract Ref 107136	The system timed out when attempting to edit the Brands glossary. The brand keywords glossary is changed from a table to a paged view with each keyword dealt with as a record. <b>Note:</b> For existing implementations, the feature which enables the brands list to be shown in the selector in table order is removed as part of this change. This means that when the selector for brands is now opened, it presents brands in alphabetical ascending order.

**Table 3 mySupplier Fixed Issues**

Defect Number	Description
TRUNKONEEIGHT-474	The system was incorrectly unlinking a site from its supplier. The system no longer removes the link between a site and its supplier when the site is being deleted and the site has been used within a Produce specification.

**Table 3 (Cont.) mySupplier Fixed Issues**

Defect Number	Description
TRUNKONEEIGHT-483	Retailer Users with the Supplier User Editor Authority Profile were unable to see the All Sites Field in a Contact record.  The system now allows a user with this Authority Profile to see and use the All Sites field when editing a Contact record.

**Table 4 myLibrary Fixed Issue**

Defect Number	Description
TRUNKONENINE-123	A fix is applied to permissions to allow Library Administrators to add documents.

**Table 5 myProduct Fixed Issues**

Defect Number	Description
TRUNKONETEN-50	A fix is applied so that spaces are no longer incorrectly added to the formatted On Pack ingredients text.
TRUNKONENINE-126	An error was encountered when selecting a nutrition panel.  A fix is applied so that no error is encountered if the nutrition panel is changed on a specification, which had previously used a panel with the Nutrient Intake Category set to Adult, to a panel which has the Nutrient Intake Category set to Infant.
TRUNKONEEIGHT-449  Tesseract Ref 109117  Ref 22533157	A fix is applied to the export as csv function to allow the Formulated Non Food ingredients glossary to be exported.
TRUNKONEEIGHT-452  Tesseract Ref 108314  Ref 22491520	A fix is applied so that the products covered table is correctly displayed after the specification is moved on from Collaborative Draft.
TRUNKONEEIGHT-459  Tesseract Ref 101268	A fix is applied to allow the Copy Table function to work within the Packaging section of a specification.
TRUNKONEEIGHT-461	A fix is applied so that when editing nutrients in the nutrition table, the system can deal with a nutrient which has had its description removed from the glossary.
TRUNKONEEIGHT-463  Tesseract Ref 109754	A fix is applied which now allows a Nutrition Rounding Glossary record to be copied without an error.
TRUNKONEEIGHT-467  Tesseract Ref 101198	The system no longer shows a Pack Copy file section within non-produce specifications.
TRUNKONEEIGHT-468	Rounding rules and nutrients are now copied when a nutrition glossary record is copied.
TRUNKONEEIGHT-470	The system no longer displays inactive benchmarks in the benchmarks selector when setting benchmarks within a product.
TRUNKONEEIGHT-472	The Front of Pack (FoP) score level information was missing from the Specification outbound API.  The system now correctly populates the API with FoP score information for a new version of a specification that had previously been migrated into Brand Compliance from an external system.

**Table 5 (Cont.) myProduct Fixed Issues**

Defect Number	Description
TRUNKONEEIGHT-473 Tesseract Ref 111170	A fix is applied so that an error is no longer encountered when attempting to open a specification which contains a site that is no longer linked to a supplier record.
TRUNKONEEIGHT-478	An incorrect business category level was used when creating new Product Records.  A fix is applied so that the business category level used within the Product Record no longer uses the same as that used for a site. It is now fixed at the maximum number of business category levels set for the system.
TRUNKONEEIGHT-480	Products covered within a specification linked to the wrong Product Record.  A fix is applied so when a specification is copied and then linked to a new Product Record, it does not retain the links which point to the original Product Record.
TRUNKONEEIGHT-481 Tesseract Ref 110092	An error occurred when adding an attachment to a specification.  A fix is applied so that attachments can be added to a specification when there is no cutter guide attachment table shown in the OLC section of a specification.

**Table 6 Audits & Visits Fixed Issue**

Defect Number	Description
TRUNKONENINE-128 Tesseract Ref 11291	A fix is applied so that no error is encountered when attempting to change the status of an audit, when the audit is using an audit template which had been changed.

**Table 7 myProject Fixed Issues**

Defect Number	Description
TTRUNKONENINE-130	A fix is applied so that if the Area field of a user is changed, while at the same time that user is in the middle of unlinking a record from an activity, the activity does not get out of sync.
TRUNKONENINE-131	A fix is applied to prevent a user who is not the Owner or Responsible for an activity from unlinking a record to it.
TRUNKONEEIGHT-465	An error is no longer encountered when the status of a record, which is linked to a project activity, is updated.
